I am writing to report a suspected violation of 22 US code § 211. Nina Jankowicz filed form OMB No. 1124-0006 on November 18, 2022 (attached below). Her Foreign Agent Registration number is 7192. It is my understanding that documents and information pertaining to this filing and Ms. Jankowicz' status as a registered foreign agent operating within the United States are public information. Further, it is my understanding that the FARA Unit makes registration information and disclosures available to the public to inform the public about the activities of foreign agents within the United States.

I am a journalist and documentary filmmaker. I have been investigating the activities of Ms. Jankowicz since April 2022. In May 2022, I produced a video report which includes unimpeachable evidence that is likely to prove Ms. Jankowicz was in violation of 22 US code § 211 in May of 2022 when she received payments from multiple foreign non-profit corporations while working for U.S. Department of Homeland Security as the Executive Director of the Disinformation Governance Board.

I produced photos, originally published by Ms. Jankowicz in addition to other information, that indicate she was operating inside campaign headquarters of Ukrainian President Volodymyr Zelenskyy on election night in Kyiv Ukraine where, by her own admission, she was living at the time and studying as a Fulbright Scholar. The location and time of the photograph was confirmed by the Ukrainian photographer who took the picture and his confirmation is included in the video report.

Immediately after I published this report, Ms. Jankowicz resigned from her position as Executive Director and the unconstitutional DHS Disinformation Governance Board was disbanded. Ms. Jankowicz then went on a media tour falsely attributing her departure to her being a victim of "disinformation" rather than admitting the true facts that she was not properly registered pursuant to the Foreign Agent Registration Act as pointed out in the report. This was a false and materially misleading statement made to the public and I allege this was done to hide her true activities as a foreign agent operating within the United States.

Ms. Jankowicz, or someone acting on her behalf took immediate and unknown action to remove the video report from YouTube and destroy the entire YouTube channel I had published it on causing great financial damage to me.

On Wednesday January 4, 2023, I published a tweet on Twitter.com which linked to the FARA unit Registration form filed by Ms. Jankowicz on November 18, 2022. Ms. Jankowicz made a false and materially misleading claim when she fraudulently informed Twitter that I had violated Twitter rules by posting personal information. The address provided by Ms. Jankowicz is Post Office box at a UPS retail store in Arlington VA, not her home. Irrespective of the address Ms. Jankowicz chose to include in her filing, the filing is public information as I understand it. If I am correct, Ms. Jankowicz committed fraud when she lied to Twitter and her motive appears to be hiding her status as a registered foreign agent operating within the United States.

As a U.S. Citizen, I am very concerned about a registered foreign agent with a long history of suspicious activity who has persistently attempted to hide her status as a foreign agent and I am writing to request that you open an investigation into the activities of Nina Jankowicz. If such an investigation finds violations of the Foreign Agents Registration Act, I would hope Ms. Jankowicz will be prosecuted to the fullest extent allowed by law.

Thank you for prompt consideration of this matter.
