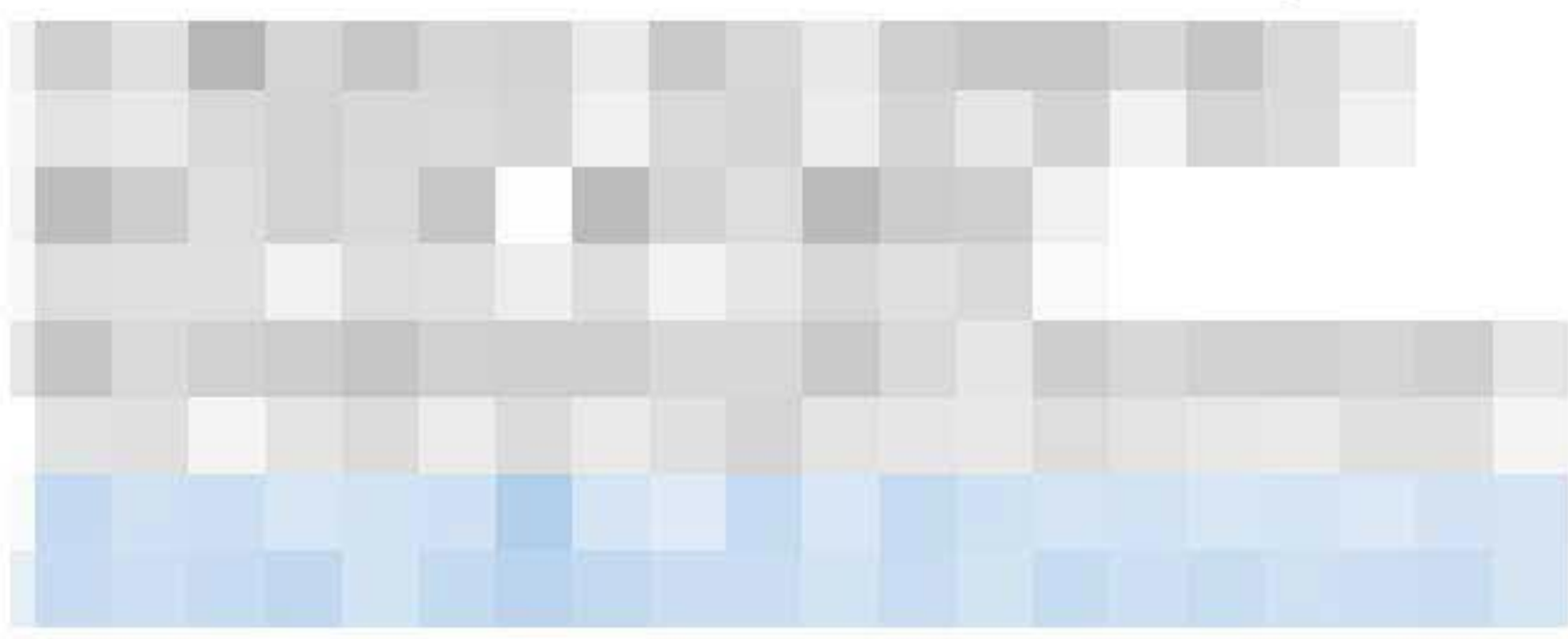

Mr. Spiro,

If you are not the appropriate party to contact regarding legal matters concerning Twitter, please forward this communication to Twitter's legal counsel. I am currently unable to determine who holds that position following the departure of Sean Edgett in October 2022.

I am writing to inform you of extremely troubling information pertaining to the activities of a foreign agent registered pursuant to 22 U.S. Code § 611 who is operating illegally on Twitter.

On January 4, 2023, I posted a tweet that included a link to the public Registration Statement filed by Nina Jankowicz ("Jankowicz") pursuant to The Foreign Agent Registration Act ("FARA").

Later on January 4, 2023, Jankowicz falsely represented to Twitter that I had violated their rule against posting private information. This false and materially misleading statement may be a violation of FARA or other laws and represents extremely serious malfeasance on the part of Jankowicz as a registered foreign agent operating within the United States including on Twitter.

In May of 2022, I published a report that alleged Jankowicz was in violation of 22 U.S. Code § 611. (<https://odysee.com/@CrowdsourcetheTruth:d/2022-05-16-20-00-03-Live:9?r=73LTQ7izBcj8qkyQcMRLcevmePnUuBoJ>)

Immediately following my publication of this report, Jankowicz resigned from her position with the United States Department of Homeland Security Disinformation Governance Board ("DHS"). (<https://www.washingtonpost.com/technology/2022/05/18/disinformation-board-dhs-nina-jankowicz/>)

Jankowicz' resignation coincided with the termination of my access to several social media accounts that were vital components of my business.

Effectively confirming my allegations, subsequent to Jankowicz' resignation from the DHS, she filed the required Registration Statement pursuant to 22 U.S. Code § 611 and registered under FARA on November 18, 2022. (<https://efile.fara.gov/docs/7192-Exhibit-AB-20221118-1.pdf>)

The document itself, as well as the statute it is filed pursuant to, both indicate the document and information contained therein are **PUBLIC** information, not private, and therefore not subject to any Twitter rules against posting private information.

Jankowicz is now employed by the UK funded Centre for Information Resilience and operates as a registered foreign agent on Twitter and elsewhere within the United States. (<https://twitter.com/cen4infores/status/1573299231225708545?lang=en>)

The FARA Unit makes registration information and disclosures available to the public to inform the public about the activities of foreign agents within the United States. I exercise my first amendment rights to do the same on Twitter. Jankowicz' false and materially misleading statement is a clear effort to deceive Twitter's Trust and Safety Department and break Twitter rules in violation of 22 U.S. Code § 611 and to maliciously damage me and my business.

Jankowicz' material misrepresentation to Twitter, that I had violated Twitter's policy against sharing personal information, was maliciously calculated to remove public information from Twitter that was unfavorable to Jankowicz and is consistent with her past actions.

On January 4, 2023, I served Jankowicz with a pending litigation notice and a warning that she must immediately withdraw her false and materially misleading, fraudulent complaint. At the time of this writing, Ms. Jankowicz has not complied.

I am writing to you to request that Twitter's legal department become immediately involved in this matter and forcibly withdraw Ms. Jankowicz fraudulent complaint against @csthetruth. This should restore @csthetruth to good standing and expunge the false complaint.

I further request that Twitter permanently suspend Ms. Jankowicz' offending Twitter account ("@wiczipedia") and recommend her for criminal prosecution to the appropriate authorities for a clear violation of law in an obvious effort to obfuscate her activity on Twitter as an agent of a foreign government.

Thank you for your prompt attention to this matter.
