Mr. Haskett:

If you review my cost estimate letter provided on May 11th for your 2/26/20 request, the ending of the letter states:

Your request will be considered automatically withdrawn if you do not notify us in writing within ten business days from the date of this letter that you either:

1. (a) accept the charges;
2. (b) wish to modify your request; OR
3. (c) have sent to the Open Records Division of the Office of the Attorney General a complaint alleging that you are being overcharged for the information you have requested.

We were not notified in writing within ten business days that you were lodging a complaint with the Attorney General alleging that you were being overcharged for the information requested, so your request was considered automatically withdrawn.

Your current information request dated 3/11/20 encompasses the same material (with some additional documents), so you still have opportunity to review the information originally encompassed in your 2/26/20 request. The records have been available for your review in my office since June 19th; Mr. Jetelina has rescheduled the inspection several times and I'm awaiting his most recent scheduling update to hopefully resolve this information request.
