Yes, I'm working from home today; I live only a few miles from the tank farm fire going on in Deer Park and I wanted to be with the family in the event we need to evacuate.

Regarding your request, the report that is referenced in the Bond Resolution discusses "the additional works, land, improvements, facilities, plants, equipment, and appliances to be purchased, acquired and constructed by the District, together with maps, plats, profiles and data showing and explaining such report." We included the cost breakdown of the associated projects in the initial email. However, the remaining documents are not able to be released as they are related to our infrastructure. While I understand you are simply trying to formulate a better understanding of the upcoming bond, there is a security concern with these documents getting into public circulation and becoming utilized for nefarious intent. At the upcoming town halls we will be discussing in greater detail the proposed projects and of course we are always available at the office (or remotely as my case is today!) to answer any questions you may have.
