This request is made under the Freedom of Information Act. I hereby request copies of the following records:

- 1) The final result from the "incorporation poll" conducted at the San Leon MUD with the use of San Leon MUD employees & facilities in conjunction with Sunny San Leon, Inc. in the summer of 2016.
- 2) Written agreement between Sunny San Leon, Inc. and the San Leon MUD for said "poll" conducted in the summer of 2016 at the San Leon MUD office.
- 3) Agenda and Minutes of all San Leon MUD meetings in which said "poll" was discussed or authorized.

The request for records is made to better understand options regarding annexation in conjunction with the decision making at the San Leon MUD (SL MUD) in consideration of the proposed Bond Election in May of 2019. This request is submitted in good faith for the benefit of the land owners within the SL MUD district.

I am a property owner and water service customer of the SL MUD.

I request a waiver of all fees for this request. Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government. The final result from the “incorporation poll” conducted at the San Leon MUD with the use of San Leon MUD employees & facilities in conjunction with Sunny San Leon, Inc. in the summer of 2016.

- The incorporation poll was conducted entirely by Sunny San Leon, Inc. so those results are not documents the MUD is in possession of. San Leon MUD resources were not used for the incorporation poll save for the use of office space to host the ballot box.

Written agreement between Sunny San Leon, Inc. and the San Leon MUD for said “poll” conducted in the summer of 2016 at the San Leon MUD office.

- There exists no written agreement between Sunny San Leon, Inc.'s and the San Leon MUD for the incorporation poll as Sunny San Leon, Inc. handled all aspects of the poll. There was a verbal agreement to allow Sunny San Leon, Inc. to place their ballot box in the MUD's office to collect the votes, but outside of that interaction the incorporation poll was conducted entirely by Sunny San Leon, Inc.

Agenda and Minutes of all San Leon MUD meetings in which said “poll” was discussed or authorized.

- The incorporation poll was conducted entirely by Sunny San Leon, Inc. so there do not exist any minutes or agendas in which San Leon MUD discussed or authorized the incorporation poll.
