Where the Addl. Secretary Dr P K Malik take a initiative and directed the staff to compile all detail by 22/06/2016 and send file to Administration reforms department but due to some official circumstance file may not move to AR department in due time.

In the view of your circular number F.1(591)/TRC/H&FW/2013/Pt.file-1/1627-58 Dated 03-09-2015 which is marked as a most urgent but unfortunately there is so much delay in this process and again TRC ask for detail by annexure-1 in the circular letter no.F.(591)/TRC/H&FW/2013/Pt.File-I/2844-83 Dated 10-03-2016 and letter no. F.(591)/TRC/H&FW/2013/Pt.File-I/3036 Dated 9-5-2016 from all hospital and dispensaries but due to negligence of services staff in your department all process stuck in the pipeline. Then our federation took imitative in this matter and get the all detail from various Delhi government hospital and organisation's and supplied to TRC for speed up the process. Finally all detail is compile on 22/06/2016 and again stuck in your ministry.

So we are requested you on behalf of all Delhi government hospital and all dispensaries to look into matter closely and precisely and reveal the delay part in this process and rectify it so that work will taken expeditiously and all concern ministry which approval may need in this review of medical laboratory Staff cadre by Govt. of NCT of Delhi
