- Conduct ultrasound procedure according to PCC/Medical Advisor approved procedure with competence and professionalism
- Effectively convey verbal and nonverbal conviction that the fetus possesses humanity
- Recognize and record the appropriate anatomy and pathology using sonographic equipment
- Care properly for sonography equipment and report equipment failure
- Write reports based upon the scan results
- Alert appropriate medical staff of any abnormalities that need immediate attention
- Work independently as well as with the PCC staff and volunteers
- Display good work ethic and friendly and cheerful disposition
- Maintain the strictest levels of confidentiality
- Maintain professional knowledge and skills by participating in continued medical education
