BEST DIRECTIONS from the NORTH or SOUTH

Travel Interstate 95 to new exit 188 for Merritt Island, Patrick AFB and Beaches, The cross road over I-95 is Pineda Causeway. Go East on Pineda Causeway about 2.6 miles to Wickham Road. Turn right (or South) on Wickham Rd. and travel 2.0 miles to the Post Road traffic light. Continue on Wickham Rd. thru the light, passing Eastern Florida State College/ King Center on your left. Go about another 0.5 miles to the 2nd traffic light (Parkway Drive) and turn left onto Parkway Drive. Continue a short distance and turn left into Wickham Park. Once in the Park turn left toward the Equestrian Center and follow registration and/or spectator parking signs.
