# **Overview**


- The Health Equity and Social Connectedness for Older Adults Program seeks to generate deep community impacts in the Older Adult Health Equity and Social Determinants of Health (SDOH) landscape-through the Partner HERO + CHW model of community-level integration of service. This program will place Partner HEROs with Community Health Workers (CHW) in Senior Centers, local agencies, and/or non-profits among rural and semi-rural populations in McKinley, Valencia, and Lea Counties.
- ~70% of older adults experience adverse SDOH, which have a far greater impact on health outcomes than medical care. One of the most devastating SDOH among older adults is isolation and loneliness, a problem exacerbated in rural New Mexico where social determinants resources are most lacking and difficult to access. Concurrently, about 50% of adults discharged from hospitals are 65-years of age or older making this an important area to target and a planned focus of this program.
- Partner HEROs and Community Health Workers will target such unmet rural resource needs as volunteer income tax assistance (VITA) sites, public transportation, social connection and cohesion, remote/in-home health monitoring, and intervention. It is foundational to this program's objectives and the work of the Aging and Long-term Services Department (ALTSD) and UNM OCH, that this program creates smooth in-lines into the communities being served.
- We will incorporate professional development training to ensure understanding of the unique needs of the older adult population generally, and specific to the communities they'll be serving so they're fully equipped to meet the needs of these clients.

# Partner HERO + CHW Dyad Model

Partner HEROs will be identified in collaboration with respective Regional HEROs.

- Partner HEROs will provide guidance and assist in identifying resources to support the CHW, to develop access to necessary resources and address unmet needs for improving SDOH adversity among older adults.
- Partner HEROs work in collaboration with Regional HEROs who provide additional support and guidance.
- CHWs engage directly with older adults on site in the physical space provided by Partner Organizations, and where needed off site (e.g. home visits) to meet the needs of clients, to provide services, support, and resources for improving SDOH adversity among Older Adults.

# Partner Organizations

**Partner Organizations will host Partner HEROs and CHWs** on site to serve older adults and facilitate access to necessary social needs and improve social drivers of health. The Partner Organizations will be paid a stipend to cover program costs in exchange for the following:

- Physical space where Partner HEROs and CHWS can serve Older Adults. E.g., Senior Centers or Libraries
- The CHW will hold publicized, regular business hours for service and engagement.
- The Partner Organization will work with the Partner HERO(s) and CHW(s). The Partner HERO and CHW will be staffed through the Partner Organization(s) and funded through the Partner Organization contract to serve Older Adults.
- The Partner Organization(s) will provide supervision and oversight for the Partner HERO(s) and CHW(s) to address barriers to access that will improve SDOH adversity.



# FY25: Phase 2 – Service Implementation

- Train CHWs and Partner HEROs to serve Older Adults
- Begin serving clients to improve SDOH adversity and develop access to previously unavailable resources.
- Create a program model that is easily replicated for state-wide expansion.

## **Our History**

New Mexico Voices for Children (NM Voices), a nonpartisan, statewide advocacy organization, was founded in 1987 by a group of pediatricians who wanted to improve the negative conditions that impacted their young patients but could not be treated by medicine alone. While they could treat the symptoms of conditions like poverty, hunger, abuse and neglect, they could not treat the underlying causes. To do that, they needed to change the state policies that allowed those conditions to exist and grow.





### New Mexico's Supplemental Poverty Rate Has Fallen Dramatically and is Just Above the U.S. Rate


New Mexico and U.S. Supplemental Poverty Measures (3-year averages, 2015-2022)



purchasing goods like computers, office supplies, squad cars, building materials, and more; and




purchasing services like IT, health care, upkeep of state buildings, and more.

### Where New Mexico gets its revenue

FY2024 estimated general fund revenues



**General sales taxes** include gross receipts taxes (GRT) and compensating taxes. GRT is levied on most goods and services and is often passed along to the consumer.

**Excise taxes** are also sales taxes, but they are reserved for things like tobacco, liquor, motor vehicles, and telecommunications services.

**Income taxes** include personal income taxes (PIT) and corporate income taxes (CIT). Corporate income taxes are levied on a corporation's net profits.

Mineral revenues are collected on crude oil, natural gas, coal, copper, and other hard minerals that are extracted from the ground, as well as rents and royalties from the sale or lease of mineral-producing land.

**Interest on investments** is primarily income derived from investing permanent fund revenue in the stock and bond markets.

All other includes gaming revenue from tribal casinos as well as the fees paid on things like registering your car or visiting a state park or museum.

## Recent Policy Wins

- Tax Fairness: Working Families Tax Credit, state Child Tax Credit
- Budget Adequacy: Federal child care funds eligibility expansion, full funding of Medicaid,
   K-12 funding increases
- Economic Security: Food tax prevention, minimum wage increase, predatory lending abolition, paid sick leave
- Cradle-to-Career Education: Land Grant Permanent Fund, Early Childhood Education & Care Department, Opportunity Scholarship increases
- Healthy & Safe Communities: Establishing and licensing dental therapists, Medicaid expansions
- Human Rights & Civic Participation: State licenses for all qualified drivers, voting rights expansion
- Racial, Ethnic, & Gender Equity: Juvenile fines & fees elimination, child care provider wage increases

### KIDS COUNT

- KIDS COUNT offers free statistical data about economics, education, and health sorted by race, sex, and age related to child well-being
  - AECF produces annual state rankings based on 16 measures of child well-being
- We use KIDS COUNT to:
  - make policy recommendations;
  - draw attention to racial disparities;
  - educate lawmakers;
  - advocate for policy changes to improve child well-being;
  - provide data for public and partner use; and
  - continuously evaluate policy decisions.
