McKinley Health Alliance Meeting minutes 2/8/23

- NM Legislation Session (60 days)- started January 17th- March 18th, 2023
 - Chris gave updates and processes for legislative session- voting, pocket vetoes, checks and balances
- Somos Gallup- attending legislative session, advocating at Roundhouse
 - HB188- economic transition act- will establish an economic transition office and fund for workers transitioning away from the fossil fuel industry
 - HB 215- expand unemployment benefits feasibility study- how to extend unemployment to excluded workers such as immigrants, independent contractors in low-wage occupations, and oil and gas workers
 - SB10- Tax rebates for NM essential workers- provide tax rebates to essential workers and their families who are still struggling financially because of the pandemic
 - SJR 9- Amending the anti-donation clause and vibrant communities act- allows state and local governments to distribute funding directly to individuals and organizations for community well-being
 - Early childcare program expansion- fully fund childcare programs for children 0 3 years old especially in rural communities and childcare desserts
 - o HB 144- child tax credit- permanent and increase it to \$600 for low-income families and index it to inflation to help kids, families and the economy
- Strong Families NM
 - Medicaid forward campaign materials (pdfs), will be sent out via email to everyone
 - o Legislative priorities:
 - Support OSI Request for Healthcare Affordability Fund
 - Asking for support, want it to be fully funded
 - Medicaid forward- populations that have difficulty getting Medicaid
- Indigenous Lifeways- focusing on environmental issues, moving towards natural gas
- NM Alliance of HCs- Working to advocate for all councils to re-enact and assure our place in public health HB49
 - o How can health councils be fully funded?
