Her history in skiing is an inspiration to all—but especially to local children and their families from Vermont—where at just age 14, Andrea Mead Lawrence made the national team. At 15, she competed in the 1948 Winter Olympics, taking eighth in slalom. In 1952, she was selected as captain of the U.S. women's team at the age of 19 and went on to win both slalom and giant slalom—the first and only time an American has won two gold medals—becoming the top American ski racer of her time. And her roots began right at Pico Mountain, where she grew up on a mountain that her alpine skiing family owned and operated. Her legacy continues to inspire young Pico skiers today.
