#### **DRAFT MEETING MINUTES**

# AGHA BOARD MEETING, Held Wednesday, May 15, 2024 IN-PERSON, V-ESPRIT, 5240 S SHALOM CIRCLE, AURORA, CO 80015 AND VIA TEAMS

- I. Call to Order: The meeting was called to order by President Fred Freeh at 7:03 pm
- II. Roll Call: Board members present: Fred Freeh, Dave Estes, Norm Arlt, Randy Simpson, Mike Zabinksi, Jennifer Vaughan, Sandra Peoples, Matt Lenhart, Duane Bredel (via Teams)
- III. Homeowners Present: Lorin Pahlau (via Teams), Derrick Laughlin (via Teams)
- IV. Minutes from April 17, 2024 were approved unanimously.
- V. Mike Zabinski announced that he was resigning from the board. He enjoyed his time on the board and feeling good about the current board. Feels like he contributed by doing the Interest Survey and that he doesn't have an interest in just doing social activities. He also has other things he wants to do with his time. He thinks the survey will be helpful guiding the association going forward. Dumpsters have been ordered for Dumpster Days in June.

# VI. Officer Reports

## A. **President:**

Board discussed a letter to be sent to homeowners inviting them to a special meeting to discuss and vote on a potential 20% dues increase for the 2024-2025 fiscal year. Matt went over the budget situation in detail to explain the approximately \$22,000 net loss for the year that was going to need to be taken out of savings. The big ticket items were an unanticipated tree removal and fence repair. Derrick Laughlin had guestions about where the money went and Matt gave him the overview. Randy pointed out to Derrick that the failure of the board to raise the dues last year was against the long-term advice of the attorney who suggested that raising the dues every year to keep up with inflation was a good idea to prevent getting into the drain on savings. Increasing costs of water, sprinkler repair, landscaping are hitting the budget. Without a 20% dues increase, any unanticipated costs could drain savings to dangerously low levels. Fred will be including all this information in a letter to homeowners inviting them to the special meeting in June to discuss the requested 20% dues increase. Some discussion centered on the rules surrounding how the vote would be conducted. Fred was going to get clarification from the attorney related to the interpretation. Derrick suggested we might wait until the annual meeting in September to give more time for discussion and see where the budget actually is.

- Fred was going to attend a quarterly meeting of neighborhood watch at Aurora City Hall on June 25, 6-7:30 pm as a kick-off to reestablishing our neighborhood watch and wanted to invite others.
- Fred had some questions related to the letter from the attorney related to the
  proposed amendment to covenants to allow sheds. Ballots would be mailed
  to each owner. The attorney would draft up the ballots and mail to the
  homeowners. Fred pointed out that our Covenants are out of date as state
  law had changed so much since the last update so paying for an attorney
  familiar with those changes is important.
- The board approved \$925 for the attorney to write the Covenant Amendment change for the allowance of sheds, and after board approval the attorney will mail the proposed change ballot to each homeowner.
- Fred brought up the trash bins left out at 14100 E. Saratoga Pl. Dave said he'd left a note on them. Fred pointed out that city code only restricts bins in front of the house but not on the side. Fred said there was another home leaving trash bins out in front at 14334 E. Layton Pl. Fred was going to report them as well to city code enforcement. Dave said he left a note on those bins as well. Matt said the city will fine repeat offenders \$50 for bins left in front, but not to if the bins are on the side.
- Vice President No Report.
- C. **Treasurer** Matt Lenhart reported a payment to All Phase landscaping. Matt said the Association would end the year down about \$20,000 for the year, due mostly to two major items a tree removal and fence repair.

## D. **Secretary**

- Norm got a quote on a new fence post that got snapped off in the wind storm we had.
