## SWIMMING POOL OPENING NEARBY

Nearby Sterling Commons HOA has extended an invitation to all Andover Glen residents to purchase a membership to their pool/clubhouse. The pool and clubhouse are located at 4934 S Carson St, Aurora. The heated pool is open every day from 5 am to 10 pm. There is an 8 person air-jetted hot tub and a pool deck with chairs and tables. Male and Female bathrooms are on site. Pool capacity is approximately 70 people. Pool area is locked with access by electronic key card. The attached clubhouse can hold up to 35 guests. It includes a full kitchen, granite countertops, electric fireplace, central heating & air conditioning, free wifi and a 60" LED flat screen. ## CHRISTMAS TREE RECYCLING

The City of Aurora offers free Christmas tree recycling from December 30 thru January 12. Nearest drop-off for Andover Glen residents is Olympic Park at Chambers and Yale. The trees are ground up into mulch which is then made available to any Aurora resident at no charge. The mulch location is north of Hampden and Dawson. On your next trip to Andover Glen Park to play tennis, visit the community garden, or enjoy a leisurely stroll, you may very well see parts of your old Christmas tree as most of the mulch that Andover Glen has used in the past few years has been from this source.

#### WILDLIFE SIGHTINGS

With our proximity to Cherry Creek State Park It is not unusual to see a wide assortment of wildlife in our neighborhood. Deer, fox, coyotes, raccoons, muskrat, rabbits, hawks, owls and the occasional eagle have been spotted in the area. The rabbit population in the area seems to have exploded over the past year which has provided a good food source for coyotes, fox, hawks, and owls. Coyote sightings are becoming more frequent, and the coyotes are becoming bolder. The wildlife are not pets and need to be treated with extreme caution. Please do not approach any wildlife and do not feed any wildlife. Feeding wildlife human food can cause serious health problems for the animals plus wildlife can spread diseases, some of which can be transmitted to pets and humans. It is exciting to see the various wildlife in the neighborhood, but use caution and common sense when you see them.

#### SHOVEL YOUR WALKS!!!!

The recent snowstorms have resulted in several phone calls to HOA Board members with complaints of snow not being removed from sidewalks. This is not a HOA covenant, but a City of Aurora Code. If you see a violation, do not call a board member, but call the City of Aurora Code Department (phone number 303-739-7000). Once again we remind everyone that Aurora City Code requires residents to remove snow and ice from their sidewalks within 24 hours of the end of the snowfall. Failure to remove snow and ice can result in a citation and fine. If you are away, or unable to clear your walks, arrange for a friend, neighbor, or contractor to clear them for you. Be courteous and safe.
