Program:

Introduction of Guest Speakers:

Doug Fast – Range and Pasture Specialist, MFA Incorporated. The presentation was about the combined applications of fertilizer and herbicide. The pros and cons of single spraying vs. combining with fertilizer was discussed. Now is the time to spray for thistle and blackberry's. Cattle should be pulled off the pasture for 10 days after spraying. Duracort is the newest spray coming on the market next year. You would use 12 oz compared to 24 oz of Graxon. Spray has a 95% effective rate and fertilizer has a 65% effective rate. Our member Max Brown can explain how the combined applications has worked on his cattle operations.

Carson Hoth and Tyler Sprenkle MJCA Board Members were introduced and presented on their appointments to the Board. They are the first MJCA Board Members from our area. Both gentlemen have shown cattle for serval years. (See attached article).
