



GRADING EVALUATION RULES

Revised winter 2023

The Grading Evaluation Day is an important day in your horse's life.

The information contained within this booklet is to help you through the stages of the Grading Evaluation process — Please take the time to familiarise yourself with its contents.

If you are uncertain after reading this booklet about any aspect of the Grading Evaluation whatsoever, please do not hesitate to contact TGCA for clarification.

PASSPORTS

The TGCA can issue passports to colts, fillies, geldings and mares without pedigree no matter what their age.

TGCA issue passports depending on the category of the horse or pony, giving them DEFRA approved passports as required by legislation:

MOTHER STUDBOOK

For ALL Traditional Gypsy Cobs (TGCs)

The aim of the Mother Studbook is to record individual TGCs, their parentage and their offspring and to use this information to encourage responsible and considered forward breeding practices that protect, promote, and build on the best of this breed. The TGCA will continually monitor and review its operation of the Mother Studbook and may make alterations and enhancements from time to time as required and in line with meeting the above aims. The Mother studbook is open to TGCs worldwide

The Mother Studbook is further divided into the below categories.

➤ **BREED IDENTITY (BIR)**

This entry level is suitable for TGCs with no verified breeding but that meet the breed standard. Horses are entitled to enter TGCA classes and competitions (stallions are required to attend a performance grading in addition.) these animals are NOT passed for breeding.

➤ **SUPPLEMENTARY 1(SSB1) & 2(SSB2)**

Suitable for TGCs with verified breeding for recording OR that are being held as potential breeding animals. Both parents must be registered with the TGCA, sire must be grade Evaluated with the TGCA. Offspring entering this level will be required to have a full DNA profile and a valid covering certificate. Further advice on requirements and expectations is available on the official TGCA webpage and the health and welfare policy document.

MASTER STUDBOOK (MSB)

Suitable for TGCS that have been registered in SSB1 /SSB2 and completed the 5 star gold status.

PART BRED REGISTER

For Part Bred TGCs

A Part Bred Register (PBR) will be maintained for Part Bred TGCs applying for a passport or to be over stamped with the TGCA. First and subsequent generations of TGCs on the Mother Studbook may enter the Part Bred Register.

Any non TGC element of a pedigree which has been verified by a current DEFRA registered breed society may be included in the TGCA passport or pedigree certificate. These horses must reside in the UK.

Registration (over stamps) of horses outside the UK will be offered a registration certificate.

AREA GRADINGS

If you are able to locate a suitable venue within easy reach of your location within the UK and are able to assure us of a minimum of 4 horses/ponies forward for Performance grading, or a minimum of 2 for Breed gradings TGCA will send 2 assessors to evaluate these animals. The cost for this is available upon request from TGCA Admin.

For Graded Breed Evaluations 2 Stage TGCA vetting The Vetting form must be provided to the TGCA 1 Week prior to the date of Grading and bring the original vetting pass to the Grading from this procedure. Mares must also be DNA tested at such time and the results supplied at the Grading. Vetting must have taken place no more than 1 calendar months prior to the Grading date.

If DNA is not currently on file, then a sample can be taken at time of Grading and processed at the cost the Owner/Exhibitor.

Anyone who wishes to arrange such grading should contact the TGCA Head Office to discuss the procedure and book the assessors.

COVERING CERTIFICATES

It is a condition that stallions which pass their TGCA Grading undertake to issue TGCA Covering Certificates (for dual registered stallions contact TGCA Administration) and are owned by current up-to-date TGCA Members.

Failure to abide by these Rules will result in their Graded status (and subsequently, any further Covering Certificates) being revoked.

Covering Certificates are available to stallion owners/managers from TGCA Head Office and should be used for all mares covered by TGCA Graded and Licensed/Approved stallions. Further details can be found in the Members' Handbook or by contacting TGCA Administration.

GENERAL GRADING EVALUATION RULES

A. Guidelines & Rules for Owners

- 1.** The exhibits forward for grade Evaluations will be expected to be well-behaved —Any behavior which could put the handler, assessors, or officials (or any other person) at risk will cause the animal to be disqualified as such will be classed a fail, ill-mannered animals will be asked to leave the premises immediately.
No refund of entry fees will be given.
- 2.** It is the owner's/exhibitor's responsibility to ensure the animal is entered for Grading Evaluations under the correct category as this is how the Grading Panel will assess the animal.
Animals eligible for Grading Evaluations as Part Breds will cover the full spectrum of "types" as associated with TGC Part Breds — each animal will be assessed on its own individual merits according to its "type/category". (if it has been entered as a Native it will be assessed as a Native and not, for example, a Show Cob, likewise if it has been entered as a Show Cob it will be assessed as a Show Cob and not Drum etc
- 3.** All animals entered for Grading Evaluations must be TGCA Registered or eligible for registration.
- 4.** All exhibits must be owned by TGCA fully paid-up current members at the time of Grading Evaluation application.
- 5.** No entry will be accepted without the correct fee in full.
- 6.** To retain Graded status with this Society, and also continuity of supply of TGCA Covering Certificates, it is stipulated that the stallion owner's membership with this Society MUST be maintained on an annual basis due 01st January each year.

- 7.** Ideally a minimum of TWO people are present with each exhibit when presented before the Assessors. Both the animal and exhibitors should have prepared for the day ahead and ideally have practiced at home for all sections.
- 8.** Age is taken as of 1st January in the current year. No upper age limit exists for mares or stallions.
- 9.** All stallions, 4 years old or over, will be required to complete Performance Grading Evaluation prior to competing in TGCA Events or TGCA Affiliated Classes at shows.
- 10.** All stallions 4 years old or over, must be evaluated if he has not completed a Ridden Assessment, he will only be permitted to compete in In-Hand Classes until a ridden assessment is passed.
- 11.** All animals forward must be sound.
- 12.** All colts, stallions and mares going through the Graded Breed Evaluation Scheme MUST have a DNA profile, and PSSM tests results, which are to be submitted to the TGCA. (Please see the requirements for special colour testing)
- 13.** Grading is optional as a 3-year-old at the discretion of the owner if he/she feels their colt/filly is sufficiently mature. Please be aware that no exhibit may be presented for Grading more than twice. If an exhibit fails on the second attempt it will not be permitted to re-present.
- 14.** Animals returning for re-assessment may request consideration of their offspring to be considered and used in this re-assessment to back-up their suitability as a breeding animal.
- 15.** Graded horses are permitted to advertise themselves as "TGCA Breed Graded" or "TGCA Performance Graded", it must be made clear which section/s they are Graded in on any advertisements. Horses with misrepresented section or omitting any information of Grading may have their Graded status revoked.
- 16.** The results of the Grading Evaluations may be published on the TGCA website and the TGCA Facebook page/group.
- 17.** No "prohibited substances" (Please refer to the current TGCA Members' Handbook for additional information on prohibited substances). Owners/exhibitors of animals found with any such prohibited substance such animals will be excluded from that Grading.
- 18.** Random Dope Testing (as defined in the current TGCA Members' Handbook) may be taken at Association discretion. Positive testing costs will be borne by the owner of the said animal.
- 19.** Amendments may be made to this Grading Evaluation Rules Handbook,
- 20.** Entry to TGCA Grading Evaluations will be deemed acceptance of all TGCA rules
- 21.** If you are in any doubts as to what to do, where to go or what is expected of you or horse - please contact the TGCA for further information and advice

There are 5 Star levels of Grading which will allow the Stallion/Mare progression in each section: TGCA gold books will only be awarded to Breed Evaluated Mares and Stallion.

SUPREME PERFORMANCE STAR STATUS

All stallions must pass Performance Grading Evaluation Visual Assessment as a minimum to compete in TGCA Events or TGCA Affiliated Classes at shows. Horses successfully passing performance grading evaluations including Youngstock will be issued with a document available on request if they wish to progress within the star system.

Presentation

1. All animals must be presented in good health.
2. All animals must be presented in "show" condition — i.e. According to their type/category (Traditional or Part bred -plaited, hogged, trimmed etc.).
3. All animals should be recently shod or trimmed ideally.
4. All animals will be expected to walk and trot-up in a controlled manner.
5. It is advised to practice at home all aspects of what will be required for the grading procedure — including in-hand work, loose schooling, ridden work etc.
6. Ensure you have the correct attire and tack as per members handbook.

B. The Exhibit

1. Please take the time to present your exhibit in a clean, fit condition, and turned out in accordance with its type/category
2. Please ensure you have with you all correct equipment you will need on the day.
3. Any animal which is deemed unsound will not be able to continue the Grading Evaluations

The Handler

4. All handlers of all animals are to wear suitable protective headgear to standard.
5. A maximum of two handlers per exhibit is required.
6. Handlers must present themselves dressed correctly
7. The instruction of the Assessors, Officials or Stewards MUST be obeyed at all times.
8. Anyone attending the grading with an exhibit are reminded that is an official TGCA event so is run under TGCA rules.
9. Owners /exhibitors wishing to challenge or dispute the Assessors' decision please contact head office

C. On the day

- 1.** Grading times will have been allocated prior to the event —contact TGCA Head office if you have not received yours
- 2.** Please allow yourself plenty of time for arrival – declare you and your horse to the Event secretary to collect your number.
- 3.** Missed time slots cannot be guaranteed to be substituted for a later time.
- 4.** Every animal presented for grading must be accompanied by its passport.
- 5.** Please take the time to locate to the area designated for assessment by the Grading Panel.
- 6.** Results will be verbally given on the day after the last entry unless previously agreed, passports need to be sent into the TGCA office for results to be registered.
- 7.** it is your responsibility to ensure you are ready and waiting, you may be called early so please keep updated with the day's proceedings.
- 8.** The Grading is divided into 2 or 3, depending on your whether you are doing the ridden assessment or not, as follows:

Stage 1 — Conformation and Movement Assessment In-hand

Stage 2 —Loose Assessment

Stage 3 — Ridden Assessment, for stallion 4 years old or over.

Please note Temperament will be assessed throughout all stages, any animal showing unreasonable behavior may be asked to retire and the grading will be discontinued.

STAGE 1

CONFORMATION, MOVEMENT

On entry into the ring, you will be expected to stand your horse up in front of the Grading Evaluation panel, where they will inspect your exhibit for conformation and breed type and mark accordingly. They may request that you move the mane, tail, feather or open the horse's mouth.

When the grading Evaluation panel have completed their inspection, they will ask you to move off, walk away from the panel in a straight line to the end of the arena, turn and return back to the panel, go past the panel and ask the exhibit to trot toward the other end of the arena then track right around the arena at trot, continue along long side of the arena until the panel indicate you to stop. If they require a further inspection or movement they will advise.

STAGE 2

LOOSE ASSESSMENT

Each horse/pony will then be required to free school in the arena. This natural balance of paces can then be assessed.

The panel will indicate when they have seen all they need.

2 handlers will be needed for this section., please ensure you have practiced at home to the exhibit can be easily caught when needed

STAGE 3

TGCA RIDDEN ASSESSMENT

This is compulsory for stallions wishing to compete under saddle with TGCA affiliated classes

It is expected that the stallion will display good manners and obedience while working within a group of other ridden exhibits.

The ridden section is run like a showing class with the same ridden format, guideline for the format can be found in the members handbook.

The panel do have score sheets to mark which will be held by the TGCA for future use.

Conformation, movement, way of going, quality of breed type, manners both individual and while working or standing in line up are some of the points the panel look for.

Any exhibit that is displaying anything deemed dangerous or at risk to its self and any officials or attendants will be asked to leave, as such will be marked as a failed exhibit.

When all exhibits have performed an individual display, the group will be asked to wait in the arena while the Youngstock and In Hand exhibits are asked to join them to presented the Champion and Reserves for each section.

TRADITIONAL GYPSY COB BREED STANDARD

A strong, active cob, full of quality and spirit coupled with an abundance of flowing mane, tail and leg hair.

GENERAL APPEARANCE The Traditional Gypsy Cob should be a strong, sturdy and powerful cob coupled with an abundance of luxuriant flowing mane, forelock, tail, and leg hair known as feather.

Traditional Gypsy Cobs should always have plenty of heart room, and a deep girth to match. They should display ample bone and be well muscled within a broad compact body and powerful hindquarters.

They should have a kind, willing, intelligent and gentle disposition. They are renowned for their patient, kind and sensible nature. Traditional Gypsy Cobs are extremely versatile, suited to both driving and riding they are ideal family horses.

COLOUR AND MARKINGS

All Colours and Markings are permitted

HEAD

Neat, small, sweet, noble and in proportion to the body. Broad between the eyes which should be bright and alert, displaying a large kind eye. Blue eyes are acceptable.

EARS

Small, neat ears slightly incurving.

NECK

Strong and slightly arched and of a medium length. The neck is to be well muscled and well set onto a good sloping shoulder. Stallions should display a bold outlook with a well-arched crest.

SHOULDERS

Well laid, long, sloping shoulders. Should not be fine at the withers.

BODY

Short coupled and a strong back of good outline, muscular loins, good deep well sprung ribs, which are round from the shoulders to the flank. Plenty of depth from the wither to the girth. Chest must be good and wide.

HINDQUARTERS

Deep, lengthy and powerful and displaying an apple shape. Second thighs well-muscled and let down. Tail should be well set on – not too high, nor too low.

FEET, LEGS AND JOINTS

Feet of good size, round and well formed, open at heels and well concaved. Pasterns to be nicely sloping and of a good length. Forelegs should be very well defined and muscular. Well defined flat broad knees. Plenty of bone below the knee (eight inches at least). Hocks should be well defined and not coarse. Canons should be short with clearly defined clean flat bone.

**MANE, TAIL &
LEG HAIR (FEATHER)**

A NATURAL abundance of long flowing mane, forelock and tail hair Feather (leg hair) should start from the back of the knee and hock joints and cover the entire hoof. Hair should be straight and silky, curly hair is less desirable and course hair is not desirable.

MOVEMENT

Clean, active, straight and true. Going forward on –all fours with tremendous energy. The knee and hock should be powerful with a workmanlike `action with hind legs flexed well under the body for powerful drive.

TGCA PART BRED

Pictures to be sent in – TGCA will advise you on the section.

NATIVE

50% Traditional Gypsy Cob, the remaining 50% to be made up of any individual Native Pony Breed as registered with their own society breed requirements.

SPORT PONY – not exceeding 148cms

50% Traditional Gypsy Cob, the remaining 50% to be made up of any individual breed that is recognised as sports bred.

SPORT – 148cms – upwards

50% Traditional Gypsy Cob, the remaining 50% to be made up of any individual horse breed that is recognised as sports or performance bred.

SHOW COB -50% Traditional Gypsy Cob the remaining made up of any type that could be termed as a show cob type and be hogged and stripped out – no height limits

DRUM – The Drum Horse must be a combination of Shire, Clydesdale and 50% Traditional Gypsy Cobs. Shires and Clydesdales crossed with gypsy cobs will breed true to type, and the outcome will be consistently predictable. Can be shown traditionally with full manes, tails and feather OR pulled tails and hogged manes.
