Simmons Named Clinton Police Officer of Year




At the January Clinton City Council meeting, Corporal Christian Simmons was recognized for being named the 2021 Clinton Police Officer of the Year.



All persons who own or control business, farm/agri-business and/or any personal property subject to taxation in Sampson County, OR made improvements to real property, must list all such property and/or improvements to real property for year 2022 from Monday, January 3, 2022 through Monday, January 31, 2022.

If you filed a listing form in 2021 with the county, you will automatically be mailed a new form at the owner's address on record as of January 1, 2022. Please review the information, make necessary additions/corrections, sign & return listing forms postmarked by USPS no later than January 31, 2022 to avoid 10% late listing penalty to: Tax Administration, PO Box 1082, Clinton, NC 28329 (Or bring to 126 W. Elizabeth St.) Unsigned forms will be considered late if received after January 31, 2022

REAL **ESTATE**

Sampson County has a permanent listing system for real estate; property owners are responsible to annually list any improvements to real property only.

Failure to list those improvements to real property is subject to the penalties imposed by NCGS 105-308 and NCGS 105-312.

Taxpayers owning only real property will not receive a listing form. If you need to list improvements to real property, please SEE BELOW FORMS AND INSTRUCTIONS.

NEW RESIDENTS

New residents and those listing for the first time should contact the Listing Department at the Sampson County Courthouse Annex at 126 W. Elizabeth St. or call (910) 592-8146. New residents are responsible for obtaining and submitting the necessary listing forms to the Tax Administrator by January 31, 2022 to avoid the late listing penalty of 10% to: 126 W. Elizabeth St., Clinton, NC 28328 or P.O. Box 1082, Clinton, NC 28329.

BUSINESS, FARM/ **AGRI-BUSINESS & OTHER PERSONAL PROPERTY**

BUSINESSES and/or persons owning or possessing personal property used or connected with a business income-producing purpose, must list such property with the tax administrator every year, including but not limited to: copiers, computer equipment, supplies, leasehold improvements, furniture, fixtures, machinery, spare parts, etc. IRP (International Registration Plan) plated vehicles must be listed annually during the regular listing period. ALL FARM/AGRI-**BUSINESSES** must list annually all income-producing personal property, including but not limited to: tractors, combines, combine headers and platforms; motors; bailers; harvesters; tobacco equipment; plows; planters; sprayers, irrigation equipment; supplies; compressors; etc. ALL PERSONAL PROPERTY must be listed, including but not limited to: all unlicensed & permanently tagged vehicles; untagged trailers; aircraft; motorcycles; campers; RVs & truck bodies; mobile homes; all boats & all boat motors; jet skis; all household rental personal property; etc. LICENSED vehicles will be billed automatically by the NCDMV. PROPERTY TAX RELIEF PROGRAMS

Elderly or Totally and Permanently Disabled Exclusion

North Carolina excludes from property taxes the greater of twenty-five thousand (\$25,000) or fifty percent (50%) of the appraised value of a permanent residence owned and occupied by a qualifying owner. A qualifying owner is an owner who meets all of the following requirements as of January 1 preceding the taxable year for which the benefit is claimed: 1) Is at least 65 years of age or totally and permanently disabled

2) Has an income for the preceding calendar year of not more than Thirty one thousand nine hundred (\$31900).

3) Is a North Carolina resident.

Income is defined as all moneys received from every source other than gifts or inheritances received from a spouse, lineal ancestor, or lineal descendant. For married applicants residing with their spouses, the income of both spouses must be included, whether or not the property is in both names

Disabled Veteran Exclusion:

This program excludes the first forty-five thousand dollars (\$45,000) of the appraised value of a permanent residence owned and occupied by a North Carolina Resident, who is an Honorably Discharged Disabled Veteran, or the unmarried surviving spouse of an Honorably Discharged Disabled Veteran. A disabled veterar is defined as a veteran whose# character of service at separation was honorable or under honorable conditions and who has a total and permanent service-connected disability or who received benefits for specially adapted housing under 38 U.S.C. 2101. Contact the Sampson County Tax Office for specific details and applications

Circuit Breaker Property

Tax Deferment: This program allows taxes billed each year to be limited to a percentage of the qualifying owner's income. However, taxes in excess of the limitation are deferred and remain a lien on the property. The three most current years of deferred taxes prior to a disqualifying event will become due and payable, with interest, on the date of the disqualifying event. Age 65 or older, with an income not exceeding \$47,850. You must file a new application for this program each year. Contact the Sampson County Tax Office for specific details and application. Application time period for property tax relief programs is January 3, 2022 to June 1, 2022

ALL BUSINESSES requesting an "Extension to file" until April 15, 2022 must be on company letterhead, & must be received or postmarked by U.S.P.S by Ianuary 31, 2022 per G.S. 105-311(b), 360(d). The N.C. Statutes do not recognize private postage meter dates; mail early to avoid the 10% late list penalty on listings received/postmarked after January 31, 2022

Guilty Plea Made for WMD Charge

*Press Release from the District Attorney's Office



On Tuesday, January 4, 2022, in Sampson County Superior Court, Jimmy Allen Tyndall, 36, of 385 JV Farm Lane, Dunn, North Carolina, pled guilty to three counts of possession of a weapon of mass destruction related to incidents on July 25, 2019, and an unrelated offense of obtaining property by false pretense from an incident involving a \$66.00 fraudulent return at the Clinton Walmart on January 5, 2019. The State was represented by Assistant District Attorney Robert N. Thigpen.

Tyndall admitted that the weapons offenses resulted in serious injury to a law enforcement officer while engaged in their official duties, though he maintained that he did not intend to hurt anyone, and Resident Superior Court Judge Henry L. Stevens, IV, sentenced him to an active prison sentence of a minimum of 17 months and a maximum of 30 months in the North Carolina Department of Adult Correction for one count. He was sentenced to two additional consecutive sentences of a minimum of 20 months and a maximum of 33 months in the Department of Adult Correction, but those sentences were suspended, and he was placed on supervised probation for 24 months to begin when he is released from the Department of Correction. The sentence for the Walmart incident was consolidated with the latter two sentences. Several drug offenses and one count of possession of a weapon of mass destruction were dismissed in exchange for the guilty pleas.

The State's evidence showed that at approximately 1:52 PM on July 25, 2019, Deputy Patrick Snell of the Sampson County Sheriff's Office was travelling south on US 13 toward Midway Elementary School when he observed a silver Dodge Durango travelling north at a high rate of speed. He clocked the vehicle at 66 MPH in a 55 MPH zone, turned around, and initiated a traffic stop. The SUV yielded and the when the officer approached it, he encountered the defendant, who was the driver and only occupant. The officer asked for the defendant's license and registration and the defendant told the officer he did not have his license on him. The defendant handed an ID card to the officer and the officer noticed his hands were shaking nervously. The officer returned to his patrol vehicle to do a record check on the defendant and requested Deputy Heath Williams bring his K9 partner for a K9 scan of the SUV as the defendant was known to law enforcement to use drugs.

While doing the records check, Deputy Snell located a warrant for arrest from Harnett County for the defendant. Deputy Josh Akers had arrived by this time and he and Deputy Snell had the defendant step from the vehicle. Deputy Snell asked the defendant if he had anything on his person that he needed to know about, and the defendant reached into a pocket a removed a syringe containing a clear liquid. Deputy Williams and his K9 arrived and scanned the vehicle; the K9 alerted on it for the odor of narcotics.

During a search of the vehicle, officers located drug paraphernalia and Snell observed a green cord sticking out between the driver seat and the center console. He pulled the cord and found it attached to a metal cylinder, which appeared consistent with a homemade explosive device. Deputy Akers also located a cylinder with an unknown material, which also looked like a homemade explosive device.

The officers closed the road several points to prevent traffic coming through. Snell advised the defendant of his Miranda rights and asked him about the devices in the vehicle. The defendant said he ordered the substances online and that the smaller device was a mixture of potassium perchlorate and aluminum; the larger device was an unknown substance, but when lit, would burn similar to a sparkler.

The North Carolina State Bureau of Investigation Bomb Squad was notified and Assistant Special Agent In Charge (ASAC) Tim Luper and Special Agent Brian Joy responded to the scene of the traffic stop and rendered the two devices safe. Deputy Akers left the traffic stop to go the defendant's residence, which was located on his father's property. When Akers arrived, he advised Snell and Williams that he'd located a burn pile beside the defendant's residence that contained what appeared to be an explosive device that had been detonated.

The officers obtained a search warrant on the defendant's residence and executed it at approximately 6:28 PM. Inside the residence officers located several buckets of unknown powders and other materials that appeared to be fuels, oxidizers, smokeless powders, fuses, and suspected explosives. They also located what appeared to be two explosive devices. One was a red cylinder with a long green fuse, covered with aluminum foil on it's top. The other was larger and was located under a sink. It was a plastic jug wrapped in plastic and black tape with a green fuse sticking out.

The agents divided the powders into fuels and oxidizers and moved them to an area away from the residence to be disposed of safely by remote burn. After the two devices located in the residence were removed and rendered safe the officers began to sample the powders that were removed from the residence for analysis and were going to dispose of the remnants on scene. Just before 1 AM, a large explosion took place where Agents Luper and Joy were working to dispose of the powders. Sheriff's deputies, other officers, and EMS personnel, ran to the scene of the explosion and observed Agent Joy on his knees severely burned about his face, head, and arms. ASAC Luper was also burned on his arms and shoulder and was attempting to assist Agent Joy. Agent Joy was transported to a helicopter to be transported to the NC Jaycee Burn Center in Chapel Hill for his injuries.

The Alcohol, Tobacco, Firearms and Explosives (ATFE) laboratory in Atlanta determined that several of the unknown powders and materials were a perchlorate and nitrate explosive mixture containing perchlorate, barium nitrate, magnesium, aluminum, and red phosphorus, homemade black powder, antimony trisulfide, sulfur, and various other chemicals. Judge Stevens specifically ordered, as a condition of probation, that the defendant not possess any of these chemicals in the future. He is also to undergo substance abuse treatment while on probation.

This plea was made in consultation with ASAC Luper and Special Agent Joy and both men were satisfied with the plea arrangement. Both agents have recovered from their injuries and are still employed with the State Bureau of Investigation Bomb Squad. ASAC Luper was present in court for the plea.

District Attorney Ernie Lee says that "I have personally worked with SA Joy in the trial of a first-degree murder that occurred in Onslow County and he is an outstanding and dedicated special agent with the SBI. I am thankful that both ASAC Luper and SA Joy have recovered from their injuries and are able to continue to serve the citizens of North Carolina. I am also thankful for the quick thinking of the deputies involved in the traffic stop. Sheriff Jimmy Thornton diligently enforces the laws of this state and he and his deputies serve the citizens of Sampson County very well as demonstrated in this case. Their vigilance may have prevented even more unnecessary injury that day. This case is an example of why traffic stops are a vital part of law enforcement. I appreciate these law enforcement officer that daily risk their own safety to protect the public."

Arrest Made in Death Investigation



On January 4, 2022, at around 7:30 a.m., deputies responded to 815 Isaac Weeks Road in reference to a disturbance which was called in by a third party. Upon arrival, no one would come to the door or respond to the deputies' commands. Entry was made into the residence and upon entering a female was located inside the residence who had succumbed to unknown injuries.

A male occupant who was also inside the residence was taken into custody for questioning. The Sheriff's Office

found sufficient probable cause to charge Stevie Williams, 46, B/M with Murder in connection with Death Investigation that occurred on January 4, 2022 at 815 Isaac Weeks Rd., Clinton, NC. Williams is being held without bond in the Sampson County Detention Center.

The victim in the death investigation has been identified as Lamarra Bouie, 30, B/F of 815 Isaac Weeks Rd., Clinton, NC. This is still a very active investigation and more charges are expected. However, no additional individuals are believed to be involved.

"It is a senseless and tragic situation and we ask that the community continue to pray for the families affected," Lt. Marcus Smith, Sampson County Sheriff's Office.

Psalm 73:26, "My flesh and my heart may fail, but God is the strength of my heart, my portion forever."

Many would rank Abraham Lincoln as one of America's greatest presidents. His firm belief that the government should be a positive force to serve the citizens guided him through his life and was at the heart of his desire to become president of the United States. However, this goal would not be simply or swiftly achieved.

A student of history will know that Lincoln's life was filled with setbacks and failures. In his first attempt at running for political office as a state representative ended in defeat. Two years later he would run again and claim victory. Over the next decade, however Lincoln suffered numerous business and political setbacks. During that time Lincoln's sweetheart died, he suffered a nervous breakdown, and he was defeated for Speaker of the Illinois House of Representatives. He failed to secure the nomination for U.S. Congress in 1843 and three years later was elected to that seat only to be defeated for re-election two years later. His U.S. Senate bid in 1854 resulted in defeat. Two years later he failed to attain the nomination for vice president, and again was defeated for U.S. Senate in 1858.

No one would have been shocked if Lincoln had just decided to practice law in his hometown. However, because he was determined to achieve his political goals and dreams, Lincoln never gave up. Though he was knocked down repeatedly, Lincoln

continued to get back up and continue on.

Consider the promise found in **Psalms 37:24**, "Though he falls, he shall not be cast headlong, for the Lord upholds his hand." This verse is the Christians promise from a loving God. God's promise is that He watches over every step we take. When we stumble, when we fail and suffer setbacks, God is there to help us keep going. He promises to support us and lead us on. International Bible teacher and four-time ECPA Christian Book Award winning author, Kay Arthur stated, "God is in control and therefore in everything I can give thanks." Pulled Beef:

- 2 pieces (about 3 pounds each) beef chuck roast
- tablespoons taco seasoning or barbecue rub
- cup beef bone broth 16 ounces Fresh Cravings
- **Chunky Mild Salsa**

Salsa and Queso Slaw: 16 ounces Fresh Cravings

- Chunky Mild Salsa 16 ounces broccoli slaw blend
