#### Legislative Recap- H.B. 50

House Bill 50 would add a certain described property to the corporate limits of the Town of Calypso. Annexation is a method by which municipali-

ties alter their boundaries. The municipality must follow the statutorily prescribed steps to add an area into its boundaries. The municipality must provide, or contract to provide, basic services to the area. These services include police protection, fire protection, solid waste collection, and the extension of water and sewer lines to the area.

North Carolina law outlines four basic ways in which a municipality may annex an area.

Legislative Act- Where the General Assembly has authority under Section 1 of Article VII of the State Constitution to fix the boundaries of counties, cities, and towns.

Voluntary Annexation. - Where the owners of all real property in an area contiguous to the municipality desiring to be annexed sign a petition requesting annexation (Part 1 of Article 4A of Chapter 160A).

Voluntary Satellite Annexation. – The owners of all real property in the area desiring to be annexed sign a petition requesting annexation, if the area otherwise meets certain statutory requirements (Part 4 of Article 4A of Chapter 160A).

Municipality-Initiated Annexation Subject to a Referendum. – The municipality initiates an annexation proceeding that must be approved by a majority of the registered voters of the area proposed for annexation (Part 7 of Article 4A of Chapter 160A).

House Bill 50 would annex 35.43 acres into the corporate limits of the Town of Calypso as a non-contiguous annexation by a legislative act. Currently, this bill has passed the House and two Senate committees. It is scheduled to be heard in Senate Rules and then will be sent to the Senate floor for a vote.

#### From the District- Sampson County Sampson Community College Trustees Reappointed

The SCC Board of Trustees reappointed three board members.

Barbara Faison, Larinda Haight, and Dr. Ted Thomas were all reappointed to serve an additional four years on the board. Thomas and Haight will continue in their roles as Chair and Vice-Chair, respectively.

The newly elected Student Government Association (SGA) President, Naomy Guadalupe Guerrero Flores, took the oath of office as well. SGA Presidents are selected by students and serve as student representatives to the board. Flores will serve as the SGA President for the 2021-2022 academic year.

#### Did You Know? - NC History and Fun Fact

The First Funny Bike, and First Wheelie Bar in Motorcycle Drag Racing – Drag Bike News



Did you know that the "Father of the Funnybike" is from Johnston County?

Ray Price (June 25, 1937 – December 16, 2015) was an American motorcycle drag racer and is credited as the "Father of the Funnybike". He was also a renowned designer, engineer and the first drag racer to be sponsored by Harley-Davidson. He also developed the first wheelie

bar and the two-speed automatic racing transmission for drag racing motorcycles. This was the first transmission that enabled the first motorcycle to ever achieve 200 miles per hour (320 km/h) and has now become standard in the sport. Price also created the Pro Fuel drag racing class. Price is an inducted member of five halls of fame including the American Motorcycle Association Hall of Fame, Sturgis Motorcycle Hall of Fame, the North Carolina Sports Hall of Fame, and the North Carolina Drag Racing Hall of Fame.

Price was born on a tobacco farm in Johnston County, North Carolina. He served four years as a radar specialist in aircraft armament control in the United States Air Force. At age 30 he purchased his first motorcycle and began his drag racing career three years later. Price continued his drag racing career through 2003 All Harley Drag Racing Association season. Through the years Price and his race team amassed numerous wins, records, and championships in AMA ProStar/AMA Dragbike, All Harley Drag Racing Association, and the International Hot Rod Association.

Price opened Precision Cycle in Raleigh, North Carolina in 1973, and in 1981 he acquired the Harley-Davidson franchise and his store became Ray Price Harley-Davidson. Price's dealership is one of the largest in the southeastern United States and is home to the Legends of Harley Drag Racing Museum on the 2nd floor of the dealership overlooking the showroom, the only museum of its kind. He died on December 16, 2015, at age 78.

Investigators were looking to speak to her husband, Carl Earl Andre Wiggins regarding Kiara Renee Wiggins whereabouts. During the course of the investigation, it was discovered that a 2003 Ford Excursion, black in color, N.C. registration KM2969 had been stolen in Bladen County by her husband, Carl Earl Andre Wiggins on June 17, 2021. Investigators have warrants on file for Carl Earl Andre Wiggins for felony larceny and possession of a stolen vehicle.

#### <u>UPDATE – JUNE 23, 2021 @ 3:00 PM:</u>

On June 23, 2021, law enforcement officers in Four Oaks discovered a Black Ford Excursion believed to be operated by Carl Wiggins. The officers attempted to stop the vehicle, which failed to yield. A pursuit started, which traveled south on US 701 into Newton Grove, then onto NC 55 to NC 50 back into Johnston County. The suspect vehicle entered I-40 westbound at the Meadow interchange and traveled toward Wake County. Several attempts to deploy stop sticks were made before a successful tire spike was obtained. The suspect vehicle crashed into a construction barrier on I-40 westbound between exit 301 and 302. The suspect jumped from the vehicle and fled into the woods. After a short foot pursuit, the suspect identified as Carl Wiggins, was taken into custody.

Mr. Wiggins was turned over to Sampson County Sheriff's deputies and the vehicle was towed back to Sampson County for processing. The investigation into the disappearance of Ms. Kiara Wiggins is on-going.

Law enforcement officers from Four Oaks Police Department, the Johnston County Sheriff's Office, the Wake County Sheriff's Office and the NC State Highway Patrol were instrumental in the safe capture of Mr. Wiggins. The NC State Highway Patrol did an outstanding job monitoring and coordinating resources to mitigate hazards to the public. A pursuit on an interstate in a metropolitan area is not what anyone wants to happen, however due to the potential of an endangered missing person being held against their will, there was an obligation to intervene.

Charges against Mr. Wiggins from the pursuit are pending the processing of warrants by different agencies. Mr. Wiggins is currently being detained for questioning by Sampson County Sheriff's Office investigators.

A reward of \$5000 is now being offered by the Sampson County Sheriff's Office to anyone who provides information that leads to locating Kiara Renee Wiggins.

will return bringing live concerts to Sampson County beginning in August. The Alive After Five Concert Series was suspended in March 2020 due to restrictions placed on mass gatherings issued by the State of North Carolina in response to the COVID 19 Pandemic. "The entire AA5 committee is extremely excited to resume presenting the AA5 Series that provides our community with exceptional concerts that are fun, family-oriented events" stated Ray Jordan, Chairman of the AA5 Committee. 2021 marks the 10th Anniversary of the Series. In celebration of this milestone, the AA5 Committee announced a line-up of five FREE-to-the-PUBLIC concerts that are sure to draw concertgoers from Sampson County and beyond.

The schedule of performances will include a "who's-who" of bands that will perform a variety of musical genres including Beach, R&B, Country, Dance and Top 40. Bands for the upcoming season include SPARE CHANGE (Aug. 19th); THE ENTERTAINERS (Sept. 16th); CAT5 Band (Sept. 30th); BAND OF OZ (Oct. 7th); and JIM QUICK AND COASTLINE (Oct. 21st).

Kicking off the season on Thursday, August 19th, is Spare Change, one of the Carolinas' most well-known and respected party bands. With a diverse playlist Spare Change becomes an instant crowd sensation everywhere they perform. From rock, country, beach, funk, rap, current Top 40 hits, and classic rock, Spare Change is sure to play a favorite song of every person in attendance. Comprised of five singers (including a female), a rapper, a trumpet player, and even an electric violinist, their range and versatility is unmatched. Spare Change is famous for their ability to switch gears, sounding like a Nashville country band one minute, a funky groove band the next, and an 80s hairband after that, all with equal comfort and authenticity. Choreographed dances, audience participation, and non-stop motion on stage help drive an energy level that will leave the crowd happily exhausted by the end of the night.

On Thursday, September 16th, The Entertainers will make their debut performance in the AA5 Concert Series. In 1980, THE ENTERTAINERS scored their first regional smash hit with LIVING FOR THE SUMMER, a song that propelled the group to the forefront of beach music, which led to The Entertainers playing the finest clubs along the Grand Strand of Myrtle Beach, and in clubs and music festivals from Virginia to Florida. During the Third Annual Beach Music Awards in 1988, THE ENTERTAIN-ERS were nominated for both the Group of the Year and Single of the Year. The group's second album, DON'T LET YOUR LOVE GROW COLD, won Album of the Year honors. In 1991, after sixteen years with the Catalinas and eleven years with the Embers, Johnny Barker, (Keyboard and Vocals) became a partner with Earl Dawkins as co-owner of the group. Barker, a noted musician, and writer in the beach music industry, lists credits such as: Love Me, Always In Love, Facts of Love, and the fourth most popular beach music song of all time, Summertime's Calling Me, a song that spawned a new generation of beach music dance styles and tempo changes. Earl Dawkins, the founder of The Entertainers, as well as lead singer/front man, co-wrote the group's first regional hit, "Livin for The Summer." Dawkins also appeared as a Male Vocalist contestant in 1985 on "Star Search." Other band members include Beaver Robinette, (Sax and Vocals) who is a graduate of Appalachian State University with a degree in music. Beaver also plays trumpet and flute and teaches in the North Carolina school system. His energy and soulful sax solos are always present. Eddie Brooks (Drums, Vocals) has been singing and playing drums for well over twenty years. With strong vocals, an easy to dance to beat, and spectacular solo ability Brooks is easily set apart from the rest. Rounding out this powerhouse group is Benjie Weaver (Guitar & Vocals) whose guitar playing, unique vocal talents, and friendly stage presence make him one of the most popular musicians around.

Making their first appearance in the AA5 Series on Thursday, September 30th is the CAT 5 Band. CAT5 consists of five individuals who bring a world of talent to the stage every time they perform. Band Members include Jerry West, who was a longtime member of the Band of Oz and who also performed with the 1980's rock-band Sugar Creek. With multiple Cammy Awards including "Vocalist of the Year" and "Instrumentalist of the Year" under his belt, West is best known for his amazing vocals on hit songs including "Somewhere Over The Rainbow" and "Build Me Up." Other band members include CBMA Instrumentalist Of The Year Award winner, Camron Dudley, (Vocals, Drums, Percussion) formally of the Jim Quick and Coastline band; Glen Tippett, (Vocalist, Multi-Instrumentalist) who has earned Multiple Cammy Awards including two Instrumentalist of the Year Awards in 2008 and 2015; Hugh Blanton, (Vocals & Bass Guitar) also a Multi Cammy Award Winning artist, and recipient of 2017 Song of the

Year, while performing with the Breeze Band; and rounding out this stellar line-up of artists is Tim Sidden (Vocals, Keyboards, Harmonica) who performed with the Band Hip Pocket for over four years, who in 2018, released the song "Carolina Queen" which went Number "1" in the Beach Music World and Spawned the creation of its own merchandise including shirts, mugs and other Items

Taking the stage on Thursday, October 7th, is the "always-popular-back-by-demand" Band of Oz who will take the stage for their 10th appearance in the series' history. The Band of Oz has made an exceptional name for itself throughout the Southeast performing at many top clubs, as well as countless corporate and private events and has received top reviews all along the way. The group has been a guest on nearly every major beach music festival in the Carolinas, Virginia, and Georgia and have been the winners of numerous Cammy Awards from the Carolina Beach Music Association. The Band of Oz remains one of the most successful and hottest bands in the Southeast. The band is comprised of a dynamic eight-member group featuring a full horn section. Wherever they travel, they always energize audiences and keep the dance floor packed. In addition to performing many of their # 1 hit songs, they offer the very best in beach, R&B, and Motown, as well as a mix of today's most popular dance and top 40 hits.

Closing out the season on Thursday, October 21st, is Jim Quick and Coastline. For Over 25 years, Jim Quick and Coastline, like their namesake the Atlantic Coastline Railroad, have been traveling the "tracks" of the southeast, and connecting with the hearts of loyal "Coastline Crazies." Pulling from the threads of Soul, Blues, R&B, and Americana, Jim Quick and Coastline weave together their own genre of music known as Swamp Soul. Delivered with precision by front man Jim Quick and his band, this group captures the true, honest spirit of traditions born and bred in the small southern towns of America. These five musicians, whose talents have landed them numerous awards in the industry, bring this indigenous music to life in the most genuine way possible. The band currently performs an average of 250 concerts per year, with an always growing fan base that is as diverse as the music of the band itself. Jim Quick has earned many accolades and has been named both Entertainer and Songwriter of the Year by the Carolina Beach Music Awards (CMBA).

## Tucker Family Victorious With Fight For Son's Memory



At Tuesday night's Clinton City Council meeting, a resolution of support for the Officer Donald Ray Tucker Memorial Bridge was once again brought before the city council, but with a different result this time. The board unanimously approved the resolution, that will allow the Tucker family to move forward with the NC DOT to see the project come to fruition.

Officer Donald Ray Tucker is the only officer in Sampson County who was shot and killed in the line of duty on November 14th, 1991. The bridge is located over the Faircloth Freeway (on US 421 over NC 24 in Clinton).

The original resolution was brought before the council on October 6th, 2021 by Councilman Daniel Ruggles. However, the resolution had to receive a unanimous vote and it failed with a 3-2 vote. At the November meeting, Mayor Lew Starling appointed an ad hoc committee with 10 members who were charged with the task of reviewing and



establishing policies and procedures of how to honor our fallen heroes.

After multiple meetings, the committee brought forth a recommendation to the council at the June 2021 meeting. The ad hoc committee brought forth the following: "The City Council should support any bridge naming resolution brought by the surviving family of any first responders employed by the City who dies in the line of duty that meet the criteria to qualify for the Federal Public Safety Officers' Benefit Program and meets the bridge naming criteria established by NCDOT. It is understood that ultimately NCDOT controls the naming process, however they require a local resolution supporting any application to name a bridge or roadway which we recommend the City Council should support such request."


Tuesday night's vote was a victory for the Tucker family and a victory for the community as well.





# **Dirty Dishes**



**Matthew 23:25-26**, "Woe to you, scribes and Pharisees, hypocrites! For you clean the outside of the cup and the plate, but inside they are full of greed and self-indulgence. 26 You blind Pharisee! First clean the inside of the cup and the plate, that the outside also may be clean."

Transformation comes first from the inside of a person. Doing good deeds has never saved anyone from the pits of hell. However, during the days of Jesus, many religious individuals thought if they did enough service projects, learn enough scripture or attend the temple regularly they would be assured a place in God's Heavenly Kingdom. Jesus turns that theological apple cart upside down when he calls the Pharisees hypocrites. The word hypocrite comes from the Greek word hypokrites meaning "an actor" or "a stage player." It literally translates as, "an interpreter from underneath," which reflects ancient Greek actors wore masks and the actor spoke from underneath that mask.

The Pharisees wanted the public to see their good deeds and heap praises on themselves. If there were cell phones when the Gospel of Matthew was written, we would probably be reading about the selfies of the Pharisees when they gave money at the temple. They appeared to be righteous and bearing good fruit, but

they were in fact a group of self-loving, artificial fruit producers. They might achieve gaining the most merit badges for their good deeds, but that wasn't what God wanted.

Consider the words of Jesus in **Luke 18:9-12**, He also told this parable to some who trusted in themselves that they were righteous, and treated others with contempt: 10 "Two men went up into the temple to pray, one a Pharisee and the other a tax collector. 11 The Pharisee, standing by himself, prayed thus: 'God, I thank you that I am not like other men, extortioners, unjust, adulterers, or even like this tax collector. 12 I fast twice a week; I give tithes of all that I get.' 13 But the tax collector, standing far off, would not even lift up his eyes to heaven, but beat his breast, saying, 'God, be merciful to me, a sinner!' 14 I tell you; this man went down to his house justified, rather than the other. For everyone who exalts himself will be humbled, but the one who humbles himself will be exalted."

This type of righteousness seen in the Pharisee was an example of a dish that was clean looking on the outside, but dirty on the inside. Today, many Christians will be active in Rotary Club, volunteer with the local fire department or coach their child's baseball team. There is nothing wrong with doing any of those things, but if we do acts of kindness for a pat on the back, we have received the reward here on earth.

Since we know that God wants us to be clean on the inside first, how does that happen? **Acts 16:31,** "Believe in the Lord Jesus, and you will be saved." Only accepting Jesus as the ruler of your life can transform you. Puritan minister Matthew Henry proclaimed, "If renewing, sanctifying grace make clean the inside, that will have an influence on the outside, for the commanding principle is within." We are commanded to be a blessing to others because we are indwelled by the Holy Spirt. Just as an apple tree will bear apples, Christians will bear the fruit of listed in the New Testament. **Galatians 5:22-23**, "But the fruit of the Spirit is love, joy, peace, patience, kindness, goodness, faithfulness, 23 gentleness, self-control; against such things there is no law."

I encourage you this week to examine your motives for doing good deeds. The Lord will bless your efforts in whatever you do for God's glory. Never do anything to receive praise from those around you. Be active and ready to answer the voice of God in order that others will give praise to the One you call Savior and Lord. **Matthew 5:16**, "In the same way, let your light shine before others, so that they may see your good works and give glory to your Father who is in heaven."

#### **Smokehouse Maple-Brined Pork Chops**

- 1/3 cup sea salt
- 1/4 cup, plus 2 tablespoons and pinch, McCormick Grill Mates Smokehouse Maple Seasoning
- 1/2 cup packed light brown sugar, divided
- cups water, divided
- 4 bone-in center-cut pork chops (3/4-inch thick, about 2 1/2-2 3/4 pounds total)
- vegetable oil
- 1 lemon, cut in half
- tablespoons unsalted butter
- Granny Smith apples, each peeled, cored and cut into six wedges

Grill until bottom side of pork chops are well marked and charred, 7-9 minutes. Flip and grill 4-6 minutes, or until cooked through and internal temperature registers 145 F. Let rest under

Place large cast-iron skillet on grill. Juice one lemon half into small bowl. Add 1 teaspoon lemon juice and remaining sugar to skillet and stir with heatproof spatula until mixture resembles wet sand. Cook with grill open, stirring frequently, until sugar melts and deepens to amber, about 8 minutes. Add butter and stir until melted. Once foam subsides, add apples. Close grill and cook, stirring gently to coat apples in caramel, until apples are tender-crisp, about 8 minutes. Remove skillet from heat and add remaining lemon juice and pinch of seasoning; stir gently.

Arrange pork chops on platter and top with apples. Zest remaining lemon half over dish. Sprinkle with chives, if desired.

#### **Best-Ever Buffalo** Rack O' Ribs Sandwich

Servings: 4

Slaw:

1/4 cup mayonnaise

1 tablespoon lemon juice 1/2 teaspoon Lawry's Seasoned

Grill ribs, turning once until meat is tender and pulling away from bone but not totally falling apart, about 1 hour, 15 minutes-1 hour, 30 minutes. Remove ribs from grill.

Unwrap ribs and let cool until cool enough to handle. Using sharp knife, carefully slit skin on back of ribs and

remove bones, keeping slab in one piece. Place boneless rib slab on direct-heat side of grill, rounded-side up, and brush top with 2 tablespoons hot sauce. Grill until underside begins to crisp, about 2 minutes. Carefully flip ribs and brush top with the remaining hot sauce. Continue to grill ribs until glossy and caramelized, about 2-3 minutes.

To assemble sandwich: Scoop out most of soft insides of top of French bread to make room for toppings. Brush cut sides with oil and sprinkle with seasoned salt and pepper. Grill on directheat side of grill until bread is toasted and grill marks appear, about 3 minutes.

Place ribs on bottom of loaf. Brush with additional hot sauce, if desired, and top with slaw, onions and blue cheese. Cover with top of loaf. Cut into four pieces.

#### **Giant Bacon-Cheddar Juicy Lucy Burger**

Servings: 8

- 2 tablespoons McCormick Grill Mates Montreal Steak Seasoning, divided
- pounds 80 percent lean ground beef ounces sliced medium or sharp white cheddar cheese 1/4 cup mayonnaise

1/4 cup yellow mustard 8 long pickle slices, plus

olive oil

2 tablespoons brine 1 round loaf soft bread (10 inches), cut in half horizontally

Sprinkle with remaining seasoning.

Lift burger from cake pan using foil. Press to flatten to about 11 inches in diameter. Refrigerate until ready to cook. (Patty can be assembled up to 2 hours in advance.)

In small bowl, whisk mayonnaise, mustard and pickle brine until smooth. Cover and refrigerate. Remove most of soft insides from top of bread to make hollow. Reserve insides

Prepare grill for indirect medium heat at about

Brush grill grates with oil. Hold burger on foil bottom and flip onto indirect-heat side of grill; peel off foil. Cook until sides of burger are cooked and it feels firm when lifted with spatula, about 8-10 minutes. Using two spatulas, carefully flip burger. Close grill and cook until burger is cooked through and cheese is melted, about 5-8 minutes longer. Move to direct-heat side of grill for 1-2 minutes per side for more char.

Brush cut sides of bread with olive oil and sprinkle with salt and pepper. Grill on direct-heat side of grill until bread is toasted and grill marks appear, about 3 minutes.

Place bottom half of bread on large cutting board. Spread with half of mustard sauce. Place burger on top and top with tomatoes, onions, pickles and bacon. Spread top of bread with remaining mustard sauce and fill with lettuce. Place top of bun on burger and cut into eight wedges.

#### GARDENING For faster yield, focus on leafy plants

If you want higher, faster yields, it's better to focus on leafy plants than rely on fruits. Here's what Self.com has to say:

"Edible plants have a pretty basic life cycle. Most edible plants start their life as a seed. They estab-

life as a seed. They establish roots and a stem, then leaves, then flowers, then fruit (if they make fruit), and then create seeds, starting the process over again. If you want a super-quick return on your garden, your best bet is to focus on plants whose main bounty is their leaves, like lettuce and herbs. Burke compared it to a race — if fruits are a marathon, leaves are a 5K. Way more attainable, though still certainly a bit of work. You'll also get a yield quicker, since fruiting happens later in a plant's life."

"The best idea for how to clean dust is to buy machine-washable items and launder them twice a year (OK, at least once). For non-machine-washable textiles, throw them in the dryer on the airfluff setting (no heat) for 20 minutes with a damp towel. The damp towel will attract pet hair, and the tumbling movement and airflow will remove the smaller particles for you."

# Some ideas for today's out-of-control real estate market

eader question: Is America in a housing bubble? We think today's out-ofcontrol real estate market is crazy. We are attempting to downsize our lifestyle with a smaller home. In two instances, we made an offer and someone outbid us. Our home is free and clear, so we are cash buyers. We don't want to sell until we know we've got a place to go. Unfortunately, there are not many homes to look at, so we don't want to sell our house first and end up compromising on our new home. Home trade-in programs and iBuyers are costly. What other options are available to us?

Author note: We addressed this question in a recent column on April 5, 2021. Here is another option.

Monty's answer: While no one knows for sure what will happen with our economy, including the housing sector, many economists are scratching their heads trying to understand the data to be able to predict the future.

Predicting outcomes is a big part of their work. Economists are sharing their thoughts and have very different views of the future. Here is an article (https://bit.ly/3nhon9J) authored by John Mauldin warning of a coming tsunami. And here is another article (https://on.wsj.com/3dItrDJ) by Alan Blinder explaining our booming economy.

#### The groundwork

One current solution is to buy a new home now and sell your existing home after. While the interest rate will be favorable, the risk is selling the old house. We have a strong seller's market today, and you may get a premium quickly.

There are also hyperlocal pockets in most areas where a quick sale at a significant premium price is not likely. Here is an old story about owning two homes (http:// bit.ly/2prYsC5) that is regularly repeated across our country today.

#### One more solution

Sellers are not selling because they are fearful they won't find a replacement they love due to a lack of inventory. Suppose someone would sell in this market at a premium, move twice and buy after the bubble bursts. In that case, it is conceivable they could save a signifi-

cant amount of money.
According to Move.
com, the average local
household move costs
\$1,250. According to
the Washington Post,
home values plummeted
over 30% following the
2008 meltdown. If a
bubble burst happens,
and the value declines
are similar, it is easy
to see the savings.


This strategy makes sense even if there is no bubble. Suppose the idea of a double move is palatable to you.

In that case, the advantage of the strategy is that you will have realized your current equity before you make the next purchase.

Maybe I like the idea because I am in the process of doing it myself. I sold my big home a few months ago, and I am renting until I find a house I really like so I don't have to compromise.
