
### Sampson County to Remember Memorial Day


Smithfield Foods Presents SCC Foundation with Funds for Annual Scholarship



The Senate Page Program is now OPEN! Senate Pages are essential to the operation of the General Assembly as they assist the members and staff of the Senate during the legislative session. They participate in daily sessions and committee meetings and perform other duties including, but not limited to, delivering messages and materials within the legislative complex, answering phones in senators' offices, and passing out documents or running errands in the Senate Chamber during daily sessions. To be a Senate Page, you must: Be in eleventh or twelfth grade, in good academic standing at school, and have prior approval by your school's principal if you are appointed to serve as a page during the school year. As always, please do not hesitate to reach out to my office for any assistance

#### Legislative Recap

This week, we will be reviewing the procedures for the upcoming short session and what to expect from new legislation this year. Because of the brief nature of this session, there will be a focus on getting keystone legislation through the General Assembly at an efficient pace. A new supplemental budget will be worked on over the coming weeks to make changes to our existing two-year budget. We will also see, in all likelihood, a number of local bills that address the needs of particular communities in each member's district. Beyond that, the filing of bills is more or less restricted to those that are going to impact the appropriations process or primarily affect the retirement system.

As we move forward, we will do our best to update you on where bills, such as the 2022-23 budget, are in the process. If all goes well, we will have passed several important new laws over the coming weeks and then recess until the next long session which would begin in January of 2023.

#### N.C. Department of Agriculture Names New Marketing Director





morial Day is to memorialize the veterans who made the ultimate sacrifice for their country. We spend time remembering those who lost their lives and could not come home, reflecting on their

service and why we have the luxury and freedom that we enjoy today.


According to the US Dept of Veterans Affairs, three years after the Civil War ended, on May 5, 1868, the head of an organization of Union veterans - the Grand Army of the Republic (GAR) - established Decoration Day as a time for the nation to decorate the graves of the war dead with flowers. Maj. Gen. John A. Logan declared it should be May 30. It is believed the date was chosen because flowers would be in bloom all over the country. The first large observance was held that year at Arlington National Cemetery, across the Potomac River from Washington, D.C. The ceremonies centered around the mourning- draped veranda of the Arlington mansion, once the home of Gen. Robert E. Lee. Various Washington officials, including Gen. and Mrs. Ulysses S. Grant, presided over the ceremonies. After speeches, children from the Soldiers' and Sailors' Orphan Home and members of the GAR made their way through the cemetery, strewing flowers on both Union and Confederate graves, reciting prayers and singing hymns."

At this year's Sampson County Memorial Day event, we will be honoring those men and women too.

Special Prayer will be done by Daryl Price, Chaplain of the Sampson County Veterans Council. Posting of Colors will be presented by the VFW Post 7547 Color Guard which includes Alvin Herring, Andrea Goodman, Marshall Thornton, Walter Raynor and Avon Jones. Service Flag Bearers include Willie Mitchell-Army; Kenny Williams-Navy; Dennis Jones- Air Force; Darryl Price- Marines and Jerome Warren- Coast Guard. Dean Wilson- United States Space Force. The Pledge of Allegiance will be led by William Deaver, President of the Sampson County Veterans Council. The National Anthem will be sung by Ms. Deondra Peterson.

According to Ann Knowles, Veterans Service Officer, the keynote speaker at this year's event will be Rev Dr. Theodore B. Thomas Ill.



Thomas and his family moved to Sampson County in 1983, and he says that he immediately began getting involved in the community, recognizing the importance of community involvement early on.

Dr. Thomas ran a successful dental practice in Clinton for over 35 years, retiring just before he joined the Board of Trustees. Thomas has also served as pastor of First Missionary Baptist Church in Warsaw for 12 years. His commitment to community reaches far and wide - even extending to service with the state. Dr. Thomas was recently nominated and elected to the

Executive Committee of the North Carolina Community College Association, which now allows Sampson Community College to more directly influence state legislation affecting community colleges.

to close the highway (24) in both directions overnight Friday, June 17 from 8 p.m. until the next morning at 6 a.m. (June 18) The ramps will be open to traffic. Law enforcement will be out with their flashing lights to help control traffic and detour it. Until yesterday, we were planning to close this highway this coming weekend in order to place more girders on the new US 70-421 bridge that you no doubt are aware is under construction. Yesterday our contractor said they couldn't do the work this coming weekend and needed to reschedule."

Mitchell, Danny Jackson, Robert Marshall, and Brian Jackson. The Closing of "Taps" will be performed by Avon Jones, Veterans Foreign Wars Post 7547. Closing remarks by Ann G. Knowles, Sampson County Veterans Service Officer.

Mrs. Knowles noted, "We will lay a carnation for each name that is called that gave their life for their country. It is a time that our family and friends can visit in the park and remember their soldier or loved one."

Ms. Knowles also noted that this is the first year and the official unveiling of the new arm of service, the United States Space Force. "We are excited about this new branch of the military."

"We have had a Memorial Day celebration in Clinton since 1977, except for 2020 and 2021 due to COVID," stated Knowles. "We have not always had the event we have now. Sometimes it was just a wreath laying at the county courthouse monuments or at a cemetery or the community college. But we always remember those who did not come back and gave their all."

"We usually have a good turnout, anywhere from as many as 200 to as few as 75. But they are there to give honor. No matter how big or small, the program is always great. This is a way that Sampson County citizens can show their respect to the ones who lost their lives for their County and Country. It tells all who live here, that our Soldiers and Veterans are important to us. We stop on Memorial Day to remember the sacrifice they made, so we can go about our lives each and every day as free people; with the right to worship in our churches and not be afraid of being taken prisoner. Even to the ones who protest our service, spit on our flag or burn our Bibles, the soldier fought to give them the right to express themselves. On Memorial Day, the citizens of our county know that there is going to be a memorial service to honor our soldiers that gave their lives. They know that this is their service and they are welcome. We want the families of our soldiers who lost their lives to know we mourn with them and care for the family left behind."

Mrs. Knowles explained why this day is so important to her, "Memorial Day to me is a day to stop and remember the service member who lost their life from the Civil War to the present War. It is a day to remember their mother, father, spouse, children, sister, and brother that does not have their loved one home with them to celebrate a holiday, to go swimming, fishing or shopping or to just have a family day. It is a day that we tell these families we are sorry for their loss. It should not be one day a year but every day. It is a day that I think about the wars that have called our men and women to go to a foreign land to fight, and the hardship and suffering that they endured. I think about the veterans today who still morn for their brothers or sisters that lost their life in service and who carry the images with them daily and how it affects their life. I think of our leaders of this great nation who get so wrapped up in power that they forget it was the soldier that fought to keep our country the home of the free and the brave. I think we forget that our freedom is not free but is paid for by the price of blood from our soldiers. They forget that we have an obligation to our servicemen and women who died for our freedom to continue the fight. We have an obligation to maintain our freedom for our children and the future generations. To me, it is a day for me to bow my head and pray for those lost and their families. And May God Bless the Widows and Orphans. We will never forget the sacrifice that your loved one made to keep us free."

Refreshments will be provided by Ladies Auxiliary, American Legion Post AL 22 and AL 133 for all that attend, and the organizers urge, "Please spend a few minutes with us in the park to remember those who gave their lives to make this country free. We share your sorrow in the loss of your loved one and share your pride in their service to our country."

The Red, White and Blue Wreath that is placed at the front of the Veterans Park in honor of all who gave their life was donated by The Atrium Florist.

### June 4th Proclaimed Tourette Syndrome Awareness Day

At the May Clinton City Council meeting, the mayor and council unanimously passed a proclamation making June 4th Tourette Syndrome Awareness Day.

According to Paula Brinkley, mother and grandmother of someone with Tourette's Syndrome, "By proclaiming June 4, 2022 as Tourette Syndrome Awareness Day, you will help those of us with TS get one step closer to the only "cure" available-awareness. My eldest daughter, Victoria, a nurse and her son, my eldest grandson, Wyatt both have Tourette's Syndrome. While they both persevere daily, the struggle is real. From communication to merely walking, they face this disability with grace and dignity. By educating and informing, we hope that the stigma is lessened one person at a time."

Brinkley went on to say, "Wyatt has received training for presenting information on TS to spread awareness and educate the public in general as TS is most often misunderstood, mis/undiagnosed and currently has no known cure. During Wyatt's training he lobbied on Capitol Hill North Carolina's Senator Burr and Senator Tillis as well as House of Representative Rouzer's office for procurement of a variety of bills that will help support research as well as healthcare plans that will cover treatment and medicines." "As there is NO CURE," stated Wyatt, "I even had genetic testing completed to determine which medicines would be beneficial to me, yet that doesn't take into account an individual's metabolism rate which can cause the need for a larger dose or even a long-acting medicine's effectiveness can be altered. There are a few "old-school" medicines that are still used since their effectiveness was positive at some point in time, however, most are only effective for a short-lived period of time as the body becomes used to it but the use at a larger dose is unknown as research is hindered by monetary constraints. I was actually hospitalized due to this issue. A combination of two of my prescribed medications had contraindications when used together that my pediatric neurologist happened to over in an attempt to bring my body some relief from my motor and vocal tics, yet it sent me into a serotonin spiral causing extreme seizures. Having access to qualified physicians, and therapists as well as medications that are covered by insurance is a large problem in our rural area. The drive to my neurologist is over two hours which means that I have to miss a complete day of school. Since Covid-19, the telehealth has been quite beneficial in dealing with this."

"My tics are both motor and vocal, sometimes either and a lot of the time both which not only hinder me from adequate learning but add in my comorbidities of ADHD, OCD and anxiety and trying to keep focused on a task while handling my tics is quite exhausting. They can be totally debilitating one minute to being functional the next. TS is not a onesize-fits-all kind of disability. It is different for each person."

In clsoing Wyatt noted, "Continuing research and awareness is our hope for a better tomorrow. Tourette's Association of America supports our triumphs and spreads awareness where there isn't any. They continue to fight for our rights and walk with us on our journey-many would not have an advocate without this organization and their continued support for research, education and awareness. The lack of qualified doctors and therapists as well as education and awareness is real. TS is no joke."

Tourette Syndrome is an inherited neurological disorder that is characterized by involuntary physical and vocal tics that occur many times a day. It is often accompanied by other mental health disorders such as attention deficit and obsessive-compulsive disorder, learning disabilities, and anxiety. Tourette Syndrome and tic disorders affect 1 in 100 children. More than 23,000 school age children in the State of North Carolina alone are dealing with Tourette Syndrome and although some of these cases are aided by medication, there is no standard treatment or known cure for the disorder. There is an important need for more professional help with interest and expertise to identify, counsel, and treat people with Tourette Syndrome, a disorder that is often misdiagnosed

Brinkley's grandson, Wyatt, will be presenting at all two levels of school at Mintz Christian Academy where he is a sophomore and a member of the National Honor Society with a GPA of 3.8. "He receives piano lessons from Newton Grove's own Michael Daughtry and is an avid archer," said the proud grandmother. "Prior to this he was a student in the Hobbton School district. MCA welcomed Wyatt and his disability openly and wholeheartedly as they see past his tics and appreciate not only his academics but his whole being as TS is a part of him not what defines him."

Jean-Paul Wyatt Lanier said, "I have Tourette's Syndrome (TS). I am a third generation diagnosed. My mom and her father also are diagnosed with TS. I was diagnosed at the age of 7 after many assessments by a variety of doctors and referrals as the rural county where I reside just didn't know what was going on. I saw behavior psychologist, yet I never had a behavior issue and am considered above average for my age academically. I have been prescribed a variety of medicines that are somewhat adequate in managing by TS symptoms, however, these are short-lived and another one is added while one is removed. This is medical professionals attempt to aid me in living a "uniquely normal" life.



## We Are Not Hotel Christians



any of these actions was because I knew this wasn't my home; I was just traveling.

Sadly, many in this world treat this side of Heaven more like their final home than just a hotel. Jesus promised His followers that He was going to prepare a final home for them. Notice that it is Jesus doing all of the work on this home and not some subcontractor. Jesus has paid the price for our residence in Heaven; however, it does require a reservation on our part. Just because you want to go to Heaven, heard about Heaven or even have family and friends there, doesn't mean you will be going there. **John 3:5**, "Jesus answered, "Truly, truly, I say to you, unless one is born of water and the Spirit, he cannot enter the kingdom of God."

The Bible describes Heaven as a city filled with the brilliance of costly stones and crystal-clear jasper. It has twelve gates and twelve foundations. The paradise of the Garden of Eden is restored: the river of the water of life flows freely and the tree of life is available once again, yielding fruit monthly with leaves that heal the nations. The Apostle John wrote in **Revelation 7:15-17**, "Therefore are they before the throne of God, and serve him day and night in his temple: and he that sitteth on the throne shall dwell among them. 16 They shall hunger no more, neither thirst anymore; neither shall the sun light on them, nor any heat. 17 For the Lamb which is in the midst of the throne shall feed them, and shall lead them unto living foun-

John 14:2-3, "In My Father's house are many rooms; if that were not so, I would have told you, because I am going there to prepare a place for you. 3 And if I go and prepare a place for you, I am coming again and will take you to Myself, so that where I am, there you also will be."

On October 16, 1829, what many consider to be the first modern hotel in the United States opened on the corner of Tremont and Beacon Streets in Boston, Massachusetts. Called the Tremont House, the hotel was a site of luxurious firsts: free soap, locked guest rooms, bellboys, a reception area, and perhaps most important of all, indoor plumbing. It hosted the most distinguished visitors to the city of Boston until the hotel's closure in 1894, including Charles Dickens, President Andrew Jackson, President John Tyler, Daniel Webster and Davy Crockett.

Have you ever made a reservation to a hotel? The reason you might do so is you are in need of temporary housing while traveling. Over the years, I have stayed at hotels that would be considered top-rated by any standard and have also been shocked by the filthiness of some. Regardless of the condition of the hotel rooms, one thing was in common with my stay, this wasn't my home. I hadn't brought my own bed; I didn't hang family photos on the wall and I never draped a "home sweet home" sign on the hotel door. The reason I didn't do

Randy Alcorn, Director of Eternal Perspective Ministries, proclaimed, "Many Christians dread the thought of leaving this world. Why? If your treasures are on earth, that means each day brings you closer to losing your treasures." The Tremont House was razed in 1895 and replaced with an office building. Today, the building at 73 Tremont Street occupies the spot, home to a Citizens Bank and parts of Suffolk University. **Q-** Why are you running for the office of District Attorney?

**A-** Serving as a career prosecutor has been an honor for me and I have been privileged to serve as an assistant district attorney and as District Attorney for four great counties-Sampson, Onslow, Duplin, and Jones. I am seeking re-election as District Attorney because this district deserves an experienced prosecutor, one who has tried the challenging and toughest cases, one who has made the difficult decisions, and one who has tried serious jury trials in all four counties. I am seeking re-election because experience matters when you or your family member is the victim of any crime. I am seeking re-election because experience matters when you or your family member have been the victim of a violent felony. I am seeking re-election because I believe in protecting victims' rights. I am seeking re-election because I believe in justice and want to continue serving you as your District Attorney.

cases including the most serious crimes such as first-degree murders. I have that experience. The DA should not simply be an individual telling others what to do in a homicide when he has never actually tried a murder. I believe in leading by example. I believe the DA should be a practicing attorney in the office in that if the DA has the experience to sit as first chair in a murder or other serious case that demonstrates an excellent allocation of resources, provides leadership to the office, and instills confidence in the public. As DA, I often will have an ADA try the case with me for that ADA as I mentor them with my experience. I worked for two experienced District Attorneys, William H. Andrews, and G. Dewey Hudson and both tried murder and other serious cases. I have continued to do the same.

In addition, I believe the District Attorney must be the supervisor and policy setter for the office. As District Attorney, I must supervise a staff of 20 assistant district attorneys and 19 staff members in four counties. As District Attorney, I must deal with personnel issues, and I have done so as the elected DA for over 11 years. As such, I must make difficult decisions about hiring and dismissing individuals. I also must be the policy setter for the district. I have done so by implementing tough policies on homicides, violent felonies, drug dealing and trafficking, domestic violence, driving while impaired offense, and other offenses. My job is to represent the State in a fair and just manner but also be tough on criminal offenses.

**Q-** Tell the readers about your family, your educational background and your work experience that helps in preparing you for the office of District Attorney?

A- I was born in New Bern, NC. I am married to Misti Cavenaugh Lee of Pin Hook in Duplin County who as journalist, worked with the Jacksonville Daily News and a free-lance writer with Our State, the Marine Corps Times, and the Wilmington Star News. We have been married over 31 years. Misti's grandfather, Jonah Swinson pastored a church in Clinton as well as other churches in Duplin County before he passed away. Misti's parents and brother, Bull Cavanaugh, who farms, reside in Pin Hook. Misti and I have three children, Ashton, age 21 years and student at Campbell University; Catherine, age 18 years who is a senior at Jacksonville High School and will be entering North Carolina State University in the fall; and Carson, age 15 years who is a 9th grader at Jacksonville High School and working to achieve his Eagle Scout. My parents, who are in their 80s, reside in New Bern, North Carolina and they have been married over 62 years. My family has taught me loyalty, the value of hard work and service to the nation.

for twelve years as an assistant district attorney for G. Dewey Hudson. Under their leadership, I immediately began trying cases. In fact, my first five and a half years as a prosecutor, I prosecuted ten first degree murder cases and ten of those were jury trials. I learned from them both, the importance of trial experience, the importance of working with law enforcement to ensure that justice is done, and the absolute necessity that one has the experience to prosecute the most serious cases and make the tough decisions. On January 1, 2011, I swore in as district attorney and in March 2011, I tried a first-degree murder case in Onslow County. The jury returned a verdict of guilty, and the defendant received life without parole. That trial shows the value of experience.

**Q-** Why should the voters in your district cast their vote for you?

**A-** I am a career prosecutor who has the experience, leadership, temperament, and dedication to service to be your District Attorney. I work hard and I do not shy away from the most difficult and challenging cases. That is evidenced by the number of jury trials I have personally prosecuted. I have tried more than 235 jury trials including DWIs, drug offenses, sex offenses, robberies, trafficking, and property crimes. I have personally prosecuted 145 defendants for murder including eight capital cases. I have obtained four death verdicts. My opponent has never tried a murder case. I have tried violent offenders in all four of my counties including an eight-week long capital triple homicide in Sampson County that occurred in Plainview. My last jury trial was in February 2022 in Onslow County and the jury convicted the defendant of first-degree murder and he received life without parole. That is my 34th first degree murder defendant to receive life without parole. I have had one other defendant receive life without parole in a jury trial in Duplin County as a violent habitual offender. If you or your family are the victims of a serious offense, you need a District Attorney who has tried cases and has proven results. I am that District Attorney.

**Q-** What are the issues that you hope to tackle if you are re-elected?

 ${f A}$ - I will continue to schedule violent cases in this district and make those a priority. I will continue to schedule first degree murders and lead by example by trying many of those cases myself. I believe the District Attorney should have the experience to serve as lead counsel in a capital murder and non-capital first degree murders. I will continue to work with law enforcement including the Sampson County Sheriff's Office in the arrest and prosecution of drug dealers and traffickers. I will continue to be tough on impaired drivers when means enforcement of the law passed by the legislature that states "a person commits the offense of impaired driving if he drives any vehicle upon any highway, any street, or a public vehicular area within the State....after having consumed sufficient alcohol that he has, at any relevant time after the driving, an alcohol concentration of 0.08 or more." That is the law of the State of North Carolina, I my office will continue to be tough on driving while impaired cases. Those who are not tough on those cases have apparently never tried impaired drivers who killed an innocent victim. I have tried those cases. If re-elected, I will continue working on the backlog of cases that were delayed by the pandemic since we lost a year of jury trial time from March 2021-March 2022. If re-elected, I will continue to treat seriously and enforce the law concerning sexual offenses, domestic violence, and property crimes that are so prevalent in our district and state. I will continue to work with the four sheriffs and the police chiefs of my district to ensure that law enforcement has the appropriate advice, as required by the NC Constitution, in charging decisions, evidentiary issues, and other matters arising in the enforcement of the laws of this State.

**Q-** Do you see the role as DA as more of practicing lawyer or as a supervisor and policy setter for the office?

**A-** I see my role as the District Attorney as all these things but primarily as a leader of the office who is prepared and experienced to try the toughest cases. I believe the elected DA must possess the experience to try

My father served and retired from the United States Air Force and as such, my mother, brother, and I lived in eight states. My brother also served and retired from the United States Air Force. Military service is very important in my family, and in service to my nation, I served retired as a commissioned officer and judge advocate from the United States Army Reserve after 22 years of service. I served with units at Ft. Jackson, SC and Ft. Bragg, NC with duty in Alabama, Maryland, Panama, and Germany. I also graduated from the Judge Advocate Basic Course and the Judge Advocate Advanced Course at the Army School at the University of Virginia as well as by correspondence the Command and General Staff College officer course. The military teaches one duty, sacrifice, and service to nation and others which are core value that are very important to me as the District Attorney.

I graduated from Campbell University School of Law and set upon a path of becoming a career prosecutor. I worked my way through college and law school with jobs at grocery stores, fast food, and two summers at Maola Milk and Ice Cream Company making ice cream. I understand the value of hard work and what it means to work on the clock.

As a prosecutor, I served first for twelve years as an assistant district attorney for William H. Andrews and then As District Attorney, I have decided ten officer-involved shooting cases including four in Sampson County. In each case, I determined after extensive investigation by the State Bureau of Investigation that the officers were justified in using deadly force. I have the experience to handle those type of investigations. My opponent has never decided an officer-involved shooting.

I have the support of all four sheriffs in my district-Sheriffs Hans Miller of Onslow County, Jimmy Thornton of Sampson County, Blake Wallace of Duplin County, and Matt Wineman of Jones County. I have their support because I have proven myself to be accessible, hard-working, and able to handle the toughest of cases.

I believe that faith, family, duty, and nation are important and those are the bedrocks of my service as District Attorney. As a Gideon since 1994 and active member of Bethlehem Baptist Church in Jacksonville, I understand the importance of faith. My family is so very important to me, and I know important you if you are ever victimized and need a strong advocate in court. **Q-** Why are you running for the office of District Attorney?

**A**- I have been humbled by the encouragement of others to do this over the past few years. From colleagues to judges to members of law enforcement to so many who have interacted with the judicial system, their confidence in me has been an important part of this decision. However, the deciding factor has been my love of country and this community and my passion for the law. As both a prosecutor and a defense attorney throughout this district over the past 15 years, I have seen firsthand the challenges that face every stakeholder in the court system. I recognize that through a more proactive approach to case management, evaluation, and prosecution, this office can both climb out of the backlog of cases experienced from the shutdown of the courts and achieve better success at reaching just outcomes in more of those cases.

**Q-** What are the issues that you hope to tackle if you are elected/reelected?

**A**- We often hear that more court time is needed, but we are not presently making the best use of the court time that we have. From district court to superior court, throughout the district, we are experiencing too many terms that break down without a sufficient number of cases being resolved. Over the past six months in the superior courts in particular, the State has not fared well in outcomes across the four counties to a level I have not previously seen in this district. I would seek to address that trend with more substantive training and mentoring in reference to case evaluation and trial preparation, while working to build a true team effort that would bring out the best in each member of the office. In reference to the backlog of cases and efficient use of court time, I would be proactive and build an ongoing dialog between the District Attorney's

**A-** Both. I own a law firm now that operates three offices and services this entire district. I am in court nearly every day and reviewing operational matters every day as well to ensure we remain on the right side of the ledger and that we meet the needs of our clients. If I failed to do either, our practice would fail. Similarly, the District Attorney cannot simply be a practicing attorney, but must concentrate even more on setting policy for the office and ensuring that each office is running correctly. By statute, our district is allowed 20 Assistant District Attorneys who generally are assigned to the cases throughout the counties in our district, but as many who have interacted with the court system have witnessed, the manner in which those cases are addressed can differ greatly even among the counties in our own district. A successful District Attorney must be willing to set appropriate policy across the entire district, remain abreast of the activity in each county, and be willing to go into court to work side by side with his team as needed.

**Q-** Tell the readers about your family, your educational background and your work experience that helps in preparing you for the office of District Attorney?

**A**- After living in Clinton for ten years, my wife Danielle and I moved to Kenansville in Duplin County nearly four years ago. Our daughter Heather and her husband Blake live in Alabama with our two beautiful granddaughters. Our family is very dear to me, and I am honored and grateful to have their support in this endeavor.



## SAMPSON COUNTY SCHOOL BOARD



**Q-** What is the biggest issues facing the Sampson County School system?

**A**- Overcoming the loss of learning due to the pandemic is the biggest challenge facing Sampson County Schools. Many of our students missed learning critical foundational skills or they lost skills previously learned in the 2 years we were fighting the pandemic. We have to ensure those gaps in knowledge are closed to safeguard the future academic success of our students. At the same time, we have to teach grade level curriculum. This is a huge task that will require dedication of all stakeholders over the next few years.

**Q-** What is your position on decreasing class sizes?

**A**- Smaller class sizes are important to allow for more individualized instruction. Sampson County Schools complies with state-mandated classroom sizes and we should maintain a good teacher to child ratio, especially in the early years.

**Q-** What do you think the school system needs to do to increase recruitment and retention of teachers?

## **KIM SCHMIDLIN**

**A-** Sign-on bonuses would be very effective in recruiting teachers to Sampson County Schools, particularly in hard-to-fill positions. Since teacher pay is mandated by the state, the only financial incentive we can offer is an annual supplement and bonuses where the budget allows. It is very difficult to find qualified teachers in certain areas so a retention bonus would be helpful. I believe retaining teachers also comes down to creating a positive culture within our schools. Teachers need to feel appreciated and county and school leaders should work to keep our schools great places for teachers to teach and students to learn.

**Q-** What can be done to increase graduation rates in the county?

**A-** Improving our emphasis on teaching trades would improve graduation rates. Many students don't see the benefit of a high school diploma and would prefer to go into the work force earlier. If we give those students more options for learning a skill that would translate to a job, they would see a benefit to completing their high school education. We also need to allow students more flexibility within the school day to work.

**Q-** Tell the readers about your education, qualifications and why they should vote for you.

#### **A**- Education:

I graduated from Midway High School in 1987 then went on to North Carolina State University where I earned a BA degree in Communications in 1991. I completed my Master of Science degree in 1993 in Speech-Language Pathology from East Carolina University.

Speech Therapist - I have spent the last 29 years working as a speech therapist which has given me valuable experience in working with students and teachers in the special education program. My training gives me expertise in literacy and phonics which have been significantly impacted in the last 2 years.

During the pandemic I have been an advocate for transparency of school board meetings, in-person learning, in-person graduations, and optional mask use. I believe parents have a vital role in the education of their students and, as valuable stakeholders, their participation should be encouraged. I was comfortable with working with our local County Commissioners, and felt I had a good relationship with them.



## SAMPSON COUNTY SCHOOL BOARD



**Q-** What is the biggest issues facing the Sampson County School system?

**A**- One of the biggest issues facing the Sampson County School District is teacher recruitment and retention. In today's job climate, the availability of certified/qualified teachers is very limited. If you add to that limited availability the inability for Sampson County to compete with larger school districts to offer incentives, especially comparable supplements, the pool of candidates becomes even smaller. At one point, the ability to attract "homegrown" teachers to Sampson County was on the rise, but even that source has become increasingly smaller as fewer students are graduating from high school and attending college to become educators. This has been evident in the fields of Mathematics and Sciences for over a decade. It is now a factor in all areas of education.

Another issue faced by Sampson County Schools is the need for new facilities. It is a known fact that there are several schools in the district that are in need of replacement or major repairs. The first one that comes to mind is Hobbton High School, followed by Roseboro-Salemburg Middle School, and Hargrove Elementary School. Members of the board of education have been painfully aware of the need for a new high school in the Hobbton district for a while, but the board has also been made aware of the lack of funding to build any new schools in Sampson County at this time. Even with help from the state, our county commissioners would have to make available matching funds on the county level. This could not be accomplished without an increase in property taxes. This is not possible at this time in our county. So, as soon as funding is available, the Sampson County Board of Education will recommend and oversee the building of a new high school in the Hobbton district, and then renovations to the other two schools mentioned.

## SONYA POWELL

The last issue I would say our district faces is that of school safety. Even though many improvements have been made to assist in the safety of our schools, there are still many more considerations. We are a rural school system and therefore many of our schools are situated on large, sprawling campuses. Our need lies in the ability to effectively protect all areas, without making our schools appear to be enclosed like prisons. We need more funding to make more areas only assessable by key cards. We also need a school resource officer on every school campus, even the elementary schools.

**Q-** What is your position on decreasing class sizes?

**A**- When the discussion is decreasing class sizes, naturally I am in favor of smaller class sizes. That can, however, be a two-edged sword. I am not in favor of smaller class sizes if it means that not every class would have a qualified teacher. I believe that it is much more important that every child has a certified/qualified teacher each and every day. As previously indicated, it is currently difficult to find teachers. I feel that placing a teacher assistant in a classroom with a certified teacher would be more beneficial than having a smaller number of students in classrooms without certified teachers in those classrooms.

**Q-** What do you think the school system needs to do to increase recruitment and retention of teachers?

**A-** The Sampson County School District is currently do everything it can to recruit and retain highly qualified teachers. That includes such measures as attending and sponsoring job fairs where positions available are advertised. Advertising teacher positions online in general, as well as on our website. Reaching out to colleges and universities that have teacher education programs and attempting to recruit teachers to come to Sampson County. Using such measures as international programs to allow teachers from other countries to come teach in Sampson County. We also continue our teacher recruitment in all our high schools with the Future Teachers program which is intended to support our "home-grown" initiative where students attend college, major in education, and then return to Sampson County for their career in teaching.

whole, efforts will be ineffective and meaningless. That would require substantially increasing the salaries of teachers as well as bringing back the pride and respect to the profession. Teaching is a noble and worthy profession and should be treated as such by other professionals and others in general.

**Q-** What can be done to increase graduation rates in the county?

**A-** I am proud to acknowledge that over the last 10 years, graduation rates in the county had been on the rise. It is with the coming of the COVID-19 pandemic that there has been a slight decrease. That decrease can certainly be attributed to the inaccessibility of technology at a crucial point in the lives of some students. Now that technology is readily available to all our students, the graduation rates should rise again.

My suggestions to assist in the continuing rise of graduation rates is that the system continue to offer pathways that lead to college, the military, or the workforce. Every student should be able to find a course of study in high school that will lead them to the beginning of a successful future. The addition of more guidance counselors in each high school would help to give each student the personalized attention they need to make decisions for the future.
