## Election Night Yields Red Wave



*Great Night for Republicans*

It's definitely been a long election season and most Sampsonians are glad that it is over. Tuesday night proved to be a Red Wave for the Sampson County Republican party with only one seat other than Judicial ones going to a Democrat.

Voters in Sampson County turned out in large numbers for the Mid-Term Elections on Tuesday with 50.59% of registered voters going to the poll. This equates to a total of 19,421 voters out of the 38,390 registered voters in 2018. In the 2014 Mid-Term elections a total of 17,627 ballots (46.60%) were cast out of the 37,778 registered voters.

## A 'Full Service' Celebration in Salemburg



*Warren's Service Center Celebrates 65 Years*

Businesses have come and gone in Sampson County over the past six decades – but there is one located in Salemburg that has stood the test of time since 1953 - Warren's Service Center.

Last Saturday, November 3, the business located at 101 Main Street in Salemburg, threw a 65th Anniversary bash that pulled in over 350 people.

"We had a great turnout," said owner Joe Warren. "It was a big day for us."

In addition to honoring the service station's customers, the event featured music, food, fun and visits from local celebrities "The Shed Heads" who have a hit show on Facebook called "The Grateful Shed"; as well as the current Miss Virginia Emili McPhail.

Visitors also got a chance to see the No. 92 race car owned by Black's Tire Service.

"Everything went really smoothly," Warren said. "We are just really happy to have such a big crowd and I am just thankful that we had a chance to say a big 'thank you' to all of our loyal customers."

The celebration was a long-time coming, according to Warren.

"Well, we have been thinking about doing this for a while now," he admits. "We wanted to do a big celebration when it was our 60th anniversary, but we didn't get to it. We figured our 65th was the right time to do it to thank everyone for supporting us all these years."

The full-service family business was the brain-child of Warrens' parents, Joseph Sr. and his mother, Janice, as Pure Oil. In 1964, the business was Union 76; then changed to Citgo in 1994. In 2013 it became Valero.

"I really grew up working here," Warren, who is also mayor of Salemburg, said. "I was born in 1957, so, being in this business was really second nature to me ... It came easy to me because I was born into it."

For 65 years, Warren's Service Center has always partnered with Sampson-Bladen Oil and has been working with Black's Tire



In the last column, we went over Senate Bill 3: Hurricane Florence Emergency Response Act, which provided much needed funding and policies to assist in the recovery of Hurricane Florence. In this newsletter, I would like to go over House Bill 1019: Fallen Wildlife Officer Memorial License. This bill honors fallen members of the wildlife law enforcement community by offering their surviving spouse, child, grandchild, or great-grandchild a Lifetime Sportsman License. There have been 11 fallen wildlife officers since 1930. This new license is named after John Oliver Edwards, who

was a wildlife law enforcement officer from Duplin County who lost his life in the line of duty.

#### FEMA Disaster Assistance Registration Deadline Extended

The deadline for North Carolinians to register for disaster assistance has been extended 30 days to 11:59 PM, Thursday, December 13th 2018. The extension comes at the request of the Governor, citing a continued flow of new applications for federal assistance in the wake of Hurricane Florence. FEMA and SBA are located in the Sampson County Disaster Recovery Center Thursday November 1st through Saturday November 3rd, from 9:00 AM to 6:00 PM. This is located at the County Administration Building, 406 County Complex Road in Clinton. FEMA encourages all survivors who sustained disaster-related damage or losses to apply for assistance before the December 13 deadline.



## Operation Round Up Funds Continue To Strengthen Communities

The Community Assistance Corporation, or CAC, South River EMC's not-for-profit foundation, awarded \$39,928 in Operation Round Up grants to local nonprofits and schools.

The following non-profit organizations each received grants: Sampson County Emergency Services, \$4,962; Autryville Area Fire Department, \$5,164; and Beacon Rescue Mission, \$5,000.

Several educational programs received funding as well. Educational institutions can apply for grants up to \$10,000. Those who received grants are: Plainview Elementary, \$10,000; Stedman Primary, \$4,802; and South River EMC's Bright Ideas Grant Program, \$10,000.

"Our community has been through difficult times, especially after Hurricane Florence," said Catherine O'Dell, VP of Member Services and PR, South River EMC. "Operation Round Up continues to offer a mechanism to ensure our community support structure is firmly in place when needed."

Operation Round Up is a voluntary program that enables members to round up their electric bill to the next whole dollar. For example, if a bill is \$118.25, the bill rounds up to \$119 and the extra 75¢ is deposited into the CAC fund. Members can put small change together to make a positive difference in their community today, as well as providing better educational opportunities for the leaders of tomorrow.

South River EMC accepts and reviews applications on a quarterly basis. The next due date is November 16 by 5 p.m. Applications and rules can be found online at [sremc.com](http://sremc.com). Always make sure you have the most recent copy of the application.

South River EMC is a locally owned and operated electric cooperative, which provides electric service to 43,000 homes, farms and businesses in parts of Harnett, Cumberland, Sampson, Johnston and Bladen counties.

## ELECTION, cont. from P. 1

### Sampson County Sheriff Race:

Sheriff Jimmy Thornton easily won re-election for a fourth term beating out Freddie Butler. Thornton (Rep) garnered 12,157 votes (63.13% percent of the vote). His competition Freddie Butler (Dem) brought in a notable 7,101 votes (36.87% of the vote). After all precincts had reported, Sheriff Thornton released the following statement to his supporters: "I would like to thank the voters of Sampson county for their overwhelming support. Serving as your Sheriff is something I take great pride in and I am humbled by your support."

Sheriff Thornton will be serving his fifth term. He was elected in 2002.



### Sampson County Clerk of Court:

Another highly contested race, Sampson County Clerk of Court was won by Republican Chris Fann who earned 10,448 votes (54.31%) and his Democrat opponent Tammy Grady garnering 8,788 votes (45.69%). Fann noted, "As a lifelong resident of Sampson County, I am committed to the citizens of Sampson County. My desire to serve and lead the citizens of Sampson County has been proven through my work with the Grove Park Baptist Church, Sampson Community College Board of Trustees, Clinton- Sampson Rotary Club, Sampson Agri-Expo Center Board, Sampson Regional Medical Center Foundation, and the Clinton-Sampson Chamber of Commerce. If elected, I will continue to apply my customer service approach and business experience in order to maintain a staff that promotes a commitment to serving others. I am committed to making the Sampson County Clerk of Court's Office a better place for ALL of Sampson County." Fann wanted to make sure he gave credit to his supporters and the countless volunteers that helped in his campaign.

### US House of Representatives District 7:

At the national level, Congressman David Rouzer defeated his opponents to continue in the House of Representatives District 7 where he has served since 2015. Rouzer easily defeated his opponents receiving 55.6% of the vote (155,705 votes). His Democrat opponent Dr. Kyle Horton received 119,606 votes (42.7%) and the Constitutionalist candidate David Fallin received 4,599 votes (1.6%). David Rouzer released the statement below following his re-election to serve North Carolina's 7th District: "It's an honor and privilege to be re-elected to serve the citizens of the 7th District. This race was a referendum on the great progress being made for this country and our district. The economic turnaround our nation has experienced the past two years proves that policies based on conservative principles work. I am humbled to have the opportunity to continue to fight for the principles that made this country great and serve the citizens of this district."

### NC Senate District 10:

Senator Brent Jackson (Rep) will continue to serve as Senator of the 10th District serving Duplin, Johnston and Sampson Counties in Raleigh. He will be serving for a fourth term defeating his opponent Vernon Moore (Dem). Jackson garnered 33,260 votes and Vernon Moore received 19,939 votes. Senator Jackson released the following statement after his victory: "Thank you all so much for your vote of confidence in my re-election campaign. I am most humbled by the overwhelming support shown to me throughout this election season. It is most appreciated, and I will continue working to serve the citizens of Duplin, Johnston and Sampson counties and our GREAT STATE in the NC Senate! I also want to thank all the volunteers that have worked so tirelessly this season and please know that you and all your efforts are most appreciated!"

### NC House District 22:

NC House of Representative William Brisson defeated his opponent Tony Denning to continue to serve Sampson County in NC House District 22. Brisson, a Republican, received 15,386 votes (56.7%) and Denning received 11,735 (43.3%). District 22 serves Bladen, Johnston and Sampson Counties. Brisson has served 5 terms in the NC House. Brisson said, "As a lifelong resident of Eastern North Carolina, I know the challenges that we face as a rural area. Growing up on the farm, my parents taught me the value of hard work and living as Christians. I take those values with me to the floor of the NC House. I have spent my life serving the people from the smallest local level to the State House of Representatives. My Campaign promises the same things that I have ran on since I first started in politics. To be open, accessible, honest, and to stand up for you!"

Brisson is the former Chair of the Bladen County Board of Commissioners, Chair of Bladen County Hospital Board of Trustees & Bladen Medical Center, and Secretary & Treasurer of Bladen County Farm Bureau. He currently serves on 15 committees in the North Carolina House of Representatives, with leadership positions on 5 of those committees.

### NC House of Representatives District 21:

Raymond Smith (Dem)- 11,939 53%

Robert Freeman (Rep)- 10,769 47%

### Sampson County Board of Commissioners:

District 3 winner Sue Lee holds onto the seat after getting the nod from voters on Tuesday night. She received 3,056 votes (76%) and her opponent Willie W. Bowden, Sr. (Dem)- received 965 votes (24%). Lee was elected county commissioner in 2014 and has served as vice-chair since that time. Lee noted concerning her record while on the board, "Continued improvement resonates with me more than change for Sampson County. Our county has made great strides in becoming more "customer friendly", utilizing our resources better, funding education at a higher rate, lowering property taxes, expanding our water infrastructure among other things. Personally, I would welcome a more united effort by all in moving our county forward. Sampson County is a great place to live and work. We need to attract more businesses to this area, not only to increase our tax base, but to provide jobs and incentives for our youth to return to the area post-graduation. To that end, the Commissioners have created an economic development fund to be used to fuel growth for Sampson County."


Other Sampson County Board of Commissioner seats on the ballot both ran unopposed.

Clark Wooten District 1 with 3,278 votes and Thaddeus Godwin District 5 with 2,464 votes.

### Judicial Races (Winners and Losers):

Judge Henry Stevens IV came out on top in the Judicial Race for Superior Court Judge of Sampson, Duplin, Jones and Onslow Counties District 4. His opponent was Sampson County native Judge Albert Kirby who had a strong backing from many Sampson County Republicans naming themselves, "Sampson County Republicans for Kirby." Kirby was appointed by Governor Roy Cooper in 2017 to replace the late Superior Court Judge W. Douglas Parsons.

Stevens received 46,918 votes and Kirby received 28,216 votes. Judge Stevens noted after the election results came in, "Melissa and I offer a heartfelt thanks for the truly humbling support that we have received throughout this election campaign. It has been a very long and challenging year since the passing of my friend and mentor, Judge William Douglas Parsons, and I am elated that the citizens



of Sampson, Duplin, Jones and Onslow Counties have elected me to serve in the seat on the NC Superior Court that Doug held with such honor and distinction! Thanks to all of you for your support, encouragement and votes, as well as for the hard work and sacrifice that many of you eagerly provided! I am blessed to call you my friends! I would also like to publicly thank NC Superior Court Judge Albert Kirby, Jr. for his service on the bench; his continued friendship; and especially for the graciousness he has shown toward me throughout this process. Thanks again, and may God Bless you all!"

Sarah Seaton ran unopposed for District Court representing Sampson, Duplin, Jones and Onslow Counties. She received 52,071 votes. Paul Hardison also ran unopposed for District Court and garnered 45,891 votes.

NC Supreme Court nod went to Anita Earls with 1,788,668 votes defeating her opponents Barbara Jackson (1,235,160 votes) and Chris Anglin (593,263 votes).

### Amendments

Of the six amendments that were on the ballot in 2018, only 4 of them passed with two failing to meet the criteria in the ballot box.

#### The following amendments passed:

- 1- Constitutional amendment to strengthen protections for victims of crime; to establish certain absolute basic rights for victims; and to ensure the enforcement of these rights.
- 2- Constitutional amendment protecting the right of the people to hunt, fish, and harvest wildlife.
- 3- Constitutional amendment to reduce the income tax rate in North Carolina to a maximum allowable rate of seven percent (7%).
- 4- Constitutional amendment to require voters to provide photo identification before voting in person.

#### The two amendments that failed were:

- 1- Constitutional amendment to change the process for filling judicial vacancies that occur between judicial elections from a process in which the Governor has sole appointment power to a process in which the people of the State nominate individuals to fill vacancies by way of a commission comprised of appointees made by the judicial, executive, and legislative branches charged with making recommendations to the legislature as to which nominees are deemed qualified; then the legislature will recommend at least two nominees to the Governor via legislative action not subject to gubernatorial veto; and the Governor will appoint judges from among these nominees.
- 2- Constitutional amendment to establish an eight-member Bipartisan Board of Ethics and Elections Enforcement in the Constitution to administer ethics and elections law.

Other wins for the night were Ernie Lee District Attorney who ran unopposed with 47,913 votes and Sampson Soil & Water Conservation Supervisor Henry Moore with 10,352 votes.

Service (Whiteville) over the past two decades.

His son, Joseph, III and his daughter, Laura Faircloth also work alongside Warren and his wife, Linda, at the full-service station. Warren and his wife have two grandchildren – Grace and Layton Faircloth – and are expecting a third, Warren IV.

"You know, the great thing is – I really do have it made," Warren said. "I have the opportunity to work with my family ... to me that is as good as it gets."

# We Should Know . . .



Chief Stephen Lovette with JW Simmons, Host of We Should Know

Tuesdays from 2:30 PM until 3:30 PM, J.W. Simmons hosts a radio show on 1170 AM called "We Should Know", and The Sampson Weekly will feature portions of the transcripts in our continuing efforts to bring you more coverage of what is happening in our community.

This week's We Should Know is focused on cooling weather, the holidays and fire prevention and the guest this week is Clinton's Fire Chief Stephen Lovette.

Chief Stephen Lovette has 32 years of service in firefighting beginning in 1986 with the Salisbury Fire Department.

JW Simmons begins the show stating that Clinton, NC was a very different community than where Chief Lovette came from, and he asks Lovette what it was that actually brought him to Clinton.

Lovette replies, "Coming from an organization that's 230 plus to an organization where we are about 30 provided lots of different challenges. And to be able to lead an organization like Clinton Fire Department provides me the challenges I'm looking for in the senior years of my career. Having over 30 years' experience as a career firefighter I'm enjoying it. I'm enjoying the opportunity to lead my own ship. And to lead an incredible group of individuals."

Simmons says that we are very blessed in this community to have such a dedicated mix of paid and volunteer first responders willing to get up a 2am to go to the scene of a wreck or fire, complete their mission and go home or back to work.

Lovette agrees, "Having started out as a volunteer myself, 4th generation firefighter, having the opportunity to start as a volunteer in 1984, having been raised in the fire department, having seen lots of life experiences through the volunteer aspect, I didn't choose fire service, it chose me."

"I enjoy the job," adds Lovette. "I enjoy the aspect of helping people. And that volunteer aspect should beat within our heart. But now we are in a career aspect and we don't have the luxury of volunteers. Where volunteer guys out numbered career guys 7 to 1, it's now down to about 3 to 1. And the volunteers, I'm sorry, are just kind of moving toward that threshold. I still get

the opportunity to work with some great volunteer organizations in Sampson County. I was a volunteer along with the career aspect before I moved to Sampson County. So, I was still a volunteer and I enjoyed it."

Next, Simmons asks Lovette to discuss the importance of fire safety and fire inspections and the connection of the two. Lovette begins, "A great inspection program, a great prevention program, a great public safety education program goes back to the aspect of having good community involvement."

"We need to be out, both career and volunteers, as professional out in our communities." Lovette explains that changing batteries in smoke detectors during the fall time change is a simple task that can go a long way to improve fire safety.

"So, we look at fire protection and fire prevention safety and that aspect of teaching our children what happens if our cloths catch fire, stop, drop and roll. Being able to provide a good quality educational message to the public is a very important task, not only with Clinton Fire Department but with any fire department."

Next, Simmons asks Lovette to discuss what happens in a house fire and how quickly fire can spread throughout a home. "Percentages have shown, and civilian deaths have shown that it's not the flame that kills the resident. It truly is the smoke."

"Fires burn differently now than they did 10, 15 or 20 years ago. Look at how things are constructed. What do we have in our house that doesn't have some form of plastic involved. Plastics put off nauseous fumes. They put off cyanide gases, they put off styrene and polystyrenes. All of these things that we inhale are going to cause our lungs to shut down. Once the respiratory system shuts down so to does the circulatory system. And we can't get by without either one of those, so we make sure we have good preventative measures in place."

"When we look at fire deaths holistically as a country, we look at what may have caused it. And there are certain situations where true the fire does get the individual and is their cause of death. But the inhalation hazards are just incredible. Things are not built, houses are not built, furnishings are not built as they were 10, 15 or 20 years ago because of the products of combustion."

Simmons next asks Chief Lovette to discuss recommendations for smoke detectors and carbon monoxide detectors. Lovette states, "Smoke detectors and carbon monoxide detectors detect two different things. Always, always, always look for that underwriter's seal. That way it's a tested product. It's a reputable product."

Lovette explains, "You have to determine what you want your detector to do. How and where do you want it placed. Where do you feel are your key points? Stop by any of your local fire departments we have pamphlets put out by the United States Fire Administration that we can give you to aid you in that. But look at what you want that detector to do."

"Smoke alarms. Smoke is a product of combustion. Smoke rises due to the heat put off by a fire. So, you want to see them close to the ceiling and close to bedroom doors and close to areas in our kitchen."

"Carbon monoxide detectors. Colorless odorless gas. You have to look to where you might have an issue. If you have propane or natural gas logs. If you have propane or natural gas stove. Ask a gas professional where you need to put detectors. They should be able to help you with that."

## CHS Senior Lukas Jerez Leading Dark Horses by Example

Clinton High School Senior Lukas Jerez is having an incredible senior year so far.

The 17-year-old back-up goal keeper for the Dark Horse Soccer Team and his team just played in the third round of the NCHSAA 2-A State Soccer Championships (against No. 10 Dixon in a game held Thursday night – results were not available before press time Thursday) after beating No. 18 seeded Beddingfield Tuesday night

5-1 and could possibly be headed for a championship appearance that will be held this Saturday (at 7 p.m.).

The team has been on an amazing run this season, going 21-1 through the regular season (the only loss coming from James Kenan High School on September 10 in a 3-2 final), beat Randleman 9-0 in the first round of the state playoffs.

"We came in with the mindset of returning to the playoffs this season," Jerez, who also plays tennis for the Horses, explains. "Especially for the seniors - our mindset has always been to get a ring. That is what we have always been shooting for."

Jerez and the remaining 11 seniors on the team have been working together for years.

"We have been playing together since recreational soccer," he explains. "So, the chemistry is really great between all of us. There are some new guys too, but, for the most part, we have been playing together for years. Those new guys are welcomed in like family – because we are a family."

Those seniors have been part of an incredible time for the Dark Horse program – since their freshman year, the players have only lost 12 games (going 20-6 in 2017; 21-3 in 2016; and 25-2 in 2015).

Last season, the team, seeded at No. 10, fell in a heart-breaking 3-1 loss in overtime to No. 2 seeded First Flight – one game shy of the championship game (First Flight ultimately lost to Newton-Conover 1-0).

"We knew last year that we were going to be prepared coming into this season," Jerez explains. "We have to be."

"Have to be" because the Dark Horses compete in one of the toughest 2-A conferences in the state – the East Central - A conference that includes James Kenan, East Duplin, Wallace-Rose Hill, Midway, Spring Creek and Goldsboro.

Which makes losing just 12 games in four seasons that much more of an incredible feat.

"We have always worked hard," Jerez explains. "Our goal is to go out and really compete with the other teams. As a captain, it is my job to keep my teammates motivated and try to get everyone to be at their best."

So, when did Jerez know the Dark Horses would be a force this season?

"Coming in, we knew we would have a good team," he admits. "But I really knew it was going to sink in was when we beat East Duplin for the second time ... that's when I knew we would have a chance to return to the playoffs."

This week, Jerez has been named the Performance Auto/Sampson Weekly Star Athlete of the Week.

"It feels great," the soccer standout said when told he won the honor. "I really didn't know anything about it; I am really surprised, but I am happy."

"Lukas truly understands his role on this team," notes Clinton High Head Soccer Coach Brad Spell. "It has been an honor for me as a coach to witness an individual such as Lukas who comes to practice each day willing to work as hard as he does to improve, not only himself, but the team."

Spell continues, "His work ethic is second to none and watching him inspire his teammates with his actions and words of encouragement motivates the program to strive for elite success. I know for a fact that our team, program and myself, are much better with Lukas's leadership as a captain. Lukas exemplifies the quote: 'If you are going to do something, do it right'."

A Clinton native, Jerez first foray into sports came at the recreational level.

However, playing the game never came easy for him.

"I was born with a Clubfoot and hip displacement," Jerez says with honesty. "So, I was in a body cast for a while."

His foot was turned inward at birth and his hip displacement (also called 'dysplasia') put him in cast. As he grew, he would still need a cast on his foot – but that didn't stop him from playing.

"During my elementary years, I would be on the team, but I would sit the bench," Jerez says. "But my three brothers (Francisco, Tomas and Jose Felipe) would always encourage me and tell me to just hang in there and my time would come. That is what I did."

By Middle School, Jerez couldn't be stopped. Still wearing a small cast on his foot, Jerez began playing keeper.

"It was good for me," he says. "It gave me a lot of time to focus and really learn the position."

During that time, Jerez was also diagnosed with severe scoliosis – a condition that still haunts him to this day.

"The doctors told me that I would have pain in my back and probably shouldn't play, but I was going to play," he explains. "Yes, I do have a lot of pain – but I have been used to playing with it, so I just keep moving and play through it."

During his seventh-grade year, Jerez also began playing travel soccer for the Clinton United team (team B), a team that also honed his skills in the net.

"It really helped me and my game a lot," he admits. "I was the starting goal keeper and played with them up until last year."

As a keeper, Jerez is ranked nationally at 154; and 12 in the state of North Carolina (according to MaxPreps.com). This season he has 18 saves and 7 shutouts.

"I just go out and do my best," Jerez explains. "I go out and compete for my spot every time I go on the field."

While he is enjoying his final year of high school, Jerez knows that it will only be a short time before he is moving on to college.

"It is going to be hard to leave this school," he said. "I am going to leave behind a lot of great memories and special people."

Jerez plans on going to college – in fact, he has already been accepted to a few that he has applied to.

"I want to study engineering and get my degree," he said. "I don't know if I will play soccer – if I do, that would be great, but I am going to focus on my education first."

His dream college to get into would be North Carolina State University. Jerez has applied but will not find out if he got in until after January 2019.

"Honestly, I really don't think that it has really sunk in yet," Jerez says about graduating in a few months. "I know when it was Senior Night, that was when it really hit me – when I walked out there with my parents (Jose Jerez and Nelly Chandia). It was intense."

Jerez says that the support of his close-knit family has been very crucial in his success.

"They have always encouraged me in whatever I have done," he said. "I am just very thankful that they have always been there supporting me."

It was his brother (Francisco) that gave him the piece of advice that has stuck with him since he was still sitting the bench when he was playing rec soccer.

"He told me to never let anyone tell me that I can't do something," Jerez says. "That has always stuck with me."

So now that Jerez is almost finished with his high school career, what piece of advice would he give to that upcoming freshman making the awkward transition from middle to high school?

"I would tell them to enjoy every minute of it," he said. "You know, it might suck at some point, but trust me, everything will work out for the good in the end."

In addition to his family, Jerez said that he wanted to thank his friends, teammates and his coaches, especially coach Spell.

"I have known Coach Spell since I was little," he explains. "My brothers played soccer and graduated from Clinton High School – so I have known him for a long time. He has always encouraged me and pushed me to be the best I can be – on and off the field. I would also like to thank coach Smith and coach Lanier."

Jerez also had something special for the Dark Horse fans. "They have always been great to us ... There is always a big crowd who have been there cheering for us and that is something very special."



# After The Ballot Has Been Cast

In the week after the mid-term elections, we will finally begin to see television commercials return to normal things like movie trailers, prescription drug, and car insurance ads. Slowly but surely, yard-signs telling us to vote for different candidates will come down. About the time they all come down, it will be time for more to come up for the primary season.

In the middle of the election cycle, how should we wait? What do we do after our ballots have been cast? First of all, let's address confusion about how Christians should or should not vote. Do not confuse your heavenly citizenship with your American citizenship. A Christian has no moral duty to vote in any election. Voting is a right as an American citizen, and as American's we are all blessed to live and thrive in a basically free system. It is wise for a Christian to vote and should certainly be considered, but by no means is voting a primary issue of the Christian faith. Your vote is your voice in the American system of politics, but don't be easily exploited by candidates and those who champion certain candidates. If you vote Democrat, you're not going to hell, despite what many believe and infer. If you vote Republican, you're not a religious maniac who is full of hate and intolerance. If you vote third-party, you're not casting a vote for somebody that somebody else doesn't like. 

Pray that they will lead well and fairly, giving proper consideration to the value of life and the execution of justice. We would do well to also pray that our elected officials will put politics aside for the betterment of our area. Politicians who are united for the good of their constituents and cast away party lines make voting for them next time around much easier.

**Medicare Open Enrollment** for 2019 runs through December 7th. This is the time when many beneficiaries review their current Medicare plan coverage and explore options for the upcoming year. We understand the options are many, and the answers are few. While we do not endorse any products or plans, our Patient Financial Services Department does offer these tips:

**1** There is a difference between a Medicare plan with a supplemental and a Medicare Advantage plan. Medicare Advantage plans are paid by Medicare to cover the beneficiaries who choose their plans. They may have different rules, such as requiring pre-approval (authorizations) for services that traditional Medicare automatically covers. They may also have higher copayments or deductibles than Medicare, especially if you are out of network for services. Plan designs may be different, so we caution you to ask. Always read the details!

**2** The plans can and do change from year to year. For example, vision coverage may be included in your plan this year but removed next year. A benefit, such as skilled nursing, may also change, say from 30 days this year to 10 next year. Deductibles and coinsurance are subject to change as well. Again, be careful as you select your plan, and read the details.

**3** Know if your providers are contracted with your insurer. Not every physician, hospital, or service provider is contracted with every insurer. Sampson Regional Medical Center, for example, currently has one signed Medicare Advantage contract. We do not believe it's right for an insurance company to sell a product in a county where the hospital is not contracted. It puts the hospital in a position to bill the beneficiary for services provided or deny non-emergency services for Medicare Advantage beneficiaries.

Sampson Regional Medical Center currently has a signed Medicare Advantage plan with **Blue Medicare** and **Aetna**. We cannot contract with insurance companies that offer to pay less than what traditional Medicare will pay. As such, we are not likely to agree in terms with United Healthcare (which is different than the AARP supplemental insurance plan) for their Medicare Advantage plan. We are in active discussions with Gateway for their Medicare Advantage plan but cannot guarantee at this point we will agree in terms by end of open enrollment. We currently do not have any contracts with Humana, nor are we in discussion with them.

We advise you to please be careful in making changes. The rules are different between Medicare Advantage plans and traditional Medicare. If you move to a Medicare Advantage plan, you can always get your Medicare plan again, but you will not be guaranteed that you can pick up your secondary insurance plan again.


## RALEIGH




