Sampson County Health Dept. to Make Appointments to Vaccinate 65 and Older

Given updated State guidance on vaccine administration, the Sampson County Health Department will start scheduling appointments for the COVID-19 vaccinations for the group aged 65 and older effective Tuesday January 19th. (As a reminder, County Offices will be closed Monday, January 18th in observance of the MLK Day holiday.)

Appointments can be scheduled by calling the Sampson County COVID-19 Helpline at 910-490-1056, Monday through Friday, 8:00 am 4:30 pm. Due to the high volume of incoming phone calls, you may experience a busy signal. Please be patient and try again later. You may also need to leave a message. If you do so, someone will contact you within 24 hours.


GILMORE SWORN-IN AS JUDGE



On New Years Day, Robert Gilmore of Clinton was sworn in as a District Court Judge in Sampson, Duplin, Jones, and Onslow counties by Resident Superior Court Judge Henry L. Stevens, IV following his four county sweep in the November elections. Due to the COVID-19 pandemic, the oath was administered to an audience of Mr. Gilmore's immediate family. Before the oath was given, Ross Holland of the Sampson County Bar did the traditional honor of presenting Gilmore to the Court for his oath. In his remarks, Holland stated that, "Robert will do a great job as a judge. We all know he's a smart guy; he graduated valedictorian of his law school class. But, he also has a head full of common sense, and that's what this job takes a lot of. Earlier this week, the General Assembly officially reconvened to kick-off the 2021 Legislative Session. During the ceremony, I was officially sworn-in and seated on the Senate floor to serve the people of Senate District 10. Legislative Recap- Senate Resolution 1

Session for the 2021-22 biennium has officially begun, and with that come new bills primed for consideration in the General Assembly. The very first bills passed by each chamber, House Resolution 1 and Senate Resolution 1, establish the rules by which each body will operate during the two year period. On the Senate side, the rules layout procedures for Committees, quorums, conduct on the Senate floor, and much more.

It is vital that these procedures be followed so as to maintain an orderly session each time the members meet. At the end of the day, the General Assembly and its members represent the people of North Carolina and the rules established help keep the process tidy, transparent, and respectful.



From the District- Sampson County- Sampson DSS receives \$371K to aid heating bills According to the Sampson County Department of Social Services, \$371,669 has been allocated this year to their Low Income Energy Assistance Program (LIEAP), which helps those in need pay their heating bills and is now officially being offered to the public.

DSS has noted that around 576 people were automatically approved due to the fact that they received LIEAP funds last year, were 60 years of age or older in December, or someone in the household received the Department of Aging services.

The one-time payments are either going to be \$300, \$400, or \$500. But it also takes into

In December, people were approved for funds based on their heating source. If they used wood, they received \$400 and if they used gas they got \$300, and those who utilize electronic heating got \$500.

For the regular LIEAP, people may be eligible based on the number of people in the home, income, and type of heating source. According to Price, the minimum payment maybe \$300 and the max will be \$500. On average people get approved for \$300.

All households may apply from now until March 31 or until funds are exhausted.

According to DSS, the target population is elderly and disabled. It is too early to have a response rate for how many people have called to fill out the application. However, staff members have steadily gotten phone calls related to LIEAP funding. It is up to them to fill out the rest of the application.

To apply, access, and complete an online application via https://epass.nc.gov/; call the agency to complete the process by phone; fax a paper application; mail a paper application or drop a paper application in the agency's external dropbox.

Vendors can register with DSS if they aren't already. DSS looks at unearned and earned income and resources.

Questions about the LIEAP Program can be answered by calling the Sampson County Department of Social Services at 910-592-7131, Monday-Friday, 8 a.m. until 5 p.m. The operator will direct callers to the right location.

Councilman Neal Strickland shared the fact that Council members felt that the Christmas trees made the city look like a Hallmark movie.

Raynor, Roberts, and Kearns stated that residents should just wait to see what's in store for Christmas 2021. They are planning for next year and hope the businesses will get involved and let volunteers decorate their stores more this year.

Roberts noted that it may not replace Christmas in the City this year but it might change the way things are done from here on out. Raynor hopes that the Christmas Tree Project will coincide with the Christmas in the City event and add to the tradition.

judge." Judge Stevens then administered the oath with Gilmore's wife Ashley holding the family Bible. In brief remarks, Judge Gilmore stated that "only in America" could someone like him, not born to privilege or a political family, aspire to serve as a judge and achieve it. Gilmore, moved by the moment, stated that he was not an extraordinary person; rather, he is an "ordinary person surrounded by extraordinary people throughout his district that believed a conservative court was necessary." Then, he thanked his family present and supporters that could not attend due to the Governor's COVID-19 restrictions. Judge Billy Sutton acknowledged his long relationship with his new colleague stretching back to his daughter attending high school with Gilmore and predicted a bright career ahead for him and great service for the district. Judge Stevens spoke about Gilmore's skill and ability in the courtroom and was certain those skills would readily translate to the new role. In a statement, Judge Gilmore stated that, "I want to thank all of my supporters and the voters. This was a group effort. We had volunteers, donors, and the community ready to help make this happen, and it would not have without them." Judge Gilmore wasted no time using his new robe as he held court on Monday in Sampson County, calling it "a true honor to hold court for the first time in my home County that has afforded me so much. Once the COVID-19 restrictions are lifted, I would encourage the public to attend court. This is your courtroom, and it is the people's court."

Please be aware that vaccinations will be dependent on available supply, and an appointment does not guarantee vaccine will be available at that time. The Health Department is also planning a mass vaccination clinic for the 65 year and older group, which will be publicized next week via the County's social media (Facebook and Twitter) and webpage (www.sampsonnc.com – COVID PAGE https://bit.ly/38MyaSv) and local media sources.

The COVID-19 vaccine is a tested, safe and effective vaccine that is available to all who want it, but supplies may be limited at first. To save lives and slow the spread of COVID-19, state and federal public health advisories recommend first protecting health care workers

caring for patients with COVID-19, people who are at the highest risk of being hospitalized or dying and those at high risk of exposure to COVID-19. It is encouraged to all to continue to keep practicing the #Ws: Wear a Mask, Wait Six Feet Apart, and Wash Your Hands until everyone has a chance to get vaccinated. The Sampson County Drive-Thru COVID Vaccination Clinic held on Wednesday at the Sampson Agri Expo Center was a huge success, vaccinating approximately 570 people over the age of 75. The event was scheduled to last until 4pm but was cut short due to the huge demands. The event ended at around 11:15am one all available vaccines were administered.

According to Sampson County Government, "There is a long list of people to acknowledge for helping us have a successful vaccination event today (Wednesday): our Sampson County Health Department staff, our Emergency Services team, our Expo Center staff, our Public Works staff, and the Clinton City Police Department. Kudos to all of you for planning, conducting and managing a successful event that brought vaccines to about 600 citizens."




Now it is my time - my voice now crackles with age - but oh how I claim that same manifestation of my dedication to, and my love

Defeating Depression



Psalm 34:17-18, "When the righteous cry for help, the Lord hears and delivers them out of all their troubles. The Lord is near to the brokenhearted and saves the crushed in spirit."

At some point in everyone's life they will be faced with a day, week or even a season of depression. Perhaps it is the death of a child, unemployment or there is no known reason why you walk in the cold darkness of depression. The Mayo Clinic describes depression as a mood disorder that causes a persistent feeling of sadness and loss of interest. Also called major depressive disorder or clinical depression, it affects how you feel, think and behave and can lead to a variety of emotional and physical problems. You may have trouble doing normal day-to-day activities, and sometimes you may feel as if life isn't worth living.

A recent USA Today article said Christian culture, especially Southern evangelicalism, creates the perfect environment for depression. Counselors say pastors suffer in silence, unwilling or unable to seek help or even talk about it. Sometimes they leave the ministry. Occasionally they end it all. When we find ourselves at this point of no return we should turn to the words of Jesus in Matthew 11:28-30, "Come to me, all you who are weary and burdened, and I will give you rest. Take my yoke upon you and learn from me, for I am gentle and humble in heart, and you will find rest for your souls. For my yoke is easy and my burden is light."

Depression can wage war against you regardless of your passion for Jesus. In fact several heroes of the faith like King David, the Prophet Elijah and Moses all faced depression. The one common factor that those Biblical champions had was to turn to God for their hope. They were willing to open up to God with their hearts in pain. These men didn't fake their feelings just to appear strong to those around them. They were authentic in standing before God who could see their inward pain.

C.S. Lewis wrote in his book, The Problem of Pain, "Mental pain is less dramatic than physical pain, but it is more common and also harder to bear. The frequent attempt to conceal mental pain increases the burden: it is easier to say "My tooth is aching" than to say "My heart is broken." When we allow the voice of the enemy to convince us that there is no hope we should turn towards the true lasting hope in Jesus. As a Christian we might feel at times defeated, but in Christ we can find joy.


David cried out to the Lord in Psalm 143:7-9, "Answer me quickly, O Lord! My spirit fails! Hide not your face from me, lest I be like those who go down to the pit. Let me hear in the morning of your steadfast love, for in you I trust. Make me know the way I should go, for to you I lift up my soul. Deliver me from my enemies, O Lord! I have fled to you for refuge." If a giant conquer can have his spirit fail, so can we. There is no shame in wiping tears from our face, but never forget that Christ knows why every tear falls.

Harrells Christian Academy football standout Devin Gardner



Harrells Christian Academy football standout Devin Gardner said he was "surprised" when told he was named this week's Performance Auto/ Sampson Weekly Star Athlete of the Week.

"I was really surprised," the 18-year-old junior fullback said earlier this week. "I didn't know anything about it. But I am honored."

The honor should come as no surprise, Gardner had an incredible football season for the Christian Crusaders, running 1,463 total yards and scoring 20 touchdowns, helping lead the team to the NCISAA State Championship.

"It was something that we talked about since I came here," he explained. "I came here from Wallace-Rose Hill and ever since then, that is what we talked about (getting to the state championship)." Gardner said that he got started in football in recreation when he was about 8-years-old. "I was put on a team playing against 9-10 year olds, which, I think, made me a stronger player, " he said. "I got involved after watching my cousins play and I wanted to play too."

He says he developed his own style of running even though at first he was a lineman. "At first, because of my size, I couldn't run the ball, so they thought I would be better on the line."

Once he grew into the part, Gardner, a fan of the Pittsburgh Steelers, felt comfortable enough to transition into a fullback. "You have to trust your line," he said. "They are the ones who are making those holes for you and these guys worked so hard this year, I trust them."

Coming to Harrells at the beginning of the year was something that Gardner wanted to do. "They didn't use me at Wallace-Rose Hill and I didn't get a lot of playing time, so when I came here, I felt like I had something to prove."

Boy did he ever prove it. Gardner averaged 170 yards per game this season.

"I wanted to finish strong," he said. "Playing in the state championship was fun. We were still in it – it was 28-19 at the half and we felt like we had a chance. We just had to keep fighting. After the loss, I was really upset because our boys really fought hard all year long."

In his first season at Harrells, Gardner said that his time was made easier by the people welcoming him.

"Oh yeah, right away, I felt welcomed here," he said. "As soon as I came here, I felt like everyone was family.it is a lot smaller than Wallace-Rose Hill, so class-wise you get a lot more attention, which is great because you have the more one-on-one with your teachers because the classes are smaller."

Gardner said that in addition to his teachers and teammates, his coaches have been welcoming as

"Coach Arnette has to be one of the best coaches I've ever had," he said.

Which will be why it will be difficult to leave next year when he graduates. "It will be hard to leave Harrells because I already feel close to everybody here," he said. "I already know that I am going to miss the class of 2021 because I have made many friends."

Although he is planning on going to college, Gardner said that he doesn't know which one he will go to. "I am not too picky," he admits. "Whoever wants to give me a scholarship –that's where I'll go."

He said that his ultimate dream is to play in the National Football League (NFL), but wants to get his degree in Criminalology.

"I watched a lot of Criminal Minds," he said. "So, I think that I will definitely go into law if the pro football career doesn't work out."

He says he is thankful for the support of his family, especially his mother (Cynthia) and his sister (Bynteo) and his teammates.

"I just like to thank the entire team," the straight 'A' student said. "We just all clicked. There was no negativity. And my coaches and the Harrells community for making me better."

SCC Graduate Makes Journey from Nicaragua to UNC Medical School

(CLINTON, N.C.) – In 2010, Marvin Albert Meza Jarquín, his parents, and his four siblings immigrated from Nicaragua to North Carolina. In Nicaragua, Marvin's family consisted of coffee and cattle farmers. He had grown up in Nicaragua until he was sixteen years old. When his family moved to North Carolina, Marvin continued his high school education in the United States. After finishing high school, Marvin decided to take another step on his educational journey at Sampson Community College (SCC).

When moving to the United States, Marvin had to learn the English language. Back in Nicaragua, Marvin was eligible to graduate, but when he and his family immigrated, he had to restart his high school education. Marvin attended Lakewood High School and was able to graduate in two and

half years. While in high school, Marvin knew that he wanted further his education by attending college. He wanted to save money, so he decided to attend SCC for two years to earn both his Associate of Arts and Associate of Science degrees.

When asked about his time at SCC, Marvin replied, "I had wonderful instructors that were supportive from the get-go. Some were more challenging than others and I cherish that they were challenging because the University of North Carolina is very rigorous. There was never a teacher who wasn't helping me grow as a student and who wasn't giving me the right amount of challenge."

While at SCC, Marvin knew that he wanted to transfer to a university after graduation. In 2015, he transferred to the University of North Carolina at Chapel Hill (UNC). While at this four-year university, Marvin received a bachelor's degree in Biology, with a second major in Spanish literature. He chose this as a double major because he wanted to stay connected with his Hispanic culture.

While at UNC he was a teacher assistant in organic chemistry, he wrote for a bilingual magazine, and he also instructed students at a bilingual elementary school. Marvin is currently enrolled in the University of North Carolina School of Medicine in Chapel Hill.

Marvin stated, "What made me really gravitate towards medicine was witnessing some discrepancies in healthcare outcomes for patients in rural areas, for example Sampson County. There is a very large percentage of uninsured people there. I think it is close to eighteen percent in Sampson County. To me that is unacceptable and because of that, there will be poor health care outcomes because people cannot go to the doctor because they cannot afford it."

Marvin has had to work extremely hard to get to where he is today. While at SCC his hard work did not go unnoticed. He has truly gone the extra mile. From coming to the United States, having to attend high school over again, to now being on track to become a health professional, Marvin has put in the hard work to accomplish his goals.

Jennifer Eavenson, SCC Math Instructor, commented on Marvin's efforts during his time at SCC.

"Marvin was determined to be successful. He worked exceptionally hard in order to graduate early. He was bright, articulate and had a personality to match his wit. He instantly put those around him at ease and had them smiling in no time. Marvin has a heart of gold and I have no doubt he will be a great leader wherever he goes." Eavenson stated.

His time at SCC was a key steppingstone in his educational path. While at SCC, Marvin recognized the wonderful and supportive instructors that he was in constant contact with. Marvin also noticed the challenge that his SCC courses and instructors provided him with him. He believes that he needed these challenging courses for the time that he spent at UNC.

Marvin Albert Meza Jarquín has a great future ahead of him after he graduates from medical school. Though, he has not decided what type of medicine that he is going to specialize in, he potentially wants to pursue primary care. He knows that he wants to return to Sampson County to give back to the community. Sampson Community College is immensely proud to be one of the many stops along Marvin's path.

FAIR OAKS RANCH, TX (formerly of Faison) William Edgar Thornton, M.D., a retired astronaut, medical professor and inventor, passed away January 11, 2021 at his home in Fair Oaks Ranch, TX with his wife Jennifer by his side. He was born on April 14, 1929 in Faison, NC to the late William E. Thornton and Rosa



B. Thornton. There will be a small graveside service at a later date in Faison. While attending Faison High School he opened a radio repair shop and used the profits to pay for college. He earned a Bachelor of Science degree in physics in 1952 from the University of North Carolina. Dr. Thornton enlisted in the United States Air Force where he served as the officer-in-charge of the USAF Instrumentation Laboratory at the Flight Test Air Proving Ground at Elgin Air Force Base, Florida. In working to improve air-to-air combat defenses, Thornton discovered that rockets could be tracked by radar. He developed the Radar Optic Firing Error Indicator (ROFEI), or Thornton Scorer, which was the first practical means of evaluating and maintaining the accuracy of interceptor aircraft. The Thornton Scorer was highly successful and Thornton, as a Second Lieutenant, was awarded the Legion of Merit in 1956. After leaving the military in 1956, he worked as the chief engineer of the electronics division at Del Mar Engineering Labs in California. Thornton married the former Elizabeth Jennifer Fowler from Newgate Street, England in 1958 and they had two sons. In 1959, he decided to continue his education and enrolled in medical school at the University of North Carolina. After graduating in 1963, Dr. Thornton returned to active duty and was sent to the USAF Aerospace Medical Division at Brooks Air Force Base in San Antonio. Thornton invented a mass measuring device to determine the weight of items in space which is still in use today. Dr. Thornton was selected as a member of the second class of scientist-astronauts in 1967. In 1972, he participated in the Skylab Medical Experiment

Altitude Test (SMEAT), a 56-day simulation of an American Skylab mission at NASA's Manned Spacecraft Center in Houston, Texas. Dr. Thornton logged over 313 hours in space aboard two missions; STS-8 Challenger (August 30-September 5, 1983) and STS-51B Spacelab 3 Challenger (April 29-May 6. 1985). During the STS-8 mission, he was responsible for making continuous measurements and investigations of the adaptation of the human body to weightlessness. These experiments included a number of first-time measurements on the human nervous system while in space. During the Spacelab 3 mission, Dr. Thornton's responsibilities included the management of the first animal payload in manned flight. Dr. Thornton holds over 60 issued patents that cover a wide range of applications from military weapons systems to the first real-time EKG computer analysis His space related patents include the Shuttle treadmill for in-flight exercise, shock and vibration isolation systems, and an improved waste collection system. In May of 1994, Dr. Thornton retired from NASA and became a Clinical Professor of Cardiovascular Physical Diagnosis at UTMB. In an effort to improve learning, he developed a hybrid hardware/software system simulating the process of auscultation. With this invention the ability of medical students to recognize anomalies in patients' hearts was greatly increased. While in his 80s Dr. Thornton spent several years writing "The Human Body and Weightlessness" a comprehensive textbook on the effects of spaceflight on the human body and solutions. Dr. Thornton was instrumental in the refurbishment of many structures in his hometown of Faison. In addition, he successfully reintroduced long leaf pine to the family farm outside Faison and planted 8000 trees knowing he would be gone long before they reached maturity. It was his desire to return the farmland to the forest of his youth. Dr. Thornton is survived by his wife of 62 years, Jennifer Thornton; son William Simon Thornton and wife Mary Kay Thornton of Fair Oaks Ranch, TX; son James Fallon Thornton, MD and wife Katina Thornton, MD of Dallas, TX; and grandchildren Nicholas Thornton, Alexandra Valentine, Michael Thornton, Sarah Thornton, Ava Thornton, Elizabeth Thornton, Alexandra Thornton, Victoria Thornton and Emily Thornton.

That's right. The NASCAR offseason is barreling toward the finish line, with the Busch Clash and Daytona Speedweeks so close you can almost hear the haulers rolling down I-95.

While teams will spend the first three weeks of 2021 in Florida, the grand prize this NASCAR season is again in Phoenix, which will serve as November's championship race. And if you want to make some money, the smart people in Vegas are saying Kevin Harvick is your man ... again.

First gear

Last week, BetOnline named Harvick the betting favorite to win the '21 championship at 5/1 odds, followed by a slew of guys at 7/1, including Chase Elliott, Denny Hamlin, Joey Logano and Kyle

This isn't anything unusual, either. In fact, since 2016, Harvick has entered the season the betting favorite in various sports-books every year except 2018, when Kyle Busch was the pick. Unfortunately, any futures bet didn't exactly pan out, as Harvick hasn't won a title

The Speedway also released a picture last week of the first batch of dirt arriving at the track and a layer of sawdust being laid down. Who knew dirt could be this exciting?
