

## FEMA to Help Pay Funeral Costs for COVID-19-Related



In early April, FEMA will begin providing financial assistance for funeral expenses incurred after Jan. 20, 2020 for deaths related to coronavirus (COVID-19) to help ease some of the financial stress and burden caused by the pandemic. The policy was finalized today, and FEMA is now moving rapidly to implement this funeral assistance program nationwide.

"At FEMA, our mission is to help people before, during and after disasters," said Acting FEMA Administrator Bob Fenton. "The COVID-19 pandemic has caused immense grief for so many people. Although we cannot change what has happened, we affirm our commitment to help with funeral and burial expenses that many families did not anticipate."

To be eligible for COVID-19 funeral assistance, the policy states:

-The applicant must be a U.S. citizen, non-citizen national, or qualified alien who

## From the Desk of Senator Brent Jackson



Wednesday morning, the North Carolina Senate Redistricting and Elections Committee heard The Elections Integrity Act - S.B. 326

The bill has four main components:

- -It bans third party donations to the Board of Elections;
- -It requires absentee ballots to be in by close of business on Election Day;
- -It changes the deadline for requesting absentee ballots to make it almost impossible for the postal delay to cause a ballot to be received late.
  -It also provides \$5 million for a mobile ID unit so that all eligible voters can get the ID
- they need to participate in an election.

Our entire system of government is based on fair elections. It's how we select the people who will govern us. Obviously, any potential fraud in an election undermines that confidence. But distrust and suspicion in an electoral process also undermines confidence and can be just as damaging. Our goal with this legislation is to work to restore that trust.

Private interests giving money to the people responsible for administering an election would create, at a minimum, the perception of a major conflict. Counting the votes needs to be free from any perception of conflict, especially from third-party donors. And requiring absentee ballots to be in by close of business on Election Day is a sound policy to create trust in our system. Every day that passes after Election Day with votes still coming in creates the possibility of distrust in the process.

Ideally, we'd have a winner for every election on election night. Sometimes, in close races, that's not possible, especially if there's a recount or some other issue. But requiring that at least all the votes are in on Election Day helps minimize the delay in declaring a winner and, for the most part, helps wrap up the process quickly.

There was a lot of concern last year that some people would wait until the last minute to request an absentee ballot. Because the ballot request deadline was so close to Election Day, there was a very real chance that somebody would not have enough time to get a ballot sent to them in the mail and then send it back before the ballot receipt deadline. That created a host of problems. The provision in this bill minimizes the chances of that happening again by moving back the absentee request deadline to make it almost impossible for postal delays to result in an uncounted ballot.

After being heard Wednesday, the bill will continue through the legislative and committee process before eventually being voted on in committees and then sent to the Senate floor for a vote.

## Legislative Recap- H.R. 1319

H.R. 1319, also known as the "American Rescue Plan Act of 2021," is a bill written by Congress in the House of Representatives and signed into law earlier this month. The bill adds over \$1.9 trillion in federal spending, some of which has been allocated to the states to respond to the COVID-19 pandemic. This funding is limited to expenses that are related to the pandemic and has an expiration date by which the funds must be allocated.

The complication of this bill adds a new level of complexity to our normal budget process as there are now multiple funds with varying restrictions to consider when appropriating for this biennium. Additionally, we do not know how the remainder of the year will play out as far as the economy or pandemic goes. That said, we fully anticipate and hope to pass a full state budget and further COVID-19 response legislation by the end of this year. Once those bills are filed, we will be able to update you on the contents of those pieces of legislation.

Mesimer named SCS Finance Officer





## Sampson County Native Serves Aboard "Fast And Feared" U.S. Navy Warship



A native of Clinton, North Carolina, is serving in the U.S. Navy aboard USS Donald Cook, a guided-missile destroyer, forward-deployed to Rota, Spain. Donald Cook is currently on her 11th patrol of the U.S. Sixth Fleet area of responsibility in support of U.S. national security interests in Europe and Africa, operating in the East Atlantic, Mediterranean Sea, and the Black Sea.

Chief Petty Officer Joshua Mclellan, a graduate of Union High School in Rose Hill, NC and Southern Illinois University at Carbondale, Illinois, joined the Navy almost 20 years ago.

USS Donald Cook is named after U.S. Marine Corps Col. Donald Cook, who posthumously received the Medal of Honor for his selfless acts as a Prisoner of War during the Vietnam War. Cook shared food and medicine with his fellow prisoners, despite his own deteriorating health.

USS Donald Cook remembers his legacy by flying a POW flag at all times. According to Navy officials, guided-missile destroyers are capable of conducting anti-air warfare, anti-submarine warfare, and anti-surface warfare. Fast, maneuverable, and technically advanced, destroyers provide the required warfighting expertise and operational flexibility to execute any tasking at sea.

Donald Cook is one of four destroyers based in Rota, Spain, assigned to Commander, Task Force 65 in support of NATO's Integrated Air Missile Defense architecture. These Forward-Deployed Naval Forces-Europe ships have the flexibility to operate throughout the waters of Europe and Africa, from the Cape of Good Hope to the Arctic Circle, demonstrating their mastery of the maritime domain.

With more than 90 percent of all trade traveling by sea, and 95 percent of the world's international phone and internet traffic carried through fiber optic cables lying on the ocean floor, Navy officials continue to emphasize that the prosperity and security of the United States are directly linked to a strong and ready Navy.

According to Chief of Naval Operations Adm. Mike Gilday, four priorities will focus efforts on sailors, readiness, capabilities, and capacity.

As a member of the U.S. Navy, McLellan, as well as other sailors, know they are a part of a service tradition providing unforgettable experiences through leadership development, world affairs, and humanitarian assistance. Their efforts will have a lasting effect around the globe and for generations of sailors who will follow.

## Did you know that the person who invented and introduced finger painting in the Education System was from Duplin County?

Ruth Faison Shaw (1889–1969) was an American artist, an educator who is credited



969) was an American artist, an educator who is credited with introducing finger painting into the USA as an art education medium. She developed her techniques while working in Rome, Italy, patenting a safe non-toxic paint in 1931.

Shaw was born in Kenansville, North Carolina, on October 15, 1889. Her father was a Presbyterian minister and she had four brothers. She attended elementary school in Cabarrus County, North Carolina. She graduated from a Presbyterian girls school, the James Sprunt Institute, in 1906. After graduation, she gained some experience as (an untrained) school teacher in the Appalachian Moun-

tains in Transylvania County, North Carolina.

In 1918 Shaw traveled to France and Italy with the Young Women's Christian Association (YWCA), before setting up a school in Rome

Shaw is credited with developing the art of finger painting and later introducing it into the American education system. She later claimed she had been inspired when she saw a child smearing iodine onto a wall, realizing children liked to 'smear'. This event took place in 1926 when Shaw had already founded an experimental school, the Shaw School, for English-speaking children. Shaw developed the techniques and materials required for finger painting. In 1931 she patented a gelatinous paint medium that would be safe for children.

Shaw returned to the USA in 1932. She took a job in the progressive Dalton School in New York City, where she introduced finger painting to the curriculum. An exhibition of finger painting art took place in Manhattan in 1933. She published several books on finger painting.

## Drug Seizure-Hunt Lane

Methamphetamines, Cocaine, and Fentanyl Among the Drugs Seized

On March 26, 2021, Investigators with the Sampson County Special Investigations Division executed a search warrant on 146 Hunt Ln. This was in response to an on-going investigation into complaints at the location.

During the search warrant, 44 pounds of crystal methamphetamines, 16 pounds of cocaine, 1, 221 blue counterfeit pulls containing fentanyl, 4 rifles, 2 pistols, 2 vehicles, and \$38,000 in U.S. currency was located. The drugs have an estimated street value of \$1.1 million.

As a result, Rumulo Medrano, 32, H/M of 146 Hunt Ln., Clinton, NC was taken into custody and charged with Trafficking Methamphetamine, Trafficking Cocaine, Maintaining a Dwelling for Sale of a Controlled Substance, Maintaining a Vehicle for Sale of a Controlled Substance, and five counts of Possession of a Firearm by Felon. A bond was set at \$1 million.

incurred funeral expenses after Jan. 20, 2020 for a death attributed to COVID-19.

-If multiple individuals contributed toward funeral expenses, they should apply under a single ap-

plication as applicant and co-applicant. FEMA will also consider documentation from other individuals not listed as the applicant and co-applicant who may have incurred funeral expenses as part of the registration for the deceased individual.

An applicant may apply for multiple deceased individuals

-An applicant may apply for multiple deceased individuals.

-The COVID-19-related death must have occurred in the United States, including the U.S. territories and the District of Columbia.

-This assistance is limited to a maximum financial amount of \$9,000 per funeral and a maximum of \$100 per funeral

-This assistance is limited to a maximum financial amount of \$9,000 per funeral and a maximum of \$35,500 per application.

Funeral assistance is intended to assist with expenses for funeral services and interment or cremation.

In the coming weeks, a dedicated 800 number will be established to help individuals who apply. In the meantime, potential applicants are encouraged to start gathering the following documentation:

-An official death certificate that attributes the death to COVID-19 and shows that the death occurred in the United States. The death certificate must indicate the death "may have been caused by" or "was likely the result of" COVID-19 or COVID-19-like symptoms. Similar phrases that indicate a high likelihood of COVID-19 are considered sufficient attribution.

## **Clinton City and Sampson** County Schools Take the 'NC First in FAFSA' Challenge to **Send More Students to College**

High schools across North Carolina are competing for grants in the School Challenge

Clinton City, NC - Clinton City Schools and Sampson County Schools have officially accepted North Carolina's First in FAFSA Challenge to help send more local high school seniors to college. Union High School and all of Clinton City high schools are competing against each other and hundreds of other high schools across the state to increase their FAF-SA completion rates.

myFutureNC, along with Carolina Demography, College Foundation of North Carolina, College Advising Corps, the Hunt Institute, and the John M. Belk Endowment, are sponsoring the NC First in FAFSA School Challenge to motivate students to take full advantage of free federal aid to help them pay for college. Studies show students who complete the FAFSA are far more likely to enroll in higher education.

"The FAFSA is the first step to free or affordable college so we are thrilled to see 100% of our school districts across North Carolina participating in our First in FAFSA Challenge,' said Cecilia Holden, CEO of myFutureNC. "We are especially grateful to the district leaders, school principals, counselors, faculty, and staff at these high schools who are helping so many students and their families complete the FAFSA and take that first step for a lifetime of opportunity and success."

NC First in FAFSA launched the inaugural FAFSA Challenge this semester to encourage high schools to earn the highest FAFSA completion rate and implement innovative strategies to support FAFSA completion locally. 494 North Carolina high schools or 75% of public high schools across the state have registered for the challenge.

Schools compete in the Challenge with schools of similar size and type, with winners earning a \$500 grant in each of the following categories:

- -Highest percentage of completed FAFSAs
- -Highest percent increase in FAFSA completion rate
- Best FAFSA completion strategy

The Challenge will conclude on June 30th, 2021 with winners announced by July 31st, 2021. Schools can keep track of their progress with the NC First in FAFSA Tracker to identify specific areas of need and create targeted efforts to increase attainment. Final FAFSA completion rates are calculated using FAFSA completion data from the U.S. Department of Education and final high school graduation counts from NC DPI.

Currently, Cooperative Innovative High Schools (CIHS) are not listed in the Leaderboard for data limitation reasons. CIHS schools include an array of graduating seniors by grade level which makes it challenging to calculate the true FAFSA completion rate for these

Updates to the leaderboard are made on the second Tuesday of each month. Winners will be announced in Summer 2021.

## ABOUT NC FIRST IN FAFSA:

NC First in FAFSA is a myFutureNC Collaborative that focuses on increasing the number of high school seniors who complete the FAFSA application. Increasing the Free Application for Federal Student Aid, or FAFSA, completion rate is a fundamental step in North Carolina's efforts to meet our state's 2 million by 2030 postsecondary educational attainment goal Students who complete the FAFSA are more likely to enroll in higher education, persist in their college coursework, and obtain a degree.

UMO students. "Change has been rapid," he said. He praised both faculty and staff for their dedicated efforts in providing students with exceptional opportunities, and "keeping the wheels turning regardless of how bumpy the path may be."


Let's Draw a fun Astronaut!

2. Using the stick figure as a guide, start adding tubes and ovals around it.


The stick figure gives your drawing a nice, solid, "foundation".

It's better to draw the stick figure first. It's like drawing the bones, and THEN adding the muscles.



Just think what an impact we could have if we simply lived thus: "I was on my way to the Savior and ran into serving and loving others!"



## Romans 3:23, "For all have sinned, and come short of the glory of God;"

How often do you hear someone use the word sin? Merriam-Webster defines sin as an offense against religious or moral law. Some might say that when we commit sin we are missing the target of God's holy standard. The apostle Paul writes about sin in Galatians 5:19-21, "Now the works of the flesh are obvious: sexual immorality, moral impurity, promiscuity, 20 idolatry, sorcery, hatreds, strife, jealousy, outbursts of anger, selfish ambitions, dissensions, factions, 21 envy, drunkenness, carousing, and anything similar, about which I tell you in advance-as I told you before-that those who practice such things will not inherit the kingdom of God." It is difficult for many individuals to acknowledge they are sinners. However, we have to acknowledge that we are sinners if we are to ever find the right standing with God.

We know that from the Bible everybody is a sinner. Regardless of our skin color, the size of our checking account or our political allegiance, we all find ourselves in the cold pit of sin. Unless we are willing to confess our sins to God and turn to Him for forgiveness we will remain in the pit. God offers His grace and mercy to anyone who will reach out to Him. We may try to pull ourselves out of the pit of sin by doing good deeds, but we will always come up short. Only through the work of Jesus can we overcome our sinful past.

If we deny or ignore that we need the grace of God we are living a lie. Without admitting our sin nature, we can never reach that feeling of reconciliation with God that is necessary to spend eternity with Him in Heaven. David, the psalmist wrote in Psalm 32:5, "I acknowledged my sin to You, and my iniquity I have not hidden. I said, "I will confess my transgressions to the Lord," and You forgave the iniquity of my sin." It takes courage to admit our transgressions to God like David did. Our life will be filled with joy in the forgiveness found in God.

Many might think that the Bible is outdated and its view of sin is archaic, however God does not change. We might want to ignore the Bible because it convicts us of our wrong, but that would be playing right into the hands of the enemy. Dwight L. Moody proclaimed, "The Bible will keep you from sin, or sin will keep you from the Bible." By turning away from the Bible, we are much like a sick person that has the medication in front of them, but refuses to take it.

John Wycliffe proclaimed, "Trust wholly in Christ; rely altogether on His sufferings; beware of seeking to be justified in any other way than by His righteousness. Faith in our Lord Jesus Christ is sufficient for salvation. There must be atonement made for sin according to the righteousness of God. The person to make this atonement must

be God and man." Sin will drive a deep wedge between us and a relationship with God. Sin that is left unchecked will destroy families, friendships and fortunes. Sin might taste sweet like rat poison, but its path leads to death.

This week I encourage you to confront your sins with the knowledge that Christ can forgive. We are loved by the One who gave His only son to pay the price for our rebellion. Even when you have been forgiven by Christ some might want to remind you of your dark past or your time spent in the pit of sin, but be of good cheer that Jesus has destroyed any record of our sin.



## NASCAR got dirty, and it was great

Well, that was ... something.

No, forget that. I'm not going to toe the line. After seeing NASCAR's first dirt race in 51 years Monday at Bristol, I am all in on more dirt racing.

Well, me and Joey Logano, of course. "How about Bristol on dirt?" an always-smiling Logano said after his historic win. "This is incredible, unbelievable racetrack.'

In predictable NASCAR fan fashion, some loved it, and some, I'm quite sure, hated it. But NASCAR's return to the dirt, for this young fan at least, was everything I hoped it would be.

Monday's rain-delayed race gave us great visuals, really good racing (yes, the ending could have been better, but we say that after most races), and the signature Bristol bump-and-run was still alive and well.

For a weekend that started with Mother Nature literally throwing a wet towel on everything, I'd say Monday's Main Event was a success.

## First gear

That doesn't mean there weren't challenges. Of course there were! Credit where credit it due, though, because NASCAR was able to adapt to most of them in real time.

After reviewing Friday's two practice sessions, officials gave each team an extra set of tires due to higher-than-anticipated tire wear. Officials also extended stage lengths and added a pair of competition cautions to be able to better prep the

The sanctioning body also called a quick audible during Monday's race when dust kept getting kicked up during Stage 3 restarts, leading to single-file restarts over the final 85 laps.

Could the racing up front have been better? Sure. Five lead changes among five different drivers (three of which led all but eight laps) isn't great. But, there was three-wide racing throughout the pack all afternoon and plenty of slipping and sliding, so I'll take it.

There have been plenty of snoozers in

this sport over the years (don't make me name names!), but this wasn't one of

## **Second gear**

Raise your hand if you thought Martin Truex Jr. would be the best dirt racer in both races on Monday?

Yeah me neither

Truex won all three stages and led 105 laps in the Truck opener, and then led a race-high 126 laps in the Cup show before finishing 19th.

Yes, Truex was in the always dominant No. 51 Kyle Busch Motorsports truck, but any time you lead 231 laps in one day across two different series, you're gonna raise a few eyebrows.

"I guess they had to put dirt on Bristol to get back into Victory Lane here," he said. "I'm still really surprised."

## Third gear

Everybody just assumed Bubba Wallace and Michael Jordan would be the new kids on the block this year that made waves, but how about Daniel Suarez, Pitbull and Justin Marks?

The No. 99 Trackhouse Racing Chevy was fast again on Monday, leading 58 laps and finishing fourth.

Suarez now has collected four top-17 finishes (no small feat for a brand new team), and worked his way to 20th in the points. Perhaps it's time to start taking that team seriously.

## Fourth gear

On the other end of the spectrum, it's safe to officially press the panic button for Aric Almirola.

The driver of the No. 10 Stewart-Haas Ford wrecked out of Monday's race early in the first stage, finishing 30th or worse (36th) for the fourth time in seven races.

Almirola has vet to record a top-10 this season, sits 28th in the points and the next track, Martinsville, is one of his worst (five top-10s in 24 career races).

The struggles of the Stewart-Haas stable have been well documented in these spaces over the first two months, and, unfortunately, Almirola is leading the charge.
