SAMPSON COUNTY SELECTS NEW LIBRARY DIRECTOR



Sampson County has hired Johnnie Pippin of Smithfield, North Carolina as the new Director of the Sampson-Clinton Public Library System. Pippin is currently a Library Consultant and Data Specialist with the State Library of North Carolina in Raleigh, where he oversees facets of the NC Cardinal program, a consortium of North Carolina public libraries focused on resource sharing via an online catalog and integrated library system (ILS). Pippin has more than 20 years of library experience, including work within the public library systems in Wayne and New Hanover counties and with the North Carolina State and UNC-Wilmington university libraries. Pippin earned his Masters in Library Science (with a concentration in Special Libraries/Public Libraries) from North Carolina Central University and his Bachelor of Arts degree in Psychology from UNC-Wilmington.

"Mr. Pippin's knowledge of library administration - including collection development, circulation and reference, grants and budgeting – as well as his management experience will serve our library system well," stated County Manager Ed Causey. "However, we were most drawn to Mr. Pippin's collaborative relationships with the community of stakeholders in the NC Cardinal consortium and his experiences helping library systems and their local governments resolve critical issues and reach or exceed their goals. The ability to build and maintain effective relationships is an integral part of customer-service driven local government departments."

Pippin will assume the reins of the library system at the J. C. Holliday main branch on January 2, 2020.

From the Desk of Senator Brent Jackson



I hope you had a great week thus far. Earlier this week, I was recognized as a "Jobs Champion" by the N.C. Chamber based on my pro-growth and pro-jobs voting record. I earned this recognition thanks to a 97% voting record this legislative session.

Legislative Recap- Senate Bill 487

In this legislative session, we introduced Senate Bill 487 as a response to our current meal debt situation in the state. However, we have learned that some students who are placed into the reduced-price category are unable to afford the cost of the meal and may receive an alternative meal instead.

The bill, which was eventually added to the state budget bill, seeks to supplement the cost of those reduced-price meals to make sure every child is fed at school. By providing our kids with proper nutrition and access to the same lunch experience as all other students, regardless of their means, we are fulfilling our obligation to provide for North Carolina's children while at school.

Sampson County- Clinton FD raises \$4K for MDA

The Clinton Fire Department held its annual "Fill the Boot" fundraising campaign. Members of the department were able to present the Muscular Dystrophy Association with a check for \$4,010.56.

The MDA boot drive lasted over the course of four days, with three being half days. The campaign was originally scheduled for Nov. 12-14, however, the circumstances changed due to rain. Clinton FD had backup dates in case of rain, which they had to use.

Many people in Sampson County are impacted by muscular dystrophy and the money raised by the department can help those residents. According to the department, they can help send more than 70 local children to MDA Summer Camp at Victory Junction. This weeklong summer program for the children will be no cost to their families.

The funds raised by the campaign go toward vital resources and support, including state-of-the-art support groups and Care Centers, including the MDA Care Center at UNC-Chapel Hill, Duke, and Wake Forest. The funds will also go toward Muscular Dystrophy research and treatment on a national level.

Firefighters from the department set up locations at the parking lot next to Arby's and Belk area along with the intersection of College and Northeast Boulevard.

Fire departments across the nation have spent 65 years contributing to the cause. Clinton FD has been contributing to MDA for over ten years according to the fire chief.

The foundation covers about 43 muscle-debilitating diseases, providing funds and services for those with diseases and their families. Fullwood explained that for every dollar that is raised, 73 cents goes toward research, services, and education.

District Spotlight - Sampson School District Honors Academic Achievements

The Sampson County Board of Education recently honored principals throughout the district for academic achievements for the 2018-2019 school year.

During a recent meeting, Dr. Linda Jewell Carr, assistant superintendent of Instructional Services, honored principals and staff members for academic progress. The administrators received certificates from the North Carolina Department of Public Instruction.

This year, the State Board of Education released accountability data for the 2018-2019 academic period. Most schools exceeded or met state growth expectations, based on a state rating system involving tests.

Sixteen schools met or exceeded growth for 2018-19. Last school year, 17 of the 18 Sampson schools met or exceeded growth expectations. Sampson Early College High School was the only school in the district with an A rating. Schools with a B rating are Hargrove Elementary School, Hobbton High School, Midway Middle School, Midway High School, and Union Elementary School.

Lakewood High School moved up to a B from a C. Other schools with B ratings are Clement and Plain View Elementary Schools, both were previously A schools.

Schools with C status are Hobbton Elementary, Midway Elementary, Roseboro Elementary, Union Intermediate, Hobbton Middle, Roseboro-Salemburg Middle, Salemburg Elementary, Union Middle and Union High School.

The six schools that exceeded growth for 2018-19 are Sampson Early College, Midway Middle, Plain View Elementary, Salemburg Elementary, Union Elementary, and Union High School. The 10 schools that met growth are Roseboro Elementary, Clement Elementary, Hargrove Elementary, Hobbton Elementary, Hobbton High, Lakewood High, Midway Elementary, Midway High, Union Middle, and Roseboro Salemburg Middle School.

Sampson Early College High School was also honored for a graduation rate of 98.1 percent.



Three Injured Including Four Year Old in Clinton Shooting



On December 9, 2019, around 8:30 PM Clinton Police Officers responded to 803 Sampson Street where a home had been shot. Officers arrived to find three people had been injured

during the shooting. There were seven people inside the home when the shooting occurred, including four adults, two four-year old children, and one eleven-year old child.

Kanisha Thomas who lives at the residence was injured falling to the floor when the shots were fired. She was checked by EMS but refused treatment. One of the children in the home, age four, was treated at Sampson Regional Medical Center for minor injuries to his back that occurred during the shooting. Shadiqua Morrisey of Dogwood circle in Clinton, was shot in the upper leg and transported to Cape Fear Valley Medical where she was being treated. None of the injuries appeared to be life threatening.

While not injured, other victims of the assault included Craig Murphy, who lives in the home and Kenny Parker of Rose Lane.


Investigators were called to the scene and are continuing to follow up on leads in this case. Early stages of the investigation indicate the suspects may have been on foot when they fired at the home with a rifle striking it several times. Information gathered so far, indicates the shooting was targeted at one of the individuals in the home at the time.

Two Separate Crashes Lead to Fatalities



Crash On US 701

On Sunday, 8 December 2019 at 0013 hours, Trooper A. T. Cox investigated a single vehicle, one fatality collision on US 701 just south of SR 1924 (Rowan Road). Trooper Cox found a blue Ford passenger vehicle, was traveling south on US 701 crossed the centerline, ran off the road to the left and struck a ditch where it came to rest. The driver was transported by EMS to Cape

Fear Hospital in Fayetteville. The passenger was pronounced dead at the scene. Speed or alcohol was NOT a factor. The collision is still currently under investigation, we will provide further information when the next of kin have been notified.

UPDATE:

The driver of the vehicle was Esther Santibanez Sanchez (62 YOA) of Clinton. The passenger was Jose Delacruz Santibanez (61 YOA) of Clinton. This collision is still under investigation.

Crash on Alex Benton Road

On Saturday, 11/30/2019 at 4:23pm, Trooper S.K. Naylor investigated a three car, one fatality collision on US 13 near SR1701 (Alex Benton Road). Trooper Naylor found that a gold, Lexus passenger car (vehicle 1), operated by Shelby Gene Morrison of Rollingwood Drive, Dudley NC was traveling south on US 13 at a high rate of speed. A white, Toyota 4-Runner (vehicle 2) and a gray, GMC Acadia (vehicle 3) were both traveling north on US 13. The Lexus traveled off of the roadway to the right, the driver overcorrected, and the vehicle crossed the centerline, into the northbound lane. The Toyota 4-Runner struck the left side of the Lexus, in the northbound lane of US 13, causing it to separate into two parts. The GMC Arcadia then struck the rear of the Toyota. The Toyota and GMC both came to rest partially in the northbound lane of US 13. The front portion of the Lexus came to rest in a ditch east of US 13. The rear portion of the Lexus came to rest in a wooded area west of US 13 and the driver was ejected and came to rest in the northbound lane of US 13, where he was pronounced dead at the scene. The driver of the Toyota was transported to Sampson Regional Medical Center with minor injuries. All occupants of the GMC reported no injuries and were released from the scene. Speed and alcohol were the contributors in this collision.

So far in 2019, Sampson County has had 16 deaths in 14 fatal crashes. Eight of the fatal crashes have been caused by a vehicle crossing the centerline, only one of those eight fatal crashed involved alcohol. In 2018 there were 17 people killed in 16 crashes.

Sampson County has a permanent listing system for real estate; property owners are responsible to annually list any improvements to real property only.

Failure improvements to real property is subject to the penalties imposed by NCGS 105-308 and NCGS 105-312.

Taxpayers owning only real property will not receive a listing form. If you need to list improvements to real property, please SEE BELOW FORMS AND INSTRUCTIONS.

NEW RESIDENTS

New residents and those listing for the first time should contact the Listing Department at the Sampson County Courthouse Annex at 126 W. Elizabeth St. or call (910) 592-8146. New residents are responsible for obtaining and submitting the necessary listing forms to the Tax Administrator by January 31, 2020 to avoid the late listing penalty of 10% to: 126 W. Elizabeth St., Clinton, NC 28328 or P.O. Box 1082, Clinton, NC 28329.

BUSINESS, FARM/ **AGRI-BUSINESS & OTHER** PERSONAL PROPERTY

BUSINESSES and/or persons owning or possessing personal property used or connected with a business income-producing other purpose, must list such property with the tax administrator every year, <u>including but not limited to</u> copiers, computer equipment, supplies, leasehold improvements, furniture, fixtures, machinery, spare parts, etc. IRP (International Registration Plan) plated vehicles must be listed annually during the regular listing period. ALL FARM/AGRI-**BUSINESSES** must list annually all income-producing personal property, including but not limited to: tractors, combines, combine headers and platforms; motors; harvesters; equipment; plows; planters; sprayers, irrigation equipment; supplies; compressors; etc. ALL PERSONAL PROPERTY must be listed, including but not limited to: all unlicensed & permanently tagged motor vehicles; untagged trailers; aircraft; motorcycles; campers; RVs & truck bodies; mobile homes; all boats & all boat motors; jet skis; all household rental personal property; etc. LICENSED vehicles will be billed automatically by the NCDMV. SEE BELOW FOR FORMS AND

PROPERTY TAX **RELIEF PROGRAMS**

North Carolina excludes from property taxes the greater of twenty-five thousand (\$25,000) or fifty percent (50%) of the appraised value of a permanent residence owned and occupied

by a qualifying owner. A qualifying owner is an owner who meets all of the following requirements as of January 1 preceding the taxable year for which the benefit is claimed: 1) Is at least 65 years of age or totally and permanently disabled.

2) Has an income for the preceding calendar year of not more than Thirty one thousand (\$31000).

3) Is a North Carolina resident. Income is defined as all moneys received from every source other than gifts or inheritances received from a spouse, lineal ancestor, or lineal descendant. For married applicants residing with their spouses, the income of both spouses must be included, whether or not the

Disabled Veteran Exclusion This program excludes the first forty-five thousand dollars (\$45,000) of the appraised value of a permanent residence owned and occupied by a North Carolina Resident, who is an Honorably Discharged Disabled Veteran, the unmarried surviving spouse of an

Honorably Discharged Disabled Veteran. A disabled veteran is defined as a veteran whose character of service at separation was honorable or under honorable conditions and who has a total and permanent serviceconnected disability or who received benefits for specially adapted housing under 38 U.S.C 2101. Contact the Sampson County Tax Office for specific details and applications.

Circuit Breaker Property Tax Deferment: This program allows taxes billed each year to be limited to a percentage of the qualifying owner's income. However, taxes in excess of the limitation are deferred and remain a lien on the property. The three most current years of deferred taxes prior to a disqualifying event will become due and payable, with interest, on the date of the disqualifying event. Age 65 or older,

with an income not exceeding \$46,500. You must file a new application for this program each year Contact the Sampson County Tax Office for specific details and application. Application time period for property tax relief programs is January 2, 2020 to June 1, 2020.

- INSTRUCTIONS. The week's We Should Know is all about Christian Charity during the Christmas Season and the guest for the show is Becky Spell Vann from Tim's Gift.

JW Simmons begins the show stating that Becky is involved in so many things during the year from Tim's Gift to the Rise Up conference. And that she has become known as the go to person in Sampson County for people in need.

time-ability in our lives. "Well JW," starts Becky, "I think as a people living in a small town, we have so many gifts that we take for granted. And we become so involved in things that we forget to make memories and we forget to share kindness because we're in such a hurry. And that has been a theme that's been on-going at Tim's Gift and The Learning Station for 31 years."

He asks Becky to discuss what's going on in her life and a recent article she wrote focusing on

"But the past few years we've had an emphasis on kindness," Becky adds. "And this past year it really escalated when Riley Pope, a local girl and Junior at Harrells, her father is a farmer here Josen Pope. And they've done an amazing job raising Riley to show kindness. And she came to me and wanted to volunteer this summer and she came in with a 10-part syllabus on kindness. And it really started the wheels rolling in the teachers and the children's minds. And we've really tried to put a lot of emphasis on it since then. And we try to do what we do at Tim's Gift with a kinder spirit."

Becky goes on to say, "We have tried to do it with the children sometimes when we get frustrated. We might do an act of kindness, but if we do it in the wrong spirit the Bible says He doesn't recognize it."

"So, through that and through Edye Carr, Wendy and Bob Carr's daughter, she volunteered this summer at the Learning Station. She's a freshman and she did a campaign called Be Nice. She started it at Clinton High School 3 years ago. She came and worked with the children 3 days a week and talked

about kindness and being nice instead of bullying."

"So, today we just wanted to challenge everyone who's listening, everyone who reads about this to pass it on and share kindness. And it's the perfect season to talk about it."

JW Simmons says that kindness is a word missing in todays polarized world of social media and politics. So much so that its not even an expectation any longer.

"That's right," says Spell. "In fact, I was listening to the news this morning and someone said why our children are acting and reacting the ways they do is they don't often see kindness. What is our leadership doing? And we know its not all of it, but it becomes contagious. And if we all stop and show more kindness and take time with people instead of just brushing people off or giving a hateful harsh word. Probably everybody watching this today has had a moment this past week that we've had traffic rage. Maybe it was at a stop light or somebody passed us, and we were angry. If we handle things in a different way and we engage with people that are showing kindness, then it will make us want to do it."

"In fact. Our children at the Learning Station, today was a half day and they just got off the school bus before I came over here and they were so excited that we stopped and sat down outside the Learning Station to look at the window. And we have 3 messages in that window, Go Horses, Share Love and Happy Gobble."

"And as we talked about what those things meant the children shared was that they've shared kindness today. And them Ms. Eleanor Bradshaw drives up. She comes up to the children and she's talking with them and she's had a little health problem with her foot, and she was limping, so the children asked, and they wanted to pray with her. So, they reached out and touched her ankle and four of the children said prayers with her. Not prayers for her, but they actually touched her ankle. And she was brought to tears and it was a powerful moment. And I was reminded that we should never say all our children are not thoughtful or kind. And neither should we say it about adults nor our leaders."

"But we have a majority. If you look at our news it is bad. I think on the nightly news on an hour episode the last minute gets a good deed shown. 1 minute out of 60 minutes about good news. So, that's why we're here today. We want to challenge the people that live in our area, our city and county; because we've got a great place to live. We want to challenge people between now a Christmas to do holiday giving in a different way."

Spell explains, "To do something tangible that will make a difference in somebody's life. In fact, while we were sitting outside the Learning Station, 2 ladies walked by pushing a cart and they had their food in it. They come by every day pushing that cart. And Ms. Eleanor was able to share with the children that yesterday when she left the grocery store, she met a lady who was walking carrying her groceries. She stopped and asked the lady could she help her. She said I'll be glad to take you home. She actually lived down 5 Bridge Road."

"Eleanor said she was so blessed by that, and the children were touched because here was a lady who just stopped by to say hello, she was prayed for and in return shared a good deed she did yesterday. So, it is contagious!"

COLLARDS, COLLARDS, OOKIN' IN THE POT

Collard greens, yum yum, set my mouth to watering. I love collards, always have. Most of my family does too. Except for one or two (and you know who you are), that make the rest of us wonder exactly what branch of the family tree they fell off of! I think it's the same way in most families, you either love collards or you don't, there's not much middle ground when it comes to collards.

It has been said, and I think it bears repeating, that

the smell of cooking collards separates a true Southerner from the "wanna-be's." The aroma of a simmering pot of collards in a Southern kitchen has been known to send visiting Yankees outside in a sprint!

Collards have been grown and been a popular food in the South for over 200 years. They came here originally from Africa and can be grown year-round in the mild Southern climate. Summer collards are good, but I like the winter collards the best, especially after they've had at least one good frost on 'em. For some reason the frost makes them tender and sweet, and it doesn't take as long to cook them either. I'm not alone in this; most of the "old people" liked their collards the best after a good frost too.

Collards are a hearty vegetable that's fairly cheap to grow. They contain calcium, iron and zinc. In short, they're "good for ya'." And they taste a whole lot better than spinach, at least in my opinion!

Collards are so popular in the South that it's common to see patches sprouting up all over the place. Yes, in country vegetable gardens to be sure, but also you spy little collard patches in backyards and sometimes beside the house itself.

Out here in the Newton's Crossroads, Harrells, and Wells Chapel communities, if you mention a collard patch with collards for sale most folks would fondly recall the collard patch of Mr. Hybert Moore. For so many years he grew his collards for sale, so much by the head. And you talk about big, pretty, tasty collards, he could grow 'em. Mr. Hybert has passed on now, and with him went his bountiful collard patch. Both are sorely missed.

Collard popularity has reached new heights. I heard a lady over in Scotland Neck by the name of Colleen Bunting has written a book titled "Collard Poems." I'm trying to track down a copy! And over in Ayden they have a collard festival every year. They proudly proclaim themselves the collard capital of the world!

They have a collard eating contest and a collard-cooking contest held during the festival. Let me tell you, those folks over there are serious about their collard growin' and cookin'. Some of the grow their collards from collard seeds that have been in their families "forever," and have been handed down from generation to generation. The seeds are saved from year to year with great care. One man declares his family collard is the cabbage collard.

But, alas, it was only a stranger once more, A bent old lady with a shawl of black With a bundle of kindling piled on her back. She asked only for a place to rest, But that was reserved for Conrad's great Guest. Her voice seemed to plead "Don't send me away; Let me rest for awhile on Christmas Day." He says it has a yellow tint to it and he prefers the taste of it to his neighbor's real green collards.

Ever what kind you grow or buy, they have to be cooked. Most all serious Southern collard cooks (male and female), have their own way of cooking up their pot of collards. Some say, "Collards have been cooked this way in my family for generations. It's a tradition!"

Seasoning meat is a vital part of collard cookin'. Country ham hocks and trimmings are one of the most popular meats. Slab or smoked bacon ends and fatback are popular too. Some people use hog jowls. I heard one man say his favorite seasoning meat was corned pig tails chopped up. (Think I'll pass on that one!) My husband's grandmother used uncut link sausage rolled up on top of the collards as they cooked. Some folks boiled a picnic ham (shoulder) in a pot of water, took the ham up and placed the collards in the ham broth with some trimmings from the ham. These collards taste mighty good, but we know now that's not the healthiest way to cook 'em. I like to use the picnic ham bone with ham trimmings to season with. One person told me they like to use neck bone for seasoning meat. Some people also put in various kinds of peppers with their collards as they cook, although my family never has. As I said, collard cookin' is serious business in the South and most families have their own way of doin' it!

Once they're cooked and coming steaming hot to the eatin' table, it's time to dig in. Salt and pepper for most. A lot of folks like homemade hot pepper vinegar on their collards. My husband does; I do not. It's a matter of personal taste.

Our favorite collard meal is served with baked whole sweet potatoes, flat baked cornbread and country ham and sometimes black-eyed peas along with it. Yep, that's a pure Southern country meal if there ever was one!

Most everyone speaks fondly of collards except for one contrary man who declares he would rather eat dog fennel tops than collards. I won't mention his name lest he should find himself harassed by collard lovers! I heard of a feller who loved collards so good he made collard sandwiches. I'll admit, I never thought of doing that, but it just might be worth trying!

I believe collards are the green gold of the South. And to all the collard lovers I say, "eat more collards!" Maybe we can have collards declared the official state vegetable.





According to Derek Brewington, head coach of the Giants, "It sure is a great day to be a Giant" is a motivational quote that is spoken every day to the team and to the parents as well. The coaching staff of the Giants feel like "useful daily encouragement" is crucial for the spirit of the team.

The Giants started work back in mid-September with the first game being played on September 30th against Hobbton and the final Championship Game was played on December 2nd against the Unions Spartans.

Coach Brewington praised the hard work and effort put in by his team. "The success of this team, hard work forever pays. I always attached a motivational quote to the Giant's Family Text on Game Day. Dedication, Unity, these young men never gave up and they never backed down. They did what we asked of them...majority of the time. We are not only teaching these kids the game of football; we are developing our future. In a world filled with so much wrong, these young men represent what is right. As coaches we take that serious."

Assistant Coach Trent Mitchell stated, "In this tech age a lot of our youth depend more on a screen to communicate with their peers rather than being out there face to face developing social skills. We think the rec department helps negate that aspect somewhat. It puts kids in a social environment. These kids are developing, and the rec offers an avenue for them to interact, make friends, build bonds with kids outside of their own neighborhood, school. Kids who participate in rec sports learn values, sportsmanship, and what it means to be a part of a team. It helps them learn to rely on others and have others rely on them. It's far more valuable than learning how to just throw and kick a ball."

Coach Brewington said that he would love for more young kids to get involved in recreation football and he noted that it was a very easy process. The Coach explains the process, "First you need to register with the Clinton NC Parks and Rec or the County Parks and Rec. This gets your child on the list and an invitation to the combine. All kids are put through a serious of physical exams and ranked by all the coaches. Gentleman's agreements are handled first respectfully between coaches, then we begin the recruiting process."

One of the most important parts of the team's success are the supportive parents. Coach Ricky Warren stated, "Parent participation is crucial. These kids can't drive, so the parent has to be just as dedicated as the players and the coaches. We are all a family. When the kids see so many people coming out to watch them play, when they look up at the stands they are inspired, and you know these boys are about to put in work. The success of this season could not have been possible without the support of our parents and our fans."

According to Coach Brewington, "Each player received two metals after the Championship game. 1 for conference champs. 1 for tournament champs. The players will also be awarded with personalized trophies at our appreciation day which is scheduled for Sunday. The 15th players, parents,

coaches, everyone will gather for a cookout and we will be having our trophy ceremony at that time. Good day of fun."

The season has been a great one. Coach Hunter Balltzglier, "Highlights of our season besides going undefeated and winning the Championship, the comradery with the kids. We have group text where parents have shared letters teammates wrote to each other. These boys are 7-9 and they are writing letters to their brothers telling them how great of a player they are, how much they value one another as friends. As coaches it feels great to know your kids have such a tight bond. It's a great feeling to know these kids are thinking about the success of our team, their hearts are pure."

Additional highlights from the season according to Coach Balltzglier was "watching the new recruits gain self-confidence, watching our seasoned players interact and unite this team. Kids that were shy and timid are no longer scared, they really stepped up and accepted the challenge, this helped the success of the team."

"The players played above and beyond expectations for me," said Coach Trent Mitchell. "These are 7-9 year old kids, some have never played organized sports prior to this season. We as coaches demand a lot from these young men at an early age and with our approach, these kids exceeded every expectation we had for them. They listened and learned as a team; they were disciplined as a team. A group of young kids that became family, a band of brothers over the course of this season. They played and acted like boys and were a bit wild at times as you would expect, but they came together when it was time for us to buckle down. For me as a defensive coach you walk in knowing that every one of these boys wants to run the football, and most will not understand just how crucial the defense is. I wanted them to learn that we can't be beat if the other team doesn't score. We wanted to hunt goose eggs every game, if we keep off or at least minimize the points on the board, it makes the offenses job a little less stressful. Our defense "The Hit Squad" as we called them, did just that!"







Digging into the NASCAR stats pile

he 2019 Monster Energy NASCAR Cup Series is officially over after competitors honored Kyle Busch as their champion in Nashville last week.

Now that the season is properly bottled and capped, it is a good time to dig around in the stats for interesting facts and figures.

The name kicked around the most in the stacks of numbers is Joe Gibbs Racing, which had a stranglehold on the series from Race 1 to the finale. The car owner's four teams won 19 of 36 races, which is a modern-era record.

It's no surprise that Busch and JGR teammates Martin Truex Jr. and Denny Hamlin held three of the top five positions in postseason driver ratings.

Busch led all drivers with a rating of 108.4, but Ford drivers Kevin Harvick, who was second at 105.2, and fourth-place Joey Logano, at 98.4, were in the mix. Logano didn't make the Championship Round but still finished just ahead of Hamlin at 98.0.

Another good indicator of JGR's dominance was in the laps-led category. Busch topped this chart by leading 1,582 laps for the season, followed by Truex at 1,371. Hamlin was fifth at 921.

Truex was second to Busch in a number of statistical categories, including the final points standings. Truex won the title in 2017 and finished second in 2018 to Joey Logano.

"Man, second again," said Truex at the awards ceremony in Nashville. "I think I hate second more than Kyle; I think that's possible."

The surprise name here would be Team Penske Ford driver Brad Keselowski, who was third in laps led by pacing the field for 1,085 circuits during the season.

Not surprisingly, Gibbs Racing drivers topped the Stage wins and points stat pile.

Busch ended the season with 12 Stage wins and 46 playoff points, which helped him navigate the rough knockout playoff waters. He was the only final-four driver who made it through on points.

Busch credited his No. 18 Toyota team and crew chief Adam Stevens for his performance numbers.

"No matter what was thrown at them, they never gave up," Busch said at Nashville. "They were able to finish off that final race at Homestead with their best performance."

Truex, who led the Cup Series with a season-high seven wins, had nine Stage wins and 42 playoff points. Hamlin had six Stage triumphs and

finished with 37 playoff points. Logano (30) and Harvick (28) rounded out the top five in playoff

points.

Truex at 8,112.

Busch posted the most laps while running around the top-15 competitors during the season. He was in the front pack for 8,691 laps or for 84.7 percent of the time. Harvick was hot on his bumper in this category, boasting 8,466 laps, followed by

And that category feeds straight into another called "average running position." Busch had the best number at 9.019 followed by Harvick (9.144), Truex (10.291), Logano (10.433) and Hamlin (10.818).

As maybe a sign of things to come, Ryan Blaney was a surprising sixth in this category. He posted an average running position of 10.932.

Blaney shows up second in another category, tagged "quality passes,' just behind Busch. Busch led the field with 2,344 quality passes, followed by Blaney with 2,191.

Busch was followed in seasonending points by Truex, Harvick and Hamlin, who had a rebound season following a 2018 downer.

"The fact is that, every week, we were a factor, and that's all you can ask for as a driver," said Hamlin, who opened the season by winning the Daytona 500.

However, not selling the naming rights to its biggest series should give NASCAR more credence in the overall sporting world. After the long-running Winston branding went away 15 years ago, we've seen the logo sold to Nextel, which became Sprint, which gave way to Monster Energy. That's a business model we're happy to lose. Everyone always just called it the Cup Series, anyway.

How about indirect effects?

Those will be long-term, assuming everything goes according to NASCAR's plan. By slipping under the fiscal sheets with four major companies and brands, NASCAR not only takes in whatever financial rewards the contracts include, but gains four major partners who will help with the heavy promotional lifting. If that leads to regaining some of the momentum from previous decades, everybody wins.

Who will eventually replace Chase Elliott as "Most Popular Driver"?
