Clinton Police Department Looking Tips on Drive By Shooting Into Vehicle



According to the Clinton Police Dept around 12:30 PM on Saturday, Antrell Garner, 18, and Tremetrius Carr, 21, of Clinton were traveling on North Blvd coming in toward town. The initial investigation indicates the men were passengers in a vehicle and were reportedly shot by suspects in a grey passenger car.

Both men were driven to Sampson Regional. Garner had a gunshot near the back of his head. He was listed in critical condition and flown out to another facility for treatment. Carr had a gunshot to his leg and was being treated at Sampson Regional.

Officers responded and closed the road temporarily. At this time the reason for the assault is not known but we do believe the victims and suspects knew one another. Detectives were called to the scene and are investigating.

RALEIGH: Governor Roy Cooper and North Carolina Department of Health and Human Services Secretary Dr. Mandy Cohen announced that North Carolina will begin a Modified Stay at Home Order after a rapid increase in North Carolina's key COVID-19 trends. The Order requires people to stay at home between 10 pm and 5 am and takes effect Friday, December 11 and will be in place until at least January 8, 2021.

SAMPSON COUNTY BOARD OF ELECTIONS NOMINATES NEW ELECTIONS DIRECTOR



The Sampson County Board of Elections announced today their nomination of Niya T. Rayner as the new Director of Elections for Sampson County, pending the issuance of a letter of appointment by the Executive Director of the State Board of Elections (pursuant to GS 163□35). At their December 3, 2020 meeting, the Sampson County Board of Elections voted unanimously to recommend Ms. Rayner, who had been serving as the Interim Elections Director since the departure of the former Director Emily DeVane. The State Board of Elections is required by law to act within ten days of receiving the nomination. Upon State approval, Ms. Rayner's promotion would be effective at an annual salary of\$48,828.

Ms. Rayner holds a BA in Strategic Communication from High Point University, and is currently pursuing an Masters in Business Administration, with a concentration in Public Administration, via Southern New Hampshire University. In addition to serving as Interim Elections Director, Ms. Rayner has also worked at the Sampson County Agri Exposition Center and the Sampson County Emergency Services Office.

A County elections director is responsible for directing administrative work, planning, coordinating, directing and supervising federal, state, county, municipal and special election processes and staff under the direction of the Board of Elections. It requires a comprehensive knowledge of federal, state and local election and voting registration laws, regulations, procedures to ensure all election related activities adhere to state and related laws.

"We already have strong safety protocols and capacity limitations in place – including a statewide mask requirement. With this additional action beginning Friday, we hope to get these numbers down," Governor Cooper said. "Our new modified Stay At Home order aims to limit gatherings and get people home where they are safer, especially during the holidays. It's also a reminder that we must be vigilant the rest of the day – wearing a face mask when we are with people we don't live with, keeping a safe distance from others and washing our hands a lot."

The Order requires restaurants, bars, entertainment venues, personal care businesses and more to close at 10 pm. Travel to and from work; to obtain food, medical care, fuel or social services; or to take care of a family member is exempted. Read more in the Frequently Asked Questions document.

In the past week, North Carolina's case count has broken single-day records on three separate days, including crossing more than 6,000 cases per day on two of those days. Just a month ago, cases were under 3,000 per day. In recent days, the percent of tests returning positive has increased to more than 10%.

Governor Cooper was clear that further action would be taken to slow the spread of the virus if trends do not improve. This could require further limiting of restaurant dining, indoor entertainment or shopping and retail capacity restrictions, among other safety protocols.

Dr. Cohen also provided an update on North Carolina's COVID-19 County Alert System map. The number of red counties (critical community spread) has more than doubled since November 23, up to 48 red counties from 20 red counties. There are now 34 orange counties (substantial community spread), as compared to 42 orange counties from the previous report. With today's report, more than 80% of the state's counties fall into the red or orange tier. Read the update to see where each county stands and how the system was designed.

"Your actions can keep people from getting sick, save lives, and make sure our hospitals can care for people whether it's for a heart attack or a car accident or COVID-19. Protect yourself, your loved ones, and your community now," said NCDHHS Secretary Mandy K. Cohen, M.D.

Dr. Cohen also provided an update on North Carolina's data and trends.

All persons who own or control business, farm/agri-business and/or any personal property subject to taxation in Sampson County, OR made improvements to real property, must list all such property and/or improvements to real property for year 2021 from Monday, January 4, 2021 through Monday, February 1, 2021.

If you filed a listing form in 2020 with the county, you will automatically be mailed a new form at the owner's address on record as of January 1, 2021. Please review the information, make necessary additions/corrections, sign & return listing forms postmarked by USPS no later than February 1, 2021 to avoid 10% late listing penalty to: Tax Administration, PO Box 1082, Clinton, NC 28329 (Or bring to 126 W. Elizabeth St.) Unsigned forms will be considered late if received after February 1, 2021.

REAL **ESTATE**

Sampson County has a permanent listing system for real estate; property owners are responsible to annually list any improvements to real property only.

those Failure list to improvements to real property is subject to the penalties imposed by NCGS 105-308 and NCGS 105-312.

Taxpayers owning only real property will not receive a listing form. If you need to list improvements to real property, please SEE BELOW FORMS AND INSTRUCTIONS.

NEW RESIDENTS

New residents and those listing for the first time should contact the Listing Department at the Sampson County Courthouse Annex at 126 W. Elizabeth St. or call (910) 592-8146. residents are responsible for obtaining and submitting the necessary listing forms to the Tax Administrator by February 1, 2021 to avoid the late listing penalty of 10% to: 126 W. Elizabeth St., Clinton, NC 28328 or P.O. Box 1082, Clinton, NC 28329.

BUSINESS, FARM/ **AGRI-BUSINESS & OTHER** PERSONAL PROPERTY

BUSINESSES persons owning or possessing personal property used or connected with a business other income-producing purpose, must list such property with the tax administrator every year, including but not limited to: copiers, computer equipment, leasehold supplies, improvements, furniture, fixtures, machinery, spare parts, etc. IRP (International Registration Plan) plated vehicles must be listed annually during the regular listing period. ALL FARM/AGRI-**BUSINESSES** must list annually all income-producing personal property, including but not limited to: tractors, combines, combine headers and platforms; motors; bailers; harvesters; tobacco equipment; plows; planters; sprayers, irrigation equipment; supplies; compressors; etc. ALL PERSONAL PROPERTY must be listed, including but not limited to: all unlicensed & permanently tagged motor vehicles; trailers; aircraft; untagged motorcycles; campers; RVs & truck bodies; mobile homes; all boats & all boat motors; iet skis; all household rental personal property; etc. LICENSED vehicles will be billed automatically by the NCDMV.

PROPERTY TAX RELIEF PROGRAMS

North Carolina excludes from property taxes the greater of twenty-five thousand (\$25,000) or fifty percent (50%) of the appraised value of a permanent residence owned and occupied by a qualifying owner. A qualifying owner requirements as of January 1 preceding the taxable year for which the benefit is claimed: 1) Is at least 65 years of age or totally and permanently disabled.

2) Has an income for the preceding calendaryear of not more than Thirty one thousand five hundred (\$31500). 3) Is a North Carolina resident. Income is defined as all moneys received from

every source other than gifts or inheritances received from a spouse, lineal ancestor, or lineal descendant. For married applicants residing with their spouses, the income of both spouses must be included, whether or not the property is in both names. Disabled Veteran Exclusion

This program excludes the first forty-five thousand dollars (\$45,000) of the appraised value of a permanent residence owned and occupied by a North Carolina Resident, who is an Honorably Discharged Disabled Veteran, or the unmarried surviving spouse of a Honorably Discharged Disabled Veteran. A disabled veteran is defined as a veteran whose character of service at separation was honorable or under honorable conditions and who has a total and permanent service-connected disability or who received benefits for specially adapted housing under 38 U.S.C. 2101. Contact the Sampson County Tax Office for specific details and applications

This program allows taxes billed each year to be limited to a percentage of the qualifying owner's income. However, taxes in excess of the limitation are deferred and remain a lien on the property. The three most current years of deferred taxes prior to a disqualifying event will become due and payable, with interest, on the date of the disqualifying event. Age 65 or older, with an income not exceeding \$47,250. You must file a new application for this program each year. Contact the Sampson County Tax Office for specific details and application. Application time period for property tax relief programs is January 4, 2021 to June 1



"The Man and the Birds." You know the Christmas story, God born a man in a manger, and all escapes some moderns – mostly, I think, because they seek complex answers to their questions, and this one's so utterly simple. 

Romans 8:28, "And we know that for those who love God all things work together for good, for those who are called according to his purpose."

The 1994 Palm Sunday tornado outbreak was the third notable US tornado outbreak to occur on Palm Sunday and the second to take place in the Southeastern United States. The outbreak produced 29 tornadoes from Texas to North Carolina, killing 40 people and injuring 491, and causing \$140 million in damage. The deadliest storm of the outbreak, as well as in the US in 1994, was an F4 tornado that devastated Piedmont, Alabama. It struck the Goshen United Methodist Church right in the middle of the Palm Sunday service, collapsing the roof on the congregation and killing 20 people inside, including the Rev. Kelly Clem's 4-year-old daughter, Hannah. Two other houses of worship were also destroyed mid-service. The supercell that formed this tornado tracked for 200 miles to South Carolina.

We live in a fallen world and shouldn't be surprised when disaster knocks on our door. However, you might wonder why innocent children, gathered in a church building in Alabama, died just a few days before the church would celebrate the resurrection of Jesus Christ. Could God stop the storm and divert the disaster for this community of faith? We know that God can do all things, but it still leaves us wondering why

He didn't act. We will never know the mind of God, yet we know God's love is unchanging. Lamentations 3:22-23, "The steadfast love of the Lord never ceases; His mercies never come to an end; they are new every morning; great is your faithfulness."

Christa Neyman, a member of Goshen United Methodist Church said, "It's definitely given us an opportunity to talk about safety during storms, and also our faith in God and how that has played a role in our lives before, during and after the tornado experience." Could this horrible experience from 1994 allowed the members of the church to draw closer together? The members of the church had to trust God in their tragedy. They looked for and saw God at work in the world and expressed their gratefulness for God's protection and provision.

The apostle Paul wrote in 2 Corinthians 4:16-18, "So we do not lose heart. Though our outer self is wasting away, our inner self is being renewed day by day. For this light momentary affliction is preparing for us an eternal weight of glory beyond all comparison, as we look not to the things that are seen but to the things that are unseen. For the things that are seen are transient, but the things that are unseen are eternal." If everything on this side of eternity was always perfect and peaceful why would we even have a desire for Heaven? What pain we might experience here can be compared to one grain of sand on the beach.

"My hope does not rest in the affairs of this world," Billy Graham once said. "It rests in Christ who is coming again." I encourage you to not give up hope in Christ when all seems hopeless. Remember, that regardless of the darkness you might find yourself in, that Jesus is the light of the world. Christians are not exempt from suffering, but we do have a savior that will never abandon us.

Who is Your Child's Medical Home?

The Medical Home model is designed around patient needs and aims to improve access to care (e.g. through stretched office hours and improved communication between providers and patients via email and telephone), increase care coordination and enhance overall quality, while simultaneously reducing costs.

The medical home relies on a team of providers—such as physicians, nurses, nutritionists, pharmacists, and social workers—to meet a patient's health care needs. Studies have revealed that the medical home model's attention to the whole-person and integration of all aspects of health care offer can help improve physical health, behavioral health, access to community-based social services and management of chronic conditions

The Sampson County Health Department has joined efforts to improve the relationships with Medical Homes and their patients through the Care Coordination for Children Program (CC4C). This program that provides these services through the Local Health Department known as Care Coordination for Children (CC4C), has been replaced with a new name and is now referred to as Care Management for At Risk Children (CMARC). This case management program functions with the goal to improve the care of children in the county by linking families with Medical Homes that will meet their specific needs, arming families with education and resources, and safeguarding to ensure needs are met with timely follow-up and evaluation.

The Care Coordination for Children (CC4C)/Care Management for At Risk Children (CMARC) Program is comprised of nurses and social workers that work as case managers under the direction of Community Care of North Carolina and NC Division of Medical Assistance. It is offered at no charge for children birth to 5 years of age who: have long term medical conditions; are dealing with challenges within their environment that may increase their stress levels; and/or referred by a medical provider or other community agencies.

The Sampson County Health Department is working in collaboration with Department of Social Services in the development of Plan of Safe Care (POSC) Referrals. This initiative is a state-wide plan involving multiple agencies and community partners. This POSC will ensure the safety and well-being of infants born with and identified as being affected by substance abuse withdrawal symptoms resulting from prenatal substance exposure. The POSC will address the health and substance use disorder treatment needs of both the infant and the affected family member or caregiver.

The Care Coordination for Children (CC4C)/Care Management for At Risk Children

(CMARC) Program utilizes screening tools to identify risk concerns on children from birth to 5 years of age. The CC4C/CMARC Program assess the basic skills needed to live and parent well through completion of the Life Skills Progression Checklist with parents of children identified at risk. The CC4C/CMARC Program utilizes the Survey of Well-Being in Young Children (SWYC) that focuses on the importance of early identification by screening infants and children up to 5 years of age at risk for developmental-behavioral disorders along with family and social concerns.

Social Determinants of Health (SDOH) are the conditions in which people are born in to, how they grow, work, live, and age along with the wider set of forces and systems shaping the conditions of daily life. Statistics show that 70% of health outcomes are tied to non-medical social determinants of health. CC4C/CMARC focuses on relationships with family and friends (social support), education and employment, access to health and medical care, knowledge of supportive community resources, housing, and transportation to help address and provide assistance for families with children from birth to 5 years of age with identified needs.

Once a referral is received, a CC4C/CMARC Care Manager is assigned to the family to assess the needs of child and family. A plan of care and goals are developed by the family with the assistance of CC4C/CMARC staff. CC4C/CMARC staff work with families through home visits, phone calls, provider visits, and other types of contact to assist them with meeting their needs.

The Sampson County Health Department works tirelessly to be an active participant in caring for the county's youth by implementing best practice recommended services to meet the needs of our youth. Other services provided by the Sampson County Health Department are Well Child Check through our Child Health Clinic.

The Child Health Clinic Well Child Check involves performing assessments on children 0-20 years old as recommended by Medicaid in partnership with the child's Medical Home. Through this program, the Sampson County Health Department is skilled to assist children to comply with the Department of North Carolina Public Instruction's requirements for entry into North Carolina Schools. Sampson County and Clinton City Schools require specific paperwork to be completed to show that physical examination/immunizations requirements have been met by no later than 30 days after entering school. If exams and immunizations are not updated by the 30th day of enrollment, the child is usually required to stay at home until the requirements are met.

Well Child Checks provided through the Health Department meet the requirements for children entering into Daycare, Preschool, Head Start, More at Four and school grades Kindergarten through 12th grade. This assists with achieving our community goal of ensuring the health and well-being of the children of Sampson County. Bright Futures, a best practice program, is used by the Sampson County Health Department. The Bright Futures principles acknowledge the value of each child, the importance of family, the connection to community, and that children and youth with special health care needs are children first. These principles are used with each Well Child Check visit to assist in delivering and supporting the highest quality health care for children and their families.

The Facts About School, Shots, and Your Child

Whether your child is starting kindergarten, entering middle school, or a rising 12th grader, local healthcare officials are urging parents to make sure their child is protected from certain vaccine-preventable disease.

All children, whether moving to uired to be up to date on all vacci-

North Carolina or entering a school system in the state, are required to be up to date on all vaccinations. Students that are entering seventh grade or turning 12 years old must receive their booster dose of the Tdap vaccine and a dose of the Meningococcal vaccine. New immunization laws now require 17 year olds and rising 12th graders to receive a second dose of Meningococcal vaccine. According to the North Carolina Immunization Branch, a booster dose of the Meningococcal vaccine is required for students entering the 12th grade or by 17 years of age, whichever comes first.

While most parents remember to keep their babies and young children vaccinated, they often forget about keeping preteens and teens up to date on their immunizations. While some of the vaccinations are required, others are not required but recommended by healthcare officials.

Required vaccinations

Prior to a child entering Kindergarten, it is required for the child to have received a number of vaccines. The state of North Carolina requires children entering Kindergarten to have received 5 doses of Dtap (Diphtheria, tetanus, and pertussis), 4 doses of Polio, 2 doses of the measles and mumps vaccines, 1 dose of rubella, 4 doses of the Hib (Haemophilus Influenzae type B), 3 doses of the Hep B (Hepatitis B) vaccine, 2 doses of the varicella (chickenpox) vaccine, and 4 doses of the pneumococcal conjugate vaccine. Many of these vaccines can be combined when the child is younger to avoid a large number of injections being administered at one time. If a child is behind schedule for immunizations, the state Immunization Branch also details a schedule to catch children up to the appropriate schedule.

The Tdap vaccine is a required vaccine that protects against tetanus, diphtheria, and pertussis. The Tdap vaccine is required for children entering 7th grade or by 12 years of age, whichever comes first, if the child has not previously received a booster dose.

Meningococcal disease is a bacterial infection spread by respiratory secretions from coughing and sneezing. It can be spread by living in close quarters and by kissing. The meningococcal vaccine is required for preteens and teens. One dose is required for a child starting 7th grade or by 12 years

of age, whichever comes first. A second dose is required for children starting the 12th grade or by 17 years of age, whichever comes first.

It is very important for your child to be up to date on immunizations. According to the North Carolina Law, every child is required to receive immunizations. Typically, a child is required to present proof of immunizations within 30 days of entering school. North Carolina Executive Order 156 was passed on August 12, 2020 and provides an extension for this requirement for the 2020-2021 school year. North Carolina immunization requirements apply to all North Carolina school settings, including students who are attending by remote access. If you have specific questions about immunizations and your child, please speak with your child's doctor or your child's school.

Recommended vaccines

Influenza, or flu, is a very contagious viral infection that affects the nose, throat, and lungs. The virus is spread when an infected person coughs or sneezes. The flu vaccine should be given every year at the beginning of flu season.

Human papillomavirus (HPV) is a virus that is passed through sexual contact. It commonly affects people in their teens and early 20's. Most people never know they have HPV and the virus can sometimes clear on its own, although if it does not, it can cause certain cancers and other problems. The HPV vaccine should be given to boys and girls beginning at age 11 and the series is sometimes started as early at 9 years old. The HPV vaccine is a two or three dose series, depending on the age of the child when the series is started.

Whether a vaccine is recommended or required, all children should receive all age appropriate immunizations. Most insurance companies pay for immunizations. If a child is not covered by insurance or is underinsured, there is a program called Vaccines for Children (VFC) that is federally funded that pays for children's vaccines.

During this time of year, many parents are concerned about physicals that are needed to enroll their child in school, whether it be Kindergarten or the child is transferring into the school system, or to play sports. The Sampson County Health Department offers child health physicals for children in need. These physicals are covered by most insurance companies. For those uninsured, the Sampson County Health Department follows state guidelines for services and payments.

How to keep squirrels away
from bird feeders

Do your bird feeders attract squirrels that steal the seed and make a mess around your yard? Here are some quick tips from BobVila.com to keep these uninvited guests away from your feeders:

- Fill your feeder with food squirrels don't like. While squirrels love birdseed, nuts, sunflower seeds, fruit and corn, they dislike safflower seed, nyjer seed and white proso millet.
- Place feeders away from trees. Squirrels can jump up to 7 feet horizontally from a tree or branch. Set up your bird feeder away from trees to prevent them from leaping onto it from a nearby limb.
- Attach a slinky to your feeder pole. A slinky can be inexpensive DIY alternative to a squirrel foil. Fasten the slinky to the top of your feeder pole to prevent squirrels from scaling it.

GARDENING These winter veggies don't require a lot of room to grow

Growing your own food has spiked in popularity due to the pandemic. It might be getting cold, but that doesn't mean you have to go back to store-bought veggies yet. These healthy veggies can survive a colder climate and don't require too much space to grow according to Well+Good:

- Greens. Kale, collard greens and lettuce can thrive during winter. Be sure to remove any dead vegetation when preparing your gardening beds for your winter veggie planting. This could have a fungus that prevents new plants from growing. Then add a layer of compost to protect the soil.
- **Carrots.** Growing mostly below ground, carrots can survive a wide range of climates, including a cold winter.
- Garlic. Because garlic doesn't need much room, you can use a container or a bucket. Add your soil and mulch until it's about three inches from the top. Drop your garlic cloves in, spacing them about three inches apart. Cover the cloves with a couple inches of soil and pace the container where it can get six hours of sun a day. Be sure to water it enough to keep the soil moist.

CLEANING Clean a scorched pan with vinegar and baking soda

If you scorched a pan while cooking and don't have any store-bought cleaners on hand, vinegar and baking soda can be used in pinch. Here's a quick guide from HGTV:

- 1. Pour a small layer of equal parts water and white vinegar on the bottom of the pan.
- 2. Heat the diluted vinegar on the stovetop and allow it to come to a boil.
- 3. After it boils for a minute, remove it from the heat and drain the vinegar down the sink.
- 4. Add a tablespoon of baking soda to the empty pan (the point is not to create a fizzy volcano, you want the two cleaning agents to operate independently). Use a scouring pad to massage the baking soda to combat any remaining burn marks on the bottom of the pan.
- 5. Rinse it clean.

Poinsettias dominate the holiday season

s Christmas approaches, one plant seems to dominate the season: poinsettias. Red poinsettias with green leaves have become symbolic of the season. Poinsettias are as much a part of Christmas as Christmas trees, colorful lights, eggnog and Bing Crosby singing "White Christmas." More than 34 million plants will make their appearance at just the right time. Florists, grocery stores, even hardware stores are all promoting these beautiful plants at this time of year.

While red is the most popular color, accounting for roughly three-quarters of all sales nationwide, there are many other colors available. Pink, neon pink, salmon, white, cream apricot and orange are colors that are grown today. There are also ones with speckled and marbled leaves and ones with sprayed on flocks.

Poinsettias (Euphorbia pulcherrima cvs.) are native of southern Mexico, and bloom in December. The Aztecs used poinsettias in the 14th, 15th and 16th centuries for practical purposes. They made a dye they used for dying clothing and they used the sap for medicinal purposes like controlling fevers. In more recent years, Mexicans have used poinsettias to decorate churches at Christmas.

For close to 200 years, Americans have also embraced poinsettias as a popular holiday plant. Dr. Joel Roberts Poinsett, an amateur botanist and first United States ambassador to Mexico, introduced the plant that became known as the poinsettia to this country. He discovered this shrub with brilliantly colored red leaves growing by the side of the road in Taxco, Mexico, in December 1828 and sent cuttings home to his plantation in Greenville, South Carolina. Dr. Poinsett propagated them and sent them to friends and family at Christmas.

Dr. John Dole, a professor at North Carolina State University, has worked with poinsettia for 37 years, doing his doctoral work with this lovely plant. He has been evaluating them at NCSU, where they have a program to help commercial growers evaluate different varieties. They assess over 100 different poinsettias each year and invite growers to come visit their greenhouses to see the different



varieties and observe which ones grew best in the trials. Poinsettias have grown in popularity and new varieties are introduced each year.

Poinsettias are the second-highest selling potted flowering plant grown today behind orchids. California is the top producer with over 6 million plants grown. North Carolina grows about 4 million with Michigan, New York and Pennsylvania each growing large numbers of plants, too.

Over the years, people have believed that poinsettias were poisonous. This is not true. According to the National Poison Center and the American Medical Association, the plant can cause stomach irritation if ingested but is not poisonous.

The success with poinsettias begins with selection. You need to look for a plant with dark-green foliage, completely colored bracts, and no sign of wilting or yellowing. The

bracts, which are actually leaves, should be blemish-free and there should be fresh yellow flowers in the center which is actually the poinsettia flower. When you purchase a plant, make sure you do not expose the plant to freezing temperatures by leaving the plant in the car in cold weather. Poinsettias are tropi-

One question that is often asked is "Can I get the poinsettia to rebloom next year?" The answer to this is yes. However, it requires some work and regularity.

cal plants and do not like the cold.

If you want to try, keep in mind that flowering in this plant responds to long, dark night hours. They need daylight for no more than 10 hours daily, beginning around Oct. 1. So, you'll need to place your plant in a darkened room that does not have any light from about 5 p.m. to 7 a.m. I have been successful by having it in a room that we do not use at night. Others, put them in a closet each night and bring it out each day. It is also important that poinsettias get trace minerals, so be sure to use a well-balanced fertilizer that contains different minerals.

DEAR MONTY

One tip often overlooked in a real estate negotiation

eader question: We are considering making an offer on a home. We are both employed in jobs that require some negotiating skills, but this is our first foray into real estate. We have built a small list of potential points to use in the negotiation if we move forward. What is the one tip you would share that most homebuyers do not consider in a home negotiation?

Monty's answer: The most challenging part of the negotiation is often

more emotional and fraught with myths and misinformation that can override data and logic. With this caveat, here is one tip, based on personal experience. Most home sellers and buyers may have a general sense of the market. They likely do not know the neighborhood's hyper-local market conditions when they make, counter or accept an offer.

Hyper-local markets

All homes are in hyper-local markets. Rural property is likely a substantial hyper-local sized area. Suppose a house is a unit in an extensive condominium development. In that case, the building or buildings themselves could be the hyper-local

market. A municipality

with seven or 8,000 homes would have many hyper-local markets.

Homes in hyper-local markets are generally in a close age range. They are also likely to be in the same price range, and the neighborhood desirability level is similar. While comparable sales from across town may possess similar amenities, the desirability levels may not be the same.

How to calculate

This data can be helpful information to consider when making an offer when placing a home on the market or changing a home's price on the market. Below is an exercise to determine where a hyper-local market stands on a particular date.

- The number of similar homes that have sold (A) in the neighborhood
- in the past six months.

 The number of similar homes that are currently for sale (B) in the neighborhood.
- A divided by six months equals the average number of homes sold per month (C).
- **B** divided by C equals (D), the statistical length of time a home will be on the market.

Daytona 500 set tone for wild 2020 season

This is the first of a series counting down the top five NASCAR Cup Series races of 2020. This week, No. 5:

Yes, there was a Daytona 500 this year.

While that may seem impossible considering what's transpired over these past 10 months, NASCAR's Super Bowl did, in fact, kick off the 2020 season back in February, and it had a little bit of everything.

The day started with Air Force One gliding over Daytona International Speedway, followed by President Trump addressing the sold-out (remember those?) Daytona crowd just before the green flag dropped on the 2020 season.

Of course, it wouldn't be Daytona without an ill-timed rain delay that sent everyone home after just 20 laps. After a quick 18-hour nap, drivers returned to the track Monday evening, and the typical Superspeedway intensity returned with them.

Chase Elliott won the opening stage of the season, while Denny Hamlin took Stage 2. Hamlin would go on to win the race - his second straight 500, and third overall — but that took a backseat to one of the most dramatic finishes in NASCAR history.

Ryan Newman and Ryan Blaney leapfrogged Hamlin for the lead coming to the white flag, and Newman led coming out of Turn 4.

Blaney made one final move to pass Newman coming to the checkers, but instead sent Newman's No. 6 Ford sideways into the wall. Hamlin narrowly avoided the wreck to take the win, but Corey LaJoie wasn't as lucky, hitting Newman's driver-side door and sending the No. 6 into the air. Newman's car finally came to a halt on its roof near pit road, and caught fire.

"I hope he's all right," a visibly shaken Blaney said after the race. "I was trying to push him to the win. I feel really bad about it. It was a close one. I just hope Ryan is all right."

LaJoie said he didn't know exactly where he hit Newman.

"I was hoping he would kind of bounce off the fence to the left, but he didn't and I hit him," he said. "I don't know exactly where I hit him. I haven't seen a replay. It was some scary stuff."

The 43-year-old Newman was removed from the mangled machine and taken by ambulance to Halifax Health Medical Center.

Amazingly, he was discharged just two days later. In May, Newman returned to racing when NASCAR resumed its season amid the coronavirus pandemic

"There's no doubt I have thought about it," Newman said in July of the crash. "The reality is it's not the truth, it's not what happened; it's a whatcould-have-been. Everybody has that in their season.

"We have to do our job to go back and replay those events and make corrections to whatever mistakes, whatever differences we can to try, to be victorious. That doesn't go just for Daytona but every race track.

The 2020 Daytona 500 featured the President of the United States, a rain delay, two overtimes, a record 209 laps, the second-closest finish in 500 history, and one dramatic crash we won't soon for-

After all that, perhaps we should've known 2020 would be a wild one.

SPEED FREAKS

Is the Daytona 500 still the Daytona 500 without a full house?

KEN'S CALL: Not for several hours through pre-race and maybe even the first 150 laps, but after that, it'll start looking very familiar.

KEN'S CALL: Pencil him in for two or three road-course wins, but beyond that, maybe the final eight at playoff
