Sampson Regional Prepares for Coronavirus



Beaman Street entrance at SRMC will be temporarily closed off to the public

Hospital leaders have worked rapidly during the last three weeks to prepare Sampson Regional in the case of a COVID-19 outbreak. Among the many precautionary measures, the hospital has expanded its visitation restriction, previously put in place for flu season, and will begin screening all visitors, effective Monday, March 16, 2020.

Temporarily, the only visitor entrance into the hospital will be through the Emergency Room & Outpatient Entrance, accessed by Cooper Drive. The entrance on Beaman Street will be closed to the public. Visitors can expect to be screened before gaining access to any area of the hospital.

As of Thursday, March 12, 2020, hospital leaders do not report any confirmed cases of COVID-19; however, the visitor restrictions and screening process SRMC, see P. 4

Lakewood High **School Receives Bomb Threat**



On Thursday at approximately 12:37pm, Lakewood High School received a Bomb Threat. According to Principal John Goode, "A message was left on the voicemail of an office phone at Lakewood High School in which the caller stated there was a bomb in the building. No other information was given."

Goode continued, "The message was received by staff at 12:39pm, and we immediately implemented critical incident procedures and evacuated all students and staff from the building. Law enforcement was also notified. All students and staff were out of the building in less than two minutes."

Deputies from the Sampson County and Cumberland County Sheriff's Departments responded, in addition to Sampson County Fire and EMS. At 2:21pm, the building was confirmed by law enforcement to be clear, and all students and staff returned to the building.

According to Principal Goode, "During this threat, our first concern was- and always will be - on the safety and well-being of our students. For that reason, we concentrated on securing our students in a safe location and clearing the building rather than making a public notification while the event was still in progress." Goode went on to thank the parents, students and staff of Lakewood High, "We appreciate your patience, understanding, and cooperation during this time."

According to Lt. Marcus Smith with the Sampson County Sheriff's Office, "Deputies responded to a reported bomb threat at Lakewood High School sometime after lunch, today. It was learned through the investigation that a phone call came into the school by an unknown person stating a bomb was inside the building. Students were immediately evacuated, and emergency personnel responded to investigate. A bomb canine from Cumberland county responded and rendered the school safe and students returned to class. An investigation is on-going at this time and no further details are available."

North Carolina Coronavirus Status Update

As the outbreak of the coronavirus continues globally, here are the latest updates on the virus and information concerning how to receive assistance if necessary.

State of Emergency Declared by Governor Cooper:

Gov. Cooper declared a state of emergency this afternoon as our state continues to deal with the coronavirus.

The state now has 7 people who have tested positive for COVID-19, the disease caused by the coronavirus.

All of the patients are in isolation while officials identify their close contacts.

All UNC hospitals will set up triage tents outside their facilities where people can come and be screened for COVID-19. On its website, UNC Health Care advises people who have symptoms and have reason to believe they have been exposed to the virus to call UNC's COVID-19 helpline at 1-888-850-2684.

The triage centers will allow health care workers to determine which patients can be sent home and which ones need to be hospitalized. The measure is designed to prevent hospitals from being overwhelmed if the spread of illness accelerates.

Coronavirus is primarily a respiratory disease, with symptoms similar to seasonal flu. According to the CDC, symptoms of coronavirus include fever, cough, and shortness of breath.

People with questions or concerns about COVID-19 can call the state's phone line at 866-462-3821.

Latest Coronavirus Update:

Five more people in Wake County have tested presumptively positive on Tuesday for coronavirus (COVID-19). According to a press release from NC DHHS. All five traveled to Boston in late February to attend a BioGen conference. Several cases of coronavirus across the country have been traced to attendance at the conference. These cases are not related to the earlier individual in Wake County who tested positive last week. All are reported to be in isolation at their respective homes.

The tests were conducted by the North Carolina State Laboratory of Public Health and are presumptively positive. The tests will be confirmed by the U.S. Centers for Disease Control and Prevention (CDC) lab. While awaiting confirmation of results from the CDC, NC DHHS will treat presumptive cases as positive and follow CDC guidelines to protect public health and limit the spread of infection.

Wake County's Public Health Division is already working to identify close contacts. The CDC defines close contact as being within approximately 6 feet of a person with an infection for a prolonged period of time. County health officials will assess risks of exposure and determine which if any additional measures are needed. These include temperature and symptom checks, quarantine and/or testing.

What are coronaviruses?

Coronaviruses are a large group of viruses that can cause illness in animals and humans. Some coronaviruses commonly circulate in the United States and usually

What is COVID-19?

Coronavirus Disease 2019 (COVID-19) is a disease that was identified in Wuhan, China, and is now being spread throughout the world. People are encouraged to take common-sense precautions to prevent the spread of all infectious diseases, including COVID-19.

- 1. Wash hands frequently with soap and water for at least 20 seconds at a time.
- 2. Avoid touching your eyes, nose, and mouth with unwashed hands.
- 3. Avoid close contact with people who are ill.
- 4. Cover your mouth and nose with a tissue when you cough or sneeze.
- 5. Do not reuse tissue after coughing, sneezing or blowing your nose.
- 6. Clean and disinfect surfaces that are frequently touched.

How does COVID-19 spread?

Coronaviruses like COVID-19 are most often spread through the air by coughing or sneezing, through close personal contact (including touching and shaking hands) or through touching your nose, mouth or eyes before washing your hands. Learn more from the Centers for Disease Control and Prevention (CDC) about how COVID-19 spreads and how to protect yourself and your community from getting and spreading respiratory illnesses.

Exposure and symptoms:

Symptoms of COVID-19 are fever, cough, and shortness of breath.

Symptoms may appear 2-14 days after exposure.

If you think you may have been exposed to COVID-19 and develop symptoms, you may need to seek medical attention. Call your local health department for further guidance. Before going to a health care provider, clinic, hospital or emergency room, call ahead to describe your symptoms and how you may have been exposed to the virus. In the event of an emergency call 9-1-1.



North Carolina Recommends New Steps to Protect Against COVID-19



Governor, DHHS urge North Carolinians to follow guidance

RALEIGH: Governor Roy Cooper today announced that North Carolina is taking proactive steps to protect the health and wellbeing of our state in the face of growing cases of the coronavirus COVID-19 around the nation and here in North Carolina. Included in today's guidance is a recommendation to cancel or postpone gatherings over 100 people and telework if possible.

"North Carolina has more tough decisions ahead, and we will be ready to make them. We have the benefit of learning from other countries and other states about the best ways to fight this

pandemic," said Governor Cooper. "We know that if we can slow the spread of this virus now, then fewer people will be infected or become seriously ill. And we can be more effective in avoiding an overload of our medical system. It will save lives."

North Carolina currently has 15 positive cases reported with more expected.

NC DHHS is making the following recommendations for all North Carolinians to reduce the spread of infection while we are still in an early stage in order to protect lives and avoid strain on our health care system. NC DHHS is making these recommendations for the next 30 days and will re-assess at that point.

1. SYMPTOMATIC PERSONS

If you need medical care and have been diagnosed with COVID-19 or suspect you might have COVID-19, call ahead and tell your health care provider you have or may have COVID-19. This will allow them to take steps to keep other people from getting exposed. NC DHHS recommends that persons experiencing fever and cough should stay at home and not go out until their symptoms have completely resolved.

2. HIGH RISK PERSONS WITHOUT SYMPTOMS

People at high risk include people:

NC DHHS recommends that people at high risk of severe illness from COVID-19 should stay at

Over 65 veers of age or with under

Over 65 years of age, or with underlying health conditions including heart disease, lung disease, or diabetes, or with weakened immune systems.

3. CONGREGATE LIVING FACILITIES

NC DHHS recommends that all facilities that serve as residential establishments for high risk persons described above should restrict visitors. Exceptions should include end of life care or other emergent

are additional steps in protecting the hospital's patients and healthcare workers. "While we have not seen COVID-19 in our community, we take the threat very seriously, as there are more and more cases reported in our state daily," said Dr. Shawn Howerton, CEO & CMO for Sampson Regional Medical Center. "We cannot prevent the coronavirus from coming into our community, but we will do our part to support the public health system in slowing the spread of this virus. And, we will act responsibly to protect our patients and staff," he added.

Visitor restrictions include:

- -No children younger than 18
- -No person with a fever (determined at visitor screening)
- -No person displaying symptoms of respiratory illness (cough, sore throat, shortness of breath), or other contagious illness.
- -No person who has traveled internationally within the last 14 days
- -No person who has been in close contact with an individual who has COVID-19

"Even healthy people can spread germs," offered Wanda Holden, RN, Infection Control Coordinator for Sampson Regional Medical Center. Holden reminds visitors how important it is to clean hands frequently, especially after touching high contact surfaces, after using the restroom, and before eating. "It's always a healthy habit to avoid touching your eyes, nose, and mouth to reduce the spread of germs," she explained.

The hospital continues to monitor COVID-19 daily. "This is an evolving situation, and we continue adjusting and responding based on new information," stated Dr. Howerton. He and his team members are working collaboratively with local agencies related to public health and the physician community to ensure the hospital continues providing safe and quality care amidst the coronavirus. Other precautionary steps include sizing up supplies, equipment, and medications and implementing a temporary travel policy for staff.

situations determined by the facility to necessitate a visit. If visitation is allowed, the visitor should be screened and

restricted if they have a respiratory illness or potential exposure to COVID-19. Facilities are encouraged to implement social distancing measures and perform temperature and respiratory symptom screening of residents and staff. These establishments include settings such as nursing homes, independent and assisted living facilities, correction facilities, and facilities that care for medically vulnerable children.

4. SCHOOLS

We do not recommend pre-emptive school closure at this time but do recommend that schools and childcare centers cancel or reduce large events and gatherings (e.g., assemblies) and field trips, limit inter-school interactions, and consider distance or e-learning in some settings. Students at high risk should implement individual plans for distance or e-learning. School dismissals may be necessary when staff or student absenteeism impacts the ability to remain open. Short-term closures may also be necessary to facilitate public health investigation and/or cleaning if a case is diagnosed in a student or staff member.

5. WORKPLACE

NC DHHS recommends that employers and employees use teleworking technologies to the greatest extent possible, stagger work schedules, and consider canceling non-essential travel. Workplaces should hold larger meetings virtually, to the extent possible. Additionally, employers should arrange the workspace to optimize distance between employees, ideally at least six feet apart. Employers should urge high risk employees to stay home and urge employees to stay home when they are sick and maximize flexibility in sick leave benefits.

6. MASS GATHERINGS, COMMUNITY, AND SOCIAL EVENTS

NC DHHS recommends that organizers of events that draw more than 100 people should cancel, postpone, modify these events or offer online streaming services. These events include large gatherings where people are in close contact (less than 6 feet), for example concerts, conferences, sporting events, faith-based events and other large gatherings.

7. MASS TRANSIT

Mass transit operators should maximize opportunities for cleaning and disinfection of frequently touched surfaces. People should avoid using use mass transit (e.g. buses, trains) while sick.

As the number of cases of COVID-19 rise in North Carolina and the United States, and with the designation of COVID-19 as a pandemic by the World Health Organization, the state is responding with a whole government response. COVID-19 is a new infection that is particularly severe in older persons and those with medical conditions, such as heart disease, lung disease, diabetes, and weakened immune systems.

At this time there are no approved treatments and no vaccine to prevent it. However, there are known methods to reduce and slow the spread of infection. Individuals can practice everyday prevention measures like frequent hand washing, staying home when sick, and covering coughs and sneezes. Community-based interventions can also help slow the spread of COVID-19. This includes measures collectively known as "social distancing." Social distancing measures aim to reduce the frequency of contact and increase physical distance between persons, thereby reducing the risks of person-to-person transmission. These measures are most effective when implemented early in an epidemic. We are at a critical inflection point where we may have the opportunity to slow the spread of this epidemic by taking proactive steps now.

Because COVID-19 is most commonly spread through respiratory droplets, North Carolinians should take the same measures that health care providers recommend to prevent the spread of the flu and other viruses, including washing your hands, avoiding touching your face, staying home if you are sick and covering coughs and sneezes with your elbow.

It is important to make sure the information you are getting about COVID-19 is coming directly from reliable sources like the CDC and NCDHHS. Dr. Mason Fuller Smith with J.W. Simmons host of We Should Know

The topic for this week's show is the Boys and Girls Home of North Carolina and the guest is Dr. Mason Fuller Smith, Director of Civic Club Relations for Boys and Girls Home of North Carolina.

Dr. Smith received his undergraduate degree from Campbell University and his Master of Divinity from Duke University. He received his Doctorate from Columbia Theological Seminary. Smith is originally from Columbus County.

JW Simmons says Dr. Smith is well traveled and is known to be a master storyteller. He asks Smith to tell the audience a little about himself and how he ended up back at Lake Waccamaw with the Boys and Girls Home.

"Well the little farming community I grew up in is affectionately Hog Waller. But its just a couple of families right on the county line. Then we moved to Whiteville, so being in Columbus County I really grew up with Boys and Girls Home kids. Some of the kids went to our church, several were involved in a scout troop. But it was kind of one of those experiences where you know about something, but I had no idea the extent of what Boys and Girls Home really meant until I was living ion Raleigh, I was still a student about to have my first kid and was looking for an opportunity. Someone mentioned to me have you thought about Boys and Girls Home. They had just built a chapel. A beautiful, multimillion-dollar facility second only to Duke Chapel."

"So, I looked into it and I was just beside myself," adds Smith. "With the amount of services with foster care, with adoptions. The way they were caring for kids. The mission. The heart that they had to provide kids a place and fell in love with it instantly. I served there for several years as the First Chaplin and preformed my first baptism right there in Lake Waccamaw with the fishes and the alligators swimming by."

"But life moved me away from there travelling internationally serving other agencies and ministries. But I think something about the need the kids faced and the way Boys and Girls Home was approaching that need and the believe that every kid deserves to be loved; that every kid deserves an opportunity. That gets into your DNA. It really changed me as a person and the way I see children and the opportunity to care for children. So, I always wanted to come back. I always wanted some avenue to come back, but it never panned out until Gary Green who was doing what I'm doing now retired."

"I kept hearing Gary's going to retire soon, but no body can replace him. And so, when he finally did, and this opportunity presented itself I called President Gary Faircloth at Boys and Girls Home and he said now who are you. And I said nobody. And so, that was the open door for me to come back and was really trilled to do so. And to be doing what I'm doing now, which is essentially just telling their story. Their story is worth hearing and they deserve to have it told."

"So, I travel all over the state. I talk to civic clubs mostly and other organizations and churches and just try to tell what going on in the lives of the children today."

Next, Simmons says that Smith is a good fit for his position and then he states the vision of Boys and Girls Home, "To be a leading human services provider, addressing the ever-changing needs of children and families, led by people of excellence and compassion."

He asks Smith to discuss the 140-acre campus at Lake Waccamaw and the children who are there. Simmons says that a large space of land, but Simmons says there is a lot going on there.

"There is," agrees Smith. "One of our sayings is that beauty is a silent teacher and you couldn't ask for a more beautiful place than Lake Waccamaw. Lake Waccamaw is the largest natural lake from Florida to Maine. It's got such a diversity of life and our campus sits in a pecan grove. It's actually one of the largest pecan orchards in the state. At one time we had hundreds and hundreds of trees. We've lost many of them over the years and we're in a replanting process. But that beauty of the orchard, the lake right there next door to us, the way we manicure and keep the place; it creates a different mindset for the kids. They've gone from some place that may be very dirty, very ugly, very hard, to a place that's soft and beautiful and full of life and growth and it has an effect on those kids."

"Our campus is sort of divided by Sam Potts Highway, and so the residential side we have our nine cottages set up kind of like a little village and at the top of the hill is the chapel. Across the corner is Thomas Academy which is our North Carolina State Charter School that gives kids an opportunity to learn, but also a vocational education. We're using that space to teach them culinary arts, woodworking, wielding, auto mechanics. And across the highway is the farm. That's a working horse farm. We have the enormous Benton Arena where we have horse shows every weekend. Rodeos. Kids have the opportunity to learn about horse care. To do equine therapy. To learn about pecans and how they grow. It just gives a different environment, a different opportunity. And the opportunity to work. The opportunity to realize that I can work hard and earn a little money and I get to use that freely. How to invest it. So, we're really doing adulting on that campus and living that farm life. Everybody should work on a farm for at least a week in their life."








this universe.





Since then, he's been burning up the track. During last season's outdoor track season, Mitchell placed third in the 300M Hurdles at a home meet with a time of 56.34; and third in the Triple Jump with a leap of 30'7 at another home meet on March 13. During the Indoor Track season, Mitchell placed first in the 300M with a run of 43.34 at the Princeton Polar Bear Meet (On January 9) and placed second in the Triple Jump with a leap of 32'5.5 at the Lakewood Polar Bear Meet on November 29.

Born in Kansas City, Kansas, Mitchell began his athletic career in rec ball. "I was about six or seven," he remembers. "I played basketball, baseball and soccer. When I was in the eighth grade, I dropped baseball and soccer and started playing football too."

Mitchell currently plays wide receiver and corner back for the Leopards football team and is a forward on the Lakewood basketball team.

Although he moved to Roseboro about 10 years ago, Mitchell has fell in love with Lakewood High School.

"I love it," he said. "I am going to miss this high school. I will miss my friends and family here and my teammates too."

Mitchell, a straight 'A' student, says that he is undecided about which college that he wants to attend, but knows that he wants to study physical therapy and sports medicine and play sports.

"If I had a dream college, I would pick Clemson," he says. "I just like the school; I think I could feel really good over there. I think I would want to run track or play football for sure."

Currently, his favorite subject is science. "I like studying the body," he says. "I am very interested in it."

The secret to his success has come from being supported by his family. "They have been very supportive of me," he said. "We are pretty tight."

So, it is no surprise when he is asked who he would like to thank, Mitchell says, "My mom and dad, my sister and my brother. They have been there for me in everything that I've ever needed. I just really appreciate

He continued, "I would also like to thank Coach Hulen and Coach Davidson, Col. Mack; all my teachers; all my teammates; my track buddy Eric Morales and my cousin, Jeremiah."

UMO Extends Spring Break and Plans for Online



MOUNT OLIVE-In a memo dated March 12, 2020, and addressed to all University of Mount Olive faculty, staff, and students, Interim President Dr. Ed Croom announced that the University

is extending spring break through Friday, March 20, 2020 as it monitors the COVID-19 virus. The memo further indicated that starting March 23, all seated courses will move to an online delivery mode until further notice. At this time, the campus will remain open and operational during the extended spring break and during the online delivery process. All adult and graduate program courses will continue as planned in the online

Croom stated. "Although we have had no cases reported involving the UMO community, we are fully aware of the need to be proactive in implementing steps to keep the entire UMO community as safe as possible."

"We have been monitoring the COVID-19 virus situation for the past several weeks,"

In another safety move, the University is canceling all events booked by third party reservationists for a three-week time period. All University campus activities and events, including departmental events, lecture series, professional meetings, chapel, club meetings, and student activity events are being canceled until further notice. In an effort to limit exposure from outside community members, the University is restricting community access to the cafeteria, Pope Wellness Center, and Moye Library.

"We are in on-going discussions with Conference Carolinas in regards to our athletic programs and sporting events," said Dr. Dan Sullivan, Senior Vice President for Student Affairs and Athletics. "We anticipate additional directive from the conference later today on how we will proceed with scheduled athletic events. This is a fluid situation and we continue to monitor and adapt University operations with the help of all available government resources."

"This situation is very unfortunate and continues to change daily," Croom said. "Part of our mission is to serve the mind, body and soul of the entire UMO community. The actions being implemented are our attempt to fulfill our cause. Let's continue to pray for God's direction and healing as we move through the next several weeks and months."

SCC Set to Launch New Programs This Fall

This fall, Sampson Community College will introduce four new programs in its Applied Technical Programs division. The four programs are Air Conditioning, Heating, and Refrigeration Technology (HVAC), Construction Management, Electrical Systems Technology, and Public Safety Administration. Leaders and instructors at SCC have been coordinating for months to establish the programs.

Graduates of each program will receive an Associates of Applied Science. Certificate and diploma options are offered for each program as well. Director of the Applied Technical Programs Division, Barney Grady, believes these programs will appeal to high school students and "non-traditional" college-aged students looking to advance or take the next step in their

Many of these job areas are in desperate need across the state. Wanda Capps, Vice President of Academic Affairs says this is why the North Carolina Community College System put the applications for these programs on a "fast track."

Still, for Grady, Capps, and others at the college, bringing these new programs to SCC has been a long road. Some programs have been in high demand for students, but also for industry leaders in the area.

Bringing the programs to SCC assists the students and the community. Capps stated, "The new programs of electrical, HVAC and construction management are a perfect fit not only for the current programs we already have but for the community of Sampson County."

Because of the great need in these areas, Grady says companies often train employees from the ground up due to an immediate demand for workers. Graduates will develop the necessary skills to work with residential, industrial, and commercial settings. This will automatically prepare them for careers in these areas where workers are in high demand.

Each program is accessible for all students—high schoolers choosing the College and Career Promise Pathway or working professionals looking to attend online or part-time. Several types of course options will be available, making these programs ideal for any student.

Dustin Hatcher, Construction Systems Technology Instructor, says that bringing the Construction Management program means bringing better career options for the students at SCC.

Hatcher stated, "With this degree, students will qualify for a broad array of careers in commercial and residential construction industries. Graduated students could also become hands-on skilled trades workers in many subcontractor fields like carpentry, concrete, siding, and roofing. We hope to continue partnering with commercial and residential contractors to better this program and help provide new employees to this industry for the future."

Students pursuing the Public Safety Administration degree could look


forward to careers in areas of public safety and service, including but not limited to law enforcement, government agencies, and more. This program allows students to gain a deeper understanding of the managerial and professional side of public safety and governmental organizations.

Graduates of the Basic Law Enforcement Training program are already ahead of the curve in the new Public Safety Administration program, as they may transfer into the program with 20 credit hours. This option would leave only three semesters remaining to graduate from the Public Safety Administration program with an Applied Associate in Science de-

Grady says bringing each program to SCC is something to look forward to this fall. Grady noted, "We have received many requests from both the industry and people seeking training in these areas to help satisfy the needs in our community. We have been successful in adding the programs, and with securing trained faculty to instruct our future students."

Despite these programs beginning in the fall, interested students can begin general education coursework in the summer. Summer registration for currently enrolled students begins on April 6th and lasts until April 24th. New students can begin enrollment on May 13th

way there. I think he will be in the low 50s when he gets to his early 40s.

KEN'S CALL: I'll say another 25-30, landing him alongside Ned Jarrett, Junior Johnson, Rusty Wallace and a few others.

Kyle Busch has 56 Cup wins,

Jimmie Johnson has 83. Does **Kyle catch Jimmie? GODSPEAK:** Kyle averages 3.5 wins a year. If he retires at 42, that's 28 more wins, which would put him one ahead of Jimmie when he's all done. KEN'S CALL: Kyle is 34 with a lot of time left. But it depends on motivation as "family time" possibly becomes a larger lure in a few years. But I'll say 90 is within reach.

THREE THINGS TO WATCH

1. Bounty hunters

Atlanta Motor Speedway will be filled with bounty hunters this weekend as a NASCAR Cup Series driver tries to put the skids on Kyle Busch's seven-race winning streak in Saturday's Truck Series race. Kevin Harvick and the series sponsor (Gander) have put up a \$100,000 bounty. Chase Elliott will chase the money at Atlanta while Kyle Larson has a ride in Homestead the following week.

2. Truck love

The Truck Series is NASCAR's version of Double A baseball, so it doesn't get the spotlight of its two older siblings (Cup, Xfinity). Harvick's bounty challenge is giving the truck guys a much needed boost. Halmar International, which

sponsors a truck team, has caught bounty fever and promises to ante up \$50,000 to any full-time Truck Series driver who can beat Busch. Said Busch, "Bring it on."

3. Family friendly

Atlanta Motor Speedway is very family friendly. For instance it has produced two father-son victories. Ned Jarrett won in 1964 and his boy Dale Jarrett got a victory in 1997. Dale Earnhardt collected nine wins at Atlanta and Dale Jr. won there in 2004. Several sets of brothers have won at Atlanta, including Terry and Bobby Labonte. In 1996 Bobby won the Atlanta race and older brother Terry captured the Cup championship.
