

# **Coronavirus Almost Shuts Down Sampson County**



Sampson County is finding itself adjusting to a new norm due to COVID-19 and county officials and agencies are quickly adjusting. The county has Declared a State of Emergency and has made many changes on a daily basis. We wanted to keep you abreast of the current situation. Please check The Sampson Weekly Facebook for any changes as they happen.

The Sampson County Health Department reported its first presumptive positive case of the novel corona virus (COVID-19) in Sampson County on March 16th. The test will be submitted to the U.S. Centers for Disease Control and Prevention (CDC) lab for confirmation. The person is doing well and is isolating at home. The County will treat presumptive cases as positive and follow CDC guidelines to protect public health and limit the spread of infection, while awaiting confirmation of results from the CDC.

The presumptive positive patient had traveled internationally. The

# ALE SEARCH WARRANTS YIELD ARRESTS, SEIZURES ACROSS TWO COUNTIES

Over the weekend, ALE special agents concluded several gambling, drug and alcohol investigations with the execution of 6 search warrants spanning two counties. The raids netted 12 arrests on 23 charges and the seizure of cocaine, marijuana, firearms, and over \$100,000 in cash.

On Friday, ALE special agents, Sampson County Sheriff's Office and the Clinton Police Department raided

two residences for gambling and illegal alcohol sales. The first location, 2915 N. Spring Branch Road in Dunn, was a residence with a large outbuilding which was used as an illegal gambling casino. The owner, Deborah Barefoot, 61, of Dunn, was charged with gambling, maintaining a gambling location, possession of illegal gambling machines, and possession of illegal slot machines.

The second residence, 406 Weeks Street in Clinton, operated as an illegal bar. The owner, Garretta Faison, 70, of Clinton, was charged with selling alcoholic beverages without an ABC permit. Two patrons, Anthony Hargrove, 49, and Thorton Bethune, 53, were arrested and served with numerous outstanding criminal processes.

On Saturday, ALE special agents and Fayetteville Police Department raided three residences and an ABC-licensed business for numerous alcohol and drug offenses. 10470 Colliers Chapel Church Road in Linden and 1409 Coley Drive in Fayetteville were raided for illegal alcohol sales. James Mckoy, 66, of Fayetteville, who had five prior charges of illegal alcohol sales, was charged with selling alcoholic beverages without an ABC permit.

Yassin Said, 31, of Fayetteville, the permittee of Jackpot Mini Mart at 503 Grove Street in Fayetteville, allowed illegal drug transactions to occur at the ABC-permitted store. Customers of the

# **Blood Donors** needed now as **COVID-19 poses** risk of critical blood shortage



Over the past week, blood centers throughout the country have experienced a significant drop in blood donations due to the mounting COVID-19 outbreak. Sampson Regional Medical Center (SampsonRMC) is among them, and the need for donors is urgent. As people are self-quarantining and social distancing and because schools and large events are cancelled, so are scheduled blood drives. The SampsonRMC Blood Donor Center is asking healthy and eligible individuals to give!

Due to additional precautionary guidelines amidst COVID-19, usual walk-ins cannot be accommodated. The Blood Donor Center requests all donors to make an appointment by calling 910-596-5417.

Donors must be at least 16 years old and weigh 110lbs or more. Donors younger than 18 years must have parental consent and may have additional height and weight requirements.

Donors are screened before giving to ensure they have a healthy temperature, blood pressure, and hemoglobin level. Donors are asked a brief set of questions regarding their health history to make sure they can safely donate, and that their blood can be

Additionally, the Blood Donor Center has tightened eligibility requirements for donors in response to COVID-19. The following people should not attempt to donate:

- · Anyone who has traveled outside of NC and/or by public transportation within the last 14 days
- · Anyone who has flu-like symptoms including a fever, cough or shortness of breath
- · Anyone who has interacted with someone who could have been exposed to COVID-19

If a prospective donor has specific questions about eligibility requirements, they may contact the Blood Donor Center at 919-596-5417.

The coronavirus does not post any known risk to blood donors during the donation process. The SampsonRMC Blood Donor Center uses sterile collection protocols required by law and is regulated by the FDA and American Blood Bank Association. This includes disinfecting donation areas frequently.

As an additional precaution, donors can exclusively and safely

# From the Desk of **Senator Brent Jackson**



This week, we have seen numerous and quickly changing updates on the virus. It is my goal to keep you all updated on these changes and make you aware of the different state mandates and suggestions to help mitigate the effects of the virus.

### **North Carolina Update:**

As of this morning, North Carolina has 97 new cases of coronavirus according to the latest count on the state Department of Health and Human Services' website. Gov. Cooper has banned mass gatherings of 100 people or more, closed K-12 public schools and ordered bars and restaurants to close except for takeout and delivery.

The state says at least 2,505 tests have been completed.

This latest update includes 11 new cases in Durham County; five new cases in Wake County, bringing the county total to 22; and three new cases in Mecklenburg County that bring the total there to 14. Buncombe County announced its first case of the virus. County health officials said the person is in isolation in Macon County. Lincoln, Hoke, Moore, Union and New Hanover counties also announced their first cases, and Watauga County reported its second case. The state announced its first known case of the virus on March 3. The virus has now been found in 23 of the state's 100 counties.

## Closing of Restaurants and Bars Throughout the State

On Tuesday, Governor Cooper announced that North Carolina restaurants and bars will be closed to sit-down service and limited to take-out or delivery orders. Grocery stores, gas stations, and convenience stores, are exempt from this order and will remain open, though they may not serve sit-down food.

The Executive Order limits the congregation of individuals by prohibiting sit-down service in restaurants. Congregation is strongly discouraged to limit the spread of COVID-19. Restaurants are allowed to provide carryout, drive-through and delivery options. Restaurant staff is not permitted to serve patrons indoors or in the outdoor seating area. If a restaurant has outdoor seating, onsite consumption in the outdoor seating area is only permitted for carry-out food and is subject to mass gathering restrictions and social distancing guidelines.

Local law enforcement agencies and district attorneys are generally responsible for enforcement of the Order provisions. Law enforcement officers are authorized to enforce the Order pursuant to N.C. Gen. Stat. § 166A-19.30(a)(2) and violations are punishable as a Class 2 misdemeanor in accordance with N.C. Gen. Stat. § 14-288.20A.

In addition, pursuant to N.C. Gen. Stat. §§ 130A-18 and 130A-25, failure to comply with the imminent hazard abatement order issued by the Secretary of the NC Department of Health and Human Services may result in injunctive relief or prosecution for a misdemeanor

Cafeterias and on-site dining facilities can provide only carry out meals. Employees are encouraged to take their food to smaller settings to prevent large gatherings of people in one location but may be allowed to utilize eating areas as long as mass gathering restrictions and social distancing guidelines are adhered to.

Additionally, the order lifts some restrictions on unemployment benefits to help workers unemployed due to Covid-19 and those who are employed but will not receive a paycheck. Additionally, it adds benefit eligibility for those out of work because they have the virus or must care for someone who is sick.

This Order will directly aid workers who may have lost wages in restaurants and meeting places due to mass gathering restrictions. For example, workers who lose income due to tips or scheduled work hours, but are still employed, would be eligible for benefits.

# **Unemployment Insurance for Workers**

Workers who may have lost wages in restaurants and meeting places due to mass gathering restrictions. Workers who lose income due to tips or scheduled work hours, but are still employed are eligible for benefits. The one-week waiting period to apply for unemployment payment for those workers who lose their jobs. There is no requirement that a person must be actively looking for another job during this time when many potential employers are closed and social distancing guidelines are in effect. Employees who lose their jobs or, in certain cases have their hours reduced due to Covid-19 can apply for unemployment benefits. Employers will not be held responsible for benefits paid as a direct result of these COVID-19 claims. Workers can apply for benefits online or by phone. Health Department will work to identify close contacts, which the CDC defines as being within approximately 6 feet of a person with a COVID-19 infection for a prolonged period of time of 10 minutes or longer. Based on information provided by the individual, County health officials will assess risks of exposure, determine which if any additional measures are needed such as temperature and symptom checks, quarantine and/or testing.

The Health Department reminds every one of the recommended measures to prevent the spread of infection, which are:

- Wash hands frequently with soap and water, and for at least 20 seconds each time. Avoid touching your eyes, nose and mouth with unwashed hands.
- Avoid close contact with people who are ill.
- Cover your mouth and nose with a tissue when you cough or sneeze.
- Do not reuse tissue after coughing, sneezing, or blowing your nose.
- Clean and disinfect surfaces that are frequently touched.

According to Sampson County officials, "We join the chorus of voices that are telling you that there is much uncertainty about the coronavirus (COVID-19) outbreak. As of March 16th, Sampson County has seen its first presumptive positive case of COVID-19. The progression of the outbreak and responses to it are, by necessity, ever evolving. However, what is of absolute certainty is Sampson County's commitment to their mission: protecting the health, safety and welfare of our citizens. To fulfill that mission, we have taken and will continue to take actions, that while they may be inconvenient, are in the best interest of our citizens and our employees and based upon guidance and direction from federal, state and local health officials. We ask for your patience and understanding."

"We have developed a resource page that will offer you information on what the County is doing in response to COVID-19 as well as guidance from public health professionals. Please understand that information is subject to change frequently, and with little to no notice."

"The Sampson County Health Department will continue to provide health care services during this difficult time. The health department will abide by guidelines from the NC Department of Health and Human Services (NCDHHS) and the Centers for Disease Control and Prevention (CDC). The Sampson County Health Department has also established a direct line for Sampson County residents with COVID-19 health questions. Call (910) 490-1056 between the hours of 8 am – 5 pm, Monday through Friday."

# State of Emergency Declaration

On Wednesday Sampson County along with each municipality across the county, declared a State of Emergency.

Currently, our state possesses a \$3.8 billion unemployment reserve. Through the actions and planning of the General Assembly, our legislature has worked to increase the size of this fund for the sole purpose of protecting North Carolinians from future economic

We are prepared to use these reserves to deal with the present and future potential negative economic impact of the COVID-19 virus. We know that our North Carolina Employers have paid these funds into this account to prepare for times like this and we are willing to use these funds to help their employees. Adjustments and changes will need to be made to our state program when the federal program becomes clearer. We anticipate knowing more specifics concerning the federal program in the coming days. However, we are prepared and we stand ready to act.

### **U.S. Small Business Administration Grants**

The SBA granted a disaster declaration to small businesses across the state, allowing affected businesses to apply for low-interest SBA disaster loans.

### H-2A Workers

Late in the evening on Monday, the State Department announced that in response to the COVID-19 outbreak, the U.S. Embassy in Mexico City and all U.S. consulates in Mexico will cancel routine immigrant and nonimmigrant visa services starting today. Although they intend to continue processing H-2 cases, they have modified their procedures to follow recommendations from public health authorities. Instead, they will prioritize the visa processing of returning H-2 workers. Returning H-2 workers are applicants whose H-2A or H-2B visas have expired in the last twelve months and are now applying for the same visa classification and did not require a waiver for their previous application. The Embassy will not be making appointments for first-time applicants or applicants who require an interview every year due to law enforcement or immigration violations.

North Carolina Agriculture is especially dependent upon foreign labor, including the H-2A agricultural visa program, and other non-immigrant agricultural worker visas to meet our intensive labor needs. The potential disruption of visa processing and limitations to visa programs could significantly alter our state's economy and our nation's food supply chain. Many of our farming communities depend on these visa programs to provide the needed labor that keeps food in our grocery stores and on our plates daily. Although this new protocol will still allow for previously approved H-2A and H-2B workers to return to farms, it will also undoubtedly prevent potential first-time or trial usage by new and growing operations hoping to participate in the program this growing season.

I am optimistic that we will be able to resolve these issues. Our state and federal delegation are well-aware of the potential impact on our agriculture communities and they will continue to advocate on behalf of our state's economic backbone. In speaking with Commissioner Troxler, Rep. Rouzer, and Sen. Tillis' office, we are confident that this will be worked out and H2a's will be able to come back to the farms and work this season.

According to county officials, "Sampson County has enacted a State of Emergency related to the COVID-19 outbreak. The document was endorsed and effective as of 3:30 p.m. (on Wednesday) The State of Emergency allows designated personnel to take appropriate preventative measures related to response to the event. The State of Emergency includes the County and, by request of the mayors of the Towns of Autryville, Garland, Harrells, Newton Grove, Roseboro, Salemburg, and Turkey, the corporate limits of those municipalities."

"The SOE orders that all emergency management personnel subject to the control of the Sampson County Board of Commissioners cooperate in the enforcement and implementation of the provisions of this Declaration, all applicable local ordinances, state and federal laws, and the Sampson County Emergency Operations Plan. Further, the Sampson County Manager is authorized to take such protective action as he deems necessary or prudent, including the implementation of prohibitions and restrictions on the County's employees and the public use of Sampson County's facilities, alterations of the manner in which services are provided by Sampson County, and the procurement of additional resources to promote and protect the public welfare during this public health emergency."

# **Event Cancellations/Postponements:**

In compliance with the Governor's prohibition on mass gatherings that bring together more than 100 persons in a single room or single space at a time, many events and programs are cancelled. As this situation evolves, additional cancellations, even small group meetings, are likely to occur. The county will offer guidance in the future regarding our Board of Commissioners meetings and the scheduled public hearings.

-Sampson County Parks and Recreation has suspended its Baseball and Softball season along with all other sports activities, including all assessments, workouts, skill development, practices and contests, until further notice.

-All events scheduled to be held at the Sampson County Exposition Center are cancelled through Tuesday, March 31, 2020.

- -The Rally for Agriculture and Sampson County Ag Day have been cancelled or postponed. -Effective immediately, all Clinton Recreation and Parks indoor facilities, including the Sampson Center and Bellamy Center will be temporarily closed and all programming, including classes, are cancelled until further notice. No facility or shelter rentals will be taken through April 6th. As previously noted, all spring sports programs including practices, games, training sessions, etc. have been postponed. The City is taking this action in consideration of the advice of public health officials and Governor Roy Cooper, to prevent or slow the spread of COVID-19 in our state.
- -The 2020 Roseboro Bloomfest has been cancelled.
- -Newton Grove and Garland Easter Egg Hunts cancelled.

## Sampson County Fire Marshal Office

The Sampson County Fire Marshal Office will perform inspections per COVID-19 event guidance provided by the Chief State Fire Marshal. Thus, fire inspections will be primarily limited to those for life safety matters.

### **Aging Department**

Due to the COVID-19 outbreak nutrition sites and senior centers will be closed to congregate participants starting Thursday, March 19, 2020 through Friday, April 3, 2020. The Department of Aging will reassess the situation and make updates at a later date. At this time, home delivered meals will continue to be delivered to those participants as normal. The Adult Day Health Care is open; however, it is recommended to keep the participants home if at all possible.

### Register of Deeds

Due to the COVID-19 outbreak, and the declaration of local, state, and national emergency, this is notification the Register of Deeds Office will be taking the following steps to restrict access to the public since receiving confirmation of COVID-19 in Sampson County!

Effective March 23, 2020 the office will be closed to the public until further notice.

All Submitters are urged to use our electronic recording system for recording documents.

The office will accept regular mail-in recordings, as well as overnight deliveries via FedEx, UPS, USPS, etc.

The public is urged to use the Register of Deeds website to process requests for copies of birth, death, and marriage records. If Internet availability is a problem, the customer may mail in a written request for copies. The request must contain the type or record requested (birth, death, or marriage certificate), name of the individual on the record, relationship to the individual (self, parent, child, etc.), a return address, and a signature of the requestor.

Request may be mailed to: Sampson County Register of Deeds, 126-A W. Elizabeth Street, Clinton, N.C. 28328

Notaries needing to take their oath of office, couples wanting to obtain a marriage license, or veterans needing to record their discharge papers (DD214), may do so by appointment only. All those seeking appointments will not be seen if they are sick.

Appointments may be made by calling (910) 592-8026. There will be no walk throughs by Funeral Homes. All documents must come to this office by way of mail.

According to county officials, "Under these circumstances, we must do things differently while adopting practices to protect personnel and the public. We will continue to conduct business to assist the public in the best way we can. If something were to happen to cause this office to be closed, no one would be able to receive any services for at least 14 days! Be assured that our focus is on doing the best we can under these circumstances."

## **Soil and Water Conservation Services**

In accordance with a Federal Government USDA Departmental Administrative Guidance, Sampson Soil & Water Conservation recommends that visitors call to schedule an appointment in advance, or be able answer "no" to the following health questions:

Have you, or someone living in your household, someone you've been in close or frequent contact with, or someone you are caring for been diagnosed with COVID-19 (Coronavirus) or had any contact with a confirmed case of COVID-19?

In the last 14 days, have you or someone living in your household, or someone you have been in close or frequent contact with, or someone you are caring for returned from, or made a travel connection through a CDC Level 3 or Level 2 country or State Department Level 3 or Level 4

Do you currently have, or have you had within the last 24 hours, any cold or flu symptoms with a fever greater than 100.4 or acute respiratory distress (e.g., shortness of breath and coughing).

To ensure that visitors and staff are safe, visitors will undergo the screening process above, as will be noted on the door of the Soil and Water Conservation Building (80 County Complex Rd., Bldg G). # **Social Services**

As a result of Coronavirus (COVID-19), certain program requirements have changed at DSS. Assistance including Food and Nutrition Services, Energy, Medicaid, Childcare and Child Support may not require an office visit. You may call the Agency at 910-592-7131 or utilize available online services linked on this website. DSS also has an outside drop box available for those who may not need to enter the Agency and there are public computers with internet service available as needed for any visitors.

# **Sampson Area Transportation**

Effective immediately and through April 3, 2020, Sampson Area Transportation will limit transportation to those which are medically necessary or for employment. Clients will be notified. Precautions will be taken to protect the health of clients that may be high risk due to age or underlying medical conditions, including increased sanitation of transportation vehicles and screening questions for symptomatic individuals to identify those with potential exposure to COVID-19.

# **Sampson County Public Works**

An important front-line defense to prevent the spread of the disease is to wash hands often with soap and water for at least 20 seconds; therefore, Public Works will temporarily cease water disconnects. That does not release customers from payment of their water bills. If you have concerns regarding your water bill, please contact them at (910) 592-0188.

# **Sampson County Public Libraries**

Sampson County Public Libraries will be closed to the general public beginning Wednesday, March 18th through March 31st. If you have questions or concerns regarding your library account, some essential staff can be reached by calling the J.C. Holliday branch, (910) 592-4153, from 9:00 am – 2:00 pm each day. Patrons are encouraged to use the book drop box for returning borrowed materials; however, fines and fees will be discontinued during this closure.

# Sampson County Schools/Clinton City Schools/Sampson Community College

On March 14th, Governor Roy Cooper ordered all K-12 public schools in North Carolina to close for a minimum of two weeks in response to COVID-19. The Executive Order also bans gatherings of more than 100 people. North Carolina currently has 23 people in 12 counties who have tested positive for COVID-19.

"We do not have the luxury of a wait-and-see approach. These are hard decisions but they are necessary so we can learn more about the virus," Governor Cooper said. "We do not want any regrets in the rearview mirror, and I am guided by one objective – doing what we must to keep people from getting sick and to make sure that those who do can get excellent care."

The Executive Order directs all public schools to close beginning Monday, March 16, 2020 for at least two weeks. The two-week period allows time for North Carolina to further understand the impact of COVID-19 across the state and develop a plan for continued learning for students should a longer closure be needed.

access the Blood Donor Center through the side door of the SampsonRMC Outpatient Diagnostic Center located at 233 Beaman Street, Clinton, NC. Upon arrival, donors are asked to ring the side doorbell and wait to be greeted by a staff member.

Blood donations help those fighting life threating illnesses, suffering from rare blood disorders, or trauma victims in need of a lifesaving transfusion. The SampsonRMC Blood Donor Center is not affiliated with other blood donor agencies, such as the American Red Cross or The Blood Connection, so it relies heavily on the loyalty of donors who live or work in Sampson County. When community members give, their donation is used to care for patients at the hospital. SampsonRMC urges the public to help maintain the blood supply needed for critically ill patients.

greatest impact to improve our communities." said Bryan House, Director of Alcohol Law Enforcement. "Because Jackpot Mini Mart holds ABC permits, we will be sending a report of our investigatory findings to the NC Alcoholic Beverage Control Commission who may decide to sanction the business through fines, a suspension, or a revocation of the ABC permits."

About ALE: ALE's 109 specially trained agents have the authority to arrest and take investigatory action throughout North Carolina. Their primary responsibility is the enforcement of Alcoholic Beverage Control, tobacco, state lottery and gambling laws.

"My family has always supported me in everything," she said. "In everything that I've done, they've always been there for me. I would also like that thank all of my friends, my pitching coach and his wife and all of my teachers for always being there to help me."

What piece of advice would she give an upcoming freshman? "I would tell them that it's completely different from middle school," she says. "There's a little bit more freedom, but I would tell them to just enjoy it because my freshman and sophomore year has just flown by. So, you have to take time to enjoy it."

When asked what she will miss the most about high school, Wilson says, "The people. I have always been friends with upperclassmen and when they have gone, I have missed them."

However, Wilson said that she holds a special place in her heart for Sampson County. "I plan on coming back to Sampson County," she said. "It will always hold a piece of me."

# Food Pantry Provides 'Fuel' For Students, Despite Limited Access to Campus

With Sampson Community College restricting access for students, the staff knows there's a likelihood that some students experience food insecurity without access to campus resources. 
"I want this to be for all students! Anyone can come to get a snack, or come get one of these bags and water," Raynor stated.

# Distance Learning Grows at SCC

Since the first online class at SCC launched in 2001, the Distance Learning curriculum at Sampson Community College has grown rapidly. Before, there was one class. Today, there are over 300 courses offered online each year.

Marion Pope, Director of Distance Learning, says that looking back over the data shows how dramatic the growth of the program has been. In 2006 and 2007, so few students took advantage of the courses, notes suggested complete suspension of the program.

Now, Pope says the program regularly "exceeds goals."

Partly due to intentional goal setting and benchmarking put in place by the college to prioritize distance learning, the number of distance learning courses at SCC exploded from the 2017-2018 academic year to the 2018-2019 year. The number of courses offered increased

For the 2018-2019 academic year, including Summer 2019, distance learning students made up 20 percent of the College's total enrollment. Another goal is to see the number of online course offerings grow and increase by two percent each year.

There are no completely online programs at SCC yet. However, having so many online courses gives working students the opportunity to complete coursework. Part of the College's 2019-2021 strategic plan proposes offering some complete online program options at SCC, but that has yet to happen.

Students commonly have the misconception that online courses are effortless, but Pope says they can often be more rigorous. There are deadlines, the need for better time management. Much more of the responsibility is on the student.

Pope says, "The face-to-face factor isn't there."

Lew Gravis, Division Chair of Arts and Sciences, says that his programs want to accomplish academic rigor in every course. Because of his background as the former Director of Distance Learning, he created a special system for evaluating online courses.

Gravis noted, "We want to ensure academic rigor in our program. I have this check sheet that I collaborated with other people on that we use to evaluate all of our online courses to make sure that they are rigorous and conform to high standards."

He encourages instructors to put meaningful material in their online courses so that students get the best out of each. Since online coursework must be self-motivated, it needs to be engaging as well.

This is why Pope often leads training and seminars with faculty and students. She says it's her favorite part of the role.

Pope said, "I enjoy helping them help each other and help themselves."

# Coronavirus the only thing slowing Logano's season

oey Logano is off to a fast start in the NASCAR Cup Series, scoring two wins in the first four races of the season in his No. 22 Team Penske Ford.

Always the optimist, Logano said he is trying to maintain an even keel knowing stock car racing has up and down cycles.

"It's been a good start for sure," he said in a recent telephone interview. "You know how things go. Sports changes so quickly, you never know what will happen next."

Logano must have a crystal ball because he made these comments before NASCAR canceled the races at Atlanta and Homestead because of coronavirus fears.

"It's nice to have a couple of victories under the belt, but things can happen quick and it's a long, long season," he said. "We are four races into the season and we have a long way to go so we need to make sure we are competitive when we get back to Phoenix."

The 29-year-old driver scored trained himself to handle the ups and downs of the sport.

"Over years of experience you got to learn a way of dealing with it," he said. "I've always been a silverlining type of guy who tries to look at the positives at the end of the day. I think that's what helps me get through it.

"In our sport you have a 1-in-40 chance of winning, so if you do the math, you lose way more than you win. What I do is find ways to find little victories in the race, like finding the balance in your car, or any kind of gain."

Logano looks at both sides of the equation. Celebrate the victories; analyze ways to get better following

"It's important to look at your weaknesses, for sure, but celebrate the parts of the race where you excelled," he said. "You try to ride the wave as much as possible and during the lows, you try to stay positive and keep grinding."

Logano has been the primary beneficiary of a crew chief swap engineered by team owner Roger

Penske paired Paul Wolfe, who spent several years on the box for Brad Keselowski, with Logano and the two have sound instant magic.

"It says a lot about what we've been able to do as a company and how well we work together," Wolfe said after Logano won Phoenix. "We need to obviously continue to do that as we move forward

It has become apparent that Team Penske will contend for a Cup Series championship this season thanks to the internal moves.

"It looks like Roger Penske is a genius at this point, doesn't it?" Logano said with a laugh. "It's been pretty cool. I think it was a healthy change for everyone at Team Penske and now we're seeing the results." Ryan Blaney, who was in position to win three races this season, and

Keselowski, round out the Penske

"All three cars are showing better performance, which is what you want to see," Logano said. "You want to see your teammates right up there with you and pushing each other to be better.

"We are seeing that and we've opened the lines of communication a little more between teams. It was a lot to wrap my head around, but obviously, the performance has been there and it was the right change at this point."

The future of the sport looks healthy (sans coronavirus), according to Logano. The 2018 NASCAR champion likes the changes he is

seeing throughout the industry. He credits the new and older players at NASCAR's executive level for creating more excitement and some recent tweaks to the future

"There's a good mix at NASCAR right now," he said. "Ben Kennedy is the younger guy with a lot of Helton, Jim France and those types of people who have been in the sport forever.

"It's good to have a little mix of both young and older. The job is to give the fans what they want and they want road courses. People need to look at the data, young or old, and the data says road-course racing."


