



At Wednesday night's special called Sampson County Board of Commissioners meeting via Facebook Live, the board unanimously approved a resolution to be sent to Governor Roy Cooper to open up ALL of Sampson County businesses IMMEDIATELY!

The county attorney Joel Starling read the resolution aloud to the commissioners.

The resolution said, "while mindful of the precautions that citizens should and will continue to take to guard against the spread of COVID-19, the Sampson County Board of Commissioners finds that it is time that the citizens of Sampson County be allowed to resume the enjoyment of the fruits of their own labor and the pursuit of happiness;

NOW, THEREFORE, BE IT RESOLVED that the Sampson County Board of Commissioners respectfully requests that, effective immediately, Governor Roy Cooper allow all of Sampson County's businesses to

The Sampson County Health Department is reporting 12 new cases which brings the total to 314 positive cases of the novel coronavirus (COVID-19) as of Thursday.

On Friday, May 22, 2020, at 5pm, North Carolina will move into Phase Two. The Stay at Home order will be lifted as North Carolina moves to a Safer at Home recommendation, especially for vulnerable populations.

### Gathering Limits:

### 10 indoors/25 outdoors

Meeting & event venues Amphitheaters Sporting venues and arenas Groups at beaches Groups at parks

Restaurants 50% capacity + other requirements

Bars/Nightclubs Museums Playgrounds Gyms and Fitness Studios (yoga, cycling, martial arts, etc) Indoor Entertainment Venues (movies, bowling, bingo, etc)

Human Services Secretary Dr. Mandy Cohen on Tuesday announced that North Carolina will move into Safer At Home Phase 2 of lifting COVID-19 restrictions on Friday, May 22 at 5 pm. Read Executive Order No. 141. After two weeks in Phase 1, the state's overall key indicators remain stable but the continued increases in daily case counts signal a need to take a more modest step forward in Phase 2 than originally envisioned.

"North Carolina is using the data to guide our decisions about when to lift COVID-19 restrictions, and overall our key indicators remain stable," said Governor Cooper. "Safer At Home Phase 2 is another careful step forward, and we have to continue taking this virus seriously to prevent a dangerous spike in infections."

"From the beginning, North Carolinians have joined together to confront this crisis. We need to rely upon one another to practice the three Ws as we begin leaving our homes more. When we wear a face covering, wait six feet apart, and wash our hands often, we are showing we care for our loved ones and neighbors," said Dr. Mandy Cohen.

Based on the metrics laid out in April by Governor Cooper and Secretary Cohen, North Carolina is evaluating a combination of the data from the following categories that shows the state is stable but still has increasing daily new lab confirmed case Trajectory in COVID-Like Illness (CLI) Surveillance Over 14 Days -North Carolina's syndromic surveillance trend for COVID-like illness is decreasing.

Trajectory of Lab-Confirmed Cases Over 14 Days -North Carolina's trajectory of lab-confirmed cases is increasing.

Trajectory in Percent of Tests Returning Positive Over 14 Days -North Carolina's trajectory in percent of tests returning positive has been decreasing and is starting to level.

Trajectory in Hospitalizations Over 14 Days -North Carolina's trajectory of hospitalizations is level.

In addition to these metrics, the state continues building capacity to be able to adequately respond to an increase in virus spread. These areas include:

### Laboratory Testing

-North Carolina has more than doubled the daily testing rate with more than 8,000 tests completed daily on average. More than 300 testing sites across North Carolina are posted on the DHHS testing information website.

#### **Tracing Capability**

-The Carolina Community Tracing Collaborative has already hired more than 150 new contact tracers adding to the 250 already working at our local health departments.

Personal Protective Equipment Supply chains continue to improve.

What's included in Safer At Home Phase 2?

Phase 2 lifts the Stay At Home order moving into a Safer At Home recommendation, especially for people at high risk for serious illness. Teleworking is also urged when possible.

Mass gathering limits in Phase 2 will be no more than 10 people indoors or 25 people outdoors in most circumstances. These limits apply to the following: event venues; conference centers; stadiums and sports arenas; amphitheaters; and groups at parks or beaches.

Some businesses will remain closed in Phase 2 including: bars; night clubs; gyms and indoor fitness facilities; indoor entertainment venues such as movie theaters, and bowling alleys.

Certain businesses will be open at limited capacity with other requirements and recommendations including: restaurants at 50% dine-in capacity with distancing and cleaning requirements; personal care businesses, including salons and barbers, at 50% capacity with distancing and cleaning requirements; pools at 50% capacity with distancing and cleaning requirements. Employees of personal care businesses will be required to wear face coverings.

Childcare facilities, day camps and overnight camps will be open with enhanced cleaning and screening requirements. Retail businesses allowed to open in Phase 1 at 50% capacity will continue at that level.

Public health recommendations are provided for worship services to practice en-

counts.

mass testing event that was held this past Saturday, May 16th. There are still a number of tests pending, as noted in the stats below. At the Saturday Drive Thru testing event 493 tests were administered.

The Sampson County Health Department continues its extensive contact tracing as part of their investigation of positive cases to identify close contacts (which are defined as being within approximately 6 feet of a person with a COVID-19 infection for a prolonged period of time of 10 minutes or longer). This allows health officials to assess risks of exposure and determine and recommend additional measures that may be needed, including quarantine or additional testing.

We encourage the use of common-sense preventative measures: practice social distancing-staying 6-feet apart, avoid touching your face, wear protective face covering when in public, cover your cough, wash your hands and disinfect surfaces frequently. If you think you have the coronavirus, call your health care provider so that he/she can evaluate your symptoms and provide the best course of action. Please stay at home and call your doctor if you have fever of 100.4 or higher, cough, or shortness of breath.

Numbers in North Carolina continue to increase with 20,860 laboratory confirmed cases, 716 deaths. A total of 290,645 tests have been administered statewide. Currently there are 578 positive Covid -19 patients hospitalized statewide.

The first case of Multisystem Inflammatory Syndrome in Children (MIS-C) associated with COVID-19 was reported on Thursday. While children generally experience mild symptoms with COVID-19, recently a possible link

has been found between COVID-19 and a serious inflammatory disease in some children and teenagers who have current or recent infections. The first reports of this syndrome came from the United Kingdom in late April. Cases in the United States were first reported in New York City in early May. MIS-C is a very rare condition, but as COVID-19 cases increase, additional reports of MIS-C could follow. Because children with this syndrome may become seriously ill, it is important that parents and caregivers know the signs and symptoms their children may have so they can get help right away.

Most children with MIS-C have fever (temperature of 100.4 degrees F or 38.0 degrees C or greater) lasting several days, along with other symptoms. Other common symptoms include:

-Irritability or decreased activity

- -Abdominal pain without another explanation
- -Diarrhea
- -Vomiting
- -Rash
- -Conjunctivitis (red or pink eyes)
- -Poor feeding
- -Red, cracked lips or red, bumpy tongue that looks like a strawberry -Swollen hands and feet, which might also be red

Call your child's doctor immediately if your child has a persistent fever plus any of the above symptoms. The doctor will ask about your child's symptoms and use that information to recommend next steps. If your child is severely ill, go to the nearest emergency room or call 911 immediately.

All adults and children should take steps to protect themselves from COVID-19. Adults and children over the age of two who can reliably wear a face covering should wear one whenever they are in public. Even when wearing a face covering, try to cough or sneeze into your elbow and practice not touching your face.

Everyone can help prevent the spread of COVID-19 by practicing the 3 Ws: Wear. Wait. Wash. Wear a cloth face covering, wait at least six feet apart to maintain social distancing and wash hands regularly or use hand sanitizer.

Trooper S.K. Naylor was called to investigate a fatal collision that occurred on US 13 near the Cumberland County line. Vehicle 1, a tractor trailer, was traveling north on US 13. Vehicle 2, 1997 Jeep Grand Cherokee, was traveling south on US 13. The driver of Vehicle 2, Calvin Antoine Poarch (02/08/1959) of Fayetteville, lost control when the vehicle hydro-planed on the wet road. Vehicle 2 travelled left of center and struck Vehicle 1 head on. After impact Vehicle 2 travelled off the right side of the road and overturned. The right front passenger, Retha Renee Hodges (04/21/1961) of Fayetteville, was ejected and died at the scene. Mr. Poarch was transported to Sampson Regional Medical Center and a third passenger was transported to Cape Fear Valley.

# World War II Veteran Ester King Turns 100



One hundred years ago in Sampson County, a young man was born on a small family farm. His destiny seemed to be already set due to the fact he was born into a black family in 1920 America. However, Ester King did not let this limit his path and his future.

Ester was born on May 21, 1920 into a family with 8 kids to Needham King and Bertha McLamb. The humble parents raised their family with much love and affection.

Ester King was born the same year that the Boston Red Sox sold slugger Babe Ruth to the New York Yankees for \$125000 and a \$350,000 loan. This is what they say started the 84 year "Curse of the Bambino". He was also born the same year that Walt Disney started work as an artist with KC Slide Company for \$40 a week- when Walt Disney died in 1966 his fortune was worth over \$150 million, equivalent to \$1.1 billion today. Also, the same year as Ester's birth, the National Negro Baseball League was started, setting the stage for more rights for minorities in sports. On June 13th, 1920, the US Post Office said that children cannot be sent by parcel post anymore- due to various instances occurring. On November 2nd, 1920, Warren G Harding was elected President of the United States. Mr. Ester King has lived to see 17 different presidents take office, even the first black president Barack Obama.

Ester lived to see Jackie Robinson, in 1947, be the first African American to play on a major league team, the racial Integration of schools, the civil rights movement of Martin Luther King Jr, and the 1965 Voting Rights Act. Mr. King has seen the horrors of war such as World War II, the Korean War, the Vietnam War, the Gulf War, and the Iraq War.

He was born the same year that hair dryers, kiss-proof lipstick, and submachine guns were invented.

He has lived through the invention of television, penicillin, the nuclear bomb, a man in space, the computer, and cell phones. So, life has changed indeed during the lifetime of Ester King.

Ester attended school at Keener School from the age of 8-13. At 13, his education

Once back home from war in 1945, Ester came back home to Sampson County and married his childhood sweetheart Alease Monk. The couple had two children Starling King and Suella King.

The war had changed things in America and once arriving home Ester was also allowed to fulfill his dream of having his own carpentry business, which he did with great success. Some of Ester's carpentry and brick laying skills are still visible today in the Newton Grove Post Office, the Sampson County Courthouse, White Oak Church in Newton Grove, Bethlehem Church and the house of Veterinarian Dr. Guy Bertich.

Ester was determined to live his life a certain way and he still does so today.

Longevity is something that runs in Ester's genes. His sister Sudie Mae is almost 99 years old. He has two brothers still living, Silas King, who is 90 years old and lives in New York, and Paul Mitchell who is 85 and lives in Oklahoma. Ester is one of the oldest surviving World War II veterans in Sampson County. Ester is also the oldest member at Union Grove Freewill Baptist Church.

Ester King has been planning for years for his 100th birthday party. He wanted a big community party but with the COVID-19 pandemic, this will not be possible. However, the community is going to make sure he gets the party he most definitely deserves. According to friend, Bud Gilmore who is heading up a birthday card campaign for Ester, "He was very adamant about a big party but with COVID-19 we having to go to Plan B." Gilmore is urging everyone to send Mr. Ester King a birthday card full of best wishes for his 100th Birthday.

Gilmore says that Ester loves Pepsi Colas and Honey Buns. "Everybody in the community tries to look after Mr. Ester and keep an eye on him. Mr. Ester is such a gift to the community. And everybody loves him. He is full of good history stories." Gilmore explained that Ester was born during the time that the Spanish Flu was winding down and "He's turning 100 years old during a quarantine again."

Gilmore continued, "Mr. King still lives at home (which he built) and can be seen daily

was halted due the fact that in 5th grade he had to start working in the cotton fields. In 1937, Ester took it upon himself to better himself and he learned the carpentry trade from Forrest McCullen. It was in carpentry and brick laying that Ester would earn his living moving forward.

At the age of 18, this young man bought his first piece of property, 20 acres for the huge sum of \$300. At the age of 21, on that same property, Ester built the home that he still lives in today. Ester helped in building Camp Lejeune in Jacksonville and Camp Butler in Durham. Ester had a desire to start his own business, but back in 1940, black men were not allowed, so he had to take on jobs considered as "common labor". But that would soon change as society realized the injustice of suppression.

But war was calling, and Ester was drafted to serve in World War II in 1942, where he served until 1945. Ester was stationed in Fort Bragg where immediately he was placed on a "big ship" and sent to North Africa and Italy. He was stationed with the US Army 907th Air Base Security where he guarded planes so they could not be blown up by the Germans. He also served as an Advanced Scout and would go out and look for approaching enemies and report back to camp.

sitting outside drinking a Pepsi and tending his garden. Many know him simply as "the man on the roof", as he would often sit on his roof enjoying the sun."



It was therefore no surprise, that in 2016, when a full-time IT Instructor position opened up at Sampson Community College, that McKee jumped at the opportunity. After all, it was closer to home, it was a chance to give back to his alma mater, and it was an opportunity do what he loved.

In 1999, McKee graduated from Piedmont Virginia Community College with his associate's degree in computer information systems. He took a job with Outsource, Inc. as a Data Analyst and moved to Clinton,

NC in 2000. In 2005, after returning home from a combat deployment to Iraq, McKee enrolled at Sampson Community College (SCC), using the Montgomery GI Bill. After two semesters, he transferred to Mount Olive College, now the University of Mount Olive, where he obtained his bachelor's degree in computer information systems in 2007. Although he was an adult student, Mckee chose to enroll in the traditional day-

"The administration and my professors were very helpful when I needed to miss class due to military obligations," McKee recalled. "UMO helped me prepare for my career by teaching me a great deal about technology and more importantly how to not give up when things get tough."

In addition to his studies McKee became a walkon for the Trojan track team, where he ran cross country. I enjoyed working with a team and traveling to competitions," McKee shared. "Although I was older than the students and the coach, I never gave up."

McKee still enjoys running today. He can often said of his teaching career. "It is also great to be validated by former students who contact me to let me know that they have gone on to bigger and better things, due in part to what I taught them."

A year after joining SCC, McKee retired from the NC Army National Guard as a Sergeant First Class, and he was promoted to his current role at SCC as Information Technology Department Chair. As Department Chair McKee is responsible for planning curriculum and course offerings, as well as supervising faculty within the Department. He also teaches courses dealing with Information Technology and Cyber Security. Under McKee's leadership, the SCC Information Technology Department has grown tremendously and added several strategic partners.

"We now partner with Cisco Systems, Palo Alto Networks, VMware, and Network Development Group, among others," McKee shared.

In November of 2019, as a result of McKee's "never give up" attitude, SCC was designated by the National Security Agency (NSA) and Department of Homeland Security (DHS) as a Center of Academic Excellence in Cybersecurity Education. It was an arduous process and one in which McKee spent countless hours outside of his normal duties to insure its success.

"It was a year-long validation process which ensures that SCC's Cybersecurity curriculum is rigorous, relevant, and is producing a highly skilled cybersecurity workforce to both government and industry," McKee said. "As of 2020, only nine colleges and universities throughout NC have achieved this designation," he add-ed.

"It is simply wonderful to hear that Nathan, an exemplary graduate in the UMO Computer Information Systems program, is now positively impacting the lives of his students- thus, the student becomes the master!," said Dr. Karl Reimers, UMO Computer Information Systems Professor.

Chair of the Tillman School of Business at UMO Dr. Kathy Best said, "We are proud of the success of our alumni! Nathan has done an excellent job of utilizing his education at UMO to transform his career and make a difference in the lives of others."

Likewise, Mckee shared his praise for UMO. "I am so appreciative to UMO for giving me the ability to find my true calling of educating others. For anyone considering returning to college, I would say, 'It's never too late to learn something new,'" he concluded.

McKee and his wife, Michele, who is a UMO alumna from the class of 2010, have one son, Kyle. They are members of Clinton Community Church.







# **THROUGH THE GEARS** NASCAR breaks the silence at Darlington

fter more than two months on the sidelines, NASCAR cranked the engines again and began picking up the pieces on a revamped 2020 schedule.

After Sunday and Wednesday dates at good ol' Darlington, it's on to another familiar stock-car stomping ground – Charlotte – for a pair of races next week.

Let's climb through the gear box and get up to speed ...

**FIRST GEAR:** Kevin Harvick emerged from NASCAR's coronavirus shutdown the same way he went in — as one of the most competitive drivers on the track by winning the "Pandemic 400."

The 44-year-old competitor is the only driver to score top-10 finishes in all five Cup Series races run to date. He was second to Joey Logano at Phoenix before the two-month break.

Harvick, who started sixth in the 40-car field, led twice for a race-high 159 laps in his No. 4 Stewart-Haas Racing Ford. There was no practice or qualifying before the race. "I really thought that it would definitely play into our hand just because our guys are so good at hitting the car off the truck for the most part," Harvick said.

**SECOND GEAR:** On the other end of the welcome-back-to-racing spectrum was Ricky Stenhouse Jr., who failed to complete the first of 293 laps at Darlington. He crashed out in his No. 47 Chevrolet seconds after

the race went green. "Not really sure what to say there about our first

lap, first corner," he said. "It was pretty embarrassing for myself, our team." Jimmie Johnson, who wheels

the No. 48 Hendrick Motorsports Chevy, was heading for a Stage 1 victory when his car spun and hit the wall on Lap 90. He had led nine laps.

"Gosh, what I would do to get that corner back to do it over again," Johnson said after donning a face mask. "Coming to the end of the stage, I was just trying to make sure I got a good run off of Turn 2... (then) things just went horribly wrong there."

**THIRD GEAR:** Had there been no coronavirus outbreak and subsequent shutdown of racing, last weekend would have been the NASCAR All-Star Race and a prelude of sorts for Sunday's Coca-Cola 600 at Charlotte Motor Speedway. Instead, drivers raced at Darlington to jump-start the 2020 Cup Series season.

The 600, which first appeared on the NASCAR schedule in 1960, will be staged on its traditional date, minus fans in the stands.

Participants in Darlington's first race said it was weird staging a race without people in the grandstands.

"When you look up in the stands, you certainly missed the fans, that vibe, the energy," NASCAR executive vice president Steve O'Donnell said. "Even the music that was playing in the garage area doesn't do it justice."

**FOURTH GEAR:** NASCAR scheduled seven NASCAR national races (Cup, Xfinity, Truck) from May 17-27. Kyle Busch, the 2015 Cup Series champion, will compete in all of those races in NAS-CAR's compressed schedule.

The endurance run includes a Truck Series race at Charlotte on May 26.

Don't forget this: There is a \$100,000 bounty for any driver that beats Busch in that Truck race.

On Mad Dog Sports Radio, Busch did not sound too excited about the racing slate.

### QUESTIONS & ATTITUDE

Compelling questions ... and maybe a few actual answers

#### Kevin Harvick now at 50 career wins. Will any other current driver get there?

Denny Hamlin is at 38 wins and pushing 40 years old, and he could, or he could stall a bit and run out of time. Joey Logano (nearly 30 with 25 wins) and Brad Keselowski (age 36, 30 wins) could also conceivably do it. But there are a lot of moving parts, on and off the track, and a lot of things have to go right for a driver to reach 50 wins. No guarantees. For all we know, Harvick might be the last for a very long time.

### How do you rate Matt Kenseth's comeback?

It's like he never left. The guy could always roll off the futon, kiss the kids goodbye and go finish 10th, anytime and anywhere. It's certainly admirable that Mild Matt, at 48, could go 18 months without racing and finish 10th (at Darlington, no less) without a warmup, but frankly I'm just not surprised. Death, taxes and Matt Kenseth in the top 10.
