







The event was held in the General Court of Justice Superior Court Division 4th Judicial District (the main courtroom). Friends, family, peers, and colleagues filled the courtroom for this momentous occasion. The Honorable Charles H Henry presided the session.

Opening the event was Lt. Vernon Huffman with the Sampson County Sheriff's Office with the invocation by Roscoe M. Holland Jr Esquire. Mayor Lew Starling recognized all dignitaries that were present in the audience including judges, commissioners, mayors, school board members and councilmen.

SAMPSON COUNTY SELECTS NEW ECONOMIC DEVELOPMENT DIRECTOR


Sampson County has selected Stephen R. Barrington of Wake Forest, North Carolina as their new Economic Development Director, effective October 28, 2019. Barrington is currently an Account Executive with Emsi, a company specializing in educating economic developers on how to leverage data to attract and retain business. He has wealth of experience as an economic development professional, having previously served as Director of Business Engagement for the Wake County/ Capital Area Workforce Development Board (a public-private partnership), as Economic Development Project Manager for the Wake Forest Cham-



ber of Commerce, and as Executive Director of the Franklin County Chamber of Commerce. He served a four-year term as a Town Commissioner for the Town of Wake Forest from 2003-2007, during which the town obtained their first bond to assist with open space and transportation infrastructure needs and updated its land use plan. Barrington holds a master's degree in Public Administration and a bachelor's degree in Political Science from Western Carolina University, and a bachelor's degree in Foreign Language from Mars Hill College.

Separate Overnight Shootings Lead to 3 Injuried

Clinton, NC – On October 7, 2019, the Sampson County E-911 Center received a call regarding a shooting victim at 964 The Avenue, Clinton, NC. Upon arrival, deputies discovered that the victim had been transferred by private vehicle to Sampson Regional Medical Center. The victim was identified as LaShanda Yvette Petty (age 38) who was a resident of the location. Ms. Petty was shot in one of her lower extremities, however the injury was non-life threatening.

Deputies conducted a search of the crime scene and located a male hiding outside the property, along with a stolen firearm. The male, identified as Daniel O'Neal Gaither, age 43, of the same residence, was detained.

Investigators developed enough probable cause and evidence to charge Mr. Gaither with Assault with a Deadly Weapon Inflicting Serious Injury and Possession of a Stolen Firearm. Mr. Gaither was placed in the Sampson County Detention Center under a \$115,000.00 bond with an initial court date set for October 18, 2019, in Clinton,

Shortly after midnight, on October 8, 2019, a report of a second, unrelated shooting was called in to the E-911 Center. Deputies were dispatched to 251 Byrd-Yancey-Bass Road, Clinton, NC in regard to two shooting victims. Upon arrival, deputies discovered two young males outside the residence being tended to by family members. Both males had apparent gunshot wounds to their lower extremities, however the wounds did not appear to be life

According to family members, they were in the residence, when gunshots rang out and bullets started piercing the single-wide trailer. No one was able to provide a suspect description. A second residence, 268 Byrd-Yancey-Bass Road was also damaged by gunfire, however no one was

The wounded, Kweli Harrington (age 18) and a seventeen-year-old juvenile were transported to Sampson Regional Medical Center for treatment. No additional information is available at this time.

Legislative Recap

Weekly Legislative Update

This week, following the vote to not concur with the House version of the Farm Act, conferees have been appointed from both the House and Senate to discuss and rectify the differences between each version of the bill. It is our hope that we can meet with members of both bodies and resolve our differences in such a way that we can grow and protect agriculture in North Carolina. Hemp in particular is a burgeoning industry and we expect to have a lively debate on that issue. That said, it is still my intention to give this crop the strong start it deserves as our farmers embrace new options for protecting their livelihoods.

Committees also continue this week with a number of appropriations bills finding their ways to the floor. We are hopeful that our major legislative endeavors will conclude on or before the last day of October. This session has extended far beyond what we originally anticipated, but it is time for us to fulfill our obligation to the people of North Carolina and complete funding for our most important projects and programs.

Duplin County- Faison Cemetery Wreaths Across America

This year, National Wreaths Across America Day will be held on Saturday, December 14th, 2019. Locally, a ceremony will begin at 12:00pm followed by the placement of the wreaths at Faison Cemetery located at 100 Cemetery Drive, Faison, NC where 184 local veterans are laid to rest. With the generosity of our community, they are hoping to meet this goal and ensure no veteran is forgotten. Sampson County- Coat Closet Collection commences

The Clinton-Sampson Chamber of Commerce is holding the Chamber Coat Closet project for the 10th year in a row and looking to build off the past for another success annual endeavor.

Coat boxes have been placed in locations across the county. Chamber members who have volunteered to participate in the event have coat boxes at their offices or businesses.

Sampson County has received thousands of coats over the past decade, providing those in need of a little warmth over the winter. The Chamber of Commerce has partnered with schools across the county to determine how many students could be in need of a coat. Coat requests are sent in by Coat Closet partners, with the ultimate goal to fulfill every request received for a child or family in need.

The coat collections started Sept. 27 and will continue until Oct. 31. People in the community can find coat boxes in multiple locations.

Autryville's Town Hall will have a coat box. Garland's Southern Bank has a coat box. Clinton has multiple locations that have coat boxes, including the Chamber of Commerce; BB&T on Warsaw Road; Belk of Clinton; Clinton Appliance & Furniture; Clinton Community Church; Deacon Jones Automotive; First Citizens Bank; Performance Automotive; Performance Ford of Clinton; Sampson Community College; Tim's Gift; and Timberlake Country Club.

Harrells has a donation box at Harrells Christian Academy, while Newton Grove's BB&T and First Citizens Bank have coat boxes. Additionally, Roseboro's First Citizens Bank has a collection box, as does Salemburg's Town Hall and Southern Bank and Turkey's Town Hall.

The Chamber asks the community to help in collecting as many gently used and new coats as possible. They are looking for sizes that would fit children, since most request are for younger children who need a coat. The sizes can range from infant sizes to young adults who are 18 years old, but adult coats are accepted as well.

The Clinton-Sampson Chamber of Commerce is a non-profit organization of more than 350 businesses and professionals who seek to improve and maintain the overall economic well-being and quality of life in Sampson County. 

Remarks concerning the late Judge W. Douglas Parsons were made by the Honorable Henry L Stevens IV- Resident Superior Court Judge and close friends of Judge Doug Parsons, Judge William B Sutton Jr and John P. O'Hale, Esquire. Remarks were also made by Chairman of the Sampson County Board of Commissioners Clark Wooten.

A resolution for the renaming of the Courthouse Extension and W. Douglas Parsons was read by Judge Sutton. The resolution described the life of Judge W. Douglas Parsons and his vast achievements:

"Doug Parsons was born on Octo-

dergo an extensive screening process conducted by Developmental Associates, LLC that included an EQ-i assessment, structured interviews, followed by written and in-person negotiation and presentation simulation exercises. "Throughout the assessment and interview process, Mr. Barrington demonstrated that he not only possesses the knowledge and technical skills required for the position of Economic Developer, but also that he has the demeanor and leadership competencies that will engender and sustain collaborative partnerships, stated County Manager Ed Causey. "For the past two years, the Board of Commissioners has committed both time and financial resources to proactively planning for the economic growth that is needed to sustain our rural communities," Causey noted. "Selecting the candidate who can synergize the efforts of our many capable community partners and effectively implement the Board's vision for economic development is without question one of the most critical steps in our plan."

Chairman of the Board of Commissioners Clark Wooten, who participated in the interview portion of the candidate assessments, echoed Mr. Causey's sentiments, "The Board acknowledges there is no more critical issue for Sampson County at this time than positioning us to capitalize on our resources – be it infrastructure, workforce, transportation, or relational – to ensure our existing businesses thrive and prosper and that new industries are recruited to locate." He added, "We believe that we have selected the candidate who can best translate that philosophy to action."

ber 7, 1950 the son of Seth and Irma Parsons. Doug Parsons was married to Roxanne Parsons and had one son Michael who is an architect in Raleigh, North Carolina and one daughter Rachel who is a special needs teacher in Mebane, North Carolina and was the grandfather of William Cole Parsons. Doug Parsons graduated from Clinton, North Carolina public school system; received his Bachelor's Degree at the University of North Carolina in Chapel Hill in 1972, attended Wake Forest University School of Law and graduated in 1975 and was admitted to the North Carolina State Bar in 1975. Doug Parsons was an Assistant District Attorney for the Fourth Judicial District from 1975-1978; Assistant United States Attorney, for the Eastern District of North Carolina, Raleigh, North Carolina 1978-1979. Admitted to practice in all North Carolina Courts, U.S. District Court, Eastern District North Carolina, U.S. District Court, Middle District and Western District of North Carolina, U.S. Circuit Court of Appeals, Fourth Circuit, and the United States Supreme Court. Parsons was a lecturer and presented manuscripts on Criminal Law and trial of criminal cases for the North Carolina Academy of Trial Lawyers, Wake Forest School of Law, University of North Carolina School of Law, North Carolina Bar Association, Eastern District Federal Defenders Conference, North Carolina Public Defenders Conference, and the North Carolina District Attorneys Conference. Doug Parsons was appointed by the Lt. Governor to the North Carolina Criminal Justice Education and Training Standards Commission, 1985-1989, was appointed by the Governor to the North Carolina Courts Commission, 1993-2001, was President of the Sampson County Bar Association, 1984, was President of the Fourth Judicial District Bar Association, 1986, was appointed by North Carolina State Bar to Criminal Justice Section Counsel, 1981-1984 and 1999-2002, was appointed by North Carolina State Bar to Criminal Law Specialization Committee, 1991-1999, and was Chairman, 1995-1999, was on the North Carolina Academy of Trial Lawyers Board of Governors, 1987-1997 and 2006-2009, was a Legislative Chair of the Criminal Law Section and Vice President of Legislation, 1989-1991, was Board Certified Specialist in State Criminal Law and Federal Criminal Law, North Carolina State Board of Legal Specialization."

The resolution went on to explain, "Doug Parsons was appointed by the Lt. Governor to the North Carolina Criminal Justice Education and Training Standards Commission, 1985-1989, was appointed by the Governor to the North Carolina Courts Commission, 1993-2001, was President of the Sampson County Bar Association, 1984, was President of the Fourth Judicial District Bar Association, 1986, was appointed by North Carolina State Bar to Criminal Justice Section Counsel, 1981-1984 and 1999-2002, was appointed by North Carolina State Bar to Criminal Law Specialization Committee, 1991-1999, and was Chairman, 1995-1999, was on the North Carolina Academy of Trial Lawyers Board of Governors, 1987-1997 and 2006-2009, was a Legislative Chair of the Criminal Law Section and Vice President of Legislation, 1989-1991, was Board Certified Specialist in State Criminal Law and Federal Criminal Law, North Carolina State Board of Legal Specialization. Parsons was officially appointed by Governor Beverly Perdue in March of 2012 to replace retiring Superior Court Judge Russell Lanier, Jr. and was sworn in, in the Sampson County courtroom in June of 2012 as Resident Superior Court Judge for Judicial District 4A, which encompasses Jones, Duplin and Sampson County and held that position until his death on September 24, 2017."

The resolution went on to say, "At the time of his death Doug Parsons was a member of the North Carolina Judicial Standards Commission and was on the UNC Board of Visitors. Parsons loved to spend time with his family and children and grandchild, and he loved to hunt and fish."

In closing the resolution summed it all up, "Doug Parsons was an outstanding criminal law attorney and was an outstanding Judge for the State of North Carolina."

Friend and colleague John P. O'Hale made remarks about his dear friend Judge Parsons and unveiled the portrait that will eventually be hung in the Sampson County Courthouse. The portrait was painted by artist Vicars Lynn McKinney.

The family of W. Douglas Parsons unveiled the painting for everyone in attendance to view. The portrait will be hung in the main courthouse along with portraits of past judges.

SCT Alum Cast in His **First National** Tour with "The Color Purple"

One of our very own theatre alumni has just begun his first national tour and we

are thrilled for him. Jarrett Anthony Bennett is part of the cast of "The Color Purple." This production is a Tony award winner and is touring across the nation and Canada during the next year. Jarrett, who recently moved to New York City was chosen to be part of this 19-person cast and will be touring with the company as they travel and perform in cities across North America. Jarrett has been in several productions at SCT including, "Hairspray" in 2013, in which he played Seaweed. He also portrayed Horton the Elephant in 2017 in our production of "Seussical."

Jarrett is a Hobbton High School graduate and is the son of Anthony and Carolyn Bennett of Roseboro. He and his family attend First Baptist Church in Roseboro. While at Hobbton, Jarrett was an officer with the Drama Club, featured soloist for the HHS Show Choir, FBLA President and Drum Major of the HHS Marching Band. He attended William Peace University and starred in numerous productions including, Joseph in "Joseph and the Amazing Technicolor Dreamcoat" and as Harold Hill in "The Music Man." Jarrett has also been in numerous regional shows throughout the state and in the US.

On a personal note, I am beyond thrilled for this young man's success. As a junior at Hobbton High School, I discovered Jarrett - who had never thought about being in a theatre production. I was told he could sing, and I sought him out in the hallway one day between classes and asked him to audition for my production of "Dreamgirls." He not only auditioned, but he portrayed Jimmy Early in the production. Jarrett's talent was evident from the beginning and he went on to star as Arthur Fonzarelli in Hobbton High School's production of "Happy Days." I also developed and created a Show Choir at Hobbton, in large part because of Jarrett's incredible talent.

I am so thankful to be able to support, encourage and develop Jarrett into the actor and young man he has become. I caught up with Jarrett as he began rehearsals for "The Color Purple." When I asked Jarrett what has been his favorite role, he said, "my favorite role I have ever portrayed is Wailin' Joe in "Memphis." I got to showcase both my vocal range, as well as my dance ability. Also, I did the role completely injured at one point during the run of the show." Jarrett is considered a swing in the production of "The Color Purple," so I asked him what exactly does a swing do? "Swinging in a show like "The Color Purple" is difficult. Mainly because I have to cover so many tracks, instead of one clear cut track. My job is to be prepared just in case someone cannot go on. I enjoy it, because I get the opportunity to put a twist on each character that I go on for." I also have had Jarrett come to Hobbton to speak to the Drama Club and my students on academic success and his career. My students have also seen Jarrett in collegiate and regional performances. "Some advice I would give someone who wants to pursue theatre, is to know who you are. The reality is that you can't play every role, but there is a place for everyone in theatre. Whether that be on stage performing, or behind the scenes (i.e. stage manager, lighting design, set design, etc)." Jarrett also went on to say about pursuing a career in performing, "don't be afraid to be told no. You'll be told 100 No's before you get one Yes, and once you get that you put in the work to show why you should've never gotten a No. NEVER give up on you. At the end of the day, you are your biggest supporter. Keep faith and believe in your abilities."

Jarrett's tour will find its way to NC a few times, with show stops in several cities including Wilmington, Durham, and Charlotte. NC Dates are as follows:

Hobbton Wildcats Soccer Perfect At 40-0 in Conference



Four years of perfection has opponents looking to upset the team

For the past four years, the Hobbton Wildcat Men's Soccer Team has been positioning themselves as the team to beat in the Carolina 1-A Conference.

After Monday's victory over Neuse Charter, the team is currently on a 12-game winning streak (13-1-1 overall and 6-0 in the conference) going into Wednesday's game against Rosewood (because of a Wednesday print time, results were not available).

Monday's win also broke a record at the school - the Hobbton Men's Soccer Team have remained perfect in the Wildcats are at 40-0.

The last time the team has lost a conference game was back on September 28, 2016. Out of the six seniors on the team, only two - Evan Hope and Keelssyn Martinez - have played in all 40 games.

"To me, it is a big milestone," says junior captain Milton Cinto, "I am very proud of what we have accomplished as a team. It is very exciting."

Cinto says that being undefeated in the conference is not something that is on the minds of the players before the game.

"Our team knows each other well enough that we know that coming into a game, we have to stay focused on that game and not think too far ahead," he said. "We just appreciate every step that we have made in us developing into solid soccer players."

Although excitement has been building on the Hobbton High campus, head coach Jonathon Jacobs is making sure that his team stays on the right course.

"I think Monday's game was hyped up a lot," he said. "I wanted to make sure that the guys kept their focus; taking each game one-by-one. You have to win the game in front of you - it only takes one goal to lose. You have to keep

that focus."

In his sixth season as head coach for the Wildcats, Jacobs has been to the NCHSAA 1-A State Soccer Championships for the past four consecutive years.

"... and four out of five times we lost to the eventual state championship teams," he adds.

Which means, the Wildcats are due.

"We came into the workouts this summer focused on working hard," says Cinto. "Our goal is to get back to the state championships. We talked about that right from the first practice."

Jacobs agrees. "Our ultimate goal is to get to the state championships and get that ring. That is every year."

With all the success the soccer program at Hobbton High has had, Wildcat fans are turning out in droves to check out the team.

"I am ecstatic," Jacobs said. "I work at Hargrove, but people have sent me emails and congratulated the team."

The coach continues, "This year has been great as far as the support we have received. On Monday, we got to play on the football field and a lot of people came out to support us."

What was beneficial to the fans who work late, was that game time was pushed back to 6 p.m. instead of the typical 5 p.m. start.

"I think that helped a lot," Jacobs says. "A lot of people are working until after 5 p.m., so by getting that extra hour, a lot more people were able to come out and support us"

Cinto says having the crowd cheering behind the team means everything. "A lot of people have been coming out to our games and rooting for us," he said. "We have been working hard and it means so much when someone says 'good job' or say how proud of us they are. It feels really good and I can tell you we really appreciate it."

Although Cinto and other players on the team knew they were going to be successful this season, Jacobs was more patient.

"I pretty much do the same setup every year," the coach admits. "I have two-a-days during the summer and let the guys get in there and do some touches on the ball ... Just getting out there every summer and working hard."

He continues, "I have to be honest, when we played in the Soccer Jamboree (created by Jacobs and Clinton High School head soccer coach Brad Spell), we didn't look so good. In fact, I was actually a little nervous ... But they worked their tails off and it has paid off."

Cinto agrees.

"It really comes down to having the passion for the game," he said. "It is something that you find on a personal level. My sophomore year, I was benching like 95 pounds and I am only 170 pounds. Like a lot of guys on the team, I had that desire to get better. To go in, work hard and push myself. Everyone has that little something special inside of them and I think the guys put that passion into this season."

For the record, Cinto is benching 300 pounds now. "I worked my butt off," he said. "All of us have and it shows."

And yes, the team is aware that their opponents want to be the team that beats them and spoils their four-years of conference perfection.

"I always tell the boys that everyone wants to be that team," Jacobs said. "So, not being arrogant or anything, but they have to come into the game focused on what they need to do. You have to have a bit of that."

"We are taking it game-by-game," admits Cinto. "It is exciting and everything, but everyone has to be on the same page, playing as a team. If we can do that and go out and play our style of soccer, we are going to be successful."

After Wednesday's game against Rosewood, the team will be at home vs. Union on October 14, at Princeton on Oct. 16; at home vs. North Duplin on Oct. 21; at Lakewood on Oct 23; at home vs. North Johnston on Oct. 28 and round out the regular season on the road in Smithfield vs. Neuse Charter.

"The numbers are definitely up," says Dale Godbold, Welding Instructor at the college. "More and more people are interested in this trade and this craft. The beautiful thing about this field of work is that if you become proficient at it but later decide you want to do something else for a living, you are always able to come back to this and not really worry about finding employment. We always need welders."

In the past, students in the program at SCC have created several real-world projects that help with hands-on training to include a statue of a Viking, a large three-dimensional logo and currently plans are underway for handrails that will be used on the bridge that lies on the path of the college's new walking trail.

New equipment, including a welding simulator that often has the look of a video game and reduces scrap material costs, has drawn interest as well as the fact that the college has made an investment in a new state-of-the-art welding facility that is scheduled to open early next year.

surements like they're going to do in the real world," adds Godbold. "We are just finishing construction of a large gooseneck trailer. They learn how to make it square and how to make quality welds. We are also making a cooker for the college. We teach as if you had a shop and were making items to sell, so you get a real practical experience."






