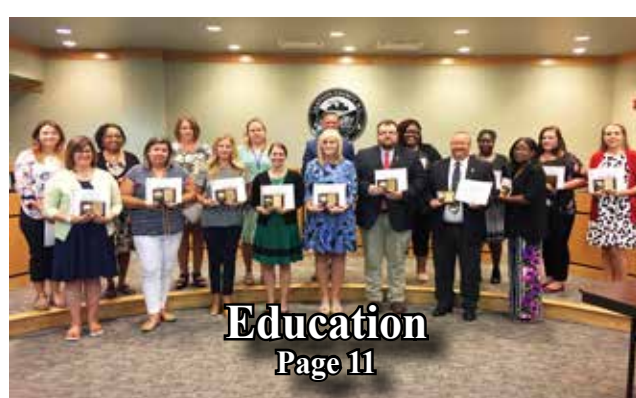

## Hobbtown Band Looking for Donations for Monumental Trip



Last Tuesday morning at the Sampson County School Board Work Session, Hobbtown High Band Director Jeffrey Tart presented the fundraising efforts of the Hobbtown High School Band. The band is currently raising money to represent North Carolina in the 2020 National Memorial Day Parade in Washington, DC.

The Hobbtown High School Band was nominated by US Senator Thom Tillis in April of this year and were notified in May that they had been picked to attend. The parade will be held on May 25, 2020- Commemorating the 75th Anniversary of the end of World War II. The parade will take place in Historic Constitution Avenue from 7th to 17th Street before an audience of several hundred thousand spectators. The parade will consist of musical ensembles from each branch of the military, invited bands from each state in America, veterans' groups, military and specialty units, floats and VIP's.

The parade will be broadcast on the Discovery's Military Channel and worldwide to American troops on the Pentagon Channel. The National Memorial Day Parade will be

## Garland Receives \$750,000 Grant



Garland Mayor Winifred Hill Murphy recently received notification from the NC Department of Commerce Rural Economic Development Division that the Town of Garland has been awarded a Community Development Block Grant for Neighborhood Revitalization in the amount of \$750,000.

The grant compiled and submitted by McDavid Associates, Inc, at the request of the Garland Board of Commissioners, was submitted on July 17, 2019. The intent of these funds is to assist in community development efforts for housing and revitalization within the town of Garland.

Prior to the grant submittal, a selection committee was formed, two public hearings were held regarding the proposal to benefit low-moderate income homeowners and the low-moderate population at large to solicit citizen input. The town of Garland will also invest some local monies into this initiative. The funding will provide rehabilitation of seven homes and reconstruct one home. To meet the low to moderate (LMI) population at large and to help meet the needs of the elderly and handicapped population, the grant will also construct ADA compliant restrooms and a walking trail at the Curtis D. Cain Memorial Park which currently has no restroom facilities or general exercise facilities for an aging population. These park additions will also help with overall community revitalization, provide wholesome activities for all citizens, and boost economic development.

Participating residents were selected based on home ownership, income level, and severity of their housing needs. Throughout the lifetime of the grant, citizen engagement and input will continue to be solicited. The Rural Economic Development Division (REDD) which administers the CDBG Program will assist with implementation and monitoring of the grant to ensure that all grant guidelines and conditions are met.

Since 2012, the Town of Garland has received several significant grants to assist the town with economic development, town beautification, and water/sewer infrastructure. The town was the recipient of the North Carolina Small Town Economic Prosperity (NC STEP) Initiative which helped with town beautification, store front improvement,

### Legislative Recap

#### Weekly Legislative Update

This week may be the last for this session. We are preparing some final bills and would like to get as much accomplished as possible before Thursday's adjournment. The Farm Act has passed the Senate and promises to help our farmers for years to come as they explore new crops like hemp. However, the House has decided to put off a vote on the Farm Act. We have a number of budget provisions needing a vote. And of course the full budget vote is in the wings. I still believe we can work in the Senate to override the Governor's veto of the budget and it is by far the best ever for Eastern North Carolina. Until then, we will keep working and negotiating to get the best deal for our citizens.

### From the District

#### Sampson County- Brown named Principal of Year

Principal Vanessa Brown is a very busy woman at Sunset Avenue Elementary School. For the third time in her career, she has earned the title of Clinton City Schools' Principal of the Year. Brown feels great about this achievement and hopes to continue to help the school grow. Brown is no stranger to winning awards for the work that she has done.



Through Brown's leadership, Sunset Avenue received the Lighthouse Award from the North Carolina Association for Supervision and Curriculum Development last year. It was one of only four schools in the state to win such an honor. It is awarded to schools that have furthered student achievement in innovative and creative ways and have nurtured a positive and supportive school and community climate. Brown is a big believer in data. She leads her school through discussions about performance-based data that she has with teachers in the school, who are in turn responsible for having talks with their students. The data comes from NC check-ins, common assessments and benchmark testing.

Brown has served as a teacher, an assistant principal and a principal in her career as an educator. The Sunset Avenue principle got a Master's Degree in school administration with a certification in curriculum at the University of North Carolina at Pembroke in 2004. She also attended Hobpton High School and went on the Fayetteville State University. After she graduated, she became assistant principal at East Bladen High-School for a year and even taught at Clinton High School. The Faison native was offered a job as an assistant principal at Butler Avenue School in 2005, which she took to be closer to home. Three years later, she became the principal for Sunset Avenue and has been there ever since.

saluting America's military & fallen heroes from the American Revolution through Afghanistan and Iraq.

Tart explained to the school board that the trip will cost approximately \$60,000 for the entire group which will include travel, accommodations and most of the food expense for the students. Tart also noted that there will be approximately 70 students who have shown interest in taking part. Tart also noted that he had invited band members from 2019 graduating class considering they were part of the band when the band was nominated in April of 2019.

School board member Timothy Register instructed Dr. Eric Bracy to work with the school accounting department to see if there was any way that the school system could help financially with the trip, which Bracy stated he would. School Board member Tracy Dunn stated that she agreed with Register but that she would like to see fundraising efforts continue by the students as well.

The band is currently holding fundraising activities to help raise the necessary funds. Events include, car washes, Belk Charity event days, and reaching out to local businesses and individuals for support. Tart stated that they are trying to get 600 people to donate \$100, that is \$100 for each mile of the journey. So far Tart noted that they had raised approximately \$20000 so far.

According to Tart, the band members are going to busy the month of November raising funds for the trip. He said, "Upcoming fundraisers are Belk Bucks sold for Belk Charity Day on Nov.9; Mattress Sale Nov. 16 in the Hobbton HS Gym, and also bed sheet and bamboo sock fund raiser. All happening the month of November. Also, a fun filled evening at Oasis Nov. 8th."

The event on November 8th will feature Johnny Rawls and the Johnny Rawls Band at the Oasis Sports Bar located on Hobbton Hwy in Clinton. Doors will open at 7:00pm with Showtime at 8:00pm. The event is sponsored by Lockamy Tek Insurance and WCLN 1170AM Boogie Shoes Radio Network. However, all proceeds will go to benefit Hobbton High School's Band trip to Washington DC. For more information call 910-592-4700. Tickers are for sale at Lockamy Tek Insurance located at 1940 Hobbton Highway. Tickets are \$20 in advance and \$25 at the door.

The group's itinerary includes leaving on Saturday May 23, 2020 and returning on May 26. The group will get in some sight-seeing and walking tours throughout Washington, DC. That will include the Lincoln, Korean, Martin Luther King, Jr., Vietnam, National World War II Memorial, a view of the outside of the Washington Monument, as well as the Thomas Jefferson Memorial. They will get the opportunity visit Lafayette Square, Ford's Theater, the Peterson House, the US Holocaust Memorial Museum, the Smithsonian Institute, the National Mall, Marine Corps Iwo Jima Memorial, the National Air Force Memorial, the National 9/11 Pentagon Memorial, and Arlington National Cemetery. They will also attend the official National Memorial Day Concert on the West Lawn of the U.S. Capitol, featuring the National Symphony Orchestra and broadcast live on PBS. They will also have the honor of performing at the National Festival of the States.

This will be a once in a lifetime trip for most of these band students and well-deserving of course.

Tart, who is very proud of his band members, stated, "This is a national event that will be shown world-wide. This is the first time that the Hobbton High School Marching Band has hit the world/national stage except for the year in the late 70's the band traveled and marched in the Mardi Gras Parade. The band members work hard year after year to prepare a marching show and compete. It takes a lot of hours and a lot of hard work and dedication to be successful with our shows. Coming from a rural school it is difficult to be seen at times. Being nominated for this goes to show what hard work, compassion, and dedication can do. This will truly be a once in a lifetime event for our students! The band is very excited to be able to be a part of this event!"

However, some of the credit needs to be given to the Band Director himself, Jeffrey Tart, who without him

this honor would not be possible. During his tenure, the Concert and Marching Bands have received Excellent and Superior ratings. Mr. Tart is a graduate of Emmanuel College in Franklin Springs, GA and received his Bachelors in Music Education from Western Carolina University located in Cullowhee, NC. He was Hobbton High School's Teacher of the Year for school year 2012-2013 and was also awarded the coveted North Carolina Long Leaf Pine Award from former Governor Beverly Purdue for his volunteer efforts in North Carolina.

and offered grants to businesses to help with retention and renovation. One such grant was awarded to Southern Smoke Barbeque which helped with their initial renovation of their present facility. The town has received a water/sewer planning grant, and two (2) CDBG water/sewer grants of over \$2Million Dollars to rehab and replace sewer lines. The Asset Inventory Grant (once completed) will also assist with rapidly identifying sewer lines using GIS mapping. These grants have been critical to maintain and improve aging infrastructure necessary for quality water and maintenance of our sewer system.

With the recently awarded grant, this is another indicator that Mayor Murphy and all commissioners will continue to work collaboratively with each other, with community members, and with partnering agencies to build on our successes, to eradicate today's neighborhood problems, and to invest in the future of our citizens, neighborhoods, and town.

## Warsaw Remembers Our Vets for 99 Consecutive Years

Titled, "Saluting the Wounded as We March Towards 100", Warsaw's 99th Consecutive Veterans Day Celebration will take place Saturday, November 2nd beginning with a Pancake Breakfast at St. John's Masonic Lodge #13 and Warsaw Baptist Church at 7:00 AM. The rest of the day will be packed full of festive events, including a Memorial Service at 10:00 AM and Veterans Day Parade at 11:00 AM with a Fly Over and Special Forces Parachute Team Jump.

Warsaw, which sits just 12 miles east of Clinton, holds claim to our nations "Oldest Consecutive Veteran's Day Celebration". According to Frank Rhodes, President of the Warsaw Chamber of Commerce, "Veterans and the Veterans Day Parade is important to all of us; the town, the community, the state, the country, and to us all individually, because if we don't remember the work and sacrifice of our brothers and sisters in arms, we will not know the importance they bring to our freedoms and our way of life. The Veterans Day Parade gives us the opportunity to remember and celebrate the armed forces past and present."

Continuing Mr. Rhodes noted the importance of our Veterans. "It is important to recognize our Veterans, but it is also important to understand why our Veterans are necessary. We need our Veterans for stability in an unstable world, for consistency and to stand the front lines all over the world so that we and our neighbors can pursue the freedoms afforded to us by their efforts. We need to recognize their efforts and effects on our lives. Without them, we would be lost. Veterans and the Veterans Day Parade are here to remind us of all the soldiers that have gone to war but didn't come home. Without them we would not be living in the United States of America. It is because of Veterans that we live in a free country and have our independence to speak freely and agree or disagree with our friends and neighbors."

According to Carolyn Quinn with the Warsaw Chamber, "The Parade was started in 1921 as a way to honor our military veterans. As we have moved forward in time, it has also become

a time to celebrate our first responders, law enforcement, fire and rescue. # We Should Know . . .



Nancy Carr with J.W. Simmons Host of We Should Know

Tuesdays from 2:30 PM until 3:30 PM, J.W. Simmons hosts a show on 1170 AM and on Star channel 16 SD and 316 HD called "We Should Know", and The Sampson Weekly will feature portions of the transcripts in our continuing efforts to bring you more coverage of what is happening in our community.

The week's We Should Know concerns the United Way with guest Nancy Carr. Carr has been with the United Way since 2003.

United Way is a global charitable organization with as many as 1,200 local chapters. Carr is director for the Sampson County chapter of United Way and she reports that all money collected in Sampson County remains in Sampson County.

Carr explains, "You touched on something I do want to highlight. Our United Way in Sampson County is part of a broader organization. We have an umbrella called United Way Worldwide and it is a global organization that extends well beyond the United States. And we have many United Ways in the United States and United Way of North Carolina."

"And I want to point out that United Way of Sampson County, we are able to do the branding for United Way because we are a partner with them. So, we pay a very, very modest membership due. So, the majority of the money that is raised here in Sampson County, it does not go to the global organization. It stays right here in our community. And I do think that's a misunderstanding that many people have because they associate the United Way. They see the NFL commercial. They see a lot of the partnerships United Way Worldwide has across the world."

"But," adds Carr, "for all intents and purposes, the local chapters – and we are not unique in this way – we raise the money. We have the money come directly to us and it stays here. So, again there is a modest amount that goes to United Way Worldwide, but that's so we can enjoy some of the licensure, branding and take advantage of some of their marketing. The free material they offer which keeps our overhead very, very low."

Simmons states that he had read that only 16 cent per dollar goes to administrative functions at United Way. That's very low compared to other organizations. "That's corrected," says Carr.

"It's very low in fact," adds Carr. "Every year when we have our financial audit done by our accountants, they comment on the fact that our United Way is really a barebones operation. I'm the only paid employee and I work part-time. We have a governing board that consists of 18 volunteer

community leaders. So, we are definitely trying to be as slim as possible as we can on the overhead side so the money that is coming in is going back to serve the community."

Next, Simmons asks Carr to discuss the board and how that board interacts with her. "As in many organizations, I serve at the pleasure of the board. We have 18 board members who currently consists of many community leaders and I'll highlight a few. Catharine Ezzell is currently our President and Sherrill Allen is our Vice-President. Dempsey Craig is our Treasurer and Jonelle Strickland is our Secretary for the 2019 year."

"So, the governing board meets once a month. What they do is review the financials of our organization to make sure we are on track to meet our financial obligations that we made back in January. Any upcoming information from United Way Worldwide – It's important to note that we have a very stringent accreditation process for our United Way. So, in order to operate we have a certification process we have to go through every year with United Way Worldwide and the board is very much a part of that. So, they're the one who reviews us to make sure we're doing the right thing, that our financials are in order and that we are serving the mission that we set out to do."

"So, the governing board will look at any financials. They look at any upcoming events that we have. Fundraising events. I really do very little without the board's approval. So, anything we're going to do, any efforts like the upcoming street festival that we'll be participating in, they're very active. And I will say I have to shout out to our board members because they are the ones that are the backbone of this organization. Because when it comes to anything we're doing, any fundraising, the Street Fair, when we do our Dine Out, they are the ones going out in the community too and supporting us."

"So, they rollup their sleeves and get involved and I'm really proud to say that because we have a wonderful, outstanding board of directors. Basically, they serve a term of three years. But they are given the option if they would like to continue and we have many. We have several veterans on our board that has been in some capacity, perhaps they took a brief hiatus. But we organized in 1991, so we have board members that have a lot of history which I think is important to an organization. And we have new board members and you want new blood, new ideas. So, we have a cross-section. We try to reflect the diversity of our community both from an age and social-economic and ethnic diversity."

Next, Simmons asks Carr to discuss how the United Way interacts with community members during natural disasters such as the recent hurricanes. "Very good question," says Carr.

"Just prior to hurricane Matthew the board made a decision to use the funds from two events that we had called Outstanding in their Field. We took the proceeds from those events and put them on a separate line item for disaster relief. That money at that time was about \$25,000. So, that kind of became a kitty and then we had a generous anonymous donor that purchased a community assistance trailer. So, we purchased a trailer and had some funds on hand, and we went ahead and proactively purchased some items. Sarah Bradshaw with DSS is on our board and she was instrumental in listing, besides water, what someone might need following a disaster. Bedding, kitchen items, things like that. So, we had gone out and purchased these items prior to hurricane Matthew."

Carr says that United Way of Sampson County was prepared to go door to door after Matthew to offer assistance to those in our community that needed aid.

The Duplin County Veteran Museum was established as a tribute to all Duplin County Veterans who served whether in war time or peace time. Museum Curator, Earl Rouse says, "Our current Honor Roll list 4,610 veterans from the Voluntary war to current times. We invite everyone that is attending our celebration to come by and visit the Museum located at 119 E. Hill Street Warsaw. The Museum is located within walking distance of all Veterans Day Activities. The Museum will be opened from 1 to 4pm on Veterans Day. All other times the Museum will be open each Thursday and Friday from 1 to 4pm."

Warsaw's Veterans Day Celebration started in November of 1921 by Judge Henry L. Stevens Jr. and at that time was known as the Armistice Day Parade. It later became the Warsaw Veterans Day Celebration and is now the longest continuous Veteran Day commemoration in the United States. In 1995 during the 75th Anniversary, The Veterans Day Commemoration was dedicated to Judge Stevens' memory as Warsaw's "Native Son". And since that first celebration in 1921 it has never been cancelled or postponed.

Warsaw is a Veterans Day Regional site again for 2019, and Mr. Rhodes credits the community for Warsaw's nationally recognized Veterans Day Celebration. Rhodes wanted to make sure to thank all the volunteers, the Veterans Day Parade Committee, Mayor AJ Connors, Warsaw Police Chief Eric Southerland, the Warsaw Chamber of Commerce, local businesses and Warsaw town employees. "Without their support and contributions, the Veteran's Day Celebration would not be possible."

Carolyn Quinn added comments as well, "The Veterans Day Celebration has put our community on the map, however, no one person can take the credit. There is a lot of work that goes into organizing this event. Many man hours are used to make every detail a focus point of our Celebration. Who deserves the credit...every citizen that lives here, every visitor that we have that day, every fireman, law enforcement and town employee that works so tirelessly to make this a great celebration. Our committees from both the Chamber and the Parade Committee that works on this event several years in advance, our volunteers, our churches, our business and our neighboring towns and communities. Our past and our present all contribute to the success of our Veterans Celebration...it not just a Parade...it's a family reunion. Friends, Family Co-workers, Classmates. The Parade is a THANK YOU to our Veterans."

Mr. Rhodes closed by saying, "We would love for everyone to come out and enjoy the parade and the festivities. But let me share that there are a lot of visitors who come to the parade, so come early and find a good spot to set up a chair and view the parade is a must. There are plenty of vendors to visit and find just that perfect gift for yourself or someone else. There will also be lots of food and drinks to enjoy."

There will be many opportunities to celebrate and dedicate Veterans Day on November 11th, and Warsaw welcomes all to celebrate with them.

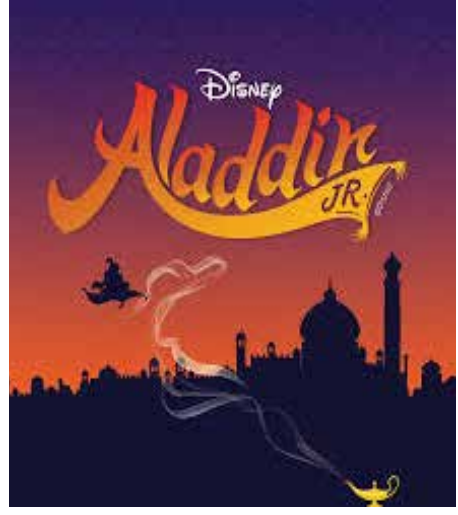

## Masquerade Cookies

- 1 teaspoon baking powder
- 1 teaspoon salt
- 1 cup (2 sticks) unsalted butter, softened
- 1 1/2 cups granulated sugar
- 1 egg

Preheat oven to 350°F.

In large bowl, mix flour, baking powder and salt. In second large bowl, beat butter and sugar with electric mixer until light and fluffy. Beat in egg and extracts. Add flour mixture to butter mixture 1 cup at a time, mixing after each addition. Do not chill dough. Divide dough into 2 balls.

On floured surface, roll each ball into a circle approximately 12 inches in diameter by 1/8 inch thick. Dip eye and glasses cookie cutters in flour before each use. Arrange cookies on ungreased cookie sheet.

Bake 8–11 minutes or until cookies are lightly browned. Cool completely on cooling grid. Decorate as desired using tinted royal icing, colored sugars and Halloween icing decorations. Use melted candy to attach sticks to backs of cookies; chill until set.

## Pumpkin Spice Popcorn

Servings: 6 cups

- 6 cups popped kettle corn
- 2 cups mini pretzel twists
- 1 package (10 ounces) Pumpkin Spice Candy Melts candy

- 3/4 cup roasted salted peanuts
- 1 package (10 ounces) Caramel Apple Candy Melts candy
- 1 bottle (2.5 ounces) Spider Mix Sprinkles

Spread popcorn and peanuts on parchment paper-lined cookie sheet.

In disposable decorating bag, melt candy in microwave at 50 percent power for 1 minute; remove bag and knead. Continue melting candy for 30-second intervals at 50 percent power until completely melted. Snip off end of bag and drizzle melted candy over popcorn. Immediately top with sprinkles. Let stand until candy has hardened, about 20 minutes. Break into pieces to serve.

## Pumpkin Pound Cake

Servings: 16

- 3 cups all-purpose flour
- 1 teaspoon baking powder
- 1 1/2 teaspoons ground cinnamon
- 1/2 teaspoon salt
- 1/4 teaspoon ground nutmeg
- 1 cup (2 sticks) butter, softened
- 2 cups granulated sugar
- 4 eggs
- 1 teaspoon pure vanilla extract
- 1 1/4 cups canned 100 percent pumpkin (not pie filling)

Preheat oven to 325°F. Prepare Dimensions Large Pumpkin Pan lightly with vegetable pan spray with flour. Place on baking sheet.

In medium bowl, combine flour, baking powder, cinnamon, salt and nutmeg. In large bowl, beat butter and sugar with electric mixer until light and fluffy. Add eggs, one at a time, mixing well after each addition; beat in vanilla. Add flour mixture alternately with pumpkin; mix well. Pour batter into prepared pan.

Bake 70–80 minutes or until toothpick inserted in center comes out clean. Cool 15 minutes in pan. Turn onto cooling rack. Cool completely before serving.

Servings: 6

- 3 cups ginger ale, chilled
- 1 1/2 cups pineapple juice, chilled
- 1/3 cup sweetened lime juice, chilled
- Green gel food color or green icing color (optional)
- Black Colored Sugar Gummy Eyeball Skewers

In large pitcher, combine ginger ale, pineapple juice, sweetened lime juice and, if using, gel food color.

To prepare glasses, dip rims of martini glasses in water, then in black sugar. Fill with drink mixture; add eyeball skewers.

Servings: 8

- 1 cup (half of 12-ounce package) Bright White Candy Melts Candy, melted according to package directions

## Dark Horse Cross Country Runners Named Athletes of Week



The Clinton Dark Horses' Cross Country team has worked hard this year. And that hard work has paid off with four runners making it to the Regional Cross-Country meet that will be held this Saturday November 2nd at Croatan High School.

On October 22nd Harrison Williams, Peyton Matthis, Cristal Ortiz and Olivia Gillespie placed All Conference at the meet at Spring Creek.

Conference meet was a PR for each of the runners:

-Harrison Williams: 10th grade; 4th place conference--Finished in top 5 at every meet, often placed in top 3; conference time: 18:32 (PR)

-Peyton Matthis: 9th grade; 7th place conference--Incredible conference finish, showed steady improvement throughout the season, but conference meet was by far his best run; time: 19:06 (PR)

-Cristal Ortiz: 11th grade; 2nd place conference--consistently finished 2nd in every meet; conference time: 21:15 (PR)

-Olivia Gillespie: 11th grade; 7th place conference--consistently finished in top 10, conference meet was a personal best for her; conference time: 23:00 (PR)

And that is why these four Dark Horses have been named this week's Performance Automotive Athletes of the Week.

Junior Olivia Gillespie, surprised at being named this week's Athlete of the Week, stated that her time in her last meet was 23 minutes for the 3.1 mile event. "I placed in the top seven at conference," noted Gillespie.

Gillespie has been running on the Dark Horse Cross Country team for three years, her Freshman, Sophomore, and Junior years. She said that she was planning on running her senior year as well.

Gillespie remarked, "It feels great to be running at Regionals on Saturday at Croatan. This will be my third time running at Regionals and I am super excited. I am ready to compete and hopefully move on to the next level." She has been preparing this week by running but not too much she noted, "so I can have my legs rested."

Gillespie, who also plays soccer, said, "I have always loved to run. I have played soccer since a young age and have always had to run to prepare for my seasons. When I started middle school, I started running in local 5K's and my love for running started to spark even more. Then when I became a Freshman in high school, I decided to start running cross country and my love for running has continued."

Inspired by her parents Anna and Perry Gillespie and her Meme, Gloria Gillespie, Olivia gives credit to her family, "These three people are my biggest fans and push me to do my very best. They are at everything that I do and motivate me to do my best. My ultimate goal in cross country is to attend states. I don't even have to win states, but I think it would be an honor to be able to run in the states race."

Sophomore Harrison Williams said of his chances at Regional, "It's very exciting. I'm really looking forward to representing my school and team at such a big meet."

Williams has been running on the Cross-Country team for a little over a year. However, this didn't stop him from placing second at the All Conference meet with a time of 18:31.

Williams remarked, "I originally joined the cross-country team because it seemed like the only sport I had a chance of being good at. The moment I knew I was a runner was at my first ever cross-country practice. I arrived early in the morning in late summer before freshman year. I had never run a mile without stopping. I met my coach and we began to run. Before I knew it, we were at 5 miles. I had never felt so much pain and had never been so exhausted. I was so proud of what I had accomplished and became instantly hooked."

Williams said that he has goals he wants to accomplish before he finishes his years as a Dark Horse. "My goal is to run a sub 17 minute 5k before I graduate high school. My biggest inspiration is the late Oregon track star, Steve Prefontaine."

Junior Cristal Ortiz runs the 5K for the Cross-Country team with a winning time for this season sitting at 22:08, bringing her in at second place in every meet.

Ortiz said, "I am proud and excited to be moving to regionals in Croatan. It is my second year making it to regionals and this year I will be in a different atmosphere, so I am looking

forward to this race." Ortiz continued, "I am preparing for this race by running every single day, doing a few workouts, and staying hydrated."

Cristal explains her foray into running, "I have enjoyed running since I was 10. During my freshman year I was a tennis player, but later that year during my soccer season I was convinced to join the cross-country team. I did cross country my sophomore year and I ended up deeply enjoying it"

Ortiz says that her inspiration is her mother. "She is one of the strongest individuals that I know of. My goals are to graduate from high school and attend a university to carry out my goal of double majoring in psychology and social studies."

Freshman Peyton Matthis, who is new to the Cross-Country team this year said that he is pleased with his 7th place finish with an average of 24 minutes per run. His best is about 21 minutes.

Matthis said he was surprised at his successes this year. "Truthfully, I was never a runner, I was a swimmer. Though I wanted to try something new, and here that has landed." Peyton's goal is to run his meet in under 20 minutes.

He says that he has been putting in the hard work preparing for regionals on Saturday.

Cross Country coach Kristen Lee is just as excited for her team. Coach Lee said, "There are 21 members of the CHS CC team, all of whom have been dedicated to both their individual progress as well as the team success. I am so proud of how hard this team has worked together to get better. All of them hit individual PR's throughout the year, and nearly every athlete hit a PR each race, which is an incredible accomplishment. I am most proud of how they supported each other as a team, celebrating one another's success and pushing one another to be better. I started awarding "PR Bars" (candy bars) after each meet for any runner who hit a Personal Record (PR) best time. This small reward recognizing individual accomplishment was a huge hit and they were excited each week to see who would be rewarded with a PR bar!"

Coach Lee explained why these four particular runners have seen such successes this year, "The 4 conference athletes are some of my most dedicated runners. Even when unable to attend practice, they run on their own and train on the weekends. They have an amazing work ethic; they are committed to their sport and to daily improvement. They are easy to coach because they have the determination and drive to be better. Each of them has a goal to make not only Regionals, but States. All of them hit a personal best time at the conference meet. Six boys and four girls will be running in Regionals this Saturday at Croatan High School, and I anticipate that several of them will qualify for States. All of my Regional runners have continued to train hard this week in preparation for Saturday's meet."

In closing Coach Lee said, "I am INCREDIBLY proud of this team, not just the 4 top runners, but the team as a whole. My goal as a coach is to work with each athlete at their level so that everyone experiences individual success. I want these kids to learn to love running and to make it a lifelong activity. Unlike many sports where athletes can only participate when they are relatively young, running is something individuals can continue to do for the rest of their lives. I want each athlete to experience success, so I'm not just focused on my "top runners" or those who earn team points. Every athlete contributes to this team and plays a role. I'm committed to seeing them support one another and work together as a group so that as they improve as individuals, we improve as a team. My last runner across the line is as important and gets as many cheers and accolades as my first runner to cross. We are a team and we support one another every step of the way."
