applicable). The breeder transfers in fee simple all rights, privileges and respon	nsibilities associated
with the ownership of a () male, () female dog of the Yorkshire Terrier b	reed to Purchaser as
of the date and time specified below with delivery on	by () airline,
() automobile shipment or () personal pickup at Mary's Little Yorkies ken	nel.

Use of the Dog:

It is agreed between breeder and purchaser that this dog is being acquired as a family companion dog (pet), a therapy dog or for exhibition in AKC conformation, obedience, or agility competition. We agree that the dog is not purchased for resale nor will it be used or trained for activities which are illegal or for which it is not suited by reason of temperament or conformation. Specifically it will not be used as a guard or attack dog or to hunt or fight other animals.

Health:

The breeder warrants the dog to be in good health. The puppy has been vaccinated for distemper, parvovirus and other communicable diseases (as recommended by a qualified Veterinarian) and free from disease and parasites as of the time of sale and will provide purchaser with proper health certification from a qualified Veterinarian, if requested.

Breeder strongly encourages purchaser to have the dog seen by a Veterinarian, of purchaser's choice, within 72 hours of receiving the dog. If at this initial examination, by your Veterinarian, there is a finding of an unhealthy dog and we receive this diagnosis in writing, from your Veterinarian, the breeder will assume the cost of return shipping in addition to a full refund.

If a deposit has been made on a particular puppy and that puppy becomes ill or dies before delivery, a full refund of the deposit will be made or, at the purchaser's discretion, the deposit can be applied to another puppy.

Breeder guarantees the dog against congenital or genetic defects of the heart, lungs, liver, kidneys, hips or eyes up to 12 months of age. In the event of identification of a congenital or genetic disorder which is sufficiently serious, in the opinion of a qualified Veterinarian, and we receive a written diagnosis of such a finding, the breeder agrees to:

- A. Refund the original purchase price (or at purchaser's discretion).
- B. Replace the dog with one of equivalent quality (once the dog has been returned and this finding has been substantiated by our Veterinarian).

Registration:

The breeder certifies that the dog is eligible for full registration under the Regulations of the American Kennel Club as a purebred Yorkshire Terrier and will provide the proper forms for such a registration.

Ownership Responsibilities:

The purchaser agrees to maintain the dog in a humane environment and properly train and care for it. Specifically the dog will be properly licensed and continually inoculated against rabies, distemper, parvovirus, and other communicable diseases as recommended by a qualified veterinarian. The dog will not be allowed to roam and will be socialized and obedience trained appropriately. The breeders strongly recommend permanent identification by tattoo or microchip.

This represents the entire agreement between Breeder and Purchaser in an outright sale.
