This contract is made between PAW IT FORWARD SANCTUARY AND _____ (Adopter)

Adopter agrees this animal will be kept as a pet for him/herself and his/her family. Adopter agrees not to sell, give away, or otherwise dispose of this pet without the express consent of PAW IT FORWARD SANCTUARY. Adopter agrees to NEVER abandon this pet.

DOG: Adopter agrees this animal will be a house pet not used as a guard dog and the pet will NO BE CHAINED. This pet will not be used for experimental purposes, vivisection or as food. Adopter agrees the dog will be confined in an enclosed yard with a fence five (5) feet or higher. Adopter agrees to keep the animal under his/her supervision when outside, and not to let it roam unattended.

CAT: PAW IT FORWARD SANCTUARY requires cats remain as INDOOR PETS ONLY.

If the pet is no longer wanted, Paw It Forward Sanctuary reserves the first right of refusal. We cannot guarantee there will be space available at the time of request. Options will be discussed if it's not possible for Paw It Forward Sanctuary to take the pet back into Rescue.

No warranty or representation of any kind is made by PAW IT FORWARD SANCTUARY as to the health, disposition, or suitability as a domestic animal or specifically as to any hazard it may present to known or unknown adults or children Adopter releases PAW IT FORWARD SANCTUARY and its volunteers from any claim, cuase of action or liability, whether known or unknown, arising out of damage this animal may inflict upon any person or property, or for the transmittal of any illness or parasite to any other animal or person.

Initial

Adopter agrees to accept all financial responsibility and provide the animal reasonable life care, including adequate FOOD, WATER, SHELTER, LOVE, HUMAN TREATMENT, annual veterinary examinations and vaccinations and further veterinary care in the event of illness or injury. If the animal is not yet spayed or neutered at the time off adoption, Adopter agrees to work with PAW IT FORWARD SANCTUARY Medical Coordinator to have this performed by _____ (date).

Adopter agrees if PAW IT FORWARD SANCTUARY has concerns the conditions of this contract are not being met, a member of PAW IT FORWARD SANCTUARY may inspect the pet and its environment to make the determination.

Adopter agrees if PAW IT FORWARD SANCTUARY determines that Adopter has mistreated the above-described animal, has otherwise failed to perform his/her obligations under this contract, or has misrepresented his/herself, PAW IT FORWARD SANCTUARY may reclaim possessions of this animal. If the animal is not returned withing five (5) days after demand, PAW IT FORWARD SANCTUARY will contact the local Animal Control Agency to take appropriate action.

Adopter agrees to notify PAW IT FORWARD SANCTUARY upon change of address so we may update our records. Adopter agrees to also update any microchip contact information.

Adopter agrees to provide pet with the proper license required by their local Animal Control Agency (DOGS) and to keep such information on the pet's collar along with the pet's ID tag. You should be able to always slip 2 fingers under the pet's collar for proper fitting. Adopter agrees to always keep a means of identification on this animal. If this pet should become lost, Adopter agrees to make eery reasonable attempt to locate and claim the animal. Adopter will notify PAW IT FORWARD SANCTUARY if pet is lost so we may assist in the location and return as a courtesy, not an obligation.
