

# Parade Entry Form 2018

## Rules

1. No burn-outs or wheelies will be allowed during the parade.
2. No intoxicants will be allowed during the parade.
3. All horse entrants must furnish their own clean-up crew and equipment.
4. Floats must be in position no later than 9:00am to give adequate time to judges.
5. Candy throwing is allowed, but the candy must reach the sidewalks.
6. No parking is allowed in the staging area, other than parade entries.
7. Max speed is 5 MPH.

## Entry, Check-in, and Other Information

- Deadline for entries is September 15, 2018. Late entries will be accepted on a case-by-case basis; contact Taylor Franz.
- All entries must check-in at the registration table between 8:00am and 9:50am to receive your parade position number.
- The registration table will be located at Emma Street and South Weaver Street.
- Busses may unload at Pine Street, but then must move out to the bus parking area located at the baseball park on South 1<sup>st</sup> Street, south of the gas station.
- Please be aware that all roads into downtown Rockford will be closed by 10:00am.

## Do you have a four-wheeler, side-by-side, golf cart, or other ATV and an interest in winning \$25?

**WHAT:** Southeast Spokane County Fair Parade ATV Decoration Contest. The theme this year is "Country Strong."

**WHERE:** Rockford, WA
