AMENDMENT TO  
DECLARATION OF CONDOMINIUM  
AND BY-LAWS

CAMDEN G CONDO ASSOCIATION, INC., at CENTURY VILLAGE, WEST PALM BEACH, AS recorded in Official Book 2057, Page 210, PALM BEACH COUNTY, Florida.

A. The following underlined text is now a part of the official record.

ARTICLE IV. DIRECTORS ON GOVERNING BOARD

SECTION 1. Number, Term and Qualifications. The twenty-six Unit Owners comprising CAMDEN G CONDO. ASSN., INC will elect a FIVE MEMBER GOVERNING BOARD at an ANNUAL MEETING. Only one person from each unit is eligible to serve on the Governing Board and each unit will have one vote.

SECTION 11. NOTIFICATION OF ANNUAL MEETING AND VOTING FOR ANNUAL BUDGET And ELECTION OF OFFICERS TO THE GOVERNING BOARD

- A. The Annual Meeting will convene between the 15th and 31st of December, yearly, to elect a Governing Board and to adopt an OPERATING BUDGET for for the upcoming year to begin January 1st. The date of this ANNUAL MEETING will be announced on or before NOVEMBER 15th, and all UNIT OWNERS will be duly notified in writing.
- B. The Board shall designate a committee to oversee all balloting procedures and accept the names of nominees to be placed on the ballot.
- C. Voting is by secret Ballot. Voting by LIMITED OR GENERAL PROXY is permitted for those who cannot be present at this ANNUAL MEETING.
- D. To fill a BOARD vacancy, the Board may convene a special meeting at which a MAJORITY of those present may nominate Association members from the floor and vote for person(s) to fill the vacancy.
- E. A simple majority of votes cast by eligible voters will elect the Governing Board for a twelve-month period. The Ballots cast will be UNSIGNED and Anonymous. The results of totaled votes will be posted within 48 hours.
- F. The CAMDEN G CONDO ASSOCIATION, INC. by a majority vote of its 26 voting interests, may revise its voting and election procedures only.
- G. A 2/3 affirmative vote, of the Association, is needed to revise these BY-LAWS.

We hereby certify that this AMENDMENT does not effect the interest of the LESSOR of the Long-Term Recreational Lease. THIS AMENDMENT has been duly presented to the Association the necessary APPROVAL received and recorded.
