FIREARMS TRAINING AGREEMENT

Release, Waiver, Indemnification, Hold Harmless, and Assumption of Risk

Shoot Safe NJ IIc and or Brian Nolder is not authorized to provide legal advice. Student agrees to indemnify, hold harmless and defend Shoot Safe NJ, LLC (including Brian Nolder, property owners, range, employees, agents, and/or assistants) hereinafter referred to collectively or individually as "Instructor", from any and all fault, liabilities, costs, expenses, claims, demands, or lawsuits arising out of, related to or connected with Student's presence at and/or participation in the course of instruction; the use of instruction in the future; the discharge of firearms by Undersigned, Undersigned's presence on or use of the range, building, land, and premises and, any and all acts or omissions of student. Student hereby expressly assumes the risk of taking part in the course for instruction in firearms and taking part in the activities on the Premises, which include, but are not limited to, instruction in Safety training, CPR, First aid, the use of firearms, the discharge of firearms and the firing of live ammunition.

Under section (C.2C:58-3.1) A temporary transfer of a firearm under this subsection shall be for not more than eight consecutive hours in any 24hour period and may be made for a set fee or an hourly charge. The firearm shall be handled and used by the person to whom it is temporarily transferred only in the actual presence or under the direct supervision of the legal owner of the firearm and or the Firearm Instructor for use of firearms safety training. If student is using their own firearm, they must know how to use it properly and make sure it is in safe working condition prior to bringing it to the range and or class. All ammunition shall be of the correct caliber for the firearm in use, store bought in the factory box for training purposes to ensure the safest possible experience.
