II. Public Portion

Janet VanSykle congratulated the board for their direction on energy issues. Montauk has been the sight of wrong doings. Someone put down tons of concrete by the Ocean View. Peter says that the contractor made a mistake and it will be corrected. She spoke about the Breakers Motel in regards to their opening a restaurant. There isn't enough parking for the people that stay at the motel let alone a restaurant. She says that there was never a restaurant at this site. It was a pass thru for hotel guests for small things like muffins, etc. She questioned the grandfather clause.

Margaret Turner, Executive Director of the EH Business Alliance, she spoke about a business study and a hamlet study that were spoke about a few months ago. Sylvia states that a draft outline of the study will be discussed at the next work session meeting. Margaret thought that members of the initial committee should have been able to give their comments long ago. Get this on the radar and get it done, it has been more than five months already.

Jerry Morielo asks why the people of the town paying for the benefits of others. He questions why the parking at Kirk Park is free. People that live next to the Surf Lodge should not have to suffer the way they do. All you are doing is encouraging more people to come to this area.

John Ryan, Sr. Hampton Lifeguard Association spoke about their "Water Proofing Program". He spoke about the programs available. He challenges every third and fourth grader in East Hampton and Southampton to pass the Junior Lifeguard Program Pre-test. He told how Sag Harbor, Springs and EH Schools use the YMCA for swim lessons. He states that Montauk Schools would like to get the same benefits.

Rhona Klopman spoke about the 350 homes that are in her community all being happy that this board is not allowing Showtime to film in the heart of the season.

III. Topics

A. Montauk Adult Day Care & Senior Transportation - Diane Patrizio

Montauk Adult Day Care presentation from Diane Patrizio spoke about the bus transportation that is available for residents in Montauk. Montauk has just received two new vehicles for use to transport these people. She encouraged all residents of Montauk to call the office and learn about the programs available.

B. Showtime - Kathee Burke - Gonzalez

Showtime Kathee gave a briefing on the upcoming movie shoot that Showtime is planning.

Peter VanScoyoc spoke about the Ditch Plains Comfort Station project.
