**ORDER granting [45] Motion for Extension of Time to File. Plaintiffs' motion for a briefing schedule for their dispositive motion is GRANTED. Plaintiffs shall file a dispositive motion with regard to their first two claims on or before April 1, 2016. The FAA shall respond and/or cross move on or before May 2, 2016. The Committee and Town shall file their briefs on or before June 17, 2016. Plaintiffs shall file their reply, if any, and their response to any cross motion filed by the FAA on or before July 19, 2016. The FAA shall file its reply, if any, to any cross motion on or before August 12, 2016. The Court GRANTS Plaintiffs' request to defer briefing on Plaintiffs' third claim for relief. The parties are directed to submit a proposed briefing schedule for any dispositive motions to be filed with respect to Plaintiffs' third claim within thirty (30) days of the Second Circuit's determination of the pending appeal in Friends of the E.
