Authorize Entry to Conduct Test Hole Drillings Site No. 15 on the Filed Map of East Hampton Town Industrial Park (Shown on the Suffolk County Tax Map as SCTM #0300-191.00-02.00-009)

WHEREAS, HTO, E. Hampton Distr. L.L.C. has an option to lease the premises at the East Hampton Airport known as Site No. 15 on the filed map of East Hampton Town Industrial Park (shown on the Suffolk County Tax Map as SCTM #0300-191.00-02.00-009); and

WHEREAS, the aforementioned site is not needed for aviation purposes and is not necessary for the efficient and proper operation of the airport or landing field, and the Town does not foresee the site being needed for such purposes during the term of the lease or any renewals provided for in the lease; and

WHEREAS, HTO, E. Hampton Distr. L.L.C. requires a number of test hole drillings to be conducted to collect information for applications and approvals from the Suffolk County Health Department; and,

WHEREAS, the Town desires to allow HTO, E. Hampton Distr. L.L.C. to conduct such testing provided that they indemnify and hold the Town harmless now therefore be it

RESOLVED, that HTO, E. Hampton Distr. L.L.C. is authorized to conduct test hole drillings at the East Hampton Airport known as Site No. 15 on the filed map of East Hampton Town Industrial Park (shown on the Suffolk County Tax Map as SCTM #0300-191.00-02.00-009); to be conducted to collect information for applications and approvals from the Suffolk County Health Department, provided that HTO, E. Hampton Distr. L.L.C. execute and deliver an indemnity and hold harmless agreement, in a form to be approved by the Office of the Town Attorney, prior to entering the property; and be it further

RESOLVED, that this authorization shall extend through December 1, 2018.
