RANGE AND SAFETY RULES

SECTION 1: SPECIFIC RANGE RULES

- A. Safety is our number one concern at all times.**
- B. Absolutely no shooting at aerial targets with rifles or handguns.**
- C. Absolutely no alcoholic beverages on the property at any time.**
- D. Absolutely no glass targets are allowed at any time.**
- E. Absolutely no guests are allowed to use the range without the presence of a legitimate club member. Your membership covers you, your spouse, and your minor children (under the age of 18). All applicants, spouses, and minor children must attend Range Orientation to qualify for membership. Everyone else in your family is considered a guest at the range.**
- F. Absolutely no minors may use the range without adult supervision.**
- G. Absolutely no shooting at range markers or target stand framing. Attach targets to white plastic backing only.**
- H. Members must pick up and remove any trash they generate. Any non-paper targets that you bring to the range should leave with you.**
- I. The gate must be closed, locked and combination zeroed by the last member to leave the range.**
- J. Anyone may call "CEASE FIRE" command at any time they observe a potentially dangerous situation or hazard.**
- K. All members are required to enforce all range regulations and report any violations to club officers.**
- L. Club members are responsible for their guests and their actions.**

SECTION 2: GENERAL RANGE RULES

- A. Know and obey all range commands.**
- B. Know where others are at all times.**
- C. Shoot only at authorized targets.**
- D. Avoid ground level targets to avoid ricochets.**
- E. Clear, unload and bench all weapons when down-range or a cease fire is called.**
- F. Always keep muzzle pointed in a safe direction.**
- G. Be courteous of other shooters.**
- H. Be sure of your target and direction of fire.**
- I. Wear eye and hearing protection.**
- J. Firearms not in use will have actions open and magazines/clips removed.**
