

BARRON'S LEASH | ELITE PET CARE AGREEMENT

Jackson Hole Dog Sitting & Private Luxury Boarding

This Elite Pet Care Agreement is between **Barron's Leash** and the **Client** or authorized representative listed below.

1. SERVICES

Barron's Leash provides private residence dog boarding, dog sitting, enrichment, and pet logistics in Jackson Hole, Wyoming.

Services are offered by reservation only and are subject to availability, dog temperament, health status, and approval by Barron's Leash.

2. RATE, RESERVATION RETAINER & PAYMENT

Private Boarding Rate: \$250 per night, per dog.

A **\$250 reservation retainer** is required to secure approved boarding dates.

The reservation is not confirmed until the reservation retainer has been received.

The remaining balance is due in full **72 hours before the scheduled start date**.

Accepted payment methods may include credit card, bank transfer, Venmo, or cash, as approved by Barron's Leash.

3. CANCELLATION POLICY

Cancellations made more than 72 hours before the scheduled start date may receive a refund of payments made, excluding any non-refundable reservation retainer if applicable.

Cancellations made within 72 hours of the scheduled start date are non-refundable.

Early pickups, late arrivals, trip changes, or unused nights are not refundable once the reservation has begun.

4. PRIVATE RESIDENCE & APPOINTMENT-ONLY POLICY

Barron's Leash operates from a private residence and elite pet care facility.

For the safety, privacy, and tranquility of all canine guests, visits are by appointment only.

Walk-ins are not accepted.

Client agrees not to arrive outside scheduled drop-off or pickup windows without prior approval.

5. HEALTH, VACCINATIONS & VETERINARY CARE

Client confirms that all dogs are current on required vaccinations, including Rabies, Distemper/Parvo, and Bordetella, unless otherwise approved in writing.

Client must disclose all known medical conditions, medications, allergies, dietary needs, mobility issues, anxiety triggers, or behavioral concerns before the stay begins.

In the event of illness, injury, or emergency, Barron's Leash is authorized to seek veterinary care from Fish Creek Veterinary, an emergency veterinary provider, or the nearest available veterinary facility.

Client is responsible for all veterinary costs, transportation fees, emergency charges, medication costs, and related expenses.

6. BEHAVIOR, SAFETY & DISCLOSURE

Client must disclose any history of aggression, biting, escape attempts, destructive behavior, separation anxiety, resource guarding, reactivity, or unsafe behavior around people, dogs, wildlife, vehicles, livestock, or children.

Barron's Leash reserves the right to refuse, cancel, or terminate services if a dog presents a safety risk, requires care beyond what was disclosed, or is not suitable for a private residence boarding environment.

If service is terminated early due to undisclosed behavior, aggression, health issues, or safety concerns, Client remains responsible for all fees incurred.

7. MOUNTAIN ACTIVITY & LIABILITY WAIVER

Client understands that dog care in Jackson Hole may include outdoor activity, walks, trail access, yard play, vehicle transport, wildlife exposure, snow, ice, uneven terrain, and other inherent risks.

Client accepts these risks and releases Barron's Leash from liability for injury, illness, escape, loss, accident, or death except in cases of gross negligence or intentional misconduct.

Client is responsible for any injury, property damage, veterinary expense, or third-party claim caused by their dog.

8. TRANSPORT & LOGISTICS

If pet transport is requested or required, Client authorizes Barron's Leash to transport the dog by vehicle for approved services, veterinary care, airport logistics, estate transitions, walks, or emergency needs.

Additional transport or logistics fees may apply.

9. PRIVACY, DISCRETION & MEDIA

Barron's Leash respects the privacy of all clients, including high-profile clients, second-home owners, and families using aliases or business entities.
