This agreement is between Barron's Leash (the Company) and the Client (or their authorized representative).

#### **1. THE ELITE STANDARD & BILLING**

- **Rate:** \$250.00 per night per dog.
- **Deposit:** A 50% deposit is required to secure your reservation.
- **Payment Methods:** We accept **QuickBooks Online (Credit Card/Bank Transfer), Venmo,** or **Cash.** Please indicate your preference so the appropriate invoice can be issued.
- **Schedule:** All services are paid upfront. The remaining balance is due in full 72 hours prior to the service start date.
- **Confidentiality:** We respect the privacy of our high-profile clientele. Accounts may be managed under an Alias or Business Entity name, provided a designated human emergency contact is verified.

#### **2. CANCELLATION POLICY**

- **72-Hour Rule:** Cancellations made within 72 hours of the scheduled start time are 100% non-refundable. Cancellations made prior to the 72-hour window will receive a full refund of the deposit.

#### **3. HEALTH & VETERINARY CARE**

- **Primary Provider:** Our preferred provider is **Fish Creek Veterinary (Dr. Theo) in Wilson, WY.**
- **Authorization:** In the event of a medical emergency, Barron's Leash is authorized to seek care at Fish Creek Veterinary or the nearest emergency facility.
- **Financial Responsibility:** Client assumes 100% of all veterinary costs, transportation fees, and emergency surcharges.
- **Vaccinations:** Dog(s) must be current on Rabies, Distemper/Parvo, and Bordetella.

#### **4. BEHAVIOR & LIABILITY**

- **Disclosure:** Client must disclose any history of aggression. Barron's Leash reserves the right to terminate services immediately if a dog poses a safety risk.

- Liability Waiver: Client acknowledges the inherent risks of mountain activity and boarding. Barron's Leash is not liable for injury, illness, loss, or death of the dog except in cases of gross negligence.
- Indemnity: Client is responsible for any damage caused by their dog to property, persons, or other animals.
