Standby Fees - Standby fees occur when a clinician is asked to attend a Court hearing on a specific day but the retaining attorney does not have an exact time. Standby fees are put into place due to the clinician

having to cancel any standing appointments they have during that day in order to be accessible for testimony. Standby fees begin occurring when a clinician is assigned "a time" to be available for Court and end when the retaining attorney releases the clinician for the day.

Court Preparation of Clinician by Dr. Woller – This includes pre-court consultation of Dr. Woller personally on a case where another clinician is being requested for testimony, case research, any time on the phone or by emails with attorney's with case managers or foster parents on a case with Dr. Woller where another clinician is requested for testimony. This also includes time Dr. Woller spends prepping and reviewing all case documents, inclusive of TSV notes, FSFN materials, and prepping clinicians under the supervision of Dr. Woller for expert witness testimony.

Court Preparation Fee – Flat Rate - This includes any pre-court attorney consultation, case research, anytime on the phone with attorneys, case managers, or foster parents. This also includes the time for gathering and reviewing all current case documentation, inclusive of FSFN, prepping personal notes and timelines for Court testimony.

Private Attorneys - Retainer and agreement are required prior to testimony or deposition. A square invoice will be sent to the retaining attorney prior to the hearing and/or deposition. Invoice is to be paid prior to testimony or deposition.
