GGA BOAT RAMP RULES AND REGULATIONS

1. To be eligible to put watercraft on the lake, you **MUST BE A CURRENT MEMBER OF THE GLORIA GLENS ASSOCIATION.**
2. Owners of a residence (not just a parcel of property) in the Village of Gloria Glens Park are eligible for a boat ramp key and watercraft sticker.
3. **RENTERS** are **NOT** eligible for these privileges.
4. In order to be eligible the watercraft must be **OWNED (TITLED)** by the owner. Proof of ownership for the watercraft and property must be presented to obtain a key.
5. The **KEY** will remain the property to the GLORIA GLENS ASSOCIATION and must be returned to this Association when a residence is **SOLD/TRANSFERRED** or **NO LONGER A CURRENT GGA MEMBER.** Keys are subject to repossession by the Association in the event of a violation of any of the **RULES.** **ONE** key will be issued per boat owner who is a member of the GGA.
6. Each owner who will be entitled to a key will be issued 1(one) weatherized sticker for each watercraft. In order to be eligible for a sticker, **EACH** watercraft must be owned by the property owner per **TITLE AND/OR REGISTRATION.**
7. Only persons with a properly issued key with properly registered watercraft will be permitted to use the gate and boat ramp.
8. Watercraft stickers shall be displayed on the watercraft at **ALL** times and placed on the front **RIGHT HAND SIDE** above the water line. The sticker shall be in **CLEAR VIEW** without **OBSTRUCTION** at all times.
9. Authorized boat ramp users shall **NOT** lend or permit use of their key by any person who is not entitled to use the boat ramp or watercraft not properly registered to him/her.
10. **CLOSE** and **LOCK** the boat ramp gate **IMMEDIATELY** after each passing through. The key cannot be taken out of the lock until the lock is closed and locked. Leaving the gate **UNLOCKED AND/OR OPEN** for others is subject to repossession of the key by the GGA.
11. Cars with boat trailers **MAY NOT BE PARKED** IN THE BEACH AREA or parking lot at any time.
12. Lending your key **TO OTHER WATERCRAFT OWNERS OR NON-RESIDENTS** IS **PROHIBITED** and is a **VIOLATION** of the **BOAT RAMP REGULATIONS** and is subject to **REPOSSESSION** of the key.
13. Duplication of the boat ramp key is **PROHIBITED.** Keys cannot be duplicated and are also marked with the GGA name and assigned number.
14. The **ASSOCIATION** shall maintain a ledger listing each key and sticker issued which will include the key number, watercraft identification, property owner's name/address/phone number and date the key was issued.

I, the undersigned, do state that I am the property residence owner and watercraft owner as noted above. I have read the GLORIA GLENS BOAT RAMP/KEY REGULATIONS concerning the use of the boat ramp and key and further understand the violations of these rules and regulations. The key is the property of the GLORIA GLENS ASSOCIATION and MUST be returned to the ASSOCIATION when my property is sold or transferred.
