Academic Instruction

Bluefield State University:

Formal Teaching

- **CRMJ 164 - Criminal Procedure and Evidence**
Theory and practice of the criminal justice system from arrest to release. The following areas are covered: rules of evidence, burden of proof, and testimonial privilege.
- **CRMJ 208 - Criminology**
A study of current theoretical explanations of crime as a social problem, including structural, social, psychological, and critical theories of crime causation and treatment.
- **CRMJ 221 - American Correctional Systems**
A study of contemporary American corrections, including detention facilities, organizations and personnel, programs and activities, inmate society, and trends.
- **CRMJ 232 - Criminal Justice Writing and Communication**
Specialized instruction in preparing Criminal Justice Documentation; instruction in preparing various types of Business Communications.
- **CRMJ 252 - Drugs and Crime**
This course examines the history and consequences of mind-altering drugs and criminal behavior as it is affected by drugs, the legal response to substance abuse, treatment, and prevention of substance abuse. Students will learn about drug use, drug misuse, and drug abuse and control from a criminal justice perspective.
- **CRMJ 292 - Juvenile Delinquency**
A study of deviant behavior and current criminological theories, with emphasis on justice system applications as related to juvenile offenders.
- **CRMJ 297 - Fundamentals of Homeland Security**
This course will examine the fundamentals of Homeland Security and Anti-Terrorism techniques and strategies. Students will also be introduced to the structure and functionality of the United States Department of Homeland Security.
- **CRMJ 301 - Probation, Parole, and Community-based Corrections**
A study of the history and philosophy of probation, parole, and community-based corrections. Emphasis will be given to organizational and community structures of federal, state, and local methods of correction in the community, as well as to problems of supervision, case management procedures, legal framework of

correctional operations, and use of emerging community-based correctional techniques.

- **CRMJ 331 - Ethics in Criminal Justice**
A treatment of ethical issues which arise in areas of Law Enforcement, Corrections, Community Corrections, Private Security, and Government. Emphasis will be placed on current issues in the Criminal Justice Field.
- **CRMJ 335 - Forensic Investigation**
Forensic investigation is the practice of lawfully establishing forensic evidence and facts, which are to be presented and accepted in a court of law. It relates to the application of expert techniques to reconstruct and investigate crimes and present evidence in court based on rules of evidence.
- **CRMJ 341 - Contemporary Issues in Criminal Justice**
In-depth study and analysis of critical issues facing the American system of justice.
- **CRMJ 343 - Firearms & Tool Marks**
Explores the analysis of impression evidence including tool marks foot and tread wear, tire tracks, and firearm-related impression evidence. Includes techniques for evaluating projectile trajectories as well as explosive evidence and post-blast crime scenes.
- **CRMJ 350 - Counterterrorism & Intelligence Strategies**
This course is an in-depth analysis of anti-terrorism, counterterrorism techniques, and intelligence strategies. Students will analyze current and historical terrorist organizations and previous attacks from a domestic and international perspective.
- **CRMJ 352 - Investigating Domestic Terrorism**
This course is an in-depth analysis of domestic terrorism and its definition. Students will also examine current and historical domestic terrorist groups and attacks. Then analyze anti-terrorism measures, counterterrorism techniques, and intelligence strategies that could have been effective in these situations and compare them to what strategies were implemented. The student will also gain a working perspective and understanding of the methods and techniques used to investigate domestic terrorism incidents.
- **CRMJ 353 - Investigating International Terrorism**
This course is an in-depth analysis of international terrorism and its definition. Students will also examine current and historical international terrorist groups and attacks. Then analyze anti-terrorism measures, counterterrorism techniques, and intelligence strategies that could have been effective in these situations and compare them to what strategies were implemented. The student will also gain a working perspective and understanding of the methods and techniques used to investigate international terrorism incidents.
- **CRMJ 360 – Forensic Interviewing**
This course is an in-depth study of forensic interviewing methods, protocols, standards, and objectives. This course heavily focuses on interviewing children and adult victims but also delves into the interviews of offenders.

- **CRMJ 414 – Victimology**
 The purpose of this course is to provide a better understanding of the plight of crime victims. This course will explore "victimology" the study of victims, and will look at all aspects of victims of crime, from prevalence and demographics to needs and perspectives. The student will gain knowledge related to crime victims and their relationship to the criminal justice process. The student will understand the impact of the criminal justice process on victims of crime, as well as offenders through victim-offender mediation programs restorative justice model. Various services provided to crime victims throughout the country will be explored, as well as programs related to compensation for crime victims.
- **CRMJ 431 - Private Security**
 An in-depth study of private security organizations' needs and requirements in the United States.
- **CRMJ 477 - Directed Investigations**
 This course will examine the fundamentals of criminal profiling, gathering evidence, completing a profile, understanding the psychological components of forensic profiling along with case studies, analyses of serial killers and their profiles, eyewitness testimony, expert testimony, and rules of evidence.
- **CRMJ 478 - Psychology of Terrorism**
 The student will gain an in-depth knowledge of the psychological aspects of terrorism from an international and domestic perspective. As well as the terrorist and victims' perspectives and an in-depth understanding of psychological terrorism.
- **CRMJ 480 - Sexual Assault Investigations**
 Explores the steps throughout sexual assault investigations. Includes the history of society's response to sex crimes, investigation techniques, forensic applications, offender typologies, victim studies, legal procedures, judicial decisions, and expert testimony.
- **CRMJ 485 – Investigative Psychology**
 This course is an in-depth study and analysis of Investigative Psychology (IP). Students will learn to apply the main principles of investigative psychology to their work by directly applying the technique to current and historical casework.
- **CRMJ 490 - Seminar in Criminal Justice**
 An analysis and discussion of problems and experiences gained during the field internship, and of the knowledge gained through the course work completed in criminal justice. An emphasis is placed on integrating theory and practice. Spring
- **CRMJ 492 - Terrorism**
 An in-depth analysis of the origins and historical perspectives of terrorism, both domestic and international. Areas of study will include definitions, origins, historical development, and usages.

- **CRMJ 495 - Special Topics in Criminal Justice (Forensic Psychology)**
Studies in major fields for students who have demonstrated a capacity for responsible work. Not repeatable.
- **CRMJ 498 - Internship**
Monitoring and tracking the completion of the student's field internship.
