

Terms and Conditions

Agreement between User and www.GateTVs.com

Welcome to www.GateTVs.com. The www.GateTVs.com website (the "Site") is comprised of various web pages operated by Gate TVs LLC ("Gate TVs"). www.GateTVs.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of www.GateTVs.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference. www.GateTVs.com is an E-Commerce Site.

Terms of Your Order

This website serves as a platform for Gate TVs to receive orders for smart TV rentals (32", 39", 43", 50", 65", and 75") as well as other items and accessories by semester at Colgate University for its students living on-campus and off-campus. Our services include pick-up and delivery and include HDMI cables with our TV rentals as well. Our services also include the sale of items and accessories.

Before we deliver your rented smart TV, you must provide payment for one semester plus the security deposit indicated plus sales tax through www.GateTVs.com. Once your TV is picked up at the end of the rental period, it will be inspected. If it is found to be in good, working condition, your security deposit (and the sales tax paid on your security deposit) will be refunded to the address you specify in your order.

If the TV is not returned, the security deposit will not be refunded and will become the property of Gate TVs. If the TV is returned with damage, you will be responsible to Gate TVs for the cost to fix or replace it. The decision to fix or replace, and the associated costs shall be determined by Gate TVs in its sole discretion. Gate TVs reserves the right to apply some or all of your security deposit to the cost of repair or replacement, and shall refund any excess to you to the address you specify in your order.

If you break the TV and would like a replacement, you must pay the semester fee for a new rental and new security deposit in addition to the original rental fee and security deposit. If the TV is defective (and confirmed by our examination), we will replace it cost-free. When purchasing our services from our website, you are agreeing to the terms and conditions in this document.

Electronic Communications

Visiting www.GateTVs.com or sending emails to Gate TVs constitutes electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

Children Under Thirteen

Gate TVs does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use www.GateTVs.com only with permission of a parent or guardian.

Arbitration

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and Gate TVs agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
