1. Roger Langevin came to talk about his bid to be Franklin County Sheriff. Election is coming up on August 14th.
2. Maurice said there are some issues with the tractor, but it's now been fixed. South Road paving will be done tomorrow.
3. Chester Arthur Road/North Road warning light not working properly. Amanda to follow up.
4. Chris Brunelle and Jim Smith are going to look at the North Road culvert in the morning.
5. Matt Gillian is going to do the shoulders on South Road. Around \$1K. Ok.
6. Jimmy and Moe gave a salt shed update.
7. Gavin made a motion to enter executive session to discuss a personnel issue. Norm seconded. All in favor. Exit. Can we insure liability and property on rented/leased piece of equipment? Amanda to check it out.
8. MM to follow up again with Sarah Rutherford – the artist who did the murals in Jeffersonville
9. Gavin made a motion to enter executive session to discuss a personnel situation. Norm seconded. All in favor. Exit. We should pay the part-time mowing person the same rate as a part-time plow person. \$18/hr.
10. Fire Department building in EF is now on our insurance policy. The building costs \$405/yr. for property insurance. Still waiting on liability insurance.
11. The town attorney has reviewed the Bill Hanon agreement for Ryan Road. Approved.
12. Personnel policy update reviewed and approved.
13. Letter from John Cronin re dog attack at 224 North Road. MM to do a letter re no leash law but owner is liable and responsible.
14. Shila Boomhower says the posts are rotting around the porch and she needs gravel around the stairs. Jim Paradee will look it over.
15. Issue with backhoe. The wrist on the back bucket needs rebuilding.
16. Increase in retirement 12.5%. Employer contribution up 5.625%, Employee up 5%.
17. Tom has to sign the municipal general roads permit. Cost is \$240 processing fee, \$400 for application review and an annual fee of \$1350.
18. Re the school agreement for Veterans Hall. No response from school to Amanda. Sean O'Dell gave Charlie the building use form. The minutes of the school board meeting suggest that they don't feel any other agreement is necessary.
19. Issue with batting cage/new building in EF. Who's in charge of it? Issue with updates to the Town owned building with money donated to Little League but located on a town property. Charlie feels the Rec Department needs
