
Dear Mr. Howrigan,

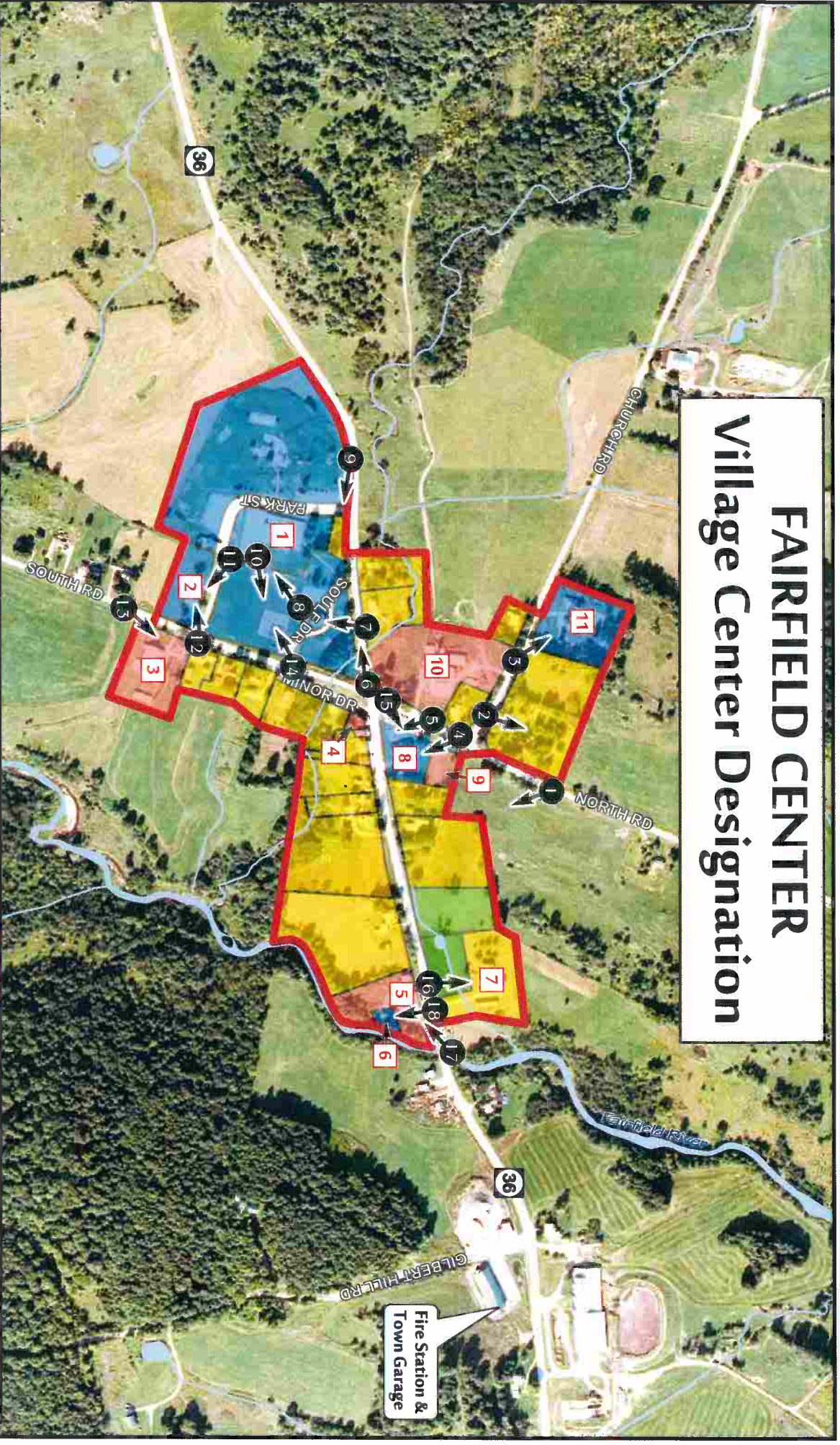

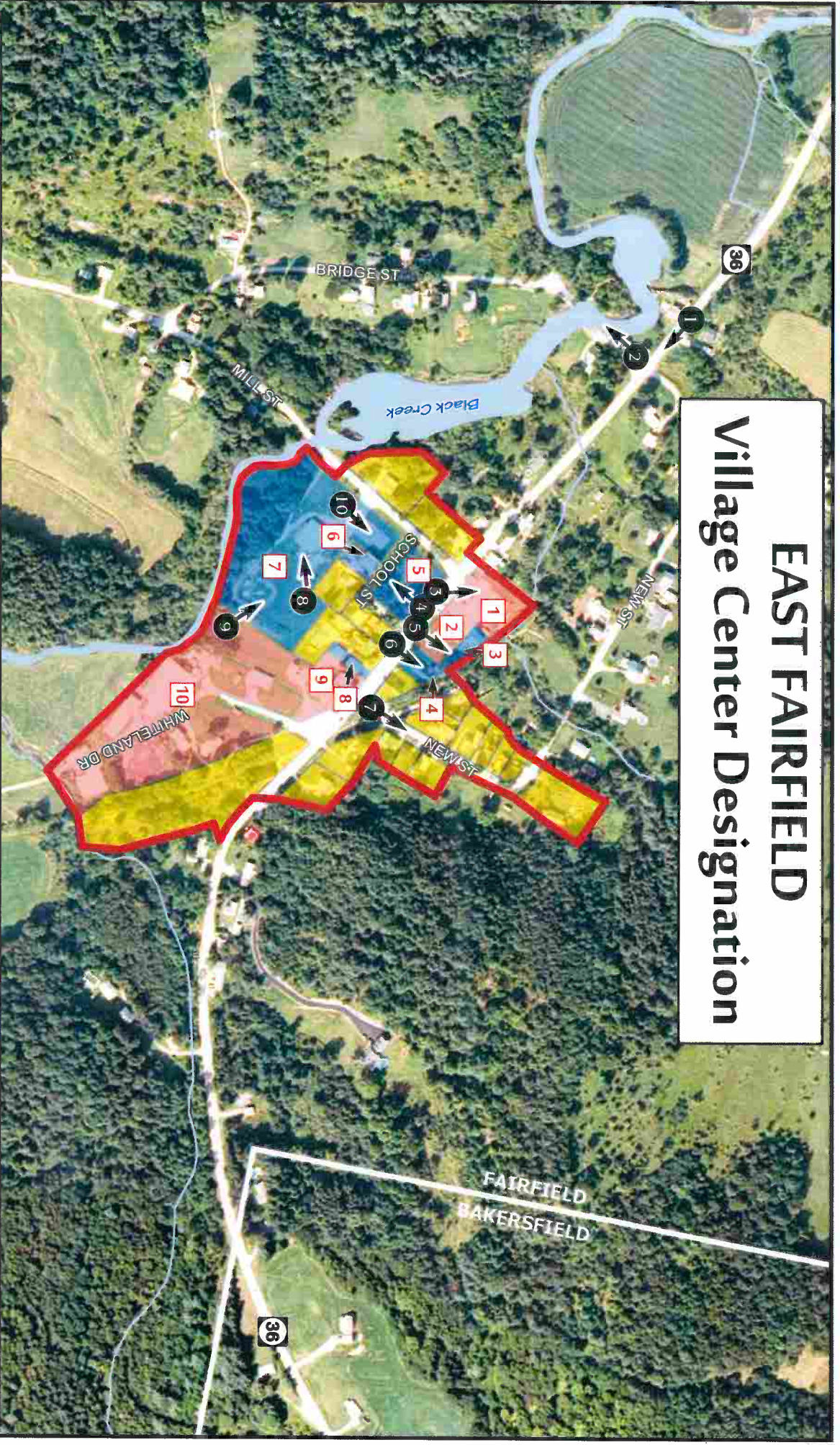
