5. ASSUMPTION OF RISK, RELEASE & INDEMNIFICATION AGREEMENT

In consideration of being permitted to participate in the Low Rider Derby at Bakewicz Farms (the "Event"), I, the undersigned dog owner or authorized handler, acknowledge and agree to the following:

A. Acknowledgment of Risks

I understand that an event involving multiple dogs, people, farm animals, and outdoor activities involves inherent risks, including dog bites, scratches, fights, attacks, injury to or death of an animal, injuries to participants, spectators, children or staff, falls, collisions, escapes, heat-related illness, farm conditions, property damage, and injuries arising from races, pup cup challenges, contests, or interactions with other dogs. I voluntarily accept the inherent risks associated with participation for myself and my dog.

B. Owner Responsibility

I certify that I own the dog identified above or have legal authority to register and handle the dog. I accept responsibility for supervising, controlling, and handling my dog at all times. I agree to maintain control of my dog, follow event rules and staff instructions, promptly remove my dog from any unsafe situation, and immediately report any bite, injury, escape, or aggressive incident to event staff. I acknowledge that I am responsible, to the extent provided by applicable law, for injuries,

bites, attacks, and property damage caused by my dog, including incidents involving other dogs, participants, spectators, employees, or farm animals.

C. Release of Liability

To the fullest extent permitted by applicable New York law, I release and agree not to hold Bakewicz Farms, Bakewicz Properties LLC, Little Bakes LLC, and their respective owners, officers, employees, volunteers, and event representatives liable for claims arising from inherent risks of my voluntary participation in the Event, including injuries to myself or my dog caused by interactions with other participating dogs. This release does not apply to liability that cannot lawfully be waived, including negligence where a release is prohibited by applicable law.

D. Indemnification

To the fullest extent permitted by law, I agree to indemnify and hold harmless Bakewicz Farms, Bakewicz Properties LLC, Little Bakes LLC, and their respective owners, employees, volunteers, and event representatives against third-party claims, damages, liabilities, and reasonable legal expenses arising from injuries or property damage caused by my dog or from my own negligent or wrongful acts or omissions. This obligation does not extend to claims to the extent caused by the negligence or wrongful conduct of a party seeking indemnification, or where indemnification is otherwise prohibited by law.

E. Veterinary Care & Expenses

I authorize event staff to contact me or my emergency contact if my dog becomes injured or ill. If I cannot be reached and immediate veterinary care appears necessary, I authorize staff to arrange transportation or veterinary attention when reasonably practicable. I understand that Bakewicz Farms does not guarantee veterinary services or emergency transportation. I remain responsible for my dog's veterinary expenses except to the extent another party is legally responsible.

F. Removal & Event Rules

Bakewicz Farms reserves the right to deny entry, discontinue an activity, or remove any dog or participant whose behavior or condition presents a safety concern. I agree to comply with all posted rules and reasonable instructions from event staff.

G. Acknowledgment

I confirm that the information I provided is accurate, that I have read and understand this agreement, and that I am signing voluntarily. I understand that this agreement may affect my legal rights.
