DATES for 2025-26 11/9/25, 12/14/25, 1/11/26, 2/8/26, 3/8/26, 4/19/26. Two relays per day at 8:30 am and 12:30 pm.

NRA 1800 ENTRY- Any competitor may enter. NRA membership is not required. Izaak Walton membership is not required. Match is limited to 16 competitors. Out-of-town competitors should contact the Match Director to secure a place on the firing line. 1800 Match fee is \$35.

PISTOLS ALLOWED: 22LR Pistol Match - Any 22lr pistol with a trigger pull of at least 2 pounds. Center-Fire Pistol Match - Any center-fire pistol, .32 caliber or larger, with a trigger pull of at least 2.5 pounds, any .45 caliber pistol with a trigger pull of at least 3.5 pounds, revolvers 2.5 pounds. Pistol Sights-Any sights, including red dots and scopes, except laser.

COURSE OF FIRE- NRA 1800 Tournament is the aggregate of the 22lr Pistol Match, and the Center-fire Pistol Match.. All shots will be fired standing, single handed, with no support. Match #1 20 shots slow fire (.22), Match #2 30 shots NMC (.22), Match #3 20 shots timed fire (.22), Match #4 20 shots rapid fire (.22), Match #5 aggregate of #1-4, Match #6, 20 shots slow fire (CF), Match #7 30 shots NMC (CF), Match #8 20 shots timed fire (CF), Match #9 20 shots rapid fire (CF), Match #10 aggregate of #6-9, Match #11 aggregate of #5 & 10

TARGETS- The slow fire match will be fired on NRA B2 targets at 50 feet. The timed fire and rapid fire match will be fired on NRA B3 targets at 50 feet, with turning targets. The 22 match will be 10 shots per target, center-fire will be 5 shots per target.

AWARDS- Match #11 winner \$10, 1st in class \$5. Matches 5 & 10 winner \$4, 1st in class \$3. Matches #1-4 & 6-9 winner \$3, 1st in class \$2. Any class with less than 3 will be combined with the next higher class. Less than 3 masters will compete for win only.

SAFETY- All competitors must wear eye and ear protection. Please keep all pistols cased until the start of the preparation period, and unloaded until the command to load has been given. Empty Chamber Indicators (ECI) will be used. All safety devices of the pistol must function properly.

LOCATION-Linn County Izaak Walton League is located at 5401 42nd St NE, Cedar Rapids IA. The Indoor Pistol Range, with 8 firing points, is the first building on the right after passing through the gate, with parking directly in front. Enter through the red door. GPS coordinates 42.0205 -91.7195
