

From The Captain:

I, Captain William Owens or Relief Captain _____, promise and certify that I have a Captain's License issued by the U.S. Coast Guard and that I am legally qualified to take passengers on fishing charters. Our credentials are available for you to view.

I promise not to take unnecessary risks and will avoid bad weather to the fullest possible extent. My goal is to make your trip both memorable and safe.

In the event a charter is ended before its scheduled time for weather or mechanical issues the charter will be charged on a prorated basis based on number of hours completed. If the issue is after three hours, then the charter will be considered completed.

In the event of rain, without the threat of severe weather, small craft advisory, or lightening, the charter will continue unless the guests desire to end the charter or the captain deems conditions unsafe.

Charter Boat Guest:

I, all those in my boating party, and the undersigned, fully understand that I am boarding a charter fishing vessel to fish in open water. I understand this waiver covers my entire group and that all adults in this group have read or will read this waiver understanding and assuming the risks and hazards associated with offshore fishing.

These risks and hazards include, but are not limited to:

Sun, rain, lightning, sea spray, and any other weather condition; seasickness; pitching and rolling; slippery and wet decks; injuries, both internal and external from boarding and disembarking the vessel; fish, fishing, fishing tackle, and gear; and the unintentional conduct of any other persons on the boat.

I understand and agree that I will not hold the Captain, Crew, or Sirius Dog LLC DBA Rampage Charters, liable for risks and hazards associated with offshore fishing, and I expressly release them from all such risks and hazards.

I verify that I am not in possession of any illegal substances and I release the Captain, Crew, and Corporation from any liability whatsoever for any illegal actions taken by myself on the vessel.

I understand that if it comes to the attention of the Captain or Crew that I (we) have any illegal substances or participate in any illegal actions, the charter will end immediately.

I further understand that this trip is not recommended for anyone with pre-existing conditions such as circulatory problems, high blood pressure, heart conditions, pregnancy, weak bones, knee, back, or ankle problems.

I agree that any personal items that I opt to not stow safely, are under my own control and the loss or damage of any item is not the responsibility of the Captain, Crew, or Sirius Dog LLC DBA Rampage Charters..

I have read this waiver and understand it is a legal document designed to inform me of risks and release the Captain, Crew, and Sirius Dog LLC DBA Rampage Charters from any and all

liability for personal injuries, personal property damage or loss, mishaps, or omissions from the conduct of other fishermen (intentional or not) and crew (unintentional) during this fishing charter.

I agree that my signature below constitutes a waiver and release for any future charters I or my group may take with Rampage Fishing Charters.
