



NATCHITOCHES TRIBE OF LOUISIANA

Update 16 AUG 2025

With the leadership of your Corporate Officers (President/Chief Fred Simon, Vice Chief David Stevenson, Treasurer Peggy Smith, Secretary Kenneth Rachal) and the other Board of Directors, (Frank Perot, Glen Henson, Thomas Alemond, Dr. Vercher) the tribal business has never been neglected and has continued in our mission for BIA approval.

Here are the facts.

Starting in Oct 2024 and continuing to the present Brett Anderson and his ten followers attempted to pass documents that would have destroyed our Tribe. This group was suspended from their position and duties. They continued to create a major division of the Tribal Leaders and started spreading false and slanderous information. They attempted to stagnate our Tribal mission and business.

This group also has attempted to hinder our effort to validate our Tribal Registry by stating false information on Facebook causing great concern for some of you. This group may also attempt to have future applications for Tribal membership be sent to a false address rather than Natchitoches Tribe of Louisiana-P.O. Box 85-Campti, LA 71411 as well as asking for illegal donations to support their insurgency.

On December 28, 2024, Primary Chief Fred Simon called a special executive session held in Oak Grove Louisiana to address the current situation and take the necessary action to insure our Tribe stayed intact and continue our mission. At this meeting Chief Fred presented certified documents about our Tribe creation. It was determined the "Council" was in fact nothing more than a committee set up to establish actions to gain BIA recognition and had no governing authority. The non-existence of any Tribal Council (calling itself an "unincorporated association") as a legal entity has also been determined by the State of Louisiana.

Due to the above facts it was necessary to expand the Board of Directors and appoint new Officers. After this, a motion made and approved by the Board of Directors which eliminated the committee known as the "Council", all positions and members. From this time to the current date, the official and legal Nonprofit Corporation Natchitoches Tribe of Louisiana continues work on our BIA submission as well as community service.

A food pantry has been established in Campti, La with great success. Bikes and gifts to needing children were done in Campti for Easter. We have established a partnering relationship with the Mayor and leaders in Campti. In Aug 2025 we sent to all members in the registry a post card advising web sites to see the true facts. All of this without a dime of Tribal funds spent.

May 2025 – Brett Anderson began sending letters of impeachment to our Board of Directors. He did this still believing he and his followers are a viable existing entity with authority. He made a change on our hi-jacked web site naming himself from the speaker to Vice-Chief. Then in Aug 2025 he posted himself as the Primary Chief then conducted a "Council" meeting to impeach our Board of Directors from "his" dissolved committee.
