"REGISTRANT" AND OTHER DEFINED TERMS The term "Registrant," as used in this ENROLLMENT AGREEMENT, DISCLAIMER AND RELEASE ("Enrollment") means the student ("Student") enrolling for one or more sessions or productions sponsored by Ovations Studios, Inc. ("Ovations"), or, if the Student is under the age of 18 or still under the financial support and/or guardianship of a parent or legal guardian, the Student and Student's parent or legal guardian. **All policies set forth by Ovations are subject to change, without notice, at any time at the sole discretion of Ovations.**

ENROLLMENT AND TUITION

Registrant understands and agrees that this Enrollment entitles the Student to attend only the particular session, workshop, intensive, or production identified in the associated enrollment registration and does not entitle the Student to participate in any other Ovations' session, workshop, intensive, or production. For example, enrolling in a session of 2026-27 specific dance class(es) does not entitle the Student to participate in a production of any productions that occur during the 2026-27 session. Ovations reserves the right at any time to convert any offering that Registrants are enrolled in to a digital offering if, in Ovations' sole determination, this is necessary or advisable due to things such as: to studio conditions, health advisories, HVAC or water related problems, instructor availability, or other conditions. Such conversion may occur at any time and may persist for an extended length of time including the entirety of a session, workshop, intensive, or production. If a class is held with only ONE registered dancer present, class will be shortened by 15 minutes if a combined class option is not available.

Tuition for any session, workshop, intensive, or production is due upon Enrollment for the entire session and is not refundable even if a class is dropped. Tuition may be paid by credit card or by personally delivered check. Checks for tuition may be used for payment; however, if tuition is paid by check, Enrollment will not be effective, and the Student will not be entitled to participate in the session, workshop, intensive, or performance, until the check or money order has cleared Ovations' account. There will be a \$35.00 fee for each payment returned for insufficient funds via check. A late fee of 3% will be charged for electronic payments and a 3% declined payment if balance not settled during a 7 day grace period. Payments in cash are neither accepted nor will entitle Student to Enrollment.

- **AUDITING** Dancers who are close to completing their requirements may be invited to audit a higher-level class. Auditing a class allows a dancer to regularly attend a higher-level class at no additional cost. In lieu of tuition, dancers will not be eligible to participate in the recital piece for the class they are auditing. A teacher may approve an auditing student to participate in the recital, but at that point tuition and recital fees would be charged. Please note: an invitation to audit a higher level does not constitute placement into that level. Dancers would still be expected to be enrolled in, attending and meeting expectations in their placed class. Evaluations and placements will be solely based off of the class they are placed into and not the class they have been invited to audit.

PAYMENT PLANS Regular payments must be made if your family is on a payment plan for the 2026-27 season. Failure to provide updated credit card information or to return communication in regard to payments may result in dancers being unable to participate in classes, productions, competitions and/or recital pieces. Families that are in arrears for the previous school year will not be able to participate priority registration until they have cleared their balance.

RESTROOM POLICY

Ovations will not accompany or provide any oversight for any participant using the common area restrooms, even during designated class and rehearsal time. **Any student who is not fully able to go unescorted to and from the restroom without supervision will be required to have an adult caregiver waiting just outside our facility to accompany the student.** Ovations will not permit any parent or caregiver who has not been authorized in writing by the student's parent to accompany a student to the restroom. **Ovations will bear no responsibility or liability whatsoever for any issues arising from a student using the restroom.**

LOBBY & PARENT COMMUNICATION

In order to ensure the safe egress of our dancers during changeover times, we are respectfully asking parents to wait in the hallways of the shopping center instead of in the lobby and halls of Ovations. Parents are welcome inside with any questions or concerns at any time when front desk staff is present. Teachers will be available via email conference (all staff can be contacted at [firstnamelastinitial]@ovationsstudios.com or via contact@ovationsstudios.com) but may not be available to meet in person or over the phone. 2026/2027 OVATIONS STUDIOS POLICIES

CANCELLATIONS, WITHDRAWALS & HOLIDAYS

CANCELLATIONS, PLACEMENTS, ETC.:

- Ovations reserves the right to cancel any class in the event of under-enrollment or Ovations' inability to provide studio space or a teacher to hold a class, or for any other reason as determined by Ovations in its sole discretion. In the event that Ovations cancels a class, Ovations will notify Student or Student's family of such cancellation and provide a refund for any pro-rated tuition paid by Student or Student's family relating to such cancelled class, based on the number of classes that were not held.
- Ovations also reserves the right to convert any classes, or entire sessions to digital only and/or to hold some classes, even in studio, using digital streaming. If Ovations, in its sole discretion, determines a student or family is not abiding by any policies Ovations has in place at any given time, Ovations may, in its sole discretion, require that family to participate only via digital streaming, or may drop the participant from the class or production entirely. Tuition and/or participation fees will not be refunded if Ovations drops a participant or student or if Ovations requires digital only participation due to non-compliance relating to Ovations' policies on the part of the student or family.
- **Placement of a Student in any given class or classes or changes in placement are determined solely by Ovations staff.** While Students and parents may enroll through the Parent portal and Ovations provides guidelines and general ages for certain class levels, Ovations may, in its sole discretion, require a Student to move to a different level and different class if Ovations staff deems such movement is appropriate.
- For Academy and Advanced level classes, placements by Ovations staff are required. Tuition and Classes listed on the Ovations website and the Parent portal are listed as correctly as possible. However, in the event that a class, performance, intensive or workshop is listed incorrectly or any details about the listing are incorrect, including dates, times, prices, and any other details, Ovations reserves the right to correct any of these details and/or charge the appropriate cost of the class after notifying the Student or Student's Parent/Guardian about the error.

HOLIDAYS & MAKEUP POLICIES:

- There are no classes or makeup classes on scheduled studio holidays/closed days:
 - There are no classes on scheduled studio holidays/closed days, For 2026-27 there are no classes on the following days: 11/24-29/26; 12/7-13/26; 12/20/26 to 1/3/27; 3/22/27 to 4/4/27; 4/30/27 to 5/2/27; 5/31/27.(subject to change). There is one session for all recital classes. This session will run **September 12, 2026 - June 5, 2027.**
 - A small number of Tuesday early childhood classes will be offered in two sessions: 9/12/2026 - 1/16/202 and 1/25/2027 - 5/17/2027. A small number of Saturday early childhood classes will be offered in two sessions: 9/12/26 to 1/16/27 and 1/30/27 to 5/29/27. The early education classes that meet in two sessions (fall and spring) will each have varying days of no scheduled classes. Please note the days classes are NOT held in the specific enrollment information for each of these Creative Movement, Foundations, Combo Ballet and Tap and other Fall or Spring session only classes. These scheduled closings are subject to change at Ovations' sole discretion.

WITHDRAWAL:

- If Student withdraws from any session, workshop, intensive, or performance for any reason, no refund or pro rating will be granted or paid for any tuitions, fees or costume fees. Further, if a Student is removed from an Ovations class or production participation for certain reasons, including disciplinary reasons or violations of Policies and Procedures set forth in any Ovations' Handbooks associated with those activities, no refunds or pro ratings will be granted. **DISPUTES:** Any dispute concerning the terms of this Agreement will be decided under Delaware law, without regard to conflicts of laws provisions, and shall be decided through binding arbitration by a nationally-recognized arbitration organization, such as the American Arbitration Association.

INCLEMENT WEATHER

Due to different session and production times, **Ovations DOES NOT follow Montgomery County's inclement weather policy. In the case of inclement weather, please check our website at www.OvationsStudios.com.** A message will be posted by 8:00 a.m. for classes offered between 9:00 am and 2:00 PM, and a message will be posted by 12:00 PM for classes that start after 1:00 PM. It may be necessary to cancel a class for an emergency or other reason, in which case Registrant will be notified by email as promptly as possible. Weather, health issues, governmentally mandated closures, governmental restrictions or HVAC or other cancellations or closures out of the control of Ovations will not be scheduled or permitted and no makeups or refunds will be provided for classes cancelled or delayed due to weather-related or other class cancellations made due to circumstances out of the control of Ovations (as determined in the sole discretion of Ovations). Ovations reserves the right at any time to convert any or all in studio or in theater activities to digital options if, in the sole discretion of Ovations, such conversion is advisable or required due to weather, building conditions or governmental mandates or advisories.

ATTIRE

Please refer to the posted dress code policies available on our website for specific information; all class or genre requirements can be found on that page.

• GENERAL ATTIRE POLICIES:

- Please label all dancewear and accessories with your dancers name. Items in Lost and Found are donated to charity from time to time. Ovations is not responsible for lost or stolen property.
- Never wear dance shoes outside the dance studio.
- No street shoes permitted in the studio.
- No Nude Leotards in class.
- Remove all jewelry except medical alert jewelry, religious jewelry that cannot be removed or small stud earrings.
- Cover-Up before leaving the studio. Dancers should not leave the studio in only a leotard and tights; any removable cover-up is a great solution.
- Non-binary or gender non-conforming dancers should follow the dress code of their preferred presentation. If additional attire accommodations are needed, please reach out to the instructor and/or studio management.
- Dancers with medical conditions that require dress code accommodations should reach out to their instructor and/or studio management for an exception.

SUBSTITUTES & COMBINING OF CLASSES

From time to time, or even for extended times, specific teachers may be absent - due to illness, personal emergencies, maternity leave or for other reasons - from one or more classes. In the case of a teacher absence, Ovations will either combine classes of similar style at similar times, with or without differing levels, or endeavor to find a suitable substitute teacher. Combined classes may be led with some participants utilizing digital streaming in another studio. Ovations may also have a primary or substitute teacher participate via Zoom or other streaming platform to lead a class or classes on a one-off or extended basis. Ovations does not guarantee that teachers listed as primary teachers for any given class will be the teachers for any or all instances of such classes in any given session, workshop, intensive, or production. In the event that a substitute teacher cannot be organized in time for any scheduled class, the class may be cancelled and Ovations will endeavor to provide a makeup class. However, there are no guarantees that a makeup class can be organized. Registrants and participants agree and understand Ovations commitment to the safety of our community. We have in place policies and procedures designed to reduce the potential transmission of contagions within our facility. These policies and procedures are subject to change and updating in Ovations sole discretion. Policies and procedures include, but are not limited to, social distancing, mask requirements, temperature checks, hand washing, frequent cleaning of surfaces and requirements for those who feel sick to stay home. Policies also include only permitting enrolled dancers into our facility. We believe this enhances the cleanliness of our facility and dramatically reduces the potential for contagion transmission in the facility. We may, from time to time, allow parents and caregivers of younger dancers to come into the facility to watch periodic "shows", but no guarantees can be made that these will be offered.

BALLET D, BALLET E, INTERMEDIATE BALLET & ADVANCED BALLET

Students placed in Ballet D or above or split level (see below), must take at least two ballet technique classes at Ovations per week. For those in split levels, they must take at least one of the lower technique level classes as well as one of the higher level placed classes or two of the lower level classes. Also, any students approved for Pointe are required to take at least two ballet technique classes per week plus a pointe class. Some dancers, such as those placed into Pointe 1, are required to take at least two pointe classes per week. For Advanced only students, dancers are required to be enrolled in at least two advanced ballet technique classes per week. All levels that require TWO classes per week (Ballet C/D, D, D/E, E, E/Int, Intermediate, Int/Adv and Advanced) must enroll in TWO classes on two separate days of the week; dancers MAY NOT stack back to back ballet classes UNLESS they are enrolled in another class on a separate day of the week.

- **Split level placements:** Split level dancers are dancers who have not fully mastered the skills of one level but are ready for accelerated coursework. Split level placements are only available for classes that have a two class per week requirement (Ballet D-Advanced Ballet). Dancers who are split-level approved for a higher-level class must also be enrolled in, attending and meeting expectations in their lower-level class. Dancers may choose to take more than one higher-level class if they would like, but must maintain enrollment in the lower level. If they intend to participate in the ballet pieces at recital, they would need to participate in the lower-level recital piece in order to participate in the higher-level piece as well.
- **Recital Participation:** Please note that Advanced Ballet recital pieces will be prepared in the Advanced Repertoire classes. In order to participate in Advanced Ballet recital pieces in the Recitals, students must enroll in at least one Repertoire class. Students approved for a split level must participate in the lower technique level class' recital dance in order to participate in the higher level class' recital dance. If dancers are only able to do one recital piece, the lower level class will be automatically chosen for them.

2026/2027 OVATIONS STUDIOS POLICIES

SPRING RECITALS

All enrollees in classes eligible for the recital the 2026-27 session will be assumed to be participating in our June recitals unless families contact us directly at Contact@OvationsStudios.com to OPT OUT of recital participation by December 19, 2026. Should a family/dancer decide they do want to participate in recital after previously opting out, recital participation is not guaranteed and families may be charged an additional fee to account for extra shipping costs associated with shipping a single costume. Recital participation and costume fees will be posted to family accounts and charged during the Fall of 2026. These fees will typically be \$130-170 PER DANCER for participation fees and \$80-150 PER COSTUME. Actual fees will be announced before the recital opt out date of 12/19/2026. By enrolling in 2026 -27 classes, you agree to the recital charges as determined by Ovations. Participants in the June Recitals must register for the appropriate class(es) and recital(s) and pay the recital participation fee(s) and costume fee(s) (per costume) on or before the registration deadline in order to participate. Recital Participants must also be registered for the appropriate level class, have paid the full tuition for the session and attend class regularly in order to participate. Dancers who are enrolled in recital must attend a required dress rehearsal during the week of recital (6/7 - 6/13 of 2027). These rehearsals will be held in lieu of class during the week of recital. Failure to attend dress rehearsal may result in a dancer being re-blocked or removed from a recital dance. Dress rehearsals and performance scheduling will be solely determined by Ovations Studios. Please reserve each weekday the week of 6/7-13/27 from 3 pm to 10 pm and all day Saturday and Sunday those dates from 7 AM to 8 PM. Actual timing of shows and rehearsals will be made based on theatre availability and other factors. There are no refunds on recital participation or costume fees for any reason --even if participant is not able to participate due to injury, illness, family emergency or any other reason. Students who transfer classes after the recital deadline will likely be unable to participate in the Recital and no refunds will be provided for the Recital Registration or Costume Fee. If Students who have registered for the recital fail to attend class regularly and/or have more than 8 absences (4 absences per 15 class meetings), they may be ejected from participation in the recital and no refunds will be granted for class tuitions, recital participation or costume fees. If the recitals are unable to be held for any reason including HVAC, weather, public health, theater cancellation, governmental restrictions or for any other reason, no refunds will be provided for recital participation or costume fees.

COMPETITION TEAM

Participants in the Ovations Competition Teams rehearsals and events agree to comply with Competition Team (s) contracts that are in force from time to time. Requirements of participating on Competition Team(s) include, but will not be limited to, attendance and participation requirements as set forth by the Team leaders for any rehearsals or competitions, purchase of Team jacket(s), costumes, tights, hair accessories or other such requirements, payment of Competition Team Tuition and payment of any fees associated with participating in competitions. Competition Team participants and their families also agree to provide transport to and from any competitions and to ensure that a responsible adult for each participant remains on site at any competitions if required to do so by the Competition Leaders. Ovations Competition Team members and their families also further agree to hold Ovations completely harmless for any injury of any kind experienced by Competition Team members or any of their invited guests or family members at any Competition Team rehearsal or event taking place at either Ovations premises, at a competition venue or relating to the transportation to and from any competition venue. There are no tuition discounts applied relating to Competition team participation. There are no refunds associated with Competition Team tuitions, entry fees, media fees, and costume or any other competition team related fees. However, if a competition is cancelled and Ovations is able to receive a full or partial refund relating to that competition, Ovations will refund any entry fees paid by competition team members for that cancelled and refunded competition.

SUMMER WORKSHOPS, INTENSIVES & CLASSES

Students or parents/guardians of Students enrolling in any summer session, intensives, workshops, or productions agree to the other terms and provisions in this Registration Agreement as are applicable. Tuition for classes, intensives and workshops is required to be paid in advance and are non-refundable. THERE ARE NO DISCOUNTS OR PRO RATINGS OFFERED FOR SUMMER CLASSES, INTENSIVES OR WORKSHOPS. As is the case with various Ovations offerings throughout the year, Ovations reserves the right to cancel summer classes or workshops if enrollment is below a level deemed suitable by Ovations, in its sole discretion, or if Ovations is unable to identify an appropriate instructor to lead a specific class, intensive or workshop during the Summer. There are NO makeups allowed for any missed summer classes, intensives, or workshops. In cases of weather or other emergencies, such as building water and HVAC systems emergencies, public health emergencies or governmental restriction, classes and /or workshops may need to be cancelled. No refunds or makeups will be provided in the event of cancellation due to weather, studio or building related emergencies. If a class, intensive or workshop must be cancelled because a teacher cannot teach the class and a substitute cannot be arranged, Ovations will work with parents to come to a reasonable arrangement around makeup classes during the same summer session or, possibly, the Fall session immediately following the summer session. Ovations reserves the right to convert any offering to a digitally streamed offering if, in Ovations' sole determination this is necessary or advisable.

2026/2027 OVATIONS STUDIOS POLICIES

PRODUCTION ENROLLMENT

Please refer to the Nutcracker production handbook for all policies regarding The Nutcracker 2026.

Ovations offers several performances each year. All tuition associated with Nutcracker or the Spring productions is due at the time of enrollment and is not refundable for any reason -- even if participant is unable to participate due to illness, injury, travel or family emergencies. Further, Students and families of Students participating in any performance ("Participants") agree to abide by the additional policies set forth in the Nutcracker and/or other Production Handbooks. Violations of terms of the Handbooks could result in Participants being ejected from the Production and rehearsals. No refunds will be given based on Participants not participating in the Production for any reason or for Participants being ejected from any production due to violation of the Handbook policies by Participants or their families. In registering for Nutcracker or other Productions, Participants and those enrolling on their behalf agree to the overall Ovations Registration policies, as in effect from time to time, for all Students enrolled in any Ovations classes or performances. For the Nutcracker and Spring productions, Participants and those enrolling on their behalf also agree to various additional policies and requirements about the rehearsal, class enrollment and attendance and performance requirements and payment of any required fees, as specified here and in the Nutcracker and Spring Production Handbooks. Each Participant must regularly attend classes and required rehearsals and participate fully in preparation for the production. Each Participant must attend, including at a theater location, at least one dress rehearsal (and perhaps more, at Ovations' discretion), as well as all required performances. Additional requirements, policies and procedures are set forth in the Nutcracker and Spring Production Handbooks. Participants in the Nutcracker or the Spring Production must also take a minimum number of ballet classes at Ovations during the September 26 to June 27 session for Nutcracker. These class requirements are set forth above and, in the Nutcracker, and Spring Production Handbooks. There are no discounts applied to Nutcracker participation fees. Also, participation in the Nutcracker or any of our other productions does not count toward multi class discounts. There are also fees required in connection with the Spring Production and there are Recital Participation and Costume Fees required in connection with our Spring Recitals. Fees for those productions will be disclosed when registration opens for those productions. In the event that any theater or other venue that Ovations has booked for production purposes for the Nutcracker, or any other shows including the spring production and spring recitals becomes unavailable due ANY REASON, including inclement weather, public health emergencies, governmental restrictions, plumbing or HVAC emergencies, safety lock-downs or theater owner options to reclaim use or prohibit use of the facilities under relevant theater or other venue leases, productions may need to be CANCELLED or RESCHEDULED. In the event of cancellation, there will be no refund of participation or costume fees. However, Ovations will attempt in a commercially reasonable manner (as determined solely in the discretion of Ovations) to find an alternate venue, format (possibly digital only) or date to put on the production or show. However, no guarantees can be made that this will be accomplished. Further, if an alternate date is determined for any Ovations production that is rescheduled, no refunds will be given if a participant cannot participate in the newly rescheduled production(s).

ATTENDANCE

All Students are expected to attend their regularly scheduled classes. Excessive absences may affect recitals, performances, participation and/or advancement and could lead to injury for the dancers or those around them. Dancers having more than 8 unexcused absences over the course of the session (or 4 per 15 classes) may warrant automatic removal from recital and/or may result in their falling behind their cohort. Ovations may, at its sole discretion, require Students who are excessively absent to take set up private lessons to accommodate for the absences in order to keep up and maintain reasonable physical condition to safely attend classes in which the Student is enrolled. At certain levels, failure to attend classes may lead to a downward adjustment in Student's class level. In some cases of excessive absences or behavioral problems, Ovations may require Student to be dismissed from the class. In no event, however, will refunds be provided due to Student absences, even in the unlikely event that excessive absences by a Student may lead Ovations to dismiss the Student. Nutcracker, Other Performances and Competition Class and Attendance Requirements: For Students enrolled in Nutcracker, and other performance companies, there are additional class commitments required. **OVATIONS DOES NOT HAVE A POLICY TO OFFER MAKEUPS FOR MISSED CLASSES OR REHEARSALS. IN CERTAIN CIRCUMSTANCES WE MAY TRY TO ACCOMODATE MAKE UPS, BUT NO LONGER OFFER MAKEUPS AS A REGULAR PART OF OUR CURRICULUM.**

- **Nutcracker, Other Performances and Competition Attendance Requirements:** For Students enrolled in Nutcracker, and other performance companies, there are additional class commitments required.
 - Students in the Nutcracker must also be enrolled in ballet classes at Ovations for the full September, 2026 to June 2027 session. For en pointe Students, the requirement is at least two 1.5 hour Ovations ballet technique classes per week during the relevant session; for all other Students, the requirement is at least 1.5 hours of Ovations ballet classes per week during the relevant session for participants 9 and up who are not en pointe and 45-60 minutes for those students aged 5-8. Students enrolled in any Nutcracker may not miss more than 2 regularly scheduled ballet classes per session. A Student who misses more than 2 classes must make up these classes in accordance with Ovations makeup policies (detailed above). Students enrolled in the Nutcracker may not miss more than 1 run-through call and may not miss more than 1 choreography rehearsal call. Further, Students enrolled in Nutcracker may not miss any technical or dress rehearsals or performances. Rehearsal and performance schedules will be provided at the commencement of rehearsals, but will remain subject to change at any time.
 - Competition dancers must also regularly attend all of their enrolled classes. Due to the rigorous nature of competitions, dancers must keep up with their technique by attending classes consistently. The Competition Team teachers reserve the right to remove any dancer from dances and competitions due to an excess of class and/or rehearsal absences.

2026/2027 OVATIONS STUDIOS POLICIES

RELEASE OF LIABILITY, ASSUMPTION OF RISK

Registrant represents that (1) he/she understands that dance is a physical activity and art form; (2) Registrant is choosing to engage in such activities and/or to allow Student to do so; and (3) it may be necessary and appropriate for instructors to place hands on the Student for proper placement and correction of body alignment. Registrant agrees and acknowledges that Ovarations will not be responsible and will not provide escorting or oversight in the event that any Student needs to use one of the common area bathroom facilities even if the need to utilize the restroom arises during scheduled class or rehearsal time. Therefore, Registrant acknowledges that a Parent of the Student or a Caregiver authorized in writing by a Parent of the Student, will remain just outside of Ovarations' facilities to accompany the Student to and from the restroom if necessary. Ovarations will have no liability whatsoever if any harm in any form arises due to a Student visiting the restroom unaccompanied. Registrant also agrees that Student will be picked up in person just outside the inside doors to our studio as soon as Class or rehearsal ends. For any Students over the age of 9, Registrant may submit a form permitting Student to leave Ovarations' facilities unaccompanied. All Students must utilize ONLY the back outside staircase door when departing Ovarations facilities. Registrant hereby agrees to hold Ovarations harmless relating to any harm that Student may suffer resulting from any unaccompanied dismissal. Registrant agrees that, in exchange for Student being permitted to participate in the Enrollment session, workshop, intensive, or production, Registrant must and will indemnify and hold harmless Ovarations, and any and all owners, officers, directors, shareholders, employees, contractors, and agents of Ovarations, and their family members, heirs, executors and administrators ("Indemnitees"), from and against any and all liability arising out of or in consequence of any mental, emotional or physical injury, contagion exposure, illness, or death, sustained by Student, Registrant, any family member or caregiver of Student or Registrant, and any invitee of Student or Registrant, arising from participation in, attendance at or commuting to or from the Enrollment session, workshop, intensive, or production. Registrant agrees that none of Student, Registrant, any of their heirs, assigns, representatives, and invites will make a claim against Ovarations for any such injury, illness or death. Registrant represents that he/she has carefully read this liability waiver, has had the opportunity to seek legal advice, and fully understand its contents. Registrant understands that this agreement is intended to be as broad as permitted by the laws of the State of Maryland.
